# 'Missing' CM Soren surfaces in Ranchi after ED visits Delhi home

Jharkhand CM holds talks with alliance partners; MLAs sign letter of support without name; officials tow away a vehicle and impound about ₹36 lakh in cash from his Delhi residence; Soren likely to appear before ED at his Ranchi residence today

ours after the BJP accused Jhark-hand Chief Minister Hemant Soren of going "missing" in Delhi since **Enforcement Directorate** (ED) officials visited his residence there on Monday, he surfaced in Ranchi and held several rounds of meetings with leaders from his ruling coalition on Tuesday. The MLAs of the Jhark-

hand Mukti Morcha (JMM)led coalition expressed solidarity with the Soren government. They also signed a letter of support without any name as speculation is rife that the Chief Minister's wife, Kalpana Soren, will be given the reins of the State. Ms. Soren, who is not an MLA, attended a meeting of the lawmakers earlier in the

After their visit to his Delhi residence, the ED officials towed away a vehicle purportedly used by Mr. Soren and also reportedly impounded about ₹36 lakh in cash. It is not yet confirmed whether the agency has seized or attached those assets under any provision of the Prevention of Money Laundering Act.

Mr. Soren is likely to appear before the ED at his Ranchi residence on Wednesday afternoon to record his statement in an alleged land scam case. He had been questioned by the ED for seven hours on January 20 after evading ten previous summons from the agency.

### Homage to Gandhi

After 32 hours out of the public eye, however, Mr. Soren emerged from his residence in Ranchi on Tuesday to offer homage to Mahatma Gandhi on his death anniversary. "We will not let the teachings of Bapu be suppressed," the smiling CM told waiting presspersons. Security was beefed up at his Ranchi residence where he held meetings with his alliance

partners. Leaders of the Congress, the RJD, and the Nationalist Congress Party, all members of the ruling coalition also held a meeting at the State Circuit House. Later in the evening, legislators from Mr. Soren's Jharkhand Mukti Morcha met at his residence.

"We are ready for what may come... The BJP is abusing Central agencies to destabilise a democratically elected government but we will not allow them to succeed in their mission," Transport Minister and senior JMM leader Champai Soren said. The Minister said the meeting was convened just to express legislators' solidarity with the Chief Minister in the prevailing circumstances. On the speculation that

Ms. Soren might replace her husband as the Chief Minister, the legislators said no such discussion was held in the meeting.

Health Minister Banna Gupta said any decision in

the current scenario will be taken according to the circumstances. "We will again meet tomorrow at the CM House to express solidarity." the Congress Minister said.

### Section 144 imposed

With JMM workers protesting against Mr. Soren's summons by the ED, Section 144 of the Code of Criminal Procedure, prohibiting public assembly, was imposed near the CM's residence, as well as at the Raj Bhavan and the ED's Ranchi office. Declaring that "no one is above the law", Jharkhand Governor C.P. Radhakrishnan summoned the Director-General of Police to the Raj Bhavan on Tuesday to discuss the law-and-order situation in the State.

JMM national general secretary Supriyo Bhattacharya, however, told presspersons that "a Chief Minister is not an individual but an institution". (With inputs from Devesh K. Pandey and PTI)

## Imran sentenced ahead of Pak. polls

**Associated Press** ISLAMABAD

A Pakistani court convicted former Prime Minister Imran Khan of revealing official secrets on Tuesday and sentenced him to 10 years in prison – the latest in a slew of legal cases that supporters say are meant to sideline the imprisoned politician just days ahead of parliamentary elections.

Mr. Khan, who was ousted in a no-confidence vote in 2022, is not on the ballot because he is already serving a three-year prison term – and more than 150 other cases are still pending against him.

The former cricket star nonetheless remains a potent political force because of his grassroots following and anti-establishment rhetoric.

Pakistan saw violent demonstrations after Mr. Khan's arrest last year, and authorities have cracked down on the politician's supporters and party since then, making them wary of staging new rallies.

The February 8 elections come at a sensitive time in Pakistan, which is mired in an economic crisis that Mr. Khan's succes-

sor, Shehbaz Sharif, struggled to manage.

#### The cipher case

On Tuesday, Mr. Khan was convicted in what is popularly known as the cipher case, in which he was accused of exposing state secrets by waving a confidential document at a rally. ### Fourteen get death penalty for Kerala BJP man's murder

<u>The Hindu Bureau</u> ALAPPUZHA

A court in Kerala on Tues day awarded the death penalty to 14 of the 15 convicts in the murder of Ranjith Sreenivas, a BJP functionary. The verdict was delivered by the Mavelikara Additional District Sessions Court-I.

Sreenivas, who was a lawyer and the State secretary of the BJP's front for Other Backward Classes, was hacked to death at his house at Vellakinar in Alappuzha on December 19, 2021, in front of his mother, wife, and daughter. His family welcomed the verdict. The convicts, hailing from Alappuzha, belong to the now-proscribed Popular Front of India and its

political arm, the Social Democratic Party of India.

### 'Rarest of rare case'

Observing that the murder fell under the category of the rarest of rare cases, Judge Sreedevi V.G. directed that the 14 convicts -Naisam, Ajmal, Anoop,

Mohammed Aslam, Abdul Kalam alias Salam, Abdul Kalam, Saffaruddin, Manshad, Jaseeb Raja, Sameer, Nazir, Zakir Hussain, Shaji Poovathungal, and Shernas Ashraf – be hanged by the neck till their death. The court also imposed a ₹1 lakh fine on all of them.

Though the court has found Navas, the tenth accused, guilty of the offences charged against him, it did not pronounce his sentence as he is undergoing medical treatment at a hospital. The court will award him punishment at a later date. All 15 accused in the case were found guilty by the court on January 20, under Section 302 (murder) and various other provisions of the Indian Penal

### Israeli forces posing as women storm West Bank hospital, kill three

Israeli forces disguised as civilian women and medical workers stormed a hospital on Tuesday in the occupied West Bank, killing three Palestinian militants in a dramatic raid that underscored how deadly violence has spilled into the territory from the war in Gaza.

The military said the militants were using the hospital as a hideout, without providing evidence. It alleged that one of those targeted in the raid had transferred weapons and

ammunition to others for a planned attack, purportedly inspired by the Hamas assault on southern Israel on October 7 that triggered the war in Gaza. It did not provide details on how the three were killed.

'Targeted killing'

The Palestinian Health Ministry said Israeli forces opened fire inside the wards of the Ibn Sina Hospital in the town of Jenin. The Ministry condemned the raid and called on the international community to pressure Israel's military to halt such operations in hospitals. A hospital spokesperson said there was no exchange of fire, indicating that it was a targeted killing.

He said the Israelis attacked doctors, nurses, and hospital security during the raid. "What happened is a precedent," he said.

"There was never an assassination inside a hospital. There were arrests and assaults, but not an assassination."

Footage said to be security camera video from the hospital that circulated on social media showed about a dozen undercover forces, most of them armed,

Israel has come under heavy criticism for its raids on hospitals in Gaza, which have treated the tens of thousands of Palestinians wounded in the war as well as providing critical shelter for displaced people.

### **Collapsing healthcare**

Gaza's health care system, which was already feeble before the war, is on the verge of collapse, buckling under the scores of patients, the lack of fuel and medical necessities limited by Israeli restrictions and repeated interruptions from fighting in and near the facilities. Since October 7, vio-

lence in the West Bank has also surged as Israel has cracked down on suspected militants, killing more than 380 Palestinians, according to the Palestinian Health Ministry. Most were killed in confrontations with Israeli forces during arrest raids or violent protests. The Israeli military says it has arrested nearly 3,000 Palestinians in the West Bank over the past four months.

he INDIA bloc alliance on Tuesday faced a setback as the Congress and the Aam Aadmi Party (AAP) joint candidates lost to the Bharativa Janata Party (BJP) in the Chandigarh mayoral elections. The BJP's candidate, Manoj Sonkar, won the post of mayor by securing 16 votes in the 35-member municipal corporation House while Congress-AAP candidate Kuldeep Tita got 12 votes.

Though the INDIA bloc had 20 votes, eight votes were declared as invalid by presiding officer Anil Masih and Mr. Sonkar romped home. In Municipal Corporation Chandigarh, there are 35 councillors while the Member of Parliament from Chandigarh (of the BJP) is an ex-officio member and also has voting rights. The BJP has 14 councillors, AAP 13 and the Congress seven. The Shiromani Akali Dal has one

member in the House. The Chandigarh election was being seen as the first electoral test for the INDIA bloc's effectiveness in taking on the National Democratic Alliance (NDA) ahead of the general election, coming as it does days after one of the bloc archi-

### **Shameless** capture of democracy, says Congress

### Blatant dishonesty, hooliganism: Kejriwal

Aam Aadmi Party (AAP) chief Arvind Kejriwal on Tuesday said that through "blatant dishonesty" and "hooliganism", the Bharatiya Janata Party (BJP) won the mayoral election in Chandigarh. He said this was "extremely danger-

ous" for democracy. "On 30th January, 76 years ago the ambassador of peace and non-violence. Gandhiji was murdered. And today they have murdered democracy in the country. Fortunately, their acts of hooliganism and dishonesty have been captured on the cameras. Now, the entire country is

witnessing openly how forcibly they committed robbery of votes to elect their Mayor in Chandigarh," Mr. Kejriwal said at a press conference in New Delhi.

The AAP chief said that in the history of Chandigarh mayoral elections, votes have never been declared invalid at such a large scale.

He alleged that if the BJP can manipulate even with a mayoral election which involves only 36 votes, one can imagine the extent of manipulation in a Lok Sabha election which involves about 90 crore votes. "Even a 5-6% discrepancy in votes in national elections can significantly impact the results," he said.



### 'Himachal Rajva Sabha seat can go to Sonia or Priyanka'

Himachal Pradesh Congress chief Pratibha Singh on Tuesday said the lone Rajya Sabha seat falling vacant on expiry of six-year term of BJP chief J.P. Nadda on April 2 can go to Congress leaders Sonia Gandhi or Priyanka Gandhi Vadra. "We would discuss the matter with Congress leaders Sonia Gandhi and Priyanka Gandhi Vadra and the seat could go to them if they are willing," Ms. Singh said. Following declaration of schedule for the elections to 56 Rajya Sabha seats, search has begun in the Congress which has a clear majority of 40 out of 68 seats in the Himachal Assembly. At present, all three Raiva Sabha seats from the State are held by the BJP. PTI

### Khichdi scam: ED questions Sanjay Raut's brother

The Enforcement Directorate (ED) on Tuesday questioned Shiv Sena (UBT) leader and MP Sanjay Raut's younger brother Sandeep Raut in connection with the money laundering case related to the "Khichdi scam" of Brihanmumbai Municipal Corporation (BMC). Sandeep Raut, accompanied by Sanjay Raut, appeared before the probe agency at its office in Ballard Estate in south Mumbai around 11.30 a.m. As per the case details, rules were violated when the BMC gave a contract for providing "Khichdi" packets to migrant workers stranded in the city during the COVID-19 pandemic. The ED has arrested Aditya Thackeray's close aide and Yuva Sena functionary Suraj Chavan in the case. PTI

### 'Took permission to use AI to recreate late singers' voice'

Music composer A.R. Rahman has said that his team took due permission to use an AI software for recreating the voices of late singers Bamba Bakya and Shahul Hameed for a track in veteran actor Rajinikanth's new film "Lal Salaam". The two artists, who had worked with Mr. Rahman on multiple projects before their deaths, are credited as playback singers for the track 'Thimiri Yezhuda'. "We took permission from their families and sent deserving remuneration for using their voice algorithms...technology is not a threat and a nuisance if we use it right...#respect #nostalgia," he wrote. Bakya died in September 2022 at the age of 42. PTI

### M.P. Congress removes party spokesperson over scuffle

Madhya Pradesh Congress Committee president Jitu Patwari removed Shahryar Khan from the post of spokesperson and issued show-cause notices to him and the State unit's Scheduled Caste wing chief Pradeep Ahirwar, a day after a viral video showed the two leaders coming to blows with each other.

A video of the two leaders engaged in a scuffle at the PCC headquarters in Bhopal went viral on Monday showing Mr. Khan and Mr. Ahirwar arguing over the ticket distribution in last year's State Assembly elections. The two can also be seen hurling abuses at each other while Mr. Khan is seen falling on the ground with Mr. Ahirwar charging at him with a chair even as other leaders try to intervene in the matter.

### Jarange-Patil steps up pressure on govt. with new agitation threat

gar community. Last week, after CM Eknath Shinde met with the activist in Navi Mumbai and persuaded him to call of his protest by assenting to all his demands, the



Maharashtra government issued a draft notification which stated that blood relatives of a Maratha person, who had obtained records to prove that he belonged to the agrarian Kunbi community, would also be recognised as

'Implement in 10 days' Mr. Jarange-Patil stressed he had not stopped the quota stir and warned he would not do so until every Maratha had secured reservation. "The government must implement its promises in the next 10 days," he said.

### Amid seat-sharing talks with Congress, SP releases first list of 16 candidates for LS polls

The Samajwadi Party (SP) on Tuesday announced its first list of 16 candidates for the upcoming Lok Sabha election amid seat-sharing talks with the Congress. The Congress had staked claim to at least two of these 16 seats - Farrukhabad and Faizabad.

According to sources, senior Congress leader Salman Khurshid wanted to contest from Farrukhabad, which he has won twice in 1991 and 2009. "How could they lay a claim on the seat. considering that the Congress had polled around 8,000 votes in all five Assembly segments that make the Lok Sabha seat during the 2022 Assembly election," a senior SP leader said.

The Congress wanted the Faizabad seat as well from where its former State The Congress had staked claim to at least two of these 16 seats - Farrukhabad and Faizabad; Dimple Yadav to contest from Mainpuri

president Nirmal Khatri has won twice in the past. But the SP leaders ruled that the Congress is not in a winnable position here.

The first list includes three members of the 'first family' of the SP – Dimple Yadav from Mainpuri, which she currently represents, Akshay Yadav, son of senior SP leader Ramgopal Yaday, from Firozabad, and Dharmendra Yadav from Budaun parliamentary constituency. Both Mr. Akshay and Mr. Dharmendra have held Firozabad and Badaun seats in the past, but had lost the 2019 election.

In the Kheri Lok Sabha seat, where the SP's two-

time Lok Sabha MP Ravi Verma switched to the Congress, the party has fielded Utkarsh Verma, a first-timer. This seat is currently held by the BIP's controversial leader and Union Minister Ajay Mishra Teni.

The party is also repeating its Sambhal MP. Shafiqur Rahman Barq, from Sambhal. Annu Tandon, former Congress leader who switched to the SP, has been fielded from Unnao. She had won the seat in 2009 on a Congress ticket. The SP has been a distant second on the seat in the last two elections losing to the BJP's Sakshi Maharaj. Ravidas Mehrotra, sitting MLA from Lucknow Central, has been named as the party candidate from Lucknow. Similarly, the sitting MLA from Katehari in Ambedkar Nagar district, Lalji Verma, has been fielded from Ambedkar Nagar parliamentary constituency.

### Canal pact touted as major achievement of new BJP govt. in Rajasthan

The ruling Bharatiya Janata Party (BJP) in Rajasthan has claimed that a tripartite memorandum of understanding (MoU) signed between the Centre and the Madhya Pradesh and Rajasthan governments for the ambitious Eastern Rajasthan Canal Project (ERCP) will herald a "new era" of the State's development. A detailed project report (DPR) for the ERCP will be prepared under the pact.

The previous Congress government had turned the demand for the national project status for the ₹37,200-crore ERCP into a major election issue, while accusing the BJP government at the Centre of not taking care of the interests

of the people in 13 districts, which were set to benefit from it. The Congress alleged that the BJP had gone back on its promise.

In its original form, the ERCP was to be implemented along with the interlinking of Parvati, Kali Sindh and Chambal rivers. Since the Centre did not accept the demand for the national project status, the Congress government

started the work with its own resources, with the construction of the Navnera-Bisalpur-Isarda link, Mahalpur barrage and Ramgarh barrage at a cost of ₹9,600 crore. The MoU signed in New

Delhi on Sunday in the presence of Union Jal Shakti Minister Gajendra Singh Shekhawat and Chief Ministers Bhajan Lal Sharma and Mohan Yadav will in-

corporate the work done so far in the State. This will be the second project under the Centre's national perspective plan of interlinking programme. BJP State president C.P.

Joshi said here that the collaboration between Madhva Pradesh and Rajasthan had become possible after the formation of the "double engine government". The revamped Parvati-Kali Sindh-Chambal link project of the ERCP would be a cornerstone for development of both the States, with the availability of an ample amount of water for both drinking and irrigation, he said.

A total of 26 districts in both the States will benefit from the agreement and 25 lakh families of agriculturists in 13 districts of Rajasthan will get access to irrigation waters. The water will be available for 2.80lakh hectares in the State, contributing to an increase in the ground water level.

Rajasthan's districts which will benefit from the project are Jhalawar, Baran, Kota, Bundi, Sawai Madhopur, Ajmer, Tonk, Jaipur, Karauli, Alwar, Bharatpur, Dausa and Dholpur, where a population of 3.5 crore resides. The Congress government had sought the national project status on the ground that the huge project cost could not be borne by the State alone.

'Will receive less water' However, Kisan Mahapanchayat president Rampal Jat said the MoU had undermined the original DPR, as the quantity of water to be received by Rajasthan would be reduced by half. "The DPR of 2017 stipulated that the State would receive 3,510 million cubic metres of water. The project's integration with interlinking of three rivers will reduce the quantity of water to 1,775 MCM, which will not be sufficient for the 13 districts," Mr. Jat said.

**Uproar in Assembly** The signing of the MoU al-

so came up for a debate in the State Assembly on Tuesday with the government making a statement on the floor of the House. The proceedings were adjourned twice because of the uproar by the Opposition Congress MLAs, who pointed out several shortcomings in the agreement and demanded that the government reconsider it.

# Won't let anyone take away citizenship of people as long as I am alive: Mamata

BJP raking up NRC, CAA, and UCC ahead of Lok Sabha poll, this is nothing but politics, says West Bengal CM in response to Union Minister Shantanu Thakur's claim that CAA would be rolled out soon

ambasting the Bharatiya Janata Party (BJP) for "opportunistically raking up" the issue of Citizenship (Amendment) Act ahead of the Lok Sabha election, West Bengal Chief Minister Mamata Banerjee on Tuesday said she would not allow anyone to take away the citizenship of people during her lifetime.

Her latest remarks were prompted by Union Minister Shantanu Thakur's assertion that CAA would be rolled out across the country within a week. Mr. Thakur's statement, made during a public gathering at Kakdwip in South 24 Parganas district on Sunday, had fuelled concern regarding the imminent enforcement of the controversial legislation.

The CAA, enacted by the BJP-led government at the Centre in 2019, fasttracks citizenship to six undocumented non-Muslim communities - Hindu, Sikh, Buddhist, Parsi, Christian and Jain - from the neighbouring countries of Pakistan, Afghanistan and Bangladesh.

Speaking at a programme at Raiganj in West

Bengal's Uttar Dinajpur district, she said, "They [BJP] are speaking about NRC (National Register of Citizens), CAA, and Uniform Civil Code ahead of the election. This is nothing but politics. We have given citizenship to everyone [and] they [people in border areas] are getting everything. They are citizens, which is why they are allowed to vote," she said.

"But let me make it very clear that as long as I am alive, I will not allow the implementation of NRC in West Bengal. I will not allow them to take away the citizenship of anyone... everyone here is a citizen,"

'NRC trap'

she said.

Expressing concern over reports of the Border Security Force (BSF) allegedly issuing separate identity cards to the residents in the border areas, Ms. Banerjee cautioned people against accepting such cards, labelling those as potential tools in "NRC

She also emphasised the need for vigilance among border communities. Ms. Banerjee's statements align with her earlier claims in Cooch Behar district,

where she accused the BSF of similar actions, a charge denied by the paramilitary

Reacting to Ms. Banerjee's statement, the West Bengal BJP unit said the CAA is a law of the land and no one can stop it from being implemented. "CAA is a law of the land and no one can stop it from being implemented. Why is she making confusing statements about NRC implementation? The Centre has never said anything about NRC implementation," BJP leader Rahul Sinha said. The Chief Minister ral-

lied support against what she characterised as an alliance between the Congress, CPI (M), and BJP in West Bengal, urging people to unite under the Trinamool Congress (TMC) banner to counter this perceived threat. "It is the Trinamool Congress that is fighting for the rights of the people of the State. We all have to unite to defeat the Congress-CPI (M)-BJP nexus in Bengal," Ms. Banerjee said, calling for solidarity among citizens.

Her remarks follow her recent announcement of the Trinamool's decision to contest the upcoming Lok Sabha poll in West Bengal

### Decide Sharjeel's bail plea by next month, says Delhi HC

The Delhi High Court on Tuesday ordered a trial court here to decide by next month a plea by student activist Sharjeel Imam seeking bail in connection with a 2020 communal riots case involving allegations of sedition and unlawful activities.

Mr. Imam has sought bail on the grounds that he has been in custody for the past four years and the maximum sentence for the offence under Section 13

(punishment for unlawful activities) of the Unlawful Activities (Prevention) Act is seven years.

He said he has undergone more than half of the maximum sentence prescribed for the offence and is entitled to bail under the provision. According to Section 436-A CrPC (Code

of Criminal Procedure), a person can be released from custody if he has spent more than half of the maximum sentence prescribed for the offence.

During the hearing, Mr. Imam's counsel told the court that there are a total of 43 prosecution witnesses in the case, out of which 22 have been examined so far. In 2022, the trial court had framed charges against him under Sections 124A, 153A, 153B (imputations prejudicial to nation-

al integration), 505 of IPC

and Section 13 of the UAPA.

### Dreaded gangster 'Ravan of Sahebganj' on the run for 10 years, nabbed from Bihar

A dreaded gangster wanted in 25 cases of murder, attempted murder, extortion, and narcotics-related cases, known by his moniker 'Ravan of Sahebganj', was arrested from Paru town in Bihar's Muzaffarpur earlier this month by Delhi Police.

Ram Naresh Sahani was given the moniker after he set up his base in Muzaffarpur's Sahebganj village nearly two decades ago and terrorised its residents. He still has an active gang of nearly 50 in the area, police sources said, adding that he exerts tremendous influence over

the illicit liquor business in northern Bihar. The Delhi police booked him in a murder case in 2005 and declared him a proclaimed offender in connection with a narcotics-related case in 2014.

Sahani was accused,

along with two other persons, of murdering a man named Kumod in Surat. Police sources said Sahani ran an illicit liquor business in Gujarat for nearly four years, during which he had a dispute with Kumod, who was in the same trade. After gunning down his competitor, Sahani evaded arrest till March 2012, when Delhi Police's Crime Branch nabbed him for running a narcotics network in the national capital. In July 2013, during the trial, Sahani got an interim bail for his daughter's marriage. However, he jumped the bail. A year later, he was declared a proclaimed

Cat-and-mouse game

A senior officer said they received a tip-off about Sahani's whereabouts on January 5. "Upon reaching Bihar, we camped in Muzaffarpur for four days to apprehend him," the officer said. "We looked for him from morning to night. We had to develop a network of informers because nobody wanted to speak up against him. What made catching him more difficult was that Sahani would change his address, mobile number, and appearance to evade arrest. He would grow a beard and then remove it. His facial features kept changing," the officer added.

Additional Commissioner of Police (Crime) Sanjay Bhatia said, "Due to the terror of his gang, nobody ever shared information regarding his whereabouts with the police. Whenever the police tried mounting pressure on him, he would flee to Nepal and return to Bihar only after sensing that the pressure had eased." Sahani was finally arrested from the outskirts of Paru town in Muzaffarpur on January 8.

The government ordered the submission of a bond declaring that, after the completion of studies related to healthcare, the candidates would serve in any health institution of the State for at least two



### Man killed, one injured in gunfight in Manipur

At least one village volunteer was killed and another injured after their camp came under attack from unidentified gunmen in Kangpokpi district of Manipur on Tuesday, the police

The incident took place at the camp situated near Kadangband village in the Lamshang area in adjoining Imphal West district.

"After the unknown gunmen launched the attack, the village volunteers retaliated, resulting in a gunfight in which one village volunteer was killed and another was injured.

"Following the retaliation, the attackers retreated, regrouped and attacked again. The gunfight is under way," a police officer said. After the eruption of the gun battle, several women and children from Kadangband and neighbouring Koutruk village fled to safer areas, he said. Additional security personnel have been sent to the area to bring the situation under control, the officer said. The injured has been taken to the Regional Institute of Medical Sciences in Imphal.

### HC directs T.N. to restrict non-Hindus' entry into temples

Justice S. Srimathy of the Madurai Bench of the Madras High Court on Tuesday directed the State government, the Hindu Religious and Charitable **Endowments Department** and temple authorities to install boards in and around temples, indicating that non-Hindus were not allowed beyond the Kodim*aram* of the temples.

If a non-Hindu seeks to visit a particular deity in a temple, the authorities shall obtain an undertaking from the individual that he/she has faith in the deity, and would follow the customs and practices of Hinduism and of the temple. On obtaining such an undertaking, the non-Hindu may be allowed to visit the temple, the judge said.

Whenever a non-Hindu is allowed entry based on such an undertaking, the same shall be recorded in a register maintained by the temple. The authorities shall strictly follow the agamas, customs, and practices of the temple, the judge

The authorities submitted that if such a board was installed, it would hurt the A temple is not a picnic or tourist spot, and ought to be maintained with reverence, says the **High Court judge** 

religious sentiments of those who would like to visit the temple.

To this, the judge said that the authorities were confusing the issue. If a non-Hindu did not have faith in the religion and declined to follow its customs and practices and those of the temple, then he/she cannot be allowed entry, and hence, there was no question of hurting sentiments, she said.

On the other hand, if a non-Hindu who declined to follow such customs and practices was allowed inside the temple, it would affect the sentiments of the large number of Hindus who practise the faith reverently. It would also affect the rights of Hindus guaranteed under the Constitution, the court said.

Further, Justice Srimathy said that a temple was not a picnic or tourist spot, and ought to be maintained with reverence, and as per agamas.

# 3 CRPF personnel killed in Maoist attack in Bastar

Two commandos of elite jungle warfare unit among the deceased; 15 personnel injured but are out of danger; six Maoists killed in retaliatory fire, say police; Chief Minister slams 'cowardly act'

hree personnel of the Central Reserve Police Force (CRPF), two of them commandos of the elite jungle warfare unit CoBRA, were killed and 15 injured in an encounter with Maoists along the boundary of Sukma and Bijapur districts in the Bastar region of Chhattisgarh on Tuesday. Six Maoists were killed in the retaliatory fire, the police said. The shoot-out took

place on the first day of a newly established security camp at Teklagudem village, a Maoist stronghold about 450 km from the State capital, Raipur. The attackers were over 500 in number, Chief Minister Vishnu Deo Sai said in the evening. He spoke to some of the injured jawans hospitalised in Raipur. Some accounts had pegged the number at even 1,000, the Chief Minister added.

Inspector-General Police (Bastar Range) Sundarraj P. said that after the camp was set up, a joint

team of the Special Task Force, the District Reserve Guard [both components of the State police], the Commando Battalion for Resolute Action (CoBRA), and the CRPF was patrolling in nearby villages when Maoists opened fire on

"All the jawans gave a befitting reply and we have received information of six Maoists cadre getting killed but unfortunately, in this encounter, our three jawans – two CoBRA jawans and one CRPF jawan were martyred. Fifteen were injured too," he said.

The Maoists retreated into the forests following the retaliatory fire. Search operations were on till late in the evening, the police added.

The deceased were identified as constables Devan C. and Pavan Kumar (both from 201 CoBRA) and constable Lambdhar Sinha (150 CRPF). Among the injured are a Deputy Commandant, an Assistant Commandant, four head constables, and nine con-

stables.

Mr. Sundarraj said the injured personnel were taken to the Jagdalpur Medical College and two private hospitals in Raipur. They were out of danger, he ad-

Twenty-three security personnel were killed in an encounter with Maoists in the same area in April 2021.

Mr. Sundarraj said that the camp had been established for the security of the people and that the attack would not deter the police.

Expressing solidarity with the security personnel, the Chief Minister said areas perceived as sympathetic to Maoists were now witnessing increased deployment and effectiveness of security forces. This, the Chief Minister said, led to "a disarray among the Naxals and they were resorting to cowardly acts of terror".

### **SC** questions J&K on plea to publish review orders

The Supreme Court on Tuesday questioned the Union Territory of Jammu and Kashmir about the non-publication of review committee orders regarding Internet shutdowns in the region.

"Review committee's or-

ders are meant to be published," a Bench of Justices B.R. Gavai and Sanjay Karol addressed Additional Solicitor General K.M. Nataraj, who appeared for the Union Territory. The court's remarks came in a petition filed by the Foundation for Media Professionals, which claimed that the authorities were not complying with a Supreme Court direction in the January 2020 Anuradha Bhasin judgment to publish the orders for suspension of telecom services.

Justice Karol told Mr. Nataraj that the authorities ought to follow the directions in the judgment. Mr. Nataraj said the deliberations of the review committee need not be made public. He assured the court that he would seek instructions on the issue in time for the next hearing, posted after two weeks.

### Curbs on liquor sale do not extend to municipal areas: SC

The Supreme Court has asserted that its December 2016 ban on the sale of liquor within 500 metres of the outer edge of national and State highways will not extend to municipal areas.

A three-judge Bench headed by Chief Justice of India D.Y. Chandrachud has recalled a Supreme Court order of March 20, 2023. The March 2023 order had set aside a Madras High Court decision confirming the permission granted by the Puducherry Excise Department to a liquor retailer, represented by senior advocate P.B. Suresh, to shift his shop to ECR Main Road at Ganapathi Chettikulam from Kamarai Salai Pillathottam.

The residents' society, Kanagachettikulam Makkal Podhunala Evakkam, had moved the High Court against the shifting of the liquor shop, saying the establishment was hardly 150 metres from temples, mosques and educational institutions. The High Court dismissed the petition of the residents, who approached the Supreme



Court. A Division Bench headed by Justice (now re tired) M.R. Shah had ruled in favour of the residents in

Arguing the review petition on Monday, Mr. Suresh said the top court had clarified, in a subsequent order on July 11, 2017, that the December 2016 prohibition on the sale of liquor within 500 metres along highways, did not extend to municipal areas.

"The purpose of the directions contained in the order dated December 15, 2016 is to deal with the sale of liquor along and in proximity of highways properly understood... The order does not prohibit licensed establishments within municipal areas... We have considered it appropriate to issue this clarification to set at rest any ambiguity," a three-judge Bench had explained in its 2017 order.

## Navy foils hijacking bid by Somali pirates, rescues 19 Pak. nationals

In the second successful intervention within 36 hours, the Indian Navy's offshore patrol vessel INS Sumitra, deployed in the Gulf of Aden, neutralised a hijack situation and rescued the Iranian-flagged fishing vessel Al Naeemi and its crew of 19 Pakistani nationals from 11 Somali pirates off the east coast of Somalia.

In another incident, a coordinated multilateral response between the Indian Navy, the Seychelles Defence Forces and the Sri Lankan Navy foiled the hijacking bid on a Sri Lankan fishing trawler.

### **Swift response**

The Indian Navy, in a statement on Tuesday morning, said that INS Sumitra was pressed into action to locate and intercept the Iranian-flagged fishing vessel *Al Naeemi*, which had been boarded by pirates with its crew of 19 Pakistani nationals taken hostage.

"Responding swiftly to the developing situation, Sumitra intercepted the vessel on Monday and through coercive posturing and effective deployment

of her integral helicopter and boats compelled the safe release of the crew and the vessel. The ship also undertook confirmatory boarding to sanitise and also to check on the well-being of the crew who were held captive by the Somali pirates.

This incident came just after INS Sumitra prevented a hijack incident in the area after responding to a distress message from Iranian-flagged fishing vessel Iman, with a crew of 17 Iranian nationals, which had been boarded by pirates and the crew taken hostage.

A hijacking incident was reported aboard the Sri Lankan-flagged

trawler Lorenzo Putha 04 about 955 nautical miles east of Mogadishu, Somalia and three pirates had boarded and hijacked it on January 27.

The Indian Navy deployed INS Sharada from Kochi on Sunday afternoon and also tasked its Sea Guardian High Altitude Long Endurance Unmanned Aerial Vehicle with locating and intercepting the hijacked fishing vessel, the Navy said.

"Additionally, efficient operational coordination and information sharing through the Sri Lanka and Seychelles International Liaison Officers at Information Fusion Centre for Indian Ocean Region (IFC

IOR), New Delhi resulted in the interception of the hijacked fishing vessel by SCGS Topaz in Seychelles Exclusive Economic Zone on Monday."

The three pirates surrendered to the Seychelles Coast Guard (SCG), all six crew members are safe and the vessel is being escorted to Mahé, Seychelles, the Navy said.

"INS Sumitra, over the

course of less than 36 hours, through swift, persistent and relentless efforts has rescued two hijacked fishing vessels along with 36 crew, 17 Iranian and 19 Pakistani, in southern Arabian Sea approximately 850 nm [nautical miles] West of Kochi, and prevented misuse of these vessels as mother ships for further acts of piracy on Merchant Vessels," the Navy said on the two incidents to which INS Sumitra responded.

The Gulf of Aden has seen a sudden spurt in piracy from Somalia in the last few months after going down completely from the peak around 2010. The Indian Navy has maintained continuous presence with at least one major warship deployed on anti-piracy duties since 2008.

Mr. Singh described India and the U.S. as natural partners who must move forward together in both business and strategic sectors amidst the current global geopolitical scenario.

"India and the U.S. support a free, open and rulesbased international order. Due to this, there is a lot of alignment in our strategic interests," Mr. Singh said.

## Indian graziers confront Chinese soldiers along the LAC in Ladakh

Vijaita Singh Dinakar Peri NEW DELHI

graziers were stopped by Chinese soldiers in the Kakjung area of Ladakh along the Line of Actual Control (LAC) earlier this month, according to a video shot by the local people that was shared on X by Chushul councillor Stanzin on Konchok Tuesday.

In the video, the herders can be seen confronting the Chinese People's Liberation Army (PLA) soldiers when the latter ask them to go back claiming it to be Chinese territory. The local people, who can be heard

speaking in a Tibetan language, are seen throwing rocks at the Chinese soldiers.

The incident occurred on January 2 near Patrolling Points 35 and 36 at Kakjung under the Nyoma constituency in Ladakh, Mr. Stanzin said. While Chinese soldiers with their vehicles can be seen in the video, there is no presence of Indian security forces.

Ishey Spalzang, councillor, Nyoma, told The Hindu that the area is within India's perception of the LAC.

He said that after the face-off, the sarpanch, the sub-divisional magistrate, and officials of the Indian

Army and the Indo-Tibetan Border Police (ITBP) visited the grazing site on January 12. "It is a valley and is essential for winter grazing of cattle. In 2019, the Chinese had tried to stop the

graziers but we had pitched tents to assert our claim. The nearest Army unit is present around five to seven kilometres from this place. That particular day they were not present," Mr. Spalzang said, adding that the herders had started from their village around 20 days ago before they reached the location.

Mr. Stanzin said on X, "See how our local people are showing their bravery in front of the PLA claiming that the area they are stopping is our nomad's grazing land. PLA stopping our nomads from grazing in our territory. Seems it is never a never-ending process due to different lines of perceptions. But I salute our nomads, who always stand to protect our land and stand as the second guardian force of the nation." He later told *The Hin-* du that the place where the incident happened is within one kilometre of the Indian claim on the line of the border with China.

A defence source said the video is of an incident that happened in the first week of January where "nomad graziers [with livestock] from our side are seen in conversation with PLA soldiers".

Such incidents are commonplace and happen on both sides whenever graziers stray across the LAC on account of the differing perceptions of the LAC, the source said. Such incidents are dealt with appropriately as per established mechanism.

As reported by *The Hin*du earlier, restoration of grazing grounds for graziers on both sides is among the top of the issues on agenda at the Corps Commander-level between the two sides as part of efforts for disengagement at two remaining friction points – Demchok and Depsang – and the overall de-escalation along LAC in eastern Ladakh.

Among issues in the ongoing discussions are restoration of patrolling rights and agreeing on new parameters for patrolling in these two areas to avoid friction.

### New BJP-JD(U) alliance may cap the evolution of social justice politics

The pendulum politics of Bihar Chief Minister and Janata Dal(U) chief Nitish Kumar, who swung between the Bharatiya Janata Party (BJP) and the Rashtriya Janata Dal (RJD)-Congress axis several times in recent years, signifies the social kinetics unleashed by the rise of Hindutva. The evident opportunism in the renewal of the BJP-JD(U) alliance is only superficial.

Prime Minister Narendra Modi has subsumed the social justice rhetoric within the rubric of Hindutya. This Hindutya 2.0 has thrown old tropes of social justice politics into a tailspin. Mr. Kumar's latest

somersault is his last attempt to hold on to his base – he concluded that his political longevity would be higher as an ally of the BJP than as an opponent. The BJP, on the other hand, has split the Opposition and derailed an attempted revival of Mandal politics, through its newest alliance.

Various strands of subal-

tern politics shared a common scepticism about Hinduism, even as nationalist politics sought to advance a composite Hindu identity through appeasement and coercion. Socialists, the forebears of the current social justice stock, hoped to use the Jan Sangh, the predecessor of the BJP, to undermine the dominance of the Congress. Socialists saw the Congress as the vehicle of upper caste dominance and hoped they could opportunistically ally with Hindutva.

**Anti-Congress politics** 

Hindutva remained a marginal player within the spectrum of anti-Congress politics until the birth of Ayodhya politics in the 1980s. Terrorism in Punjab and Kashmir, supported by sections of Sikhs and Muslims, provided a helpful backdrop to the rise of Hindutva, but the simultaneous rise of Mandal politics raised a barrier. But all social justice groups were not opposing the BJP. Mr. Kumar, under his mentor George Fernandes, split from the Janata family and joined hands with the BJP in 1994.

The relations between Hindutva and caste-based social justice politics re-

mained fluid, with both sides looking to take advantage of the other, even tensions underneath.

Mr. Modi's proclamations about his own Other Backward Class (OBC) origins began making a dent in the flanks of social justice politics by 2014.

In 2015, Rashtriya Swayamsevak Sangh (RSS) chief Mohan Bhagwat's call for a rethink of caste reservations brought forth a resurgence of social justice politics and propelled the ID(U)-RID alliance to victory in the Bihar Assembly lasted only for two years. Since then, Mr. Bhagwat has made compendious arguments in favour of continuing with reservations for an indefinite period, resolving a fundamental friction between Mandal and Kamandal. The move in the past one year to infuse a new life into Mandal politics through the call for a caste census did not gain momentum.

Mr. Kumar's government conducted a caste survey in Bihar and its results were published, but it did not turn out to be a climactic political event. Meanwhile, Mr. Modi's speech at the inauguration of the temple in Ayodhya recently amplified the subaltern legends that embellish the epic of Ram.

Hindutva Subaltern

thrives by expanding representation in politics and cultural spaces that are under construction in the new nationalist project. Subaltern classes that allied with Muslims since the 1990s in Uttar Pradesh and Bihar to gain political power find three attractions in the Hindutva model of social justice.

What it offers

First, it allows numerically weaker OBC groups to break away from the Yadav-, Jatav-, and Jat-led politics in Bihar and Uttar Pradesh. Second, the BJP encouraged OBCs to decouple from Muslims and increase participation in repurposed great traditions. This is presented as upward mobility.

Third, the BJP offers subaltern classes better

Mr. Modi presents himself as a member of the OBC community; the BJP elected a Dalit followed by a tribal woman to the highest office in the country. The combination of these factors have made conventional social justice politics redundant at the moment.

The BJP model has its own contradictions that might sharpen at some point in future. For the moment, the Sangh Parivar has moved to the centre on the question of social justice, and Mr. Bhagwat's changed view on reservations is only one indicator of that. The pendulum of social justice politics might stop swinging for now. Mr. Kumar's opportunism might end with the complete assimilation of his politics by the BJP.

he Budget Session of Parliament, the last one of the 17th Lok Sabha, will commence on Wednesday. The 14 Opposition MPs who were suspended during the previous session for protesting against the lack of a response from the government after an unprecedented security breach, will return to Parliament, after the Privileges Committee of the two Houses recommended the revocation of their suspension.

A total of 146 Opposition MPs – 100 in the Lok Sabha and the rest in the Rajya

Sabha – were suspended for bringing placards into the chambers, and frequently disrupting parliaproceedings. mentary While the suspension of

The session will begin with President Droupadi Murmu addressing a joint sitting of the Lower and Upper Houses. At an allparty meeting, the government urged the Opposition parties to cooperate and ensure that no placards were on display.

With the return of the Janata Dal(U) to the National Democratic Alliance, and the differences evident between the Trinamool Congress and the Congress, the Opposition will be on the back foot. Venugopal and Jairam Ramesh, who are participating in the party's Bharat Jodo Nyay Yatra, are unlikely to be present.

This will be the first Lok Sabha without a Deputy Speaker, a post mandated under Article 93 of the Constitution.

At the all-party meeting chaired by Defence Minister Rajnath Singh, Opposition members raised a host of issues, and demanded a debate on unemployment, high inflation, agrarian crisis, and violence-hit Manipur. Parliamentary Affairs Minister Pralhad Joshi addressed presspersons at the conclusion of the meeting. "They [the Opposition] have given suggestions, but since this is the last session of the present Lok Sabha, we have said we will give them an opportunity in the next session,"

### CPI(M) reiterates its support to INDIA, but slams Cong. in Kerala

The CPI(M) Central Committee, while reiterating its commitment towards the Indian National Developmental, Inclusive Alliance (INDIA) bloc on Tuesday, slammed the Congress for "adopting a negative and anti-democratic approach"

to the Kerala government. "Voters have no control over or knowledge of what transpires electronically between the VVPAT [voter-verified paper audit trail] device and the control unit. Hence, the CPI (M) has requested the ECI to connect the ballot unit directly to the control unit and from that point to the VVPAT to ensure accurate accounting," party general secretary Sitaram Yechury

"LS polls are just 60 days away and already the notification for Rajya Sabha elections are announced. Let us strive to get good results," he said. The government is committed to fulfilling all the promises it had made to the electorate.

Mr. Reddy said the party was now preparing to reach out to people from February 2 with the first meeting at Indervalli in Adilabad district.

### P.C. George likely to merge his party with BJP

# We don't need someone who made U-turn under pressure: Rahul on Nitish

As his Bharat Jodo Nyay Yatra traversed Bihar for the second day on Tuesday, Congress leader Rahul Gandhi said his party did not need the support of Bihar Chief Minister Nitish Kumar. "A little pressure and he took a U-turn."

"I understand Nitish ji's quandary. I told him straight that you will have to conduct caste census in Bihar... And we (Congress), along with RJD, insisted Nitish ji should conduct the survey. But BJP was in a panic as they oppose the survey. Nitish ji was in a jam and the BJP provided him a back door to escape," Mr. Gandhi said while addressing an impressive public meeting at Rangbhumi Maidan in Purnea, north Bihar.

"The mahagatbandhan (grand alliance) will continue to fight for social justice in Bihar and we don't need Chief Minister Nitish Kumar," Mr. Gandhi said. The Bharat Jodo Nyay Yatra entered Kishanganj in Bihar on January 29 from West Bengal.

### **Farmers share concerns**

"In Purnea, Mr. Gandhi had an extended interaction with local farmers. The farmers highlighted how they were squeezed between rising input costs, unfair land acquisition practices, and inadequate

compensation for harvests," Jairam Ramesh posted on X.

"Rahul empathised with the struggle that farmers face in the Modi government's anyay-kaal, juxtaposing the UPA government's progressive Land Acquisition Law to the Modi government's attempts to revoke it within months of coming to power. He assured them that as soon as the Congress government is formed, it would enforce robust and fair laws for farmers across the nation, delivering on the promise of Kisan NYAY," Mr. Ramesh said.

Congress president Mallikarjun Kharge was scheduled to address the public in Purnea but could not reach the venue due to bad weather and his flight failed to land. He addressed the meeting virtually and took a dig at Mr. Kumar's sudden political U-turns.

"Bihar, which showed the light to the world, is known today as political lab of aaya-rams and gayarams", Mr. Kharge said. "Bihar was the birthplace of democracy", he said speaking of saints and eminent politicians "but sadly the politics of greed and opportunism dominate this land today".

"The Congress party has not ditched anyone and been respectful to our allies. The mahagathbandhan government tried to intensify development works in Bihar which have been halted for years but that hurt Modi and Shah and they made a mockery of Bihar's prestige and selfrespect," added Mr. Kharge in his virtual speech.

Former Chhattisgarh Chief Minister Bhupesh Baghel and Communist Party of India (Marxist-Leninist) general secretary Dipankar Bhattacharya too addressed the meeting.

### BJP hits out at Kharge over his remark on 'dictatorship'

The Bharatiya Janata Party (BJP) on Tuesday criticised Congress president Mallikariun Kharge for his remark that the 2024 Lok Sabha election will be the "last" in India if Prime Minister Narendra Modi is reelected, stating that it was in fact "dynastic politics in the name of democracy" that was at an end and that "true democracy" was in the offing.

Mr. Kharge had, while addressing a rally in Bhubhaneswar on Monday, expressed apprehensions that the 2024 Lok Sabha election would be the last opportunity for the people to save democracy, and that "if Narendra Modi wins another election", there will be dictatorship in the country. "The BJP will rule India like Putin in Russia," he had said.

Responding to Mr. Kharge's remarks, BJP Rajya Sabha MP Sudhanshu Trivedi said, "Dynastic politics under the garb of democracy is coming to an end, and they are wondering what will be their future." "Whether it is Abdullah and Mufti families in Jammu and Kashmir, or the Badals in Punjab, the Hooda family in Haryana, all of them lost elections," Mr. Trivedi said. He asserted that "only two Prime Ministers were elected democratically in India, Atal Bihari Vajpayee and Narendra Modi".

### 2 pilots de-rostered for taking off without ATC clearance

The Directorate General of Civil Aviation (DGCA) de-rostered two IndiGo pilots after the airline's Delhi to Baku flight allegedly took off on Monday night without clearance from the air traffic controller. Sources at the Indira Gandhi International Airport said IndiGo's 6E 1803 from Delhi to Azerbaijan's Baku at 7:38 p.m. on Monday took off without a departure clearance from the air traffic controller. "The matter is under investigation. The two pilots have been de-rostered from duties pending investigation," said a DGCA official. The airline said in a separate statement, "The incident is currently under investigation and, appropriate action will be taken as necessary."

### ED questions Tejashwi Yadav in land-for-jobs case in Patna

Rashtriya Janata Dal leader and former Deputy Chief Minister Tejashwi Yadav was questioned by the ED at its Patna office for several hours in a land-for-jobs case on Tuesday. This comes a day after his father and RJD chief Lalu Prasad was questioned for 10 hours. A crowd of RJD supporters and leaders camped outside the ED's office waiting for Mr. Tejashwi to come out. "This is not the office of the BJP. When elections come, Opposition party leaders get summons from them," said Rajya Sabha member Manoj Jha. The ED has alleged that land was taken in the name of Mr. Prasad's family members in return for railway jobs while he was Railway Minister.

# **Centre starts survey** on participation of women in workforce

Study undertaken to assess the spread of women employee-friendly practices such as running creche and equal pay for equal work

NEW DELHI

he Union Ministries of Labour & Employment and Women & Child Development have started a joint survey on increasing women participation in the workforce. The survey was announced by Union Minister Smriti Irani here on Tuesday at a function, "Women in the workforce for Viksit Bharat".

The survey is being undertaken to assess the spread of women employee-friendly practices in the country. Various international agencies and trade unions, including the International Labour Organization, had expressed concern over the decrease in participation of women workforce in the country.

Latest PLFS data

The latest results of the Periodic Labour Force Survey (PLFS), released by the Labour Bureau last October, showed a considerable increase in women participation. In 2017-18, the participation rate was 23.3% and

in 2022-23, 37%. The survey, conducted by the Un-Ministry ion Labour through the Employees' Provident Fund Organisation and other government agencies, has asked questions to the subscribers of government schemes about policies or initiatives for women by the companies they are employed

The government is seeking details such as formation of the internal complaints committee for prevention of sexual harassment at the workplace, creche for children, equal pay for equal work, flexible or remote working hours for women and transportation facilities during late hours.

A senior officer said the survey is carried out in a confidential manner. "We are not asking the names of [the women] or any other identification detail, except their gender," the officer said. The name of the company, its location and address are also sought in the survey.

### 'Give maternity leave to construction staff'

The Centre on Tuesday asked employers to ensure digital payment of wages and paid maternity leave of 26 weeks to women construction workers. These two were a few measures that were part of advisories issued by the Ministries of Road Transport and Highways, and Housing and Urban Affairs to agencies under them to encourage their participation in the workforce.

For more than two children and for adoption or

commissioning mothers, 12 weeks of paid maternity leave shall be provided by the employer. In addition to childbirth, the advisories addressed miscarriages, stipulating that if a woman in the construction sector experiences a miscarriage, she is entitled to leave with wages equivalent to maternity benefits for six weeks following the day of the miscarriage.

The advisory also emphasised the proactive role of employers in implementing policies and programmes to encourage women to join the workforce.

### 7 additional judges made permanent

Seven additional judges posted in four High Courts were elevated as permanent judges on Tuesday.

of the Kerala High Court and Justice Pradeep Kumar Srivastava of the Jharkhand High Court were also elevated. Justice Subhendu Samanta, an additional judge of the Calcutta High Court, was given a "fresh term" of one year effective from May 18.

Law Minister Arjun Ram Meghwal announced the appointments in a post on X. Additional judges are usually appointed for a period of two years before being made judges.

### Manvendra Singh's wife killed in road accident

Their car hit the sidewall of a flyover on the Delhi-Mumbai Expressway. The accident occurred near Khushpuri village in Alwar district.

The cause of the accident is unclear, but the police said the driver appears to have lost control of the vehicle at a high speed and hit the sidewall. The family was travelling from New Delhi to Jaipur. The injured were rushed to a private hospital in Alwar. Mr. Singh, who was injured in the ribs, was stable.

# After four years of survey, India's snow leopard count put at 718

India has an estimated 718 snow leopards in the wild, according to a first-of-its kind, four-year-long estimation exercise, the results of which were made public on Tuesday.

The snow lead known to be an elusive cat and located in mountainous terrain that is hard to access, and the exercise for the first time marks a base threshold for the animal's numbers in India.

The highest number of cats was estimated to be in Ladakh (477), followed by Uttarakhand (124), Himachal Pradesh (51), Arunachal Pradesh (36), Sikkim (21), and Jammu and Kashmir (nine). The current estimate puts the number of Indian snow leopards between 10% and 15% of the global population.

The exercise involved setting up cameras, or camera traps, in 1,971 locations and surveying 13,450 km of trails which teams surveyed for recording signs of snow leopards such as scat, hair and other body markers. Much like the approach used in surveys to estimate tiger numbers, the States conducted the surveys and the Dehradun-based Wildlife Institute of India, an autonomous body of the Union Environment Ministry, used software and statistical methods to estimate the number of individual cats that are present but not caught on camera and combined them with those caught on camera.

"Essentially we use a similar statistical approach to that being used in the tiger surveys for the past 20 years. It's a rigorously tested equation and not dependent on guesswork," V.B. Mathur, former head of the WII, involved in the study, told The Hindu.

"Over the years, technology and statistics has improved leading to better estimates. What we now have is a good, scientifically established baseline that will be a reference for future surveys," he added.

The Snow Leopard Population Assessment in India (SPAI) began in 2019 and involves the World Wide Fund for Nature-India and the Nature Conservation Foundation, Mysuru, along with the WII.

The snow leopard is classified as 'vulnerable' by the International Union for the Conservation of Nature and faces threats from freeranging dogs, human-wildlife conflicts, and poach-

## India nominates 12 forts of Marathas for UNESCO World Heritage List

India has nominated the "Maratha Military Landscapes", a network of forts that showcase the strategic military powers of Maratha rule, for inclusion on the UNESCO World Heritage List for 2024-25.

The 12 forts included in this nomination are the forts of Salher, Shivneri, Lohagad, Khanderi, Raigad, Rajgad, Pratapgad, Suvarnadurg, Panhala, Vijaydurg and Sindhudurg in Maharashtra and Gingee in Tamil Nadu.

# Astronomers spot unusual object that falls within the black hole 'mass gap'

The mass of a 'dark' companion in the NGC 1851E system is between the heaviest possible neutron stars and the possible lightest black holes. The nature and formation of objects in this gap is an outstanding question in astrophysics; the heaviest neutron stars, are thought to be around 2.2 solar masses, and the lightest black holes around 5

ometimes astronomers come across objects in the sky that we can't easily explain. In our new research, published in *Science*, we report such a discovery, which is likely to spark discussion and speculation.

Neutron stars are some of the densest objects in the universe. As compact as an atomic nucleus, yet as large as a city, they push the limits of our understanding of extreme matter. The heavier a neutron star is, the more likely it is to eventually collapse to become something even denser: a black hole.

These astrophysical objects are so dense, and their gravitational pulls so strong, that their cores - whatever they may be – are permanently shrouded from the universe by event horizons: surfaces of perfect darkness from which light cannot escape.

If we are to ever understand the physics at the tipping point between neutron stars and black holes, we must find objects at this boundary. In particular, we must find objects for which we can make precise measurements over long periods of time. And that's precisely what we've found – an object that is neither obviously a neutron star nor a black hole.


It was when looking deep in the star cluster NGC 1851 that we spotted what appears to be a pair of stars offering a new view into the extremes of matter in the universe. The system is composed of a millisecond pulsar, a type of rapidly spinning neutron star that sweeps beams of radio light across the cosmos as it spins, and a massive, hidden object of unknown nature.

The massive object is dark, meaning it is invisible at all frequencies of light from the radio to the optical, X-ray and gamma-ray bands. In other circumstances this would make it impossible to study, but it is here that the millisecond pulsar comes to our aid.

Millisecond pulsars are akin to cosmic atomic clocks. Their spins are incredibly stable and can be precisely measured by detecting the regular radio pulse they create Although intrinsically stable the observed spin changes when the pulsar is in motion or when its signal is affected by a strong gravitational field. By observing these changes we can measure the properties of bodies in orbits with pulsars.

Our international team of astronomers has been using the MeerKAT radio

telescope in South Africa to conduct such observations of the system, referred to as

These allowed us to precisely detail the orbits of the two objects, showing that their point of closest approach changes with time. Such changes are described by Einstein's theory of relativity and the speed of a change tells us about the combined mass of the bodies in the

Our observations revealed that the NGC 1851E system weighs almost four times as much as our Sun, and that the dark companion was, like the pulsar, a compact object – much denser than a normal star. The most massive neutron stars weigh in at around two solar masses. so if this were a double neutron star system (systems that are well known and studied) then it would have to contain two of the heaviest neutron stars ever found.

To uncover the nature of the companion, we would need to understand how the mass in the system was distributed between the stars. Again using Einstein's general relativity, we could model the system in detail, finding the mass of the companion to lie between 2.09 and 2.71 times the mass of the Sun.

The companion's mass falls within the "black hole mass gap" that lies between heaviest possible neutron stars, thought to be around 2.2 solar masses,

and the lightest black holes that can be formed from stellar collapse, around 5 solar masses. The nature and formation of objects in this gap is an outstanding question in astrophysics.

### **Possible candidates**

So what exactly have we found then? An enticing possibility is that we have uncovered a pulsar in orbit around the remains of a merger (collision) of two neutron stars. Such an unusual configuration is made possible by the dense packing of stars in NGC 1851.

In this crowded stellar dance floor stars will twirl around one another, swapping partners in an endless waltz. If two neutron stars happen to be thrown too close together, their dance will come to a cataclysmic end.

The black hole created by their collision, which can be much lighter than those created from collapsing stars, is

then free to wander the cluster until it finds another pair of dancers in the waltz and, rather rudely, insert itself – kicking out the lighter partner in the process. It is this mechanism of collisions and exchanges that could give rise to the system we observe today.

We are not done with this system yet. Work is already ongoing to conclusively identify the true nature of the companion and reveal whether we have discovered the lightest black hole or the most massive neutron star – or perhaps neither. At the boundary between neutron stars and black holes there is always the possibility that some new, as yet unknown, astrophysical object might

Much speculation will be sure to follow this discovery, but what is already clear is that this system holds immense promise when it comes to understanding what really happens to matter in the most extreme environments in the universe.

### Rain: how vapour becomes water



Q: Why does rain fall as drops and sheets? A: Many windblown drops can be forced together to form what weather reporters call 'sheeting rain', but

rain is always born as minuscule drops of condensed water vapour, according to the book Clouds and Weather by John A. Day and Vincent J. Schaefer.

The formation of these droplets depends on the right amount of water vapour at the right pressure and temperature, but it also requires the presence of tiny solid particles of matter in the air on which the water vapour can gather and condense. These bits of dust and salt are called cloud condensation nuclei. Salt starts collecting vapour at about 80% relative humidity, while bits of clay begin to take on water molecules at 100% relative humidity.

As the water molecules slowly collect and condense on the particles, cloud droplets form. They are a million times the volume of the original particle but are still very tiny. It takes perhaps 3,000 droplets to form a small raindrop. The drops in a heavy shower are the size of around 6,000 droplets, according to *The New* York Times.

The droplets can grow into drops by several processes. First, they can slowly continue to attract vapour. Second, larger droplets fall faster than small ones and collide with

them, sometimes joining into larger drops.

Finally, evaporating droplets may collect on ice crystals in clouds. The crystals may warm and melt into rain drops or they may grow 'branches' and fall as snowflakes.





### **Economic encomium**

A glowing 10-year report card must not stoke complacency

head of the Interim Budget for 2024-25 on Thursday, the Finance Ministry's 10-year review of the economy with some forward outlook, serves as a proxy to the annual Economic Survey. The review signals GDP will grow close to 7% in 2024-25, with scope to go 'well above' 7% by 2030. From about \$3.7 trillion this year, India's economy will expand to \$5 trillion in three years, making it the world's third largest, and could hit the \$7 trillion dollar mark by 2030, it reckons. Splicing India's growth story into two phases - 1950-2014, and a 'decade of transformative growth' since 2014 – the review stresses that the state of the economy was 'far from encouraging' when Prime Minister Narendra Modi 'assumed power'. Growth was hobbled by structural constraints such as tardy decisionmaking, ill-targeted subsidies and a large informal sector, while inflation was unpalatably high. Post-2014 reforms have restored the economy's ability to grow healthily with "longer and stronger" economic and financial cycles, and made India the fastest growing G-20 nation, it argues. The review asserts that India's 7% growth when the world is growing 2%, is 'qualitatively superior' to 8%-9% achieved when the global economy grows 4%, perhaps, hinting at a few years of the UPA era. This is debatable as India's economy is generally delinked from the world with domestic activity driving growth more than exports.

Now that the twin-balance sheet problem inherited from the UPA days has turned into an 'advantage', as the review stresses, it must translate into a wider private investment revival. That would hinge on a broad-based consumption rebound rather than the K-shaped recovery the government vehemently dismisses. Four years of 7%-plus growth, post-pandemic, would be commendable indeed. However, India needs to grow faster to create jobs at the scale its youth need and ensure that a rising growth tide lifts most boats, if not all. The review expects an 'all-inclusive welfare approach' to help enlarge the consumption base by expanding the middle class. But those dependent on handouts, such as the 800 million that need free food by the Centre's reckoning, must progressively shrink for growth to be meaningful and equitable. The report rightly mentions reforms in learning outcomes, health, easier compliances for smaller firms, as priorities, with some critical changes at the 'subnational government' level to accelerate growth. It is also essential that flaws in reforms such as GST are fixed and some of the blunt policy tools deployed, for instance, import licences and price controls on deregulated products, that send convoluted signals about India's 'open market with predictable policies' pitch, are reconsidered.

### **Vetting for vendetta**

Mechanism to scan cases for political motive cannot address issue of cover-up

he Supreme Court's suggestion for a mechanism to eliminate the perception of vendetta behind the use of investigative agencies against political opponents is sound in principle, but may not address all aspects of the problem. A case under formal investigation may be scrutinised for its legal tenability or political motive, but such a mechanism can do nothing about offences and allegations that are covered up for political reasons. During a recent hearing on a bribery case against an Enforcement Directorate (ED) officer in Tamil Nadu, the ED sought the transfer of the probe to the CBI. It also charged that the State police was not sharing details of FIRs it had registered on complaints against Ministers, officials and others in instances of corruption and illegal mining. The ED, presumably, wants to probe the money-laundering aspects of these offences, whereas the State government believes these details will be used to target its ministers and officials as the State is run by a party opposed to the ruling BJP at the Centre. The Bench's idea that an independent, pan-India mechanism to vet such cases appears reasonable. However, much of the criticism of the use of central agencies against political adversaries of the BJP stems from the view that similar allegations against its party members and allies across the country are seldom investigated.

Corruption allegations abound in several States against key political figures seen as friendly to the Centre, but the Opposition parties believe the CBI, ED and Income-Tax Department are hardly active there. The Bench is right in observing that offenders should not be spared only because they claimed to be victims of vendetta. Its remarks disapproving of retaliatory arrests are also salutary. However, despite the Solicitor-General's argument that the courts could intervene in the case of vindictive action, it has to be noted that the ED's power to summon and arrest anyone, and the difficulty in obtaining bail in money-laundering cases, renders the Union government quite invincible if it chose persecution in the name of prosecution. An unsavoury instance of how far politics over the use of central agencies can sully institutions is the recent episode of a Calcutta High Court judge ordering a CBI probe into charges against the ruling party in West Bengal, and a Division Bench staying the order. The single judge chose to ignore the Bench's order, accusing its presiding judge of political motive. In a welcome move, the Supreme Court formed a Bench of its senior-most judges and transferred the whole case file to itself for disposal. The perception of vendetta can only be removed if all agencies chose independence over subservience.

## A dark message to Delhi from Kangla Fort

n what could have been an anti-climax to a melodramatic Shumang Leela act (a traditional form of theatre in Manipur), 38 Meitei legislators took a six-point public oath-taking at the Kangla Fort, Imphal, on January 24. Unlike the four-generic resolutions passed by the State Assembly, and reportedly endorsed by 34-odd State legislators (this included a Meitei Pangal and five Nagas) three days earlier, the six-points oath (later endorsed by the Chief Minister of Manipur, N. Biren Singh) made explicit its communal overtones by castigating the 'Kuki' for unilaterally fomenting violence since May 3.

#### **Everything other than disarmament**

The six-points oath called upon the Centre to do the following: abrogate the tripartite Suspension of Agreement (SoO) that it signed with the State and Kuki-Zomi-Hmar militants since 2008; implement the National Register of Citizens but using 1951 as the base year; construct a border-fence across the India-Myanmar border; replace the Assam Rifles with other central paramilitary forces; delete 'Kuki' from the Scheduled Tribe list, and relocate 'Kuki refugees' in Manipur to Mizoram.

If these were implemented, they would not only further expose the vulnerability of the Kuki-Zomi-Hmar groups but would also effectively erase their long-standing protective discrimination benefits.

In hindsight, had the above points been played as themes of a Shumang Leela act to showcase what could have transpired in the real world, patrons of Shumang Leela would have been sorely disappointed by the inversion of its conventional themes, wherein brotherhood, tolerance and justice, among others, are sacrificed at the altar of collective self-love and perceived sense of insecurity.

Clearly, the legislators lost Tagore's dream of 'clear stream of reason' and a fearless mind which should have animated their public action even as they allowed themselves to be consumed by the burning passion to protect the interests of the 'Sanamahi' and Meitei 'community'. That this reflection and reasoned public action were missing from the legislators' public action became apparent as the six-points oath failed to mention 'disarmament', which was one of the four resolutions passed earlier by the Assembly. This is glaring given that almost half of the 6,000 automatic rifles and over five lakh rounds of live ammunitions from various police armouries that were handed over to ragtag mobs are reportedly still with the Arambai Tenggol, the armed militia under whose diktat and supervision this oath-taking event was held.

This, and the fact that much of the arms and ammunition continue to be in the hands of armed

militants across the divide, continue to be a key structural cause of this violence.

### An abandonment of constitutional duty

Given the extensive reports of Arambais being involved in violent attacks against several Kuki-Zomi-Hmar villages, the legislators' decision to publicly partake in the Arambais agenda only reinforces the partisan image and the role of the Meitei legislators in Manipur's violence. There may have been applause following the Arambai Tenggol's triumphant shout of 'Manipur na yai phare (Manipur has done well') in Kangla as they retreated to their camps in motor cavalcades after this event, but far from securing the interests of the Meiteis and protecting Manipur's territorial integrity, there are signs of a sense of insecurity. If one is to go by the hostile responses on social media, this event has also sharpened the emotional, demographic and territorial divide between the Kuki-Zomi-Hmar and Meitei.

The immediate fallout of this was evident during the event as three legislators, who included Meghachandra, the President of Congress Pradesh Committee, were physically assaulted by the Arambais for attributing the violence to misrule by the Bharatiya Janata Party in the State. The muzzling of dissent and violent intolerance stems from this. That the Arambai Tenggol brooks no dissent and might unleash terror was also evident when its cadres vandalised the residences of human rights activist Babloo Loitangbam and a retired police official, Thounaojam Brinda, when they implicated the Arambai Tenggol for its role in this cycle of

By giving in to the diktat of the Arambai Tenggol and Korounganba Khuman, its commander-in-chief (out of fear of being labelled 'enemy' and 'traitor' of the Meitei 'community'), the Meitei legislators have abandoned their primary constitutional duty and oath to protect India's Constitution.

This dramatic event is also remarkable for its symbolic and iterative significance. That an armed militia chose Kangla Fort as the site for public oath-taking demonstrates its determination to not only revive the glorious past of Kangleipak (the local name for Meitei Kingdom) from its symbolic and traditional seat of power, but also project this as a fulcrum to revive Meitei indigenous tradition, culture, and religion (Sanamahi). The event is also significant for another reason - that elected representatives of a democratic state, whose primary oath of allegiance is to the Indian Constitution, are very pliable and can be blackmailed under duress to capitulate to the partisan communal agenda of an unelected, and armed militant group. That elected legislators could be overshadowed in a democratic and constitutional state is disturbing

as it strikes at the very root of the legitimacy of the Indian state.

#### Dangers of a radical agenda

The fact that this event was organised to convey a strong political message to New Delhi is clear as it happened within days of backroom attempts by a three-member team of the Union Ministry of Home Affairs (headed by A.K. Mishra, a retired police officer and an interlocutor with Kuki-Zomi-Hmar SoO groups in Manipur), to persuade the Arambai Tenggol to either cancel or postpone the event. In its ambition to upstage the 38-odd Meitei legislators (plus the Chief Minister who later signed the pledge) as the bearers of democratic legitimacy, the Arambai Tenggol and this oath reinforced the communal and partisan agenda/interest of large segments of Meitei non-state actors and their legislators in targeting the 'Kuki' as the problematic 'other'.

Although the Arambai Tenggol is largely seen as a private militia (started and sustained under the patronage of Leisemba Sanajaoba, the titular king of Manipur, and the powers-that-be), it also represents a calibrated organisational attempt to revive Meitei indigenous culture, tradition and religion (Sanamahi). Much like the radicalisation of youths in Punjab in the 1980s under Bhindranwale's Damdami Taksal, the Arambai Tenggol has succeeded in reorienting many unemployed Meitei youth to the cause of a sovereign Kangleipak under the veneer of reviving Meitei's fast-vanishing indigenous religion, traditions and cultures such as traditional martial arts that focus on the use of sword, and a horse-mount dart as a weapon. In doing so, the Arambai Tenggol has galvanised popular interest and support in quick time. However, given that it operates in an insurgent space where the 'radical' agenda and interest of a motley of non-state actors including armed groups which espouse a sovereign Kangleipak intersect and often either coalesce or reinforce one another, the Arambai Tenggol is susceptible to manipulation and control by powerful social forces and political actors.

It is precisely here that one should be wary of the Janus-faced Arambai Tenggol. Allowing the mighty Indian state to capitulate to this armed militia, or other powerful social forces, just because it is amenable to cultural and nationalist appropriation by some vested parties in their electoral pursuit cannot be used as a ruse to denude what the eminent sociologist Michael Mann in a different context calls the 'infrastructural power' of the state – that is, the autonomous power to regulate state-society relations. Otherwise, this public event could turn out to be India's Bhindranwale moment again.

# A blurred mapping of internal female migration

nternal migration is a crucial form of physical and social transaction in India. The Periodic data on employment and unemployment indicators in the country, has estimated it to be 27% from June 2020 to 2021. Normative literature (Rajan et al., 2020; Jesline et al., 2021) usually documents it as a male-dominated narrative. However, women, especially of working age, comprise a greater share of the migrant pool but there is little dialogue surrounding them. This is a concern given India's falling Female Labour Force Participation Rate (FLFPR). It also raises the question of whether women face employment barriers due to post-migration conditions.

National surveys, inaccurate picture

National surveys such as the PLFS capture information about female migrants but often convey an inaccurate picture. For instance, surveys only ask the respondents regarding their primary reason for migration. PLFS data suggest that the leading reason for migration among women is marriage (81%), followed by migration of family members (10%), employment (2.42%), and migration for education opportunities (0.48%). There is no provision to know the secondary reasons/motivations such as climate shocks and food insecurity, which can be a crucial driver of migration for women.

In the same vein, data from these surveys regarding migrant women's labour force participation can be misinforming. According to the PLFS, approximately three quarters of migrant women are unemployed, approximately 14% of migrant women are in self and wage-employed jobs and approximately 12% are in casual labour. This round of data collection was during the COVID-19 pandemic, which might explain the low numbers, but does not adequately underscore the problem of underreporting of their employment status. Anecdotal evidence and findings from the respective works of researchers Sonalde Desai and Ashwini Deshpande suggest that it is not uncommon for migrant women to engage in

casual employment, indicating the underestimation of the number of migrant omen involved in the various sectors that might be categorised as causal (or even informal) such as agriculture, construction, and domestic help.

Second, definitional issues and women's own beliefs also lead to an underreporting of employment of migrant women. According to the definition of employment used by national surveys, only those with some form of verbal or written contract with their employer are considered part of the labour force. Consequently, women are largely classified as

However, what is often overlooked is that women choose forms of employment that allow them to handle their domestic duties while contributing to the household's production or finances. Thus, working as unpaid family workers, in household enterprises, or being self-employed is common amongst them (S. Rukmini, 2023). But they may view that as an extension of their domestic commitment instead of a form of employment which leads to them misreporting their employment status.

### **Human and social capital**

Notwithstanding these arguments, if indeed entry to the formal labour force is challenging, one important factor restricting their entry into the labour force could be the need for more human and social capital. In the PLFS data, 85% of the women have less than 10 years of education, which can create problems. While there is no significant difference in the educational levels of migrant and non-migrant women, migrant women are proportionally less employed than the non-migrant women. Coupled with the lack of social networks, especially after they migrate, these factors can significantly hinder their employment chances.

Such barriers might also explain the dismal recovery of women's labour activity after the pandemic. A study by Yale University on this issue observed that after the COVID-19-induced lockdown, 55% of women never returned to their places of employment, and those who did so. earned only 56% of their pre-pandemic income

Regardless of the sparse number of migrant women formally counted in the labour force, female migration for labour/employment increased by 101% between 2001 and 2011. However, they remain largely invisible, facing significant hurdles and marginalisation. Consequently, this results in unaddressed struggles and a lack of targeted policies. From a political standpoint, women migrants are not a considerable vote bank, and, therefore, their needs are not addressed. Although recent polls would disagree, political parties do not campaign to gain migrant women's votes. This has several detrimental outcomes, such as a lack of good data on female migrants and treating migrant men and women as the same. This engenders policy-making, which is poorly informed about the needs, motivations, and conditions of female migrants. Policies such as One Nation One ration card, e-Shram, and affordable rental housing complexes are examples of this as they are mainly targeted towards the male migrant population.

### Steps to take

To remedy this, several steps should be taken. National surveys should compile more information regarding their socio-economic conditions post-migration as very little is known about it. For instance, the PLFS indicates that a minute percentage (approximately 7%) have access to social security benefits; there is no data for the rest of the populace. There is also a lack of time-use data (Nadal et al., 2020; Charmes, 2019) for migrants, as India has not made that the norm yet. Time-use data would significantly help advance existing knowledge regarding unemployed female migrants. On a broader scale, a change in narrative is required, starting with an increased collection of female-specific data. It will illustrate the largely anecdotal problem and bring awareness about the plight of these women to encourage progressive policymaking.

# Pulling Sri Lanka out of the abyss

n January 9, 2024, the United National Party (UNP) proposed incumbent Ranil Wickremesinghe as the national presidential candidate for the elections. This move may garner support from some political parties. In July 2022, six-time Prime Minister Wickremasinghe was chosen for his economic credentials by a parliamentary majority to replace Gotabaya Rajapaksa who resigned following mass protests over economic mismanagement and rent-seeking.

In April 2022, Sri Lanka became the first Asian country in the 21st century to pre-emptively default on debt, which amounted to over \$50 billion. A devastating economic crisis followed. The GDP contracted by 7.8%, year on year inflation escalated to 69.8% in September 2022, the Sri Lankan rupee depreciated by 44.8% against the U.S. dollar, and usable foreign reserves fell to two weeks of imports creating shortages of medicine, food, and fuel.

#### **Stabilisation policies**

Mr. Wickremesinghe's government, with members of the Sri Lanka Podujana Peramuna (SLPP) led by Mahinda Rajapaksa, implemented an orthodox set of stabilisation policies. These included raising interest rates to control inflation, removing fuel subsidies, increasing taxes, passing a law to improve the independence of the Central Bank of Sri Lanka and initiating privatisation of state-owned enterprises. The government also sought Indian aid, intensified negotiations with the International Monetary Fund (IMF) on an Extended Fund Facility (EFF) and also foreign debt restructuring talks with private bondholders and bilateral creditors.

In March 2023, the IMF Board approved a EFF worth \$2.9 billion over 48 months, emphasising fiscal and governance reforms. The first review by the IMF Board in December 2023 rated Sri Lanka's performance as

"satisfactory" meaning total IMF disbursement will be \$670 million. The EFF unlocked additional funding from the World Bank and Asian Development Bank for budget support, social protection, financial sector development, and infrastructure development.

Progress is visible after 18 months of stabilisation policies. Inflation fell to 4% in December 2023 but could rise with the increase in Value Added Tax from 15% to 18% in January 2024. The Sri Lankan rupee appreciated by 12.1% against the U.S. dollar in 2023. Foreign exchange liquidity pressures eased. More import capacity means shortages of essentials and waiting lines have disappeared. The IMF projects a return to growth of 1.8% in 2024 compared with -3.6% in 2023.

Furthermore, foreign direct investment in infrastructure, due to Sri Lanka's strategic location in the Indian Ocean, may also be picking up. A joint venture project between India's Adani Group and Sri Lanka's John Keells Holdings seeks to develop the \$700 million West Container Terminal at Colombo Port. The U.S. **Development Finance Corporation** has committed \$553 million. This will expand the capacity of the port and improve transhipment trade with a growing Indian

In a geopolitical twist, China's Sinopec Group, which will also manage 200 fuel filling stations in Sri Lanka, has committed \$4.5 billion to an oil refinery in the controversial, low-profit Hambantota Port. Foreign exchange constraints and an inefficient state-owned Ceylon Petroleum Corporation led to fuel shortages and hardships for the Sri Lankans during the crisis. FDI by China's Sinopec in petroleum refining and distribution may help improve Sri Lanka's energy security provided the energy market is open to all investors and a strong competition policy is adopted. If not, Sri Lanka could be vulnerable to problems of a private monopoly under Sinopec

with higher fuel prices and variable fuel supply.

Risks to Sri Lanka's outlook Sri Lanka needs sustained economic growth of 5-6% in the medium term to escape from indebtedness. But its outlook is vulnerable to external and internal risks. The first is geopolitical competition between the U.S. and China. For instance, an intensified U.S.-China trade war following the possible victory of Donald Trump in the U.S. presidential elections could be devastating for inward FDI and trade in Sri Lanka.

The second is debt restructuring. In November 2023, Sri Lanka concluded an initial agreement with key bilateral creditors, including India and the Paris Club, to restructure \$5.9 billion in external debt. This was important for reducing interest payments and unlocking IMF financing in 2024. This deal followed China's separate debt restructuring agreement with Sri Lanka. These agreements are on similar terms, extending deadlines and lowering interest rates. But ominously, private bondholders, who held about 40% of external debt (end 2022), are concerned about the extent of the 'haircut' on debt they could face. They say there has been little engagement with them due to the focus on talks with official creditors.

Third, political risks could derail the EFF and growth beyond 2024 – presidential elections are due in September and general elections in 2025. A doubling of poverty to 25% of the population since the default, and growing dissatisfaction with the UNP and SLPP, appears to be leading to support for the left-wing populist National People's Power. And Sajith Premadasa, the leader of the opposition, who is the head of the centre-right Samaji Jana Balwegaya, says he wants to renegotiate the IMF agreement.

Mr. Wickremasinghe deserves credit for pulling Sri Lanka back from the abyss. Only time will tell whether he can win the election.

### Gruha Lakshmi is not a freebie

It signifies a redistribution of resources by the government to a marginalised section

he introduction of the Gruha Lakshmi scheme by the Karnataka government has reignited the policy debate about welfare programmes for the economically disadvantaged and fiscal prudence. The scheme guarantees a direct monthly cash transfer of ₹2,000 to women who are the heads of below poverty line households in Karnataka. About 1.36 crore beneficiaries are registered. This means that the annual outlay of the scheme is more than ₹32,000 crore.

economics Mainstream does not recognise activities primarily carried out by women at home as economic activities. Unpaid work encompasses domestic chores such as cooking and washing, while care work involves caring for the elderly and children. The participation of women in remunerative economic activity is abysmally low, while their burden of unpaid work is substantially higher than men. According to the Time Use survey conducted by the National Statistical Office, 57.3% of male respondents were involved in employment and related activities compared to 18.4% of women. In contrast, 81.2% of women bore the burden of unpaid domestic services for household members compared to 26.1% of men.

Further, the burden of unpaid and care work is disproportionately higher for economically poor women who are also engaged in wage work, as they lack the resources to outsource care activities. Thus, they are trapped in a cycle of poverty. The Gruha Lakshmi scheme represents a



crucial step in recognising the value of unpaid work. As urbanisation grows and the population ages, the burden of elderly care is expected to increase, especially for impoverished families. Income support from the state can alleviate the strain on such families. In this context, monetary support to women cannot be seen as a 'freebie'; it is an entitlement for the care work that women do, especially women who face multidimensional and time poverty.

In a patriarchal economic system, women are often paid low wages, which they reluctantly accept due to their limited bargaining power. Unconditional cash support not only helps women decontrol their labour power from the system to an extent, but possibly provides some cushion to resist accepting reservation wages by enhancing their bargaining power.

Empirical evidence supports cash transfers to households in stimulating aggregate demand and putting the economy back on a growth trajectory rather than providing sops and bailout packages to the corporate sector to revive it. For instance, according to a study by IFPRI-Indian Council for Agricultural Research, PM-KISAN, a direct benefit transfer scheme of the Union government, enabled farmers to meet expenses other than agriculture and had a multiplier effect. Direct support measures, including cash transfers to households by the Union government during the COVID-19 pandemic, led to a swift V-shaped recovery of the economy. The Gruha Lakshmi scheme is also poised to bolster aggregate demand given its target group's relatively high marginal propensity to consume. Consumption improves quality of life and also boosts economic activities.

The scheme signifies a redistribution of resources by the government to a marginalised section of society, recognising unpaid work. Nonetheless, ensuring that resources to finance the scheme are augmented from direct taxes. such as levies on high-value property and capital transactions and excise taxes on premium liquor, is crucial. Prudent administrative measures to trim unnecessary expenditures can provide additional resources to ensure timely and uninterrupted transfers. Therefore, a transparent and well-thought-out road map for resource augmentation is indispensable. While fiscal prudence is necessary, it must not come at the expense of the welfare of the marginalised.

It is naïve to consider Gruha Lakshmi as a panacea for gender inequality. There is a need to universalise such support to women in recognition of their unpaid and care work. A comprehensive institutional framework at the national and sub-national levels and cooperative federalism are indispensable to address gender inequality in the economy and ensure redistribution.

## Most teens use social media, but lack skills to protect themselves

While more than 90% use social media, only about 50% know how to block their profile or make their account private

mong Indian teenagers in rural areas who can't even read a paragraph of text, over 30% can still browse the Internet and close to 50% can find a video on YouTube, says the latest **Annual Status of Education Report** (ASER) Rural. The report provides several such insights into the digital prowess of high school and college students in India.

In the ASER survey, students in the 14-18 age group were asked to read a paragraph. Those who could read the words but not the sentences were said to belong to the 'word level'. Those who could read the paragraph but not a bunch of paragraphs were categorised as belonging to 'Grade 1 level'. Those who could read many paragraphs were said to belong to 'Grade 2 level'. The survey was conducted in 28 districts from September to November, 2023.

Chart 1 shows the share of students aged 14-18 with different leading levels who could do digital tasks on a smartphone. Among those at the 'word level', more than 30% managed to find a You-Tube video, browse information on the web, and set an alarm on their smartphone. Among those belonging to 'Grade 1 level', more than 55% could do all these tasks. Interestingly, most students, across reading levels, found it challenging to find travel time on Google Maps.

These conclusions were made for all the 28 districts put together. If the data are analysed at the district level, there are wide variations. For instance, more than 95% of teenagers in the rural parts of Ernakulam in Kerala were able to set an alarm on their smartphone, while less than 50% in Cooch Behar in West Bengal and Gariaband in Chhattisgarh knew how to do this. The India average was 66.4% (Chart 2A).

There were wide variations among those who could browse information too: while 93% in Jammu and Kashmir's Anantnag could do this, less than 50% could do so in Odisha's Sambalpur and Meghalaya's East Khasi Hills (Chart 2B).

In Nagaland's Kohima district, only 12.5% teenagers knew how to use Google Maps while more than 55% in Punjab's S.A.S. Nagar could do this (Chart 2C).

Notably, variations among districts were the narrowest when it came to accessing YouTube: with close to 70% or more teenagers in every district managing to do this (Chart 2D).

The data show that digital literacy has penetrated deep into many rural areas but a few areas are still catching up. However, worryingly, many teenagers have still not learned to protect themselves from the dangers of the online world. While more than 90% of them from across districts used social media during the survey week, only 52.3% knew how to block a profile and only 47.8% knew how to make their account private.

There were wide variations in these skills too. Just 33% in Tripura knew how to block a profile (Chart 2E) and less than 30% in Jharkhand's East Singhbhum knew how to make their profile private (Chart 2F). A bigger concern is that the share of girls who knew these skills was much lower compared to the share of boys in many districts despite the fact that girls form a majority of the victims of online abuse.

**Table 3** shows the share of teenagers who could block/report a profile and make their profile private, across genders, in select districts where the variation was noticeable. Only 46% girls in the 17-18 age group in Bihar's Muzaffarpur knew how to block a profile, whereas over 73% boys knew how to do this. Only 57% girls in Rajasthan's Bhilwara knew how to make their profile private compared to 80% of the boys.

### Online and unprotected

The charts are based on data collated from the Annual Status of Education Report (ASER) Rural 2023. The survey was conducted in 28 districts last September-November



Chart 1: The chart shows the share of students aged 14-18 who could do digital tasks on a smartphone, across reading levels (in %)










### Rupee Accord: Moynihan sure of U.S. Congress approval

Washington, Jan 30: The U.S. Ambassador to India, Dr. D.P. Moynihan, is confident that the Indo-U.S. rupee agreement initialled in Delhi last December, would win the approval of the Congressional Committees now considering it, even though two Congressmen, who are traditional foes of all forms of aid, told the House Sub Committee on South Asia before which the U.S. envoy testified yesterday that they would oppose the "give away" programme, which would in effect write off the bulk of the U.S. rupee balances in India.

One of the critics of the Indo-U.S. deal asked, "What has India ever done for us, except show enmity? Didn't Mrs. Gandhi tell us to get the hell out of there?" Another gave notice of a "sense of Congress" resolution which would voice disapproval of the rupee accord.

Congressional sources, however, doubted whether such a resolution would gain the approval of the House even though only last week the lower House had killed a Bill which would have allocated \$1.5 billions to the International Developmental Association. These sources also said that if such a resolution is adopted, it would have no binding effect on the agreement already entered into by the Governments of the two countries, though the ensuing confrontation between Congress and the Executive could create an embarrassing situation.

A HUNDRED YEARS AGO JANUARY 31, 1924

### France and Rumania

Paris, Jan. 30: A long and authoritative statement issued here now makes it clear that Rumania has finally renounced her intention of asking the French Government for a loan of hundred million francs. It is explained that inevitable delay in the French Parliament's voting loans compels Rumania to seek other means of tiding over her difficulties and most of her orders for war material have been given to Rumanian industries. This will be advantageous to both Rumania and France, to the former on account of her depreciated exchange and to the latter because it gives her an opportunity to practice another economy at the moment she is endeavouring to find means of balancing her budget. It is emphasised that France-Rumanian elections are in no way affected.

# Pakistan and Iran: calm after the storm

What prompted Iran to target Balochistan, and how did Pakistan respond to the missile strikes? What key factors contributed to the decision for both nations to de-escalate tensions? How did the arrival of Iran's Foreign Minister in Islamabad impact economic and security discussions between the two countries?

#### The story so far:

n a series of events, Iran launched missile strikes in Pakistan's Balochistan province, targeting alleged strongholds of the Jaish al-Adl. In response, Pakistan condemned the attacks, recalling its Ambassador and expelling the Iranian Ambassador, while also suspending high profile bilateral visits. A day later, Pakistan retaliated by targeting individuals and terrorist groups in Iran's Sistan-Baluchestan province. However, with a diplomatic approach, Pakistan emphasised its respect for Iran, preventing further escalation. On January 19, at a National Security Council meeting aimed at addressing security concerns for regional peace, both nations decided to de-escalate, reinstating ambassadors, and by January 28, Iran's Foreign Minister arrived in Islamabad to discuss economic and security matters, signaling a shift towards dialogue and cooperation.

#### What is special about the two Baloch provinces in Iran and Pakistan?

First, the demography and geography of the provinces. The Sistan-Baluchestan province, one of the largest provinces in Iran, shares the border with Pakistan's Balochistan and Afghanistan's southern provinces. The Baloch are the majority in the Sistan-Baluchestan province, with Sistanis as a minority. The former is Sunni, while the latter is Shia.

Geographically, Balochistan is the largest of four provinces in Pakistan, with a Baloch majority (which is now being threatened by the Pashtun ingress from Afghanistan and Pakistan's Khyber Pakhtunkhwa). However, Baloch are a minority within Pakistan.

Second, the borders. Pakistan's Balochistan province shares a long border with Iran, around 900 km. Unlike the Pakistan-Afghanistan border, which is disputed by Kabul, the Pakistan-Iran border is settled. Both countries have been building a concrete wall along the border to prevent illegal crossings between Balochistan (in Pakistan) and Sistan-Baluchestan (in Iran) provinces. However, the border remains ineffective in preventing the illicit movement of people and goods, especially along the land and maritime borders. Smuggling is common, especially in the south, closer to the Pakistan-Iran maritime border.

Third, two ports of strategic importance - Gwadar in Pakistan and Chabahar in Iran, are situated on the mouths of the Arabian Sea less than 200 km apart. China and India have invested in these two ports and see them as exit and entry points from/into maritime/mainland Asia. Baloch provinces are strategically important for Iran and Pakistan; however, they remain in the political periphery and are alienated from the national capitals. For the national capitals, the control of the provinces and the two ports is paramount.

#### Who are the militants that Iran and Pakistan targeted in each other's territory?

In Pakistan, Iran targeted a relatively little-known Sunni militant group – "Jaish al-Adl," based in Balochistan. According to Iran's Foreign Minister, "none of the nationals of the friendly and brotherly country of Pakistan were targeted by Iranian missiles and drones." Considered as a remnant of Jundullah, Iran has been fighting it since the late 2000s. The Jundullah, believed to be founded

by Abdolmalek Rigi, was present then in the Sistan-Baluchestan province and has repeatedly been targeting Iran's security forces and civilian targets through terrorist activities, including suicide bombings. Iran has been targeting the Jundullah leader; Rigi, a Baloch, was captured and executed in 2010.

Jundullah was a Sunni group with links to al Qaeda and fighting for "Sunni" rights, rather than an ethnic Baloch militant group. However, Tehran considers that the Jundullah had the support of the Baloch people across the Sistan-Baluchestan and Balochistan provinces in Iran and Pakistan, respectively. After Rigi's death, a few Jundullah members formed the Jaish al-Adl and continued attacking Iran during the 2010s.

Between 2013-2023, the Jaish al-Adl is accused of having carried out numerous attacks, mainly targeting Iran's security officials; the latest one was in December 2023, where they targeted a police station in Rask in Sistan-Baluchestan, killing 11 security personnel.

In Iran, Pakistan targeted the hideouts belonging to the "Balochistan Liberation Army" and "Balochistan Liberation Front." Pakistan has been fighting multiple waves of Baloch insurgency since 1947. The latest wave of insurgency intensified after the killing of Akbar Bugti, one of the tallest Baloch leaders. Unlike the Jundullah, the Baloch militant

organisations do not have a sectarian agenda or have links with international organisations such as al Qaeda. They have an ethnic agenda and fight for greater rights for the Baloch; some of them have a separatist agenda and want to establish an independent Balochistan.

#### Why did Pakistan and Iran de-escalate immediately after the missile attacks?

If the escalation was fast, de-escalation was faster. Immediately after Iran's initial attack, Pakistan recalled its Ambassador and asked the Iranian Ambassador to leave. Two days later, Pakistan targeted a few militant targets in the Sistan-Baluchestan province in Iran. After the swift diplomatic and military escalation, there was a de-escalation. China is believed to have pressured Islamabad and Tehran. But more than any external pressure, the bilateral dynamics might have led to the de-escalation.

Given the regional security situation and the immediate neighbourhood, both countries cannot afford an escalation now, which was reflected in their statements. Pakistan's official statement talked about "dialogue and cooperation as key tools for addressing common challenges, including terrorism," while Iran's underlined adhering to "the policy of good neighbourliness and brotherhood between the two nations" and not allowing "enemies to strain the amicable

Islamabad." It appears that Iran's missile strikes in

and brotherly relations of Tehran and

Pakistan had a limited objective as a part of its targets in Syria and Iraq in response to an earlier attack in January 2024 in Kerman. Similarly, Pakistan's response seems limited in making a domestic and a bilateral statement. Both have been careful with their statements to ensure it does not escalate. Besides there have been efforts in recent years aimed at a rapprochement, which they did not want to jeopardise.

#### What challenges lie ahead for Pakistan and Iran?

Though Tehran was one of the first to recognise Pakistan, since the 1979 Iranian revolution, the two countries had a troubled relationship. Iran's revolution in 1979 and Muhammad Zia-ul-Haq's regime in Pakistan during the 1980s brought the Sunni-Shia sectarian divide to the fore between the two. Though both refer to the "brotherly Muslim countries' rhetoric, the sectarian factor was too strong to patch the divide.

Globally, Iran saw Pakistan under the American sphere of influence during the Cold War and post 9/11, especially in Afghanistan. Pakistan and Iran remained in opposite groups; only in recent years has China tried to bring Islamabad and Tehran together.

And regionally, the struggle for supremacy, within the West Asia, pitches Iran and Saudi Arabia on opposite camps, with Pakistan aligned with the latter. On Afghanistan and the Taliban, both countries have differed on objectives and strategies. Until recently, Pakistan viewed Tehran as closer to New Delhi than Islamabad. Pakistan's nuclear bomb is seen as a Sunni one, pushing Tehran to have its own for the Shia world.

Finally, economically, the bilateral relationship is not strong enough to create a political stake; the fact that Iran is planning to approach international arbitration for Pakistan's reluctance to move ahead with the Iran-Pakistan pipeline should underline the harsh realities for Islamabad and Tehran.

On 22 January, a joint statement issued by the two Foreign Ministries agreed on the return of ambassadors. Subsequently, on 26 January, the Ambassadors returned to their offices in Tehran and Islamabad.

On 28 January, Iran's Foreign Minister arrived in Islamabad to discuss economic and security issues between the two countries.

# A betrayal of the very idea of Mahatma

The principles Mahatma Gandhi stood for represent an ideal that is being weakened every day by those in power who are pushing their agenda of bigotry; he viewed Hinduism as a faith that respected and embraced all other faiths, challenging the exclusivity promoted by Hindutva ideologues

This article dated January 27, 2023, explores the challenges to Mahatma Gandhi's legacy in contemporary India. The article contrasts Gandhi's inclusive vision rooted in Advaita Vedanta with the majoritarian creed of Hindutva ideologies, emphasising the ongoing clash between idealism and exclusionary practices within India's ideological landscape.

The Mahatma was killed, with the name of Rama on his lips, for being too pro-Muslim; indeed, he had just come out of a fast he had conducted to coerce his own followers, the Ministers of the new

Indian government, to transfer a larger share than they had intended of the assets of undivided India to the new state of Pakistan. Gandhiji had also announced his intention to spurn the country he had failed to keep united and to spend the rest of his years in Pakistan, a prospect that had made the government of Pakistan collectively choke.

But that was the enigma of Gandhiji in a nutshell: idealistic, quirky, quixotic, and determined, a man who answered to the beat of no other drummer, but got everyone else to march to his tune. Someone once called him a cross between a saint and a Tammany Hall politician; like the best crossbreeds, he managed to distil all the qualities of both and yet transcend their contradictions.

Explaining a contradiction nowThe contradiction is mirrored in the attitude of the Hindutva-inspired Bharatiya Janata Party (BJP) government of Prime Minister Narendra Modi.

Mr. Modi was schooled, like other Rashtriya Swayamsevak Sangh (RSS) pracharaks in an intense dislike of Mahatma Gandhi, whose message of tolerance and pluralism was emphatically rejected as minority appeasement by the Sangh Parivar, and whose credo of non-violence, or ahimsa, was seen as an admission of weakness unworthy of manly Hindus. Hindutva ideologue V.D. Savarkar, whom Mr. Modi has described as one of his heroes, had expressed contempt for Gandhiji's 'perverse doctrine of non-violence and truth' and claimed it 'was bound to destroy the power of the country'.

But Prime Minister Modi, for all his Hindutva mindset, his admiration of Savarkar and his lifetime affiliation to the Sangh Parivar, has embraced Gandhiji, hailing the Mahatma and even using his glasses as a symbol of the Swachh Bharat campaign, linking it to a call to revive Gandhiji's idea of seva through the recent 'Swachhata Hi Seva' campaign.

This may, or may not, represent a sincere conversion to Gandhism. The Prime Minister is hardly unaware of the tremendous worldwide reputation that Mahatma Gandhi enjoys, and is too savvy a marketing genius not to recognise the soft-power opportunity evoking Gandhiji provides, not to mention the global public relations disaster that would ensue if he were to denounce an Indian so universally admired. There may, therefore, be an element of insincerity to his newfound love for the Mahatma, as well as a shrewd domestic political calculation.

But the ambivalence speaks volumes: when many members of Mr. Modi's BJP call for replacing Gandhiji's statues across the country with those of his assassin, Nathuram Godse, the Prime Minister seeks to lay claim to the mantle of his fellow Gujarati for his own political benefit. At the same time, there is also a tangible dissonance between the official governmental embrace of Gandhiji and the unofficial ideological distaste for this icon, that is privately promoted by members and supporters of the present ruling dispensation, some of whose members have not hidden their view that his assassination was, in their eyes, a patriotic act.

The vision of the MahatmaIt is a well understood reality that the vision of Gandhiji, an openly practising Hindu, differed greatly from that of Veer Savarkar and M.S. Golwalkar, the principal ideologues of the Hindu Mahasabha and its more militarised alter ego in the post-Independence era, the RSS and eventually, the BJP (formerly the Jana Sangh).

Gandhiji embodied the central approach of Advaita Vedanta, which preached an inclusive universal religion.

Gandhiji saw Hinduism as a faith that respected and embraced all other faiths. He was profoundly influenced by the principles of ahimsa and satya and gave both a profound meaning when he applied them to the nationalist cause.

He was a synthesiser of cultural belief systems: his signature bhajan of

'Raghupati Raghava Raja Ram' had another line, 'Ishwara Allah Tero naam'. This practice emerged from his Vedantic belief in the oneness of all human beings, who share the same atman and, therefore, should be treated equally.

Such behaviour did not endear him to every Hindu. In his treatise on 'Gandhi's Hinduism and Savarkar's Hindutva', the social scientist Rudolf C. Heredia places his two protagonists within an ongoing debate between heterogeneity versus homogeneity in the Hindu faith, pointing out that while Gandhi's response is inclusive and ethical, Savarkar politicises Hinduism as a majoritarian creed.

But Gandhiji's own understanding of religion, in Heredia's words, "transcended religiosity, Hindu as well as that of any other tradition.

It is essentially a spiritual quest for moksha but one rooted in the reality of service to the last and least in the world". Unlike Savarkar, who believed in conformity, Gandhiji was a synthesiser like no other who took care to include Indians of other faiths in his canacious and agglomerative understanding of

He took inspiration from not just Advaita Vedanta but also the Jain concept of 'Anekantavada' - the notion that truth and reality are perceived differently by different people from their own different points of view, and that, therefore, no single perception can constitute the complete truth. This led him to once declare that 'I am a Hindu, a Muslim, a Christian, a Parsi, a Iew'.

Hinduism and Hindutva, as I have argued in my book Why I Am a Hindu, represent two very distinct and contrasting ideas, with vitally different implications for nationalism and the role of the Hindu faith. The principles Gandhiji stood for and the way in which he asserted them are easier to admire than to follow. But they represented an ideal that is betrayed every day by those who distort Hinduism to promote a narrow, exclusionary bigotry.

# Khan's conviction a week before election is a mirror image of the past: diplomats

While diplomats point to similar cases against other leaders before previous Pakistani elections, control by the Generals appears tighter than in the past; they indicate that this year's election winners will also be 'selected, rather than elected' by the military establishment which pulls the strings

Pakistan ormer Prime Minister Imran Khan's latest conviction in the 'Cipher Case' on Tuesday, which comes just 10 days before the general elections, is a dramatic development, but one in step with past elections that have been "managed", said diplomats who have served there. They indicated that this year's election winners would also be "selected, rather than elected" by the military establishment.

While Pakistan Tehreeke-Insaaf (PTI) leaders called the 10-year prison sentence against Mr. Khan and former Foreign Minister Shah Mehmood Qureshi a "sham" and vowed to appeal to higher courts, it seems clear that the verdict is a blow for the party that won elections in 2018 and still claims to be the most popular party in the

"Imran Khan wasn't gi-

ven a fair trial, not given access to his counsel or media and public despite the higher courts orders, and the decision was reached in haste with no right given to defence counsel to cross-question the witnesses," Syed Zulfigar Bukhari, PTI's Adviser on International Affairs and Media, said in comments to The Hindu. "These cases are politically motivated and stand no chance in higher courts so we are hopeful decision will be overturned."

### **Role reversal**

Former Indian diplomats to Pakistan pointed out that Mr. Khan is undoubtedly a victim, but of a system that he was the beneficiary of in previous elections, when roles were reversed with PML-N chief

and three-time Prime Minister Nawaz Sharif. In July 2018, with about two weeks to go to the elections, Mr. Sharif was convicted and handed a 10year sentence on charges of corruption, after being disqualified from public office in the 'Panama Papers' corruption cases, involving his property in London.

"What Imran Khan and the PTI face today is almost identical to what Nawaz Sharif and the PML-N faced then. So India should see this as one more Pakistani election and not very different from others," said former High Commissioner to Pakistan T.C.A. Raghavan, who was posted in Islamabad during 2013-15. "We should wait for the dust to settle and see what comes up."

Another former diplomat also said the conviction of Mr. Khan was not "surprising", and as in the past, all strings were being pulled by the Pakistani military. "This election is fast

turning into the mirror image of the 'managed' 2018 election, with Imran Khan at the receiving end of the wrath of the Army this time. The process of his conviction is as questionable as Nawaz Sharif's conviction in 2017-18," said Sharat Sabharwal, who served as High Commissioner to Pakistan during 2009-2013. "A managed election will neither solve the ongoing political crisis, nor result in a government capable of dealing effectively with Pakistan's intractable problems."

### Ties with India

Asked about the impact of the expected results of the elections next week on ties with India, Mr. Sabharwal said there could be a "degree of thaw", including some movement on trade. "But the government's ability to deliver on the bilateral relationship will remain contingent upon the will of the Army," referring to Pakistan Army chief Gen. Asim Munir.

While many of the characteristics of previous Pakistani elections are being repeated in 2024, some developments suggest the control exercised by the establishment over elections is more extreme than in the past. In the 2008 elections, held after former PM Benazir Bhutto was assassinated, Mr. Khan's and his party boycotted elections, claiming they would be "manipulated" by the U.S. and then-President Gen. Musharraf to favour Bhutto's Pakistan People's Party (PPP), but his party was allowed to contest. In 2013 and 2018, all three major national parties, PML-N, the PPP and the PTI were in contest, but this time, the PTI has had its election symbol of the "cricket bat" blocked or delisted by the courts, and as a result, PTI candidates at a further disadvantage.

### Israel-Hamas conflict rages as mediators push for new truce

Deadly fighting and bombardment rocked Gaza on Tuesday as international mediators pushed for a new ceasefire and hostage release deal in the Israel-Hamas war.

Heavy Israeli strikes and urban combat across the besieged Gaza Strip killed 128 more people overnight, the Health Ministry in the Hamas-run Palestinian territory said.

The epicentre of fighting has been the southern city of Khan Yunis – the hometown of Hamas's Gaza leader Yahya Sinwar, the alleged architect of the October 7 attack – where vast areas have been reduced to a muddy wasteland of bombed-out build-Troops fighting in city

blocks and tunnels have raided several military sites, Sinwar's office and "a significant rocket manufacturing facility", the Israeli military said.

Army spokesperson Daniel Hagari claimed troops

in the city had "eliminated over 2,000 terrorists above and below ground".

The Gaza war, now in its fourth month, has left much of besieged Gaza in ruins and sparked a spiralling humanitarian crisis for its 2.4 million people, many of whom face the threats of hunger and disease.

UN Secretary-General Antonio Guterres, who has pleaded for continued support to meet the "dire needs", will have talks with donors in New York on Tuesday, his office said, as investigations into Israel's claims continue.

### Doesn't want wider war in West Asia: U.S.

U.S. President Joe Biden said on Tuesday he had decided on a response to a drone strike that killed three American troops in Jordan but said he did not want a wider war in the West Asia.

Facing growing pressure in an election year, Mr. Biden said he held Iran responsible for supplying the weapons to the people who carried out the deadly attack on a military base. The White House warned that "multiple actions" were likely in retaliation for the fatal attack.

### Trump stays on Illinois ballot as board declines to ban him

Illinois' election board on Tuesday kept former U.S. President Donald Trump on the state's primary ballot, a week before the U.S. Supreme Court hears arguments on whether the Republican's role in the January 6, 2021, attack on the U.S. Capitol disqualifies him from the presidency.

The board's unanimous ruling comes after its hearing officer, a retired judge and Republican, found that a "preponderance of the evidence" shows Mr. Trump is ineligible to run for President because he

violated a constitutional ban on those who "engaged in insurrection" from holding office. But the hearing officer recommended the board let the courts make the ultimate decision.

eight-member

board, composed of four Democrats and four Republicans, agreed with a recommendation from its lawyer to let Mr. Trump remain on the ballot by determining it didn't have the authority to determine whether he violated the U.S. Constitution.

An attorney for the voters who objected to Trump's presence on the ballot said they'd appeal to Cook County circuit court.

The issue will likely be decided at a higher court, with the U.S. Supreme Court scheduled next week to hear arguments in Mr. Trump's appeal of a Colorado ruling.

### Philippines, Vietnam sign agreement on cooperation in South China Sea

The Philippines and Vietnam signed agreements on Tuesday to prevent incidents in the South China Sea and broaden cooperation between their coast guards in a growing alliance that will likely be frowned upon by China, which claims virtually the entire waters.

The agreements, along with discussions on enhancing information-sharing and training exchanges between the Vietnamese

and Philippine militaries, were forged during a visit to Hanoi by Philippine President Ferdinand Marcos Jr. Both sides agreed to boost trade and investment and signed a key deal

on rice. The Philippines and Vietnam have had especially tense confrontations with China in the strategic waterway and key route for global trade in recent years. Territorial face-offs in the high seas between Chinese and Philippine ships intensified last year, fuelling fears of a wider conflict that could involve Washington, Manila's longtime treaty ally.

Although Chinese and Philippine officials agreed earlier this month at a meeting in Shanghai to take steps to de-escalate tensions, Mr. Marcos while in Hanoi raised his concerns over the long-seething disputes and cited increasingly aggressive actions by the Chinese coast guard.

"We are firm in defending our sovereignty, sovereign rights and jurisdicagainst provocations," Mr. Marcos said. "But at the same time, we are also seeking to address these issues with Chithrough peaceful dialogue."

Vietnamese and Philippine officials did not release specific details of their agreements on managing incidents.

# amnesty Bill for Catalan separatists

Spain's Lower House on Tuesday rejected an amnesty Bill due to differences on its scope between the ruling Socialists and a Catalan separatist party, in a blow for Prime Minister Pedro Sanchez that illustrates his parliamentary fragility.

The Bill, rejected by 179 votes to 171, will now return for debate in a parliamentary committee and could eventually be sent back for another vote in the Lower House. The am-

nesty Bill is set to define Mr. Sanchez's second term and has prompted large protests against it.

In blow to Sanchez, Parliament rejects

Catalan separatists Junts voted against the law after they failed to reach a lastminute deal with Mr. Sanchez's Spanish Socialist Workers' Party.

Junts wanted all exceptions related to terrorism to be removed from the Bill since some of its politicians are currently under investigation by courts over alleged terrorism-related crimes.

### **Protesting French** farmers turn up the pressure on govt.

French farmers were on Tuesday maintaining roadblocks on key highways into Paris for a second day, increasing pressure on the government for more concessions in an intensifying standoff.

Prime Minister Gabriel Attal is expected to address Parliament and announce new measures aimed at assuaging the anger of farmers, as he faces his biggest crisis since being named Prime Minister by President Emmanuel Macron this month. There were also expectations that Mr. Macron himself would address the issue at a news conference during a state visit to Sweden on

The farmers have now staged over a week of protests, which have spread to the capital where tractors, hay bales and other objects have since Monday prevented motorists from entering Paris along several key routes. The government has so far promoted a soft approach with the protesters, while making clear that any attempts to block Paris's main airports or the vast Rungis wholesale food market would be a red line. A police source said that around 1,000 farmers and 500 vehicles had been involved in Monday's actions and they appeared intent on keeping up the protest until Friday. A convoy of producers who left on Tuesday morning from the southwestern town of Limoges heading for Rungis briefly changed route after being blocked by gendarmes, organisers said. Arnaud Rousseau, the leader of the biggest farmers' union FNSEA, said he was against any disruption of food distribution. "Our objective is not to starve French people, but to feed them," he told the Europe 1 broadcaster.

# Ukraine's air strikes inside Russia hurt Putin's efforts for normalcy at home

Increasing long-range attacks from Ukraine in spite of a frozen front line, including the deadly missile strike on border region of Belgorod, are dealing a heavy blow to President Vladimir Putin's attempts to reassure Russians that life in the country is largely untouched by the nearly two-year-old war

he wail of air raid sirens is commonplace in Belgorod, a Russian border city whose residents are on edge following a Ukrainian missile attack on a New Year's holiday weekend that left dozens of people dead and injured.

A spectacular explosion rocked a huge fuel export terminal on the Baltic Sea southwest of St. Petersburg this month from a Ukrainian drone, forcing the energy company Novatek to suspend operations for several days.

Last week, an apparent drone attack in the Black Sea port of Tuapse in the southern Krasnodar region hit one of Russia's largest refineries and ignited a fire, while another big refinery in the Volga River city of Yaroslavl, north of Moscow came under attack early Monday, but officials said there was no damage.

There also have been strikes on a gunpowder factory in the Tambov region and arms producers and military facilities in the Bryansk, Smolensk and Tula regions.

Attacks like these are dealing a heavy blow to President Vladimir Putin's attempts to reassure Russians that life in the country is largely untouched by the nearly 2-year-old war.

"Ukraine has increased

its capacity to strike back against Russia," Michael Kofman, a military expert with the Carnegie Endowment think tank, said in a recent podcast.

"You see increased Ukrainian attacks against Russian critical infrastructure, retaliatory attacks against cities like Belgorod and greater strikes against Russian military base in Crimea," he said.

#### **Challenging Kremlin**

As Mr. Putin ramps up his campaign ahead of the presidential election in March, he wants to maintain an air of normalcy. But the increasingly frequent Ukrainian attacks have raised the visibility of the war on Russian soil, and there are other signs the conflict is increasingly challenging the Kremlin's tight control of the political scene.

Thousands across Russia have signed petitions supporting the longshot presidential bid of liberal politician Boris Nadezhdin, who has made ending the war his main campaign issue. Wives of some soldiers rounded up in a partial mobilisation in 2022 have pushed for their discharge. And despite a tight ban on protests, hundreds rallied in Bashkortostan province, clashing with police to

Certainly the December 30 strike on Belgorod marked a bloody escalation in the minds of many Russians. A barrage of missiles struck the city of 3,40,000, which is about 40 kilometre east of the Ukrainian border, on a holiday weekend when people were out shopping, ice skating and watching New

Year's festivities. Officials said 25 people were killed, including five children,

and over 100 were injured. It's not the first time Belgorod has been touched by the war, with drone strikes and other attacks early in the conflict. In April 2023, a bomb accidentally released by a Russian warplane exploded in a street, gouging a huge crater and injuring two people.

On January 24, the Defence Ministry said a military transport plane was shot down in the Belgorod region while carrying Ukrainian prisoners of war, killing all 74 people aboard. Although Russia has released what it called evidence that it said proved Ukrainian POWs were aboard, officials in Kyiv disputed it and instead blamed Moscow for trying to use the incident to hurt Ukrainian morale.

Mr. Putin said the December 30 shelling of Belgorod left him "boiling with anger", describing it as an act of desperation by Kyiv following the failure of Ukraine's

counteroffensive.

"They want to show their people and their sponsors who give them money, weapons and ammunition that they can retaliate against Russia's action," he said. "They want to show that they can also do something, but instead of fulfilling military tasks, they use barbaric methods and strike peaceful settlements with indiscriminate weapons." Throughout the war, the Kremlin claims Russia has hit only military targets in Ukraine - despite widespread evidence to the contrary and heavy civilian casualties in places like Kyiv, Mariupol and

Kharkiv. Ukrainian officials rarely comment on strikes inside Russia but they emphasise their right to use all means to counter Moscow's aggression. At a news conference in August, Ukrainian President Volodymyr Zelenskyy said Russia had launched over 6,500 missiles and 3,500 drones since the war began, most of them at civilian targets. In a New Year's address to the nation, he vowed: "The one who brings hell to our land will one day see it from their own window." Russian hawks have pointed to Belgorod as a turning point for the Kremlin to raise the stakes in the war.

'Take the gloves off'

Alexander Dugin, a nationalist ideologue whose daughter was killed in a car bombing blamed on Ukraine in August 2022, argues that Russia should respond by escalating the fighting and declaring a broad mobilisation. "I would like to believe that Russia now will take off the white gloves and start fighting for real," he wrote. "Should we abide by the rules at a time when a gateway to hell opens?"

With fighting largely frozen along the 1,500-kilometere front line during winter, the missile and drone attacks inside Russia have demonstrated Ukraine's long-range strike capability that is stretching Moscow's

security assets. "Continued Ukrainian strikes in deep rear areas in Russia may thus increase pressure on Russia's air defenses overall," the Washington-based Institute for the Study of War said in a recent analysis.

If this is Kyiv's plan, it's similar to what Russia did a year ago by targeting Ukraine's power grid in the hope that repairs would take time. In the end, Ukraine managed to get enough spare parts and make quick fixes so that Moscow's campaign failed. Now, it's Russia that needs to find a coping strategy.

### Taiwan People's Party loses out in Presidential polls but emerges as viable third force

Taiwan's freshly elected lawmakers will meet from Thursday, with a new party enjoying an outsized influence over legislation after breaking through the self-ruled island's long-entrenched two-party sys-

Taiwan's political landscape has been dominated for decades by two parties, the ruling Democratic Progressive Party (DPP) and the opposition Kuomintang (KMT), both defined by how they would approach the democratic island's relationship with China – which claims Taiwan as its territory.

The DPP's Lai Ching-te won this month's election to be president, but neither of the major parties won enough seats to secure a majority in the 113-seat le-

gislature. Taiwan People's Party's (TPP) Ko Wen-je came last in the race to be President, but his party secured eight seats and a quarter of the votes to emerge as kingmaker in the new legislature.

When newly elected legislators take their seats on February 1, the first order of business will be to elect the speaker – an important role that will define Taiwan's legislative agenda.

After that, whichever

party has the TPP's support will have enough votes to pass legislation.

"For the first time ever, you have a viable third party option that... gets to play that decisive kingmaking minority party status in the parliament," said political analyst Wen-ti Sung.

TPP's arrival could mean a more diverse and vibrant democratic scene for Taiwan's future – or it could also translate to a

logjam in Parliament. But "a greater share of voters who previously felt underrepresented by existing political parties may now feel... a greater sense of empowerment", Mr. Sung said.

Mr. Ko has differentiated himself by saying it is pointless to argue over the two scenarios of "unification" or "independence", when there are "real problems" in Taiwan.

# IMF says global 'soft landing' in sight, lifts 2024 growth outlook

Lender upgrades outlook for U.S., China, the two largest economies; cites quicker-than-expected easing of inflation; raises India's growth forecast

WASHINGTON

he International Monetary Fund on Tuesday lifted its forecast for global economic growth, upgrading the outlook for both the United States and China - the two largest economies - and citing faster-than-expected easing of inflation.

The IMF's chief economist, Pierre-Olivier Gourinchas, said the updated World Economic Outlook showed that a "soft landing" was in sight, but overall growth and global trade still remained lower than the historical average.

### 'Remarkable resilience'

"The global economy continues to display remarkable resilience, with inflation declining steadily and growth holding up. The chance of a 'soft landing' has increased," Mr. Gourinchas told reporters in Johannesburg, adding, "We are very far from a global recession scenario."

But he cautioned that the base of expansion was slow and risks remained, including geopolitical tensions in West Asia and attacks in the Red Sea that could disrupt commodity prices and supply chains.

Delays in announced fiscal consolidation in what Mr. Gourinchas called "the biggest global election year



in history" could boost economic activity but might also spur inflation, he added.

The IMF said the improved outlook was supported by stronger private and public spending despite tight monetary conditions, as well as increased labour force participation, mended supply chains and cheaper energy and commodity prices.

The IMF forecast global growth of 3.1% in 2024, 0.2 percentage point higher than its October projection. The historical average for the 2000-2019 period was 3.8%. Global trade was expected to expand by 3.3% in 2024 and 3.6% in 2025, well below the historical average of 4.9%.

The IMF stuck with its October forecast for headline inflation of 5.8% for 2024, but lowered the 2025 forecast to 4.4%. from 4.6% in October.

The IMF said average oil

prices would drop 2.3% in 2024, versus the 0.7% decline it had predicted in October, and said prices were expected to drop

#### Raises India outlook

4.8% in 2025.

Growth in India is projected to remain strong at 6.5% in both calendar 2024 and 2025, with an upgrade from October by 0.2 percentage point for both years, on resilient domestic demand, the IMF said.

"Staying on the path to a soft landing will not be easy," Mr. Gourinchas said, noting that new commodity price spikes from geopolitical shocks, including continued attacks on shipping in the Red Sea, could prolong tight monetary conditions.

He added the IMF was watching developments in West Asia closely, but the broader economic impact appeared "relatively limited" as of now.

### NCLT issues notice to Sony and ZEEL on suit seeking merger

Mad Men Film Ventures on Tuesday filed the petition requesting both ZEEL and Sony to implement the merger as it was approved by NCLT in August 2023.

NCLT has set March 12 for the next hearing. Last week, Sony called

off the merger with ZEEL following a stalemate over who will lead the merged entity. This merger could have created a \$10 billion media enterprise in India.

The merger was stipulated to be completed before Dec. 21, 2023.

### Wheels India Q3 net declines 18% on low demand and floods

Wheels India Ltd. standalone net profit for the December quarter contracted by 18% to ₹13 crore from the year-earlier period due to low demand in the tractor and mining wheel segments and floods.

### Adani puts Wilmar stake sale on the backburner

The Adani Group has decided to put its plans to divest stake in Adani Wilmar on the backburner for now as it is not satisfied with the offers so far, sources said.

The Group has been in talks with leading multinational fast moving consumer goods companies to sell its near 44% stake, but negotiations have stalled, chiefly on the valuation. Sources say the promoters are aiming for a transaction value of close to \$4 billion, but the buyers are offering considerably less than this.

The Group is also exploring the option of bringing in a 'friendly' financial investor which can pick up a significant chunk of the promoter's stake in Adani Wilmar. The company did not respond to an e-mail seeking comments.

In early December, Adani Group finance head Jugeshinder Singh had said that a decision on divesting the stake or exiting Adani Wilmar would be taken in three months. He said the Group had to decide to either scale up the company or deploy the capital elsewhere. The Group is focused on the infrastructure sector and is divesting businesses that are not part of that core area. Last year, it sold its non-banking finance company Adani Capital.

At the current market price of about ₹357 a share, Adani Wilmar has a market capitalisation of \$5.6 billion while the equity valuation has been pegged at about \$5 billion, according

to a couple of brokers. Hindu businessline)

### India-U.S. annual trade can more than double to \$500 billion: Eric Garcetti

## 'G-Sec demand may outstrip supply'

Demand for Government Securities (G-Secs) could outstrip supply once these they are included in key global bond indices, leading to a significant thaw in G-Sec yields in FY25, say experts.

Also, what could accentuate demand for G-Secs is that long-term investors - such as pension and provident funds and insurers -are building up substantial corpus due to inflows, which must be invested.

"Yield of the 10-year benchmark paper right now is at 7.16% level. I don't see it moving up to 7.25-7.30% levels in FY24 as there are no headwinds and we are in a rate softening environment," said Ajay Manglunia, MD & Head, Investment Grade Group, JM Financial.

He expects yield of the 10-year paper to trade in the 7.10-7.25% range till March-end 2024.

"If large foreign portfolio investor inflows come [due to inclusion of G-Secs/Gilts in global bond indices], the yields may go down.... I see the 10-year yield stabilising at 6.50-6.75% level in FY25," per Mr. Manglunia's assessment.

Inclusion of Indian gilts in JP Morgan's
Government Bond Index-Emerging Markets
(GBI-EM) could attract investments aggregating
about \$23-25 billion in a phased manner
beginning June 2024. Further, inclusion of Indian
Gilts in Bloomberg's emerging market local
currency index from September 2024, could

# California and Big Oil are parting ways after their century-long affair

State policies favouring clean energy have oil companies fuming; the two largest U.S. oil producers, Exxon Mobil and Chevron, will formally disclose a combined \$5 billion writedown of California assets when they report fourth-quarter results; oil ouptut has been on a steady decline for 4 decades

t is the end of an era for Big Oil in California, as the most populous U.S. state divorces itself from fossil fuels in its fight against climate change.

California's oil output a century ago amounted to it being the fourth-largest crude producer in the U.S., and spawned hundreds of oil drillers, including some of the largest still in existence. Oil led to its car culture of iconic highways, drive-in theatres, banks and restaurants that endures today.

On Friday, however, the marriage will officially end. The two largest U.S. oil producers, Exxon Mobil and Chevron, will formally disclose a combined \$5 billion writedown of California assets when they report fourth-quarter results.

"They are definitely getting a divorce," said Jamie Court, president of advocacy group Consumer Watchdog, which said the companies long ago stopped investing in California production, and now want to hive off their old wells there. "They've been separated for more than a decade, now they are just signing the papers."

Exxon Mobil last year exited onshore production in the State, ending a 25-

year-long partnership with Shell PLC , when they sold their joint-venture properties.

The State's regulatory environment has impeded efforts to restart offshore production, Exxon said this month, leading to an exit that includes financing a Texas company's purchase of its offshore properties.

#### **Costly writedown**

The No.1 U.S. oil producer's asset writedown will cost about \$2.5 billion and officially end five decades of oil production off the coast of Southern California.

charges of about \$2.5 billion tied to its California assets. It is staying but bitterly contesting State regulations on its oil producing and refining operations in the State, where it was born 145 years ago as Pacific Coast Oil Co.

California's energy poli-

cies are "making it a difficult place to invest," even for renewable fuels, a Chevron executive said this month. The company pumps oil from fields developed 100 years ago but has cut spending in the state by "hundreds of mil-

lions of dollars since 2022,"

#### Green awareness

the executive said.

If oil companies fed California's car culture, their oil spills spurred the U.S. environmental movement. A devastating oil well blowout in Santa Barbara in 1969 led to the National Environmental Policy Act that for the first time required federal agencies consider

environmental effects of permitting decisions.

In the 70s and 80s, the State set curbs on drilling near homes and businesses and regulations on air pollution - rules that have been copied widely across the U.S. In 1996, California introduced reformulated gasoline to fight smog, developing the country's most stringent and costly environmental standards.

That mixed legacy overshadowed oil's economic contributions. California's high-tech industry long ago replaced oil as a major employer and its Governor, Gavin Newsom, has called for the State to ban sales of new gasoline-powered vehicles by 2035.

His administration last September filed a lawsuit targeting the oil industry for "lying to consumers for more than 50 years" about climate change. He signed into law a bill seeking to hold Chevron and other refiners liable for allegedly price-gouged consumers.

The American Petroleum Institute, the industry's trade association, said climate lawsuits hurt "a foundational American industry and its workers" and represent "an enormous waste of California taxpayers resources."

### Industry in decline

For now, the acrimony makes the story of California and oil sound a lot like a tragedy.

"This is a green transition," said Daniel Kammen, a professor of Energy at the University of California, who argues oil firms need to move to clean energy and away from fossil fuels.

"There is a pathway for these companies. But if they chose otherwise, they are dinosaurs."

Oil production in the State has been on a steady decline for almost four decades. Crude output, including at its historic Kern County fields in southern California, is off by a third since its 1.1 million-barrel-per-day peak in 1985.

The State has lacked new oil development projects and the legacy fields that produce heavy oil have not been suitable for state mandates for high quality gasoline.

As of September, more than 50% of oil drilling permits issued to companies have gone unused, according to the California Department of Conservation. Unemployment in oil producer Kern County is at 7.8%, compared with the overall 4.9% average for the state.

And California today has six times more clean-energy as oil-related jobs.

"California can't have both," said UC Berkeley's Mr. Kammen, who formerly was a Science Envoy in the Obama administration. "That means there is no room for oil and gas after that."

# Toyota plant raided for test cheating; firm says sold 11.2 mn vehicles in '23

Japanese transport officials raided the plant of a Toyota group company on Tuesday to investigate cheating on engine testing, as the company reported it kept its status as the world's top automaker in 2023, selling 11.2 million vehicles.

Hours after the probe began at Toyota Industries Corp.'s plant in Hekinan, Aichi Prefecture, central Japan, Toyota Chairman Akio Toyoda vowed to steer the company out of scandal and ensure the Japanese automaker sticks to "making good cars."

"My job is to steer the way for where the overall

group should go," he said.

He apologised, bowing deeply, and stressed the group vision was rooted in the Toyoda founding family's ideas of empowering the "genba," or the workers on the plant floor, "to

make good cars that lead to people's happiness."

The testing scandal comes at a time of otherwise stellar performance for Toyota, which makes the Camry sedan, Prius hybrid and Lexus luxury mo-

dels. Its group global vehicle sales for 2023 were a record 11.22 million units, up 7% from the previous year, topping Volkswagen AG's global sales of 9.2 million vehicles.

Mr. Toyoda spoke at a

Mr. Toyoda spoke at a news conference that was live streamed from a memorial hall in Nagoya that serves as a museum for the founding family. Sakichi Toyoda invented the automated weaving loom. His son Kiichiro Toyoda, Mr. Akio's grandfather, founded Toyota Motor Corp.

Reporters were called to Toyota's Tokyo office, where its CEO Koji Sato apologised for the latest mess: flawed testing at Toyota Industries Corp., that makes diesel engines.

# German woes darken central Europe's recovery prospects

The sickly state of the German economy is the next big challenge for the export-reliant countries of central Europe, which are still recovering from some of the world's worst inflation spikes in the wake of the COVID-19 pandemic.

Close trade ties with Germany and its oncemighty auto sector were for years a boon for the region since the collapse of communism. But now those ties risk becoming a drag on the economies of Hungary, Czech Republic and Slovakia.

Already, some local companies reliant on ties

with Germany are trying to tap deeper into other overseas markets and branch into industries like defence to mitigate the weakness of their large western neighbour, where another year of near-recession looms.

### Geopolitical issues

However such efforts come at a time of major geopolitical uncertainties, with the Ukraine war, Middle East conflict and rising protectionism. Despite the push into the defence sector, all of these factors could hamper the efforts of the region's companies.

"Economic disruption in the region's most important trade partner, and persistent weakness in the auto sector, pose additional risks of economic setback to the CEE region,"



said Dawn Holland, Director, Economic Research at Moody's Analytics.

Central Europe's inflation surge, led by eye-watering levels at 25% in Hungary last year, has prompted central banks to lift borrowing costs to their highest in two decades, with Czechs enduring the most sustained fall in real wages, now spanning eight successive quarters.

annual turnover of some €250 billion (\$270 billion) in central Europe in 2021, employing about 1 million people directly and many more through suppliers,

German companies had

according to Germany's Bundesbank.

The Czech Republic and Hungary rely on Germany for a third and a quarter of exports respectively, with Slovakia sending a fifth of its exports there based on a tally by S&P Global. Poland is seen less exposed because of the strength of its more diversified local economy, with exports less dependent on car making.

### Stagnation in turnover

The best scenario for most firms interviewed by Reuters would be stagnation in turnover this year, though some did not rule out an outright decline in revenue and possible job cuts.

Building on feedback from clients, Hungary's DGA Gepgyarto es Automatizalasi Kft, which makes steel structures, welded components and custom manufactured machinery, had been planning a 50% capacity expansion to meet the expected growth in demand over three years from 2023 to 2025.

"This (higher) demand had evaporated," Tamas Tornai, Executive Director of the holding company that controls DGA told Reuters. Even so, DGA is going ahead with its 2.5 billion forint (\$6.95 million) expansion to serve the booming defence industry.

### Wiped out

Germany's car sector is not only struggling with weak sales in U.S. and European markets but obstacles from high energy prices to the global shift to e-mobility that is forcing a rethink of the future of internal combustion engines.

Within central Europe, Hungary has led a charge in attracting investments in battery and electric car manufacturing from China, positioning itself as a meeting point for Eastern and Western investors.

"There is a very strong decline in car sector demand, caused by inflation, interest rates and economic uncertainty, which nearly wiped out private buyers from the market," said Tamas Mogyorosi, Business Development Manager at Alap Group. Rating agencies say the weakness could complicate efforts to rein in budget deficits, which S&P Global says will remain 'exceptionally wide' in historical terms for the region this year.

"Sathiyan is recovering from back injury and will be back. As for me, I have been focusing on Worlds for the last six months. We are confident," he said.

Sharath's mind is focused only on the Worlds. "It will be the be-all and end-all as far as I am concerned. India has never qualified for Olympics as a team. If we do it, we will get funding from SAI and other external sources. We are sorted for the next four years," he said. Sharath, however, is not keen on playing singles at Paris. "I might not try as it hasn't given me the motivation. "I might not take part in

the South Asian qualifying tournament as I don't want to compete with the youngsters whom I am mentor-

"If we qualify in men's team, two singles places are guaranteed (TTFI can decide as to who should go). I don't want to go there, too. In doubles, I will contribute," he said.

Sharath is more than eager to give it his all for a final shot at Paris.

'You must have tremendous support from family, especially your spouse, to stay with it for this long duration of time.

"To play at 43 – the tough part is all the work that must be put in before matches. As you get older, you slow down. The shot that was once routine is not routine anymore," Amritraj said.

"The advantage is that Rohan plays doubles. Doubles and singles is like night and day. If you have to run down everything for three hours, as you do in singles, it would have been

a nightmare. The good thing is that he has a good serve, so there will always be free points," he said.

"More than anything else, Rohan is a terrific guy. He's been a great representative for India," Amritraj added.

Later this week, India takes on Pakistan in a Davis Cup 2024 World Group I Play-Offs tie at Islamabad (Pakistan).

India will slip back to Group II if it loses – a scenario that does not sit well with Amritraj.

"I have never known what it is like to be in Group II. I never even knew a Group II existed. That is not where India belongs. It is the players' job to get us out of it," Amritraj

Don't take it lightly Amritraj warned against taking the Pakistan team lightly.

"Firstly, I do not know how good the grass courts are in Pakistan. Their players are generally good on grass," he said.

The last time an Indian Davis Cup team travelled to Pakistan was in 1964. The AITA was not keen on sending its team this year too, but the ITF rejected its appeal and said categorically that there is no reason to believe that Indian players will face any security concerns in Pakistan.

International sporting events in Pakistan came to a halt after the attack on the Sri Lankan cricket team bus in March 2009 in Lahore. Consequently, the country was barred from hosting world-level tournaments across sports.

The Pakistan Tennis Federation (PTF) could not host junior ITF events or senior men's Futures. There were no women's events and no Davis Cup team travelled to Pakistan till 2017.

It badly hit Pakistan tennis, which was nowhere near cricket in terms of popularity in the country as many promising players were forced to quit the game for lack of growth opportunities and exposure.

The ones who were playing at U14 level did not graduate to the men's level and competing abroad for ITF events is not easy either for Pakistani or Indian players considering the huge cost involved.

Things began to change in 2017 when Iran sent its teams to Islamabad. The arrival of Japan in 2021 also had a positive impact.

nothing However, matches the excitement and anticipation when India and Pakistan compete in Pakistan.

The reactions of Pakistan's top players, Aisam-ulhaq Oureshi and Ageel Khan, best summed up the excitement. They are even hoping that this tie could pave the way for the arrival of Indian cricket team to

"We are very, very excited and happy, finally the Indian Davis Cup team is here. I have always believed that we should keep politics, religion, culture away from sports. # Part Shamar, part Bopanna: Gourav finds second wind with Pondicherry

Drawing inspiration from the ageless Indian tennis star, the 32-year-old pacer, whose origin mirrors the Caribbean fast bowler, has started to make an impact in Indian domestic cricket

n a week where Shamar Joseph's youthful exuberance and Rohan Bopanna's age-defying perseverance dominated sporting headlines, Pondicherry fast bowler Gourav Yadav, whose career is a mélange of both storylines, continued his domination in the wickets-takers chart of the ongoing Ranji Trophy.

At the age of 32, with 31 wickets in seven innings, Gourav feels his career is finally peaking and takes inspiration from 43-year-old Bopanna's Australian Open triumph.

"Thirty-two kya hota hai? Aapne Rohan Bopanna ko dekha na. At the age of 43, he is World No. 1. I can still play for another six to seven years with full intensity," he said during Pondicherry's match against Madhya Pradesh, where he added another eight scalps to his tally.

His origins, meanwhile, mirror those of Joseph, who worked as a security guard till the age of about 21 and who, until 12 months ago, would have dismissed his place in cricketing folklore as a pipe-dream.

Gourav, who hails from Bisoni Kilan, a small village of about 1200 to 1500 people in Madhya Pradesh, had never played with a leather ball till he was about 19 or 20.

"I used to play tennis-ball cricket in school and college. One day, the older boys told me that I bowl fast and that I should take a shot at bowling with a leather ball. I got myself admitted into a club in Bhopal and played there for about six to seven months. I was bowling quick with the leather ball too and received a lot of praise," he said.

With Indore being the epicentre of cricketing activity in MP, Gourav soon had to relocate from Bhopal.

"I went to Indore and played club cricket there. My village is in the Hoshangabad division, which is called Narmadapuram now. Someone asked me to play division cricket in Hoshangabad. From there, within two years, I came into the Ranji Trophy team. I was 22 or 23 [21] at the time," he added.

Though Gourav made his First-Class debut in 2012 against Gujarat in Indore, he got limited opportunities in his first four to five years on the domestic circuit, largely due to a slew of injuries that were in many ways the result of a late initiation into the game.

"I had a lot of injury issues initially. I would toil so hard in practice that I had no energy left after it. There was no time for my body to recover fully. Because I started playing so late, I was trying to compensate for it by bowling as much within two years as someone would have bowled in five years. That led to a lot of injuries, which set my career back a little bit," he said.

"MPCA (Madhya Pradesh Cricket Association) rated me so highly that the moment I was fit, they would select me after just a couple of selection matches... I could never play a full season. It's only since the last two seasons that I have been playing regularly," he added.

For Gourav, playing the Ranji Trophy wasn't only about pursuing his passion but also about proving a point and winning over his father, who was sceptical of his son's late entry into a sport that millions in the country aspire to play.

"I asked my father to give me two years to pursue cricket and I promised him that

if I fail, I will never play the sport again. *Main kabhi bat-ball nahi uthaunga*," he reminisces.

When his father would fret over his future in case his plans went awry, Gourav would assure him that he had no qualms about returning to his roots.

"Aap bhi toh kheti karke hummein paal rahe ho. Main bhi kheti kar lunga, usmein kya burai hai. (You have raised us with the income you got from farming. I will do the same. There's no harm in doing that)," he would tell his father.

But once Gourav made his entry into First-Class cricket and his name began appearing in the papers, his father was convinced and never disapproved of his son's choices again.

Gourav made another enterprising decision ahead of the 2023-24 season when he quit MP to play for Pondicherry. Though he was a mainstay in red-ball cricket and an integral part of MP's Ranji Trophy title triumph in 2021-22, Gourav was rueing the lack of opportunities in limited-overs formats.

In more than 10 years with the MP team, he had featured in only 16 List A and nine T20 games despite showing promise in both formats.

"I wanted more opportunities in white-ball cricket. I was playing red-ball cricket consistently but chances in white-ball cricket were few and far between. I was the highest wicket-taker in the Vijay Hazare Trophy [2019-20] for MP, but still, I didn't get too many opportunities in white-ball cricket," he explained.

What also irked Gourav and stalled his progress was MPCA's repeated refusal to allow him to attend trials and net sessions of Indian Premier League franchises.

"I wasn't allowed to attend trials on two or three occasions. CSK (Chennai Super Kings) had called me as a net bowler and they were going to take me to UAE, but they [MPCA] didn't allow me to attend the trials or even go there as a net bowler. And neither were they giving me chances in white-ball cricket, so I had no other option," he told *Sportstar*.

Gourav could finally attend the Royal Challengers Bangalore (RCB) camp last year as a net bowler, where he dismissed Virat Kohli on a couple of occasions on the first day.

"Virat Kohli came up to me and said, 'Where are you from? You are bowling really well," he recounts gleefully.

In his first full white-ball season since 2019-20, Gourav emerged as Pondicherry's leading wicket-taker in the Vijay Hazare Trophy last year, picking 14 scalps in seven games.

In the Ranji Trophy, he inspired Pondicherry's wins against more fancied sides such as Delhi and Uttarakhand before facing defeat against his former side MP on Sunday.

However, Gourav believes the team, which is only five First-Class seasons old, has got what it takes to qualify for the knockouts.

Although minute in the global context, that story would well be in keeping with the pacer's odds-defying journey and the sporting world's giant-killing mood of late.

## Iran 'following dreams' in bid to clinch its first Asian Cup crown since 1976

Iran is "following our dreams" in trying to win the Asian Cup for the first time in 48 years, winger Alireza Jahanbakhsh said ahead of the last-16 clash with Syria.

Three-time champion Iran faces Syria in Qatar with a quarter-final against Bahrain or pre-tournament favourites Japan up for grabs.

Along with holder Qatar, Iran is the only team left in the competition which went through the group stage with a 100 per cent record.

"We know the importance of this tournament for the people of Iran and for ourselves," Feyenoord's Jahanbakhsh said on Tuesday.

"We are doing our best to follow our dreams."

Syria is in the knockout round for the first time and Iran is clear favourites, but Jahanbakhsh warned: "It's going to be very difficult, they are very physical.

"They only conceded one goal in the group phase and are very good defensively.

"It is all about details," the 30-yearold former Brighton player, who captained Iran in its 1-0 group-stage win over Hong Kong, added.

"The biggest difference between the group phase and the knockout is that if you make one mistake, you can easily go out."

Iran's coach Amir Ghalenoei identified his Syrian counterpart, the experienced Argentine Hector Cuper –who guided Egypt to the 2017 Africa Cup of Nations final – as a formidable opponent.

Cuper called Iran one of the strongest teams at the tournament while his men squeezed into the knockout rounds with one win, a 1-0 victory over India in three games

er India, in three games.
It was the only goal Syria has



scored, but it has also only conceded once, in a defeat to Australia.

"We are optimistic and have big ambitions," the 68-year-old Cuper said.

"I want to make the long-suffering Syrian people happy and put a smile on their faces."

Syria, ranked 91 in the world to Iran's 21, will look to soak up pressure and hit its opponents on the break.

"My players have the spirit and talent to change the game at any moment," warned Cuper.
