# ED hot on the heels of Soren and Lalu

In a stark reminder to the then "hiding" accused Coal Minister Shibu Soren in the UPA-I Government, his son, Jharkhand Chief Minister Hemant Soren, was allegedly on the run evading the Enforcement Directorate. The senior Soren was on the run the CBI and surrendered after a fortnight. Now, the ED team reached Hemant's New residence as they searched for the JMM leader in connection with a money laundering case linked to an alleged land

On the other hand, Rashtriya Janata Dal (RJD) chief Lalu Prasad appeared before the ED in Patna for questioning in connection with a probe into a land-for-jobs scam. Supporters of the RID gathered outside the ED office to protest Lalu's questioning. According to ED sources, a the agency, accompanied by Delhi Police personnel, reached the 5/1 Shanti Niketan building in South Delhi around 9 am and staved there until late evening, attempting to locate but he remained untraceable.

The ED maintained that the searches at his Delhi home were conducted based on fresh inputs related to the land scam. As per procedure, a statement is recorded during the searches. Since Soren was not present, the ED

not record his statement.

Later, a team of seven ED officials reached Jharkhand Bhawan to enquire about Soren's whereabouts. When the staff at Jharkhand Bhawan was asked if the Chief Minister stayed there, they replied in the negative. 'We came to the residence of

the Chief Minister to question him, but he is not here. The ED teams also went to Iharkhand Bhawan and a few other locations but could not find the Chief Minister," a source said.

The ED teams will remain at the residence until Soren

also keeping vigilance at the Delhi airport.

Amid reports of going incognito, Soren, who left for Delhi from Ranchi on January 27 night, has sent an email to the ED agreeing to a fresh round of questioning by the agency's investigators on January 31 at his Ranchi residence around 1 pm. The ED had previously

questioned Soren at his official residence in Ranchi on January 20 in the alleged land fraud case and issued a fresh summons, asking him to confirm his availability for questioning on either January 29 or January 31, according to returns, the sources added, the sources. Soren had noting that authorities are communicated with the

Directorate Enforcement (ED) but had not confirmed the date and time for

questioning.

While the Chief Minister's office remained tight-lipped development, the Governor CP Iharkhand Radhakrishnan said that he was keeping a watch on the situation in the State in light of the ED summons to the CM. "I am monitoring the overall situation as the custodian of the Constitution. It is the duty of the Governor, and I am fulfilling it. We will cross the bridge when it comes," he told reporters when asked about the options before the Raj Bhavan in the wake of the political situation

Soren, who has skipped the ED summons nine times, made an impromptu trip to Delhi on Ŝaturday night, cancelling the scheduled government events without any explanation, triggering speculations. This further fueled speculation as he cancelled his scheduled including events, programme in Chaibasa on January 29, in Palamu on January 30, and in Giridih on January 31. His trip to Delhi occurred against the backdrop of the ED asking him whether he would be available for

29 or January 31. A top Jharkhand Government official said, "It is an unprecedented situation here. No one knows the whereabouts of the chief minister."

Giving details here, they said the Indian warship INS Sumitra was missiondeployed along the east coast of Somalia and responded immediately to the distress call after the fishing vessel was boarded by some pirates. "INS Sumitra, on anti-piracy operations along the East Coast of Somalia and the Gulf of Aden, responded to a distress message regarding the hijacking of an Iranian-flagged Fishing Vessel, Iman. The vessel had been boarded by pirates, and the crew was taken as hostages," Navy spokesperson Commander

Vivek Madhwal said. INS Sumitra intercepted the and vessel acted with the Standard accordance established Operating Procedures (SOP) to coerce the pirates for the safe release of the crew along with the boat, he said.

It ensured the successful release of all 17 crew members and the boat, the spokesperson said. The vessel



was subsequently sanitised and released for onward transit.

"Mission-deployed Indian naval ships on anti-piracy and maritime security operations in the Indian Ocean region symbolize the Indian Navy's resolve towards the safety of all vessels and seafarers at sea," Madhwal said.

The Red Sea and parts of the Arabian Sea have, in the past few weeks, witnessed some drone and pirate attacks on merchant vessels. The Indian Navy has stepped up surveillance in the troubled region substantially and deployed task groups consisting of around 10 warships in the face of the recent attacks on India-bound merchant vessels.

Recently, Iran-backed Yemen's Houthi militia has been targeting commercial

shipping in the Red Sea with missiles and drones after the Israel-Hamas conflict began on October 7.

The Houthi rebels declared their support for Hamas. Several shipping companies suspended have their operations in the Red Sea following the attacks, which have forced mariners to change course and take longer routes around the southern tip of Africa.

On Saturday last, India's guided missile destroyer INS Visakhapatnam responded to a distress call made by a merchant vessel that caught fire after a missile attack reportedly by the Houthis in the Gulf of Aden, with the incident putting the spotlight on the worsening security situation in one of the world's busiest shipping routes.

### **Maldives President swims** in deeply troubled waters

The main Opposition MDP, which holds a majority in the Maldivian Parliament, is planning to submit a motion to impeach President Mohamed Muizzu, according to media ports on Mond

Maldivian After the Democratic Party (MDP) and The Democrats parliamentary group decided to withhold parliamentary approval for four members of President Muizzu's Cabinet ahead of the voting, the pro-Government MPs from the ruling party Progressive Party of Maldives and People's National (PPM/PNC) Congress coalition initiated a protest, obstructing

the parliamentary sitting. "The MDP, in partnership with the Democrats, have gathered enough signatures for an impeachment motion. However, they have yet to submit it," sun.com said, quoting a lawmaker from the MDP. The decision to submit an impeachment motion was

# After apple cultivation success in Mizoram, CSIR to harvest new territories

President Droupadi Murmu during the Beating Retreat ceremony, at Vijay Chowk in New Delhi, Monday

**Columbia:** President Joe Biden said on Sunday that the US "shall respond" after ARCHANA JYOTI ■ NEW DELHI Encouraged by the success of its pilot project on apple cultivation in Mizoram, a first

in the Northeastern States, scientists from the country's top research agency, the Council of Scientific and Industrial Research (CSIR), have devised an ambitious plan to expand the cultivation of high-revenue, low-chilling fruit crops in the region, aiming to boost the income of local communities.

This initiative also means that locals won't have to import the fruit from other States, thereby reducing carbon footprints through transportation, as highlighted by Dr Rakesh Kumar, Senior

Principal Scientist CSIR's Institute of Himalayan Bioresource Technology (IHBT) in Palampur. IHBT been tasked with spearheading apple

cultivation in the region. Dr Rakesh Kumar reflected on the success, stating, "Our experiment, involving the planting of the low-chilling apple variety in 2022, has yielded positive results.

While this has encouraged scientists like him to take more such initiatives, locals also seem to be enthusiastic about apple cultivation, considering these crops as a cornerstone of sustainable agriculture and a response to the threats posed by climate change. "We have identified some

visited Mizoram to monitor the growth of aromatic plants and low-chilling varieties of apples, conducting training programmes in various locations, including the College of Horticulture, as

mentioned by Dr Rakesh Kumar

He explained that the region has the potential to produce low-chilling apple types such as Anna, Dorset Golden, Sun Fuji, and others, as these varieties do not require additional and very cold temperatures to flourish.

"Unlike traditional apple varieties, like those grown in Kashmir, which require about a thousand to fifteen hundred hours of chilling, the ones we have introduced in the North East require just about three hundred to five hundred hours of chilling," explained the scientist. Meanwhile, Dr Sudesh Kumar

Yadav, Director of CSIR-IHBT in Palampur, added that apple cultivation is one of the three projects sanctioned to them by the Department of Biotechnology under the Inter-Institutional Programme to support the development and sustainable utilisation of bioresources in Mizoram. "We are also involved in the promotion of Oyster Shiitake and mushroom cultivation, as well as high-value aromatic crops, in addition to cultivating lowchilling varieties of apples." In villages like Khanpui in the Aizawl district, scientists are directly engaging with local apple farmers, assisted by the senior scientific officer of MISTIC. Dr Lalruatliana.

The members of the Pahari Ethnic Group in Jammu and Kashmir have once again set their eyes on the last Budget session for consideration and passing of the bill granting Scheduled Tribe status to the Pahari tribe, Paddari tribe, Koli, and Gadda Brahmins. In the absence of any direct

communication with the Union government, the community leaders are left with no other option but to pin all their hopes on the last budget ses-

# BJP using CAA for political gain in 2024 elections, alleges Mamata

Hours after Union Minister Shantanu Thakur claimed that Citizenship Amendment Act was going to be imple-mented in a week's time Bengal Chief Minister Mamata Banerjee jabbed back saying elections are such big liability on the BJP that they have to "dig out" skeletons of "redundant" issues like CAA or National Citizenship Register. "Suddenly as the elections are approaching the BJP has again started shouting CAA and NRC ... my question is what CAA? What new things are there in CAA? All people who have their names in electoral rolls, are giving votes, have ration cards and getting their getting, have land patta are already citizens of India ... this is because we have already given citizenship to them through these facilities ... there is nothing that can take that from them," Banerjee said alleging "the BJP has dug up a redundant issue once again as they are used to doing this

Other opposition parties like the Congress and the Left immediately called the verbal duel between the BJP and the TMC a ploy to polarize the voters ahead of the elections.

democracy it is the people are



the best judge... Let the people of Bihar make the judgment." The Left however wondered how many times Bengal Chief Minister Mamata Banerjee had changed sides. "She was with the BIP, then she left them and went with the Congress in 2001 ... again she went with the NDA and then again left them and went with the Congress before leaving them again in 2012 ... and now she no one knows whether she is in the INDIA or not," a CPI(M) leader and a former Minister

ship too has been critical of the Chief Minister for trying to impede Rahul Gandhi's Bharat Jodo Nyaya Yatra.

Though he invited Banerjee for the fifth time to join the Yatra, senior Congress leader Jairam on Sunday complained that the

### AAP Government formulates Delhi Solar Policy 2024

 $P^{\text{ower consumers in Delhi}}_{\text{have a reason to cheer as the}}$ Delhi government has formulated the Delhi Solar Policy 2024 that will not only ensure zero electricity bill to them but also give them an opportunity to earn by installing solar panels on their rooftops. Making amendments to its Solar Policy 2016 the Arvind Kejriwal government has come out with a more consumer-friendly Solar Policy 2024 that will provide 4500 MW of installed capacity of solar power in Delĥi by

Addressing a press conference Chief Minister Arvind Kejriwal said the Delhi Solar Policy 2016, announced in the first term of the AAP government after coming to power in 2015, laid the foundation for solar adoption in Delhi.

Under the policy, the rooftop solar panels installed by the people in Delhi have the installed capacity of 250 MW discoms in Delhi purchased 1250 MW solar power from outside Delhi. So, in total, 1500 MW solar power was made available under the policy. We all know that solar power reduces air pollution," he said. The chief minister said as of



now, the Delhi government gives 200 units of electricity free (fully subsidized) to residents and gives subsidy of 50% to those residential consumers who consume 201 units to 400 units a month (partly subsidized) and for those with consumption above 400 units a month, there is no subsidy. "But electricity bills of all residential consumers who install solar panels on their rooftops by opting for this policy will be zero, no matter how much electricity they consume. That is the most important takeaway of the policy," said Kejriwal. T

he chief minister said not only this, each domestic consumer will also be able to generate an additional income of Rs 700 to policy and inflation will come down further in Delhi. "As per a recent report by the Central government, the national average inflation rate is 6%, and 7% in Haryana and Gujarat, but in Delhi it is only 3%, which is the lowest in the country. After the

implementation of the policy, the inflation rate will decline further in Delhi," he said. Kejriwal said that it is estimat-

ed that there will be an installed capacity of 4500 MW of solar energy by 2027 in Delhi after the implementation of the policy. "The target of Delhi Solar Policy is to increase the total installed solar capacity of Delhi to 4,500 MW by March 2027, that is, by three times of the current capacity of 1500 MW in only three years. This includes 750 MW of rooftop solar plants installations in Delhi and the 3750 MW purchased by the discoms through utility scale solar plants installed outside Delhi by 2027," he said.

The chief minister said that the cost of installing the rooftop solar panels will be recovered in four years. "In addition to zero bill, they will get a monthly income of Rs 700-900 through Delhi govt's Generation Based Incentive (GBI) and the total cost of panel will be recovered in four years. Let us say a residential consumer's average monthly consumption is 360 units and the consumer installs a 2kW rooftop solar plant at approx. cost of Rs 90,000 with taxes and subsidy included.

Raising slogans such as "Hemant Soren Mat Ghabrana, Hum Tumhare Saath Hain" (Hemant Soren, don't worry, we are with you), the rally passed near the CM House and Raj Bhavan before returning to Morabadi ground. 

There are 814 SÁRS-CoV-2 sequences of JN.1 across 18 states and UTs while its sub-lineage JN.1.1 has been detected in 943 cases. JN.1.11 has been detected in 244 cases while the rest of the cases were detected in the sub-lineages of JN.1. Last month, the Centre asked the states and Union Territories to maintain a con-

He also recommended sharing the passcodes of all mobile phones in the household with every member to establish transparency. The PM establish emphasised that technology should not be considered a burden, but it is essential to learn how to use it to one's advantage.

"Parents should formulate a set of rules and regulations in the family, like having no electronic gadgets during dinner and creating gadgetfree zones in the house. In today's world, one cannot run away from technology. It should not be considered a burden but is mandatory to learn its effective usage," he

"Students need to make themselves ready to go through any condition. If we visit any cold place, we make our minds, and accordingly, keep ourselves ready...(in the) same way you have to be ready for exams," Modi said.

"Teachers must expand their connections with students much beyond their subject syllabus so that students can reach out to their teachers even for the smallest of problems. Music teachers can not only help their own students deal with tensions, the entire school," Modi said. Replying to questions on Modi said every person has to balancing studies with a manage situations and tests, healthy life, Prime Minister and some people believe in Modi said many students use mobile-phones and some do it for many hours. He advised

students not to use their sleep time for watching reels.

"They should understand that even mobiles need recharge to be used, and similarly, our body also needs to be recharged. # JNUSU protests outside UGC over dereserving of posts

Students groups on Monday staged a protest against the UGC draft guidelines that suggest "de-reserving" vacancies in Higher Education Institutes reserved for SC, ST, and OBC candidates if suitable candidates are not

The JNU Students' Union (JNUSU) along with other Left-backed student outfits such as AISA and SFI demonstrated outside the UGC headquarters demanding the proposal be rolled back. In a statement, AISA said that the draft guidelines are detrimental to the ethos of democratic India and will "ruin all inclusiveness and justice from education institutions.

"This notice will not be tolerated by the students and no empty promise, but outright deletion of it from the guideline must be ensured," the statement said.

The student body also raised objections to the draft guidelines being issued only in English, online, and without a broadcast to the press. It submitted preliminary comments on the matter in a letter to the University Grants

Commission on Sunday. A delegation of students representing different outfits met officials at the UGC office and



the student community they stand to face if the draft guidelines are implemented. According to the Students Federation of India, students were assured by the UGC officials that the draft guidelines will be revised to remove the clause on de-reservation of SC, ST, and OBC posts. "Following the protest at UGC, delegates met with the officials of UGC and expressed the grievances of the student community

regarding the guidelines released by the body. "The officials accepted that it was a grave mistake that hap-

pened from their side and the revised draft will not carry the clause on de-reservation," the SFI statement read. Krantikari

ipated in the demonstration and demanded the dismissal of UGC Chairperson M Jagadesh Kumar.

In its statement, the group alleged the draft guidelines are an attempt to lower the number of reserved seats in higher education institutes so that eligible candidates could be rejected as 'not found suitable,' or NFS, cat-

The 'Guidelines for Implementation of the Reservation Policy of the Government of India in Higher Education Institutes, stipulate that a vacancy reserved for SC, ST and OBC candidates can be declared 'unreserved" if enough candidates from these categories are not available.

# **US** issued 1.4 million visas to Indians in 2023

The US processed a record 1.4 million visas to Indians in 2023, bringing down visitor visa appointment wait times by 75 per cent, the US Embassy said here on Monday. There was a 60 per cent increase in visa applications from Indians compared to 2022.

Process improvements and investments in staffing have brought down appointment wait times for visitor visas from an average of 1,000 days to only 250 days around the country while wait times are minimal in all other categories, it said. "In 2023, the US Embassy and

Consulates in India processed a record-smashing 1.4 million visas, bringing down visitor visa appointment wait times by 75 per cent. Demand across all visa classes was unprecedented, with a 60 per cent increase in applications compared to 2022. Indians now represent one out of every 10 US visa applicants around the world," the Embassy said in a statement. Visitor visas (B1/B2) have rebounded to represent the second highest number of applications in the US Mission's history at more than 700,000.

"The US Embassy and Consulates met this demand through a three-month staffing surge in Mumbai early in the year, by increased permanent staff levels and through the employment of innovative technical solutions. Process improvements and investments in staffing have brought the appointment wait time for visitor visas down from an average of 1,000 days to only

Union Minister of State for Personnel Jitendra Singh said the Department of Pensions and Pensioners' Welfare (DoPPW) has introduced an amendment to the Central Civil Services (Pension) Rules, 2021, allowing female government employees or pensioners to grant family pension to their eligible child/children after their own demise, in place of their spouse.

The amendment will address situations where marital discord leads to divorce proceedings or cases filed under laws such as the Protection of Women from Domestic Violence Act, Dowry Prohibition Act or the Indian Penal Code, he said.

In a path-breaking decision with far reaching socio-eco-nomic impact and in keeping with Prime Minister Narendra Modi's policy to provide equitable rights to women, the government has amended the long-standing established rule, thereby granting the woman employee the right to nominate her son or daughter for family pension, instead of her husband as has been practice so

far," said the statement issued by the Personnel Ministry.

Now, woman employees can nominate

children for pension instead of husband

Singh said, the amendment is in line with Prime Minister Modi's policy of giving just and legitimate rights to the women functionaries in every sector. The DoPPW said, the female government servant or pensioner must make a written request to the concerned head of office, stating that family pension should be granted to her eligible child/children in precedence to her spouse, in the event of her death during the ongoing proceedings.

"If the female government servant or pensioner passes away during the proceedings, the family pension will be dis-bursed accordingly," the statement said.

If a woman employee is survived by a widower with no eligible child, the family pension will be payable to the widow-

However, if the widower is the guardian of a minor child or a child suffering from a mental

disorder, the family pension will be payable to the widower, as long as he remains the guardian, the statement said, adding that once the child attains majority and remains eligible for family pension, it will be payable directly to the

For cases where the deceased female government servant or pensioner is survived by a widower and children who have attained majority but are still eligible for family pension, the family pension will be payable to such children, it said. Singh said a series of gover-

nance reforms have been introduced under the Prime Minister to provide an enabling environment for working women.

The minister said the Department of Personnel and Training (DoPT) has taken concerted efforts to increase the representation of women in central government jobs and to provide them a balance

The Prohibition of Child Marriage (Amendment) Bill, 2021, which was introduced in the Lok Sabha and remains pending there, is likely to lapse when the tenure of the House ends in June.

Bills introduced in the Lok Sabha and pending there as well as those passed by the Rajya Sabha and pending in the lower house lapse on the dissolution of the Lok Sabha. "Chairman, Rajya Sabha, has granted extension of time for a period of four months with

effect from 24th January, 2024 to the Department-related Parliamentary Standing Committee on Education, Women, Children, Youth and Sports for examination of The Prohibition of Child Marriage (Amendment) Bill, 2021," a bulletin issued on January 24

The committee has been given extensions to finalise its report in the past too. The Prohibition Child (Amendment) Bill, 2021 was introduced in the Lok Sabha in December 2021 and was referred to the standing committee on Education, Women, Children, Youth and Sports which functions under the Rajya Sabha Secretariat.

Soon after introducing the bill, Women and Child Development Minister Smriti Irani had requested the Lok Sabha speaker to refer the bill to the standing committee for detailed examination.


Irani told the House that the government was seeking to bring parity among men and women. She said the Bill also seeks to override all existing laws, including any custom, usage or practice governing the

# I cannot do JEE, so killing self: Girl writes days before exam

An 18-year-old student preparing for JEE alleged-ly hanged herself at her home in this coaching hub on Monday, leaving behind a suicide note saying sorry to her parents and calling herself a "loser".

"Mummy, papa I can't do JEE So I suicide," the note said, according to police. She was to give the JEE test in a day or two. ter. Sorry mummy papa. Yahi last option he," the note found in Niharika Singh's room added. This was the second suspected suicide in Kota in less than a

The suicide was reported on a day Prime Minister Narendra Modi held his annual interaction with students preparing for their school board exams, asking them and their parents not to let competition get to them. Niharika lived at her family home in Shiv Vihar Colony in



the city's Borekheda police station area and was to take her JEE test on January 30 or 31, circle officer DSP Dharmveer

The suicide note suggested she was under the stress of studies and found herself unable to tackle the exam, the officer

The student was the eldest of three sisters. Her father is a security guard at a private bank in Kota, he said. The family hails

from Akawdakhurd village in Jhalawar district and has been staying in the city for the last

Her cousin said Niharika was under severe stress over the upcoming JEE test. She had to repeat her 12th class exam because she got a low score, the relative told reporters outside the mortuary.

However, according to him, she was good at studies and devoted seven or eight hours

Niharika's grandmother knocked at the door of her room around 10 am. When there was no response, she raised an alarm. The family found her hanging from the ventilation window above the door.

Last year, 26 students allegedly committed suicide in Kota, where children come from across the country to prepare for competitive tests like the for admission to top engineer-

On January 23, 19-year-old Mohammed Zaid was found hanging in his hostel room in Kota. He had come to the city from Uttar Pradesh's Moradabad district a year back to prepare for the medical entrance exam NEET. No suicide note was found in that case. Niharika was found dead about an hour before the PM's "Pariksha pe Charcha" interaction in Delhi began.



This Early Earthquake Detection System, based on Japanese Shinkansen technology, will detect earthquake-induced tremors through primary waves and enable an automatic power shutdown.

Emergency brakes will be activated when the power shutdown is detected and the trains running in the affect-

ed area shall stop. Out of the 28 seismometers, 22 will be installed along the alignment. Eight will be in Maharashtra-Mumbai, Thane, Virar, and Boisarand fourteen will be in Gujarat-Vapi, Bilimora, Surat, Bharuch, Vadodara, Anand, Mahembadad, and



will be installed in Traction Sub-Stations and Switching Posts along the alignment. The remaining six seis-mometers (termed as inland

seismometers) will be installed in earthquake-prone areas—Khed, Ratnagiri, Latur, and Pangri in Maharashtra, and Adesar and Old Bhuj in Gujarat. The areas near the MAHSR alignment, where earthquakes greater than 5.5 magnitudes have occurred in the past 100 years, were surveyed by Japanese experts. # to influence health policies, says WHO

World Health **I** Organisation's (WHO) has cautioned its member nations to be vigilant against the tobacco industry's attempts to influence health policies through financial and in-kind incentives, ahead of the Framework Convention on Tobacco Control (FCTC) Conference of Parties meeting in Panama next month.

Noting that country surveys consistently show that children aged 13-15 years in most countries are using tobacco and nicotine products, influenced by the tobacco industry marketing tactics, the WHO has designated this year's World No Tobacco Day to the theme of "Protecting children from tobacco industry interference.

According to the latest esti-mates in the WHO tobacco trends report released recently, globally there are 1.25 billion adult tobacco users.

Stating that trends in 2022 show a continued decline in tobacco use rates globally as about 1 in 5 adults worldwide consuming tobacco compared



Be vigilant against tobacco industry efforts

Krech, Director of WHO Department of Health Promotion said that, "Good progress has been made in tobacco control in recent years, but there is no time for complacency.
"I'm astounded at the depths

the tobacco industry will go to pursue profits at the expense of countless lives. We see that the minute a government thinks they have won the fight against tobacco the tobacco industry seizes the opportunity to manipulate health policies and sell their

deadly products." The report shows that 150 countries are successfully

reducing tobacco use. Brazil and the Netherlands are seeing success after they implemented MPOWER tobacco control measures, with Brazil making a relative reduction of 35% since 2010 and the Netherlands on the verge of reaching the 30% target, it said. However, India seems to have a long way yet in meeting the goal as it does not find mention on the success list. Currently the WHO South-East Asian Region has the

highest percentage of population using tobacco at 26.5% closely followed by the European Region at 25.3%. The WHO also noted that while the numbers have steadily decreased over the years the world will make it to a 25% relative reduction in tobacco use by 2025, missing the voluntary global goal of 30% reduction from the 2010 baseline. Only 56 countries globally will reach this goal, down four countries since the last report in 2021. Appreciating the WHO ini-

tiative to take the battle head on with the Industry, renowned wrestler and actor Sangram Singh said it is a matter of concern that despite the ban on tobacco advertisements, the industry is spending hefty amounts on promotion of such items by adopting various marketing tactics, at the cost of health of the younger generation.

He also advocated for strict regulations or prohibitions on surrogate tobacco advertisements involving celebrities in films and sports as their acts have a strong impact on impressionable minds of the teenagers and youth.'

# Firing blanks

Pak's claim of an India link in the killing of two terrorists on its soil is purely to score brownie points

akistan is back to doing what it is known best for --- India bashing. Taking a cue from the India-Canada spat, though that controversy has petered out and Ottawa has even acknowledged that New Delhi is helping it in the probe, Islamabad has accused India of conspiracy to kill two of its citizens (known terrorists) on its soil. While Pakistan's attempt to draw a parallel with the Canada situation is not surprising, it is important to scrutinise the evidence and call Pakistan's bluff. Rather than launching a thorough investigation into the alleged killing of the two operatives, Pakistan has swiftly pointed the finger at India. In doing so, it aims to divert attention from the real issues and create a parallel narrative that manipulates public perception and serves its geopolitical interests. However, it is essential to note that each incident has its unique context, and attempts to equate these oversimplify complex geopolitical dynamics. India has categorically denied any involvement, besides calling for a transparent and



impartial investigation to ascertain the facts. Basically, New Delhi has effectively challenged Islamabad to provide concrete evidence supporting its claims. This is not the first time that Pakistan has sought to blame India for its problems. It has often accused India of instigating insurgents in Baluchistan, though without any evidence. The latest allegation must be seen in light of Pakistan's background of harbouring terrorists on its soil.

It must be remembered that it was Pakistan that provided a sanctuary to Osama bin Laden. The country is currently undergoing a serious existential crisis and would do everything to blame others for its

shortcomings. Terrorists that are creating havoc in Pakistan are its own creation. It does not help if it keeps indulging in theatrics to pacify hardliners back home. Pakistan has a history of deflecting attention from internal issues and gain international sympathy. By blaming India, Pakistan hopes to portray itself as a victim of external aggression, conveniently ignoring the persistent issue of terror within its borders. As the world scrutinises Pakistan's claims, it becomes imperative for Islamabad to present verifiable proof linking India to the alleged killing. Until such evidence is produced, the international community must resist the temptation to hastily accept Pakistan's narrative. Instead, nations and global organisations should insist on a thorough and unbiased investigation into the incident. By doing so, they can contribute to the establishment of truth and discourage the manipulation of facts for political gain. The recent allegations linking India to the killing of two terrorists demand a meticulous examination of the facts. The international community must remain objective. By calling Pakistan's bluff, the world can contribute to fostering regional stability and holding nations accountable for their actions. As the situation unfolds, a commitment to truth and justice will be essential in navigating the complex web of geopolitics in South Asia.


# Rural India deserves better schooling

Despite the Government's support, the Annual Status of Education Report suggests that the urgency for educational reforms is not uniformly recognised across States

he recent 'Annual Status of Education Report' -ASER- published by the NGO Pratham has once again attracted the attention of all those interested in education and the future of India; and its march towards a knowledge society. The first ASER report came in 2005 and it was expected to stir the conscience of not only the education system but India as a whole. By that time, the credibility and public acceptance of government schools was already very low and anyone who could afford it financially made every effort to put their children in private schools, which interestingly, are known as public schools in India. The decline has continued and it is evident by the mad rush in cities and towns, for admission to preschool classes in private schools. People are willing to pay exorbitant fees and the aspiring middle class is ready to cut even other necessary family expenses to educate their children in good schools. Over the years, school education in India has shown remarkable progress on various fronts, but several major concerns have also emerged regarding quality, skill acquisition and institutional work culture.

One of the great achievements of the past few decades has been the social acceptance of educating girls and this has become equally acceptable in rural India also. However, the present report indicates 43.7% of boys having a smartphone as against only 19.8% of girls. It is encouraging to note that 90% of youngsters have a smartphone at home. The present survey was conducted amongst rural kids of 14-18 age group in 28 districts of India across 26 states with a sample of 34,745 children. The quality of the 'growing up' is indicated by the percentages of children who indicated their work aspirations for the future. One was disappointed that 21% could not respond to what they would like to become in years ahead. The top preference of 13% is for a job in the police

Agriculture-related work is an aspiration of only 1.4%! One could safely state from other



studies and interactions that in rural areas, preference for becoming a teacher is still considered an achievable choice by parents and family members. Getting a job as a police- it must be stated- is now suspect because of the widely prevalent public perception that it would require too much of resources and sources. Even for the job of teachers, perceptions are changing fast. There is no surety about regular recruitment or recruitment regularly. Even if one gets appointed as a Shiksha-karmi or an honorarium-paid teacher with any other fancy designation, the sword of uncertainty looms large for years together with no guarantee of getting absorbed in the regular pay scale and

t was established under the Private Education Act (RTE) with the noble purpose of providing quality education to students from economically weak and disadvantaged families. Due to RTE, the condition of private unaided schools has become financially weak. The Maharashtra state government has spent 2400

crores of subsidy to the schools, and the schools themselves have now become financially weak. In 31 thousand schools of the state, 17 thousand 670 rupees were being given to each student in the form of subsidy under the RTE Act. However, the state government reduced this subsidy to 8000 rupees during the Corona period, but the schools accepted it. In fact, this figure has been increasing for the last six years. For this academic year, the government had announced an outstanding grant of 200 crores, but actually Rs. 40 crores reached the schools. The law was enacted with a noble intention through RTE to provide quality education to students from economically weak and deprived families, but the same law is making the school management financially weak and deprived. ### EAT TO LIVE, DO NOT **LIVE TO EAT**

Food can't fill emotional hunger and eating doesn't cure sadness

e all eat to live to survive because if we stop eating, we will die. Hence to avoid this fate, we all eat good food & drink enough water. However, nowadays there has been a new prevalent fashion of 'live to eat' that's getting rampant in society. This new concept has nothing to do with our biological survival. Those who indulge in this do it because of some other reason outside of simply staying alive. In short, eating to live is a biological understanding whereas, living to eat is a psychological, social, and emotional disorder that needs urgent attention because emotional and disordered eating can wreak havoc on our mental, emotional, and physical health if left unaddressed, and, not to mention, the massive amount of time and energy it takes up, leaving one much less able to focus on what matters in his/her life.

For most of us, emotional eating has become a habit of comfort – in other words, it's a behaviour induced by certain cues like situations, feelings, people, commercials, etc. Scientific studies done over the years reveal that animals & people who were more stressed ended up eating more and getting fatter. In general, most of us consider emotional eating as food addiction, just like we consider shopping, gambling, and other behaviours as addictions. There is no doubt that these behaviours can sometimes seem to take on a life of their own and make you feel like you're just going along for a scary ride. But are they all the same? Well! they do seem like addictions on the surface, and it may be handy to use the term as a metaphor. We need to understand the difference between emotional eating and other behaviours are compulsions, not addictions. A compulsion is something you feel you have to do; an addiction is something you can't live without. Emotional eating, therefore, is a psychological compulsion to do something that would otherwise cause emotional distress, not physical withdrawal. The force that drives the behaviour, is the need to counteract feeling controlled by certain external forces by acting out against those or other external forces



Learning to recognize your emotional eating triggers is the first step to breaking free from food cravings and compulsive overeating, and changing the habits that have sabotaged our diets in the past. Using food from time to time as a reward, or to celebrate isn't necessarily a bad thing. But, when eating becomes our primary emotional coping mechanism & when our first impulse is to open the refrigerator whenever we get upset, angry, lonely, stressed, exhausted, or bored, we get stuck in an unhealthy cycle where the real feeling or problem is never addressed. Emotional hunger can't be satisfied with food; it only temporarily masks underlying feelings. To break the cycle of overeating, address the emotions triggering the urge. Without effective emotional management, controlling eating habits becomes challenging. Recognize the power you have over cravings; delay satisfying them for a few minutes. Use this time to assess your emotions.

Psychologists who have examined patients with eating disorders found that those who were taught how to meditate had lower levels of relapse and more positive outcomes after release than those who received only conventional diet or nutrition treatments. Hence it would not be difficult to recognise the value of Meditation for the elimination of the habit of stress eating and introduce this theory and practice as a subject in Education so that the youth & children can be saved from this fatal disorder which is more prevalent among them. Remember! Calming the mind for a few minutes may provide the distance needed to make a reasonable and healthy decision about whether to eat a chocolate cake or go in for a meditation session.



# Dilemma of regulating speech on social media



To meet the escalating challenge of hate speech, the relevance of Gandhian communication cannot be overstated



he Internet's rapid global connectivity has positively transformed communication and knowledgesharing, yet it also poses challenges. Over 3.19 billion social media users can swiftly disseminate harmful content, leading to concerns about regulating online speech. As offensive messages proliferate, despite some measures, countries grapple with the dilemma of how to legislate effectively in the digital age, where the speed of online publishing is in sharp contrast with the sluggishness of regulato-

The ease and anonymity of generating online hate speech, amplified by social media, pose a global menace, transcending borders at minimal cost. Its enduring impact exacerbates societal divisions, fueling violence and discrimination. Recognized also by the United Nations, this crisis violates human rights, correlates with hate crimes, and propels extremist ideologies, even contributing to atrocities like genocide. Effectively addressing this peril is crucial to curtail ongoing disputes, preserve societal cohesion, and protect individuals from dehumanization based on identity factors. Further, hate speech, particularly prevalent in cyberbullying, inflicts diverse harm on young minds, also fostering intolerance. Multiple shreds of evidence prove that the digital realm initially celebrated for fostering connections, has of late transformed into a breeding ground for real-world consequences, where hate speech perpetuates bigotry among children and

One would recall the American student Tyler Clementi's tragic suicide - a result of relentless online bullying due to his sexual orientation that further illustrates the profound consequences of hate speech. Further, the Christ Church Mosque shootings in New Zealand, where the perpetrator livestreamed the massacre after online radicalization, highlight the connection between hate speech and real-world violence. In India, several cases of lethal mob lynchings

Amidst the escalating threat of hate speech, Mahatma Gandhi's Nonviolent Communication (NVC) philosophy – even after 76 years of his passing away – shines as a guiding light. Mahatma Gandhi was a skilled communicator, using words for profound social impact. Rooted in truth, nonviolence, and empathy, his approach centered on 'Satyagraha' — holding onto truth through love and nonviolence. This Gandhian communication model, prioritizing understanding and dialogue over confrontation, offers a blueprint for addressing conflicts without resorting to hate or vio-

His communication wasn't just informational but a powerful moral appeal, urging peaceful action.

Mahatma Gandhi pioneered nonviolent communication, advocating it as a life philosophy rooted in love,

compassion, understanding, and respect for all living beings. Beyond a mere tactic, he viewed nonviolence as a transformative force, inspiring global social justice movements. Gandhi emphasized self-reflection as crucial for empathy and understanding, urging individuals to contemplate their thoughts, feelings, and beliefs before engaging in meaningful communication with others. The renowned psychologist, Marshall Rosenberg, says that Nonviolent Communication' (NVC) aims to create a safe and respectful space for dialogue, where individuals can express their needs and feelings without fear of judgement or retribution.

In the context of hate speech, NVC can be used to de-escalate conflicts and promote understanding between different groups. Daryl Davis, musician and activist who spent years engaging with members of the 'Ku Klux Klan' and has had a firsthand experience to witness the power of NVC, feels that NVC can transform hearts and minds', for, "By listening to the concerns and needs of those who engage in hate speech, we can create a sense of empathy and understanding, which can ultimately lead to peace'

Addressing hate speech in contemporary communication parlance requires embracing Gandhian principles. For this, prioritising truth through fact-checking and responsible journalism, fostering empathy through open dialogue, advocating nonviolence and tolerance, advancing education with media literacy and engaging communities collectively, is the need of the hour. Mahatma Gandhi always highlighted 'collaboration', 'active listening', 'respect', 'empathy', and 'forgiveness' for effective use of nonviolent communication in all his cam-

Countering hate speech does not mean to limit the freedom to speak. # **ASEAN optimistic of progress on Myanmar, SCS conflicts**

China's increasingly assertive posture in the South China Sea and escalating violence in Myanmar topped the agenda for Southeast Asian diplomats at their meeting in Laos on Monday, with the Laotian foreign minister expressing guarded optimism that progress could be made this year on both acrimonious issues.

Lao Foreign Minister Saleumxay Kommasith told reporters that Thailand was moving ahead with plans to provide more humanitarian assistance to Myanmar, where more than 2.6 million people have been displaced by civil war.

He said it was a good sign that the military leaders who seized control of Myanmar in February 2021 from the democratically elected government of Aung San Suu Kyi had for the first time sent a high-level representative to attend the meeting of ASEAN foreign ministers in the historic city of Luang Prabang in Laos. "We feel a little bit optimistic that the engagement may work, although we have to admit that the issues that are happening in Myanmar will not resolve overnight," Saleumxay said. "I think there is probably a small light at the end of the tunnel."

Myanmar has been prohib-Myanmar has been prohibited from sending its foreign minister or any political representative to high-level ASEAN meetings since the end of 2021, when it blocked the group's envoy from meeting with Suu Kyi. Instead, it has sent non-political representatives to lower-level working meetings but has refused to send anyone but has refused to send anyone to high-level meetings.
In Laos, however, it sent a

non-political Foreign Ministry official, ASEAN Permanent Secretary Marlar Than Htike, which Saleumxay called "a pos-

### US 'shall respond' after drone strike by Iran-backed group

 $P^{\text{resident Joe Biden said on}}_{\text{Sunday that the US "shall respond" after three American}$ troops were killed and dozens more were injured in an overnight drone strike in northeast Jordan near the Syrian border. Biden blamed Iranbacked militias for the first US fatalities after months of strikes by such groups against American forces across the Middle East since the start of

Biden, who was travelling in South Carolina, asked for a moment of silence during an appearance at a Baptist church's banquet hall. "We had a tough day last night in the Middle East. We lost three brave souls in an attack on one of our bases," he said. After the moment of silence, Biden added, "and we shall respond". With an increasing risk of military escalation in the region, US officials were working to conclusively identify the precise group responsible for the attack, but they have assessed that one of several Iranian-backed groups was behind it.

Biden said in a written statement that the United States "will hold all those responsible manner (of) our choosing." Defence Secretary Lloyd Austin said "we will take all necessary actions to defend the United States, our troops, and our interests". Iran-backed fighters in east Syria began evacuating their posts, fearing US airstrikes, according to Omar Abu Layla, a Europe-based activist who heads the Deir Ezzor 24 media outlet. He told The Associated Press that the areas are the strongholds of Mayadeen and Boukamal.

US Central Command said at least 34 troops were injured by the one-way attack drone, with eight flown out of Jordan for follow-up care. It described the eight as being in stable condition. The large drone struck a logistics support base in Iordan known as Tower 22. It is along the Syrian border and is used largely by troops involved in the advise-andassist mission for Jordanian

## "Trump cannot bully his way through nomination'

Donald Trump cannot "bully" his way through nomination, Indian-American presidential aspirant Nikki Haley has said after her party said that it's time for Penublicans to unite around Republicans to unite around the former US president and frontrunner in the race for the White House in 2024. Haley is the only remaining Republican after Florida Governor Ron DeSantis and Indian-origin entrepreneur turned politician Vivek Ramaswamy withdrew from the 2024 presidential race earlier this month with both endorsing Trump.

After the New Hampshire primary, where she came in second to Trump, there has been increasing pressure on the 52-year-old politician to with-



draw from the race in favour of her former boss. Trump, 77, has also called on her to withdraw from the race. Haley, the former two-term Governor of South Carolina, has refused to quit. The next major primary is scheduled to be held in her home state of South Carolina later next month. "He (Trump) can't bully his way through the nomination. I think, it's not surprising that he is surround-ed by the political elite, but let's keep in mind, the political elite has gotten nothing done for us in stopping the wasteful spending, has gotten nothing done to secure the border, has gotten nothing done to keep us gotten nothing done to keep us more safe, as we see wars around the world," Haley told NBC News' Meet the Press. 'The reason the political elite are upset and the members of Congress are upset is because I've pushed for term limits; I've pushed for mental competency tests. I've said, if they don't get a budget out on time, they shouldn't get paid. So, look, i have fought this political class my entire life, and it's - I'd much rather be fighting for the people than fighting for the elected officials in D.C.," she

### **IS** claims responsibility for **Istanbul church attack**

The Islamic State group claimed responsibility for an attack on a Roman Catholic church in Istanbul during a Sunday Mass that killed one person, in a statement issued late Sunday. The extremist group said that it "attacked a gathering of Christian unbelievers during their polytheistic ceremony" inside the Santa Maria Church in the Buyukdere neighborhood in Istanbul on Sunday.

Interior Minister Ali Yerlikaya said shortly before midnight that two men he described as members of the Islamic State extremist movement had been arrested for the attack. One of the suspects is from Tajikistan, and the other from Russia. The statement



published on Aamaq, the media arm of the militant group, along with photos of two masked men holding guns whom it identified as the attackers. It described the attack as killing one person and wounding another, while Turkish authorities said no one was injured besides the person killed. Yerlikaya said police had raided 30 locations and detained a total of 47 people as part of the investigation into the attack. "We will never tolerate those who try to disrupt the peace of our country terrorists, their collaborators, both national and international criminal groups, and those who aim at our unity and solidarity," Yerlikaya said.

On Jan 3 this year, 25 suspected Islamic State members were arrested across Turkey, accused of plotting attacks on churches and synagogues, according to state-run Anadolu Agency. The Islamic State has not previously targeted places of worship in Turkey, but the militant group has carried out a string of deadly attacks in the country, including a shooting at an Istanbul night club in 2017 that killed 39 people, and a 2015 bombing attack in Ankara that killed 109.

### Rodrigo Duterte accuses Marcos of plotting to expand grip on power

Former Philippine President Rodrigo Duterte is throwing allegations at his successor, Ferdinand Marcos Jr., and even him from office, bringing into the open a long-rumoured split between the two. In an expletiveladen speech late Sunday, the former populist leader alleged Marcos' legislative allies are plotting to amend the constitution to lift term limits and warned that could lead to him being ousted like his father — the late dictator Ferdinand Marcos. Duterte's allegations, speaking to reporters before he flew to Vietnam for a visit. Marcos said he would not dignify the question with an answer, but claimed his predecessor is using fentanyl, a powerful opioid. In 2016, Duterte said that he had used fentanyl in the past to ease pain caused by spinal injuries from a motorbike accident, but has not acknowledged ongoing use of the drug. "I think it's the fentanyl," Marcos said. "Fentanyl is the

strongest pain killer that you can buy. ... After five, six years, it has to affect him that's why I think this is what has happened."

Members of the House of ing about amending the constitution, and Duterte claimed without offering any evidence that lawmakers who support Marcos, including House Speaker Martin Romualdez, are bribing local officials to amend the 1987 constitution to remove term limits so they can extend their grip on power.

Romualdez, who is the current president's cousin, has denied that claim, saying he wants the constitution amended only to remove restrictions on foreign investment.

Marcos has said he is open to altering economic provisions of the constitution but opposes changing a provision that restricts foreign ownership of land and other critical industries like the media. Philippine presidents can serve only a single sixyear term. Opponents of opening the constitution to changes include the Senate. It issued a statement last week warning its

checks-and-balance role could be undermined if the House of Senate and the 316-strong House.The 1987 constitution, which is laden with safeguards to prevent dictatorships, came into force a year after Marcos' strongman father was ousted by an army-backed "people power" uprising amid allegations of plunder and human rights atrocities during his rule.

The speech put credence into months of rumours about a political split with his successor even though Duterte's daughter Sara is Marcos' vice president following their landslide election

victory in 2022. ### N Korea: Kim Jong Un supervised tests of Cruise missiles North Korea in past years has

North Korean leader Kim firings of new cruise missiles designed to be launched from submarines and also reviewed efforts to build a nuclear-powered submarine while reiterating his goal of building a nucleararmed navy to counter what he portrays as growing external threats, state media said Monday. The report came a day after South Korea's military said it detected North Korea firing multiple cruise missiles over waters near the eastern port of Sinpo, where the North has a major shipyard developing submarines. It was the latest in a streak of weapons demonstrations by North Korea amid increasing tensions with the United States, South Korea and

North Korea's official newspaper Rodong Sinmun published photos of what appeared to be at least two missiles fired separately. Both created grayishwhite clouds as they broke the water surface and soared into the air at an angle of around 45 degrees, which possibly suggests they were fired from torpedo launch tubes.

State media said the missiles were Pulhwasal-3-31, a new type of weapon first tested last week in land-based launches from North Korea's western coast. The reports implied that two missiles were fired during the test but did not specify the vessel used for the launches.

fired missiles both from developmental, missile-firing subplatforms built on barges.

In recent years, North Korea has tested a variety of missiles designed to be fired from submarines as it pursues the ability to conduct nuclear strikes from underwater. In theory, such capacity would bolster its deterrent by ensuring a survivable capability to retaliate after absorbing a nuclear attack on

land. Missile-firing submarines would also add a maritime threat to the North's growing collection of solid-fuel weapons fired from land vehicles that are designed to overwhelm missile defenses of South Korea, Japan and the United States.

Still, it would take considerable time, resources and technological improvements for the heavily sanctioned nation to build a fleet of at least several submarines that could travel quietly and execute attacks reliably analysts say.

The North's official Korean Central News Agency said Kim expressed satisfaction after the missiles accurately hit their sea targets during Sunday's test. He then issued unspecified impor-tant tasks for "realizing the nuclear weaponization of the navy and expanding the sphere of operation," which he described as crucial goals considering the "prevailing situation and future threats," the report

# **HK court orders China Evergrande to liquidate**

Hong Kong court ordered AChina Evergrande, the world's most heavily indebted real estate developer, to undergo liquidation following a failed effort to restructure \$300 billion owed to banks and bondholders that fuelled fears about China's rising debt burden.

Judge Linda Chan said Monday it was appropriate for the court to order Evergrande to wind up its business given a "lack of progress on the part of the company putting forward a viable restructuring proposal" as well as Evergrande's insolvency. China Evergrande Group is one of the biggest of a series of Chinese developers that have collapsed since 2020 under official pressure to rein in surging debt the ruling Communist Party views as a threat to China's slowing economic growth

But a crackdown on excess borrowing has tipped the property industry into crisis, making it a drag on the economy, as scores of other developers ran into trouble, their predicaments rippling through financial systems in and outside China. Global financial markets were rattled earlier by fears an Evergrande liquidation could cause global shockwaves. But Chinese regulators said risks could be contained. Only a few billion dollars of

foreign creditors. It's unclear how the liquidation order will affect China's financial system.

Evergrande's Hong Kongtraded shares plunged nearly 21% early Monday before they were suspended from trading. But Hong Kong's benchmark Hang Seng index was up 0.8% and other property developers saw gains in their share prices. China's largest real estate developer. oper, Country Garden, gained 2.9% and Sunac China Holdings jumped 4%. Some other property companies logged moderate declines. The Shanghai Composite

index dropped 0.6% while Shenzhen's A-share index fell more than 2%. Evergrande gained a reprieve from the Hong Kong court in December after it said it was attempting to "refine" a new debt restructuring plan of more than \$300 billion in liabilities. It could appeal the ruling. Fergus Saurin, a lawyer representing an ad hoc group of creditors, said Monday he was not surprised by the outcome. "The company has failed to engage with us. There has been a history of lastminute engagement which has gone nowhere," he said. Saurin said that his team worked in good faith during the negotia-tions. Evergrande "only has itself to blame for being wound up," he said.

# King Charles III, 'Pak, Iran militants backed, led by third countries'

In an apparent reference to Taliban-led Afghanistan, Iranian Foreign Minister Hossein Amir Abdollahian on Monday said there was "no doubt" that militants located in the border areas of Pakistan and Iran were "led and supported by third countries", days after the two neighbours conducted tit-for-tat military strikes at alleged terrorist bases in both countries.

Abdolahian arrived in Pakistan late Sunday night to de-escalate the tension between the two nations following the military strikes conducted earlier this month. In a joint press conference along with Pakistan Foreign Minister Jalil Abbas Jilani, Abdollahian said: "There is no doubt that the terrorists located in the common border regions and areas of Iran and Pakistan are led and supported by third countries and they never favour any good action in line with the benefits of the Iranian and Pakistani governments and nations."

He, however, did not name any nation. On his part, Jilani said Pakistan and Iran have agreed to "establish a high-level constructive mechanism at the level of foreign ministers of the two countries".

Both the nations have agreed to "cooperate to fight terrorism in our respective areas", he said, emphasising

said Jilani and Abdollahian have underscored the importance of "robust dialogue and cooperation as the pathway for a positive, forward-oriented and upward trajectory in bilateral relations". "The two sides agreed to

the need to "allay and address

each other's concerns". Jilani said the threat of terrorism posed a common challenge to both countries, and, therefore, Islamabad and Tehran have agreed to "adopt collaborative approaches to confront this menace to leverage the robust institutional mechanism". He said the two sides have agreed to station liaison officers at the Iranian cities of Turbat and Zahedan and an agreement is already in place at the earliest date.

He said Abdolahian's visit to Pakistan at "such short notice" testified to the deep commitment on both sides to solidify ties" with each other. Taking to X, the Foreign Office

### Officials register Putin to run in March election

 $R^{\text{ussia's election commission on Monday formally}}$ registered President Vladimir Putin as a candidate for the March presidential election, a vote in which he's all but certain to win another six-year term in office.

Putin, 71, is running as an independent, but he retains tight control over Russia's political system that he has established during 24 years in power. With prominent critics who could challenge him either jailed or living abroad and most independent media banned, his re-election in the March 15-17 presidential vote

In 2018, Putin also ran as an independent, snubbing the United Russia party that nominated him to run in 2012. With his approval ratings hovering around 80 per cent, Putin is far more popular than United Russia, which is widely seen as a part of the Kremlin-controlled state bureaucracy rather than a political force.

The Central Election Commission formally cleared Putin for the race after reviewing 315,000 signatures gathered by his campaign from all 89 régions of Russia. Russian election law requires independent candidates to present at least 300,000 signatures to get on the ballot. The commission already has approved three other candidates who were nominated by parties represented in parliament and weren't required to collect signatures: Nikolai Kharitonov of the Communist Party, Leonid Slutsky of the nationalist Liberal Democratic Party and Vladislav Davankov

of the New People Party. All three parties have been



largely supportive of the Kremlin's policies. Kharitonov ran against Putin in 2004, finishing a distant second. Boris Nadezhdin, a 60-year-old liberal politician who serves as a local legislator in a town near Moscow, is also seeking to run. He has openly called for a halt to the conflict in Ukraine and starting a dialogue with the

Thousands of Russians have lined up across the country to leave their signatures in support of Nadezhdin's candidacy to allow him to qualify for the race, an unusual show of opposition sympathies in the rigidly controlled political landscape that raised a challenge for the Kremlin. The Central Election Commission is expected to review Nadezhdin's papers later this week to decide whether to register him for the race. Under a constitutional reform that he engineered, Putin is eligible to seek two more six-year terms, potentially allowing him to remain in power until 2036.

A frail Daim, 85, who was just discharged from hospital, turned up in court in a wheelchair. He pleaded not guilty to a charge of failing to declare 71 assets ranging from luxury

properties and land. He faces up to five years in jail and a fine if found guilty. After his court hearing, Daim called Prime Minister Anwar Ibrahim "a wolf in sheep's clothing who cried reforms" but instead abused government institutions to pursue his political foes. The antigraft agency has asked both Mirzan and his brother Mokhzani to declare their assets. Mahathir was Malaysia's longest serving-leader, holding office for 22 years before he stepped down in 2003, and again from 2018-2020. He now supports the opposition Malay-Islamic alliance. Mahathir, 98,

has said he believes Anwar is fishing for evidence to impli-

The two men have a long history that has shaped Malaysian politics. Anwar was Mahathir's designated successor in the 1990s before they fell out amid the Asian financial crisis. Anwar was later jailed for corruption and sodomy, charges he said were concoct ed to kill his political career.

The pair joined hands for the 2018 general elections to oust the long-ruling coalition, while Anwar was in jail on a second sodomy charge. He was pardoned by the king shortly after their victory. Mahathir became premier for the second time in a deal that called for him later to hand over power to Anwar, but their alliance collapsed amid infighting.

### China invites B'desh PM Sheikh Hasina for official visit to Beijing

**¬**hina Bangladesh Prime Minister Sheikh Hasina for an official visit to the country as Beijing is keen to work with the new government in Dhaka to cement bilateral cooperation in all fields. "We (Dhaka) will find a suitable time for the visit," Foreign Minister Hassan Mahmud told reporters after he met with Chinese Ambassador to Bangladesh Yao Wen on Sunday.

Wen met Mahmud after the Hasina-led Awami League was re-elected to power for the straight fourth term in the elections boycotted by the major opposition Bangladesh Nationalist Party (BNP) on cussions were underway to arrange it at a mutually convenient time for the premier's Beijing tour.

Prime Minister Hasina officially visited China from July 1-6, 2019. She also participated in the 13th Summer Davos Forum in Dalian. During the visit, Hasina called on Chinese President Xi Jinping. "China reiterated its position to further strengthen the bilateral relations during the tenure of the new government in Bangladesh," the foreign ministry, meanwhile said in a statement after the envoy

met with the minister. Soon after the January 7 polls, Chinese President Xi congratulated Hasina and expressed confidence in boosting the bilateral ties. Bangladesh foreign ministry officials said China wanted Hasina to visit China in September last year but the election and other engagements prevented her from visiting at that time.

China's invitation came

shortly after the ruling party's general secretary and Road Transport Minister Obaidul Quader said India stood beside Bangladesh when BNP tried to foil the polls.

"There is no reason for our strained," Quader told reporters Indian Commissioner in Dhaka Pranay Kumar Verma called on him. Quader said he believed "the wall of confusion and mistrust was finally smashed by Hasina and her Indian counterpart Narendra Modi".

A senior foreign ministry official preferring anonymity said Dhaka would continue to strike a balance in the relationship both with India and China as "we need them both for our stability and development". According to analysts, Hasina deserved credit for skillfully negotiating the rival interests of India and China as Bangladesh is virtually sandwiched between the two feuding Asian giants. She also received the support of the big neighbours and Russia ahead of the elections. India called the Bangladesh election an "internal matter" and Beijing spoke in the same tone while the Western powers, including the United States have called for credible polls.

### Iran executes 4 men for planning sabotage and links with Mossad

**AP** ■ TEHRAN

Iran executed on Monday four men convicted of planning sabotage and alleged links with Israel's Mossad secret service, state media reported. The official IRNA news agency said the men were convicted of planning to target a factory in 2022 belonging to Iran's defense ministry and involved in missile and defense equipment in the central city of Isfahan. The operation was allegedly engineered by Mossad and the four were trained by the Israeli agency in an African country before entering Iran, it said.

The four were identified as Iranian nationals: Mohammad Faramarzi, Mohsen Mazloum, Vafa Azarbar and Pejman Fatehi. The execution was carried out after the country's

Supreme Court upheld their death sentences, handed down by another court in September. The report did not say how the death sentences were carried out, but in Iran it's usually by

In 2022, Iran said its intelligence agents had dismantled a group linked to Mossad that had allegedly planned terror operations inside Iran, arresting all members of the group and confiscating a large amount of weapons and explosives. Iran from time to time reports on arrests, trials and executions of its nationals for spying for Mossad and other Western intelligence services.

Late last month, Iran executed four people - three men and a woman - and sentenced several others to prison for having alleged links with Israel's Mossad security service, local media reported. Earlier in December, another man was executed on charges of releasing classified information to Mossad. Iran and Israel have accused each other of spying and waging a shadow war for years. Israel views Iran as its greatest threat and has repeatedly threatened to take military action to prevent Iran from acquiring nuclear weapons. Iran denies it is seeking such weapons and has vowed a harsh response to any aggression. In 2020, Iran executed a man convicted of leaking information to the United States and Israel about a prominent Islamic Revolutionary Guard general, Qassim Soleimani, the head of Iran's elite Quds Force, who was killed by a US drone strike in January that year.

### **Head of a Saudi** royal commission held for graft

Dubai (AP): The CEO overseeing Saudi Árabia's royal commission for its historic al-Ula site has been arrested on corruption and money-laundering charges over some USD 55 mil lion in contracts, officials said. The charges target Amr bin Saleh Abdulrahman al-Madani in part over "illegally obtaining" contracts to benefit a private company he had interests in through a relative before joining the government, the kingdom's Oversight and Anti-Corruption Authority said in a statement late Sunday. The contracts relate to the Kingdom Abdullah City for Atomic and Renewable Énergy, the statement said. It said Al-Madani also recommended that private company for additional contracts through his work on the commission for al-Ula.

reigning world champion Doreen Vennekamp and former Olympic champion Anna Korakaki of Greece, among others. Two other Indians in the fray could not make it to the top eight as Rhythm Sangwan shot 582 to finish ninth and Manu Bhaker ended

14th with a score of 580. Doreen and Anna won gold and silver respectively with scores of 39 and 37 in the final, while Hungary's Veronika clinched the bronze. India continue to top the season-opening World Cup stage with two gold and three silver medals in their kitty after three days of competition. Two Indians, Sonam and

Nancy, had made the final after shooting 632.7 and 633.1 to finish the 60-shot qualifica-tion round in fifth and fourth spots respectively. Sonam, however, was strongest off the blocks in the 24-shot final, her 53.0 in the first five-shot series giving her the early lead.

It was quite an unprecedented final, with the scores huddled so close to each other that at the end of 10 shots, the difference between the leader Sonam and Nancy, who was placed eighth

at that stage, was just 0.8. Anna took over the lead from Sonam after the 14th shot as, despite a 10.9 from Sonam on the 13th, Anna's consistent high 10s bore fruit.

At one stage, it did look that it would be a double podium for India, but Poland's Stankiewicz pipped Nancy for bronze, while Sonam could not catch up with the experienced Janssen. onslaught.



# Mindset, technical changes imperative for India batters

A fter England tore the prediction books for an epochal 28-run victory here in the first Test, India now find themselves in a tight space, mentally and technically, ahead of the second match starting in four days in Visakhapatnam.

The eternal optimists will trace a similarity in situation to England's tour to these shores three years ago.

The Three Lions under Joe Root had consigned India to a massive 227-run defeat in Chennai, but after four days Virat Kohli's side entered the field a reinvigorated lot to level the series at the same Stadium at Chepauk.

But comparisons must end there. On a Chidambaram Stadium pitch that deteriorated incredibly fast, India had the first-mover's advantage, piling a 329, which formed the core of the hosts' big win. Moreover, India had Kohli, Ajinkya Rahane and Rishabh

Pant in the middle-order, all who could tackle spin effec-

None of these three will be in action in Visakhapatnam for different reasons, while Shubman Gill and Shreyas Iyer, particularly the former, have not inspired much confidence against spinners either. The word from the coastal Andhra Pradesh town is that the pitch for the second Test might not be entirely different in nature from one used at the RGI Stadium here, and that put the onus squarely on the Indian batters to buckle their

The top brass is not exactly keen on an under-prepared pitch, the one we saw in Ahmedabad during the previous series when Axar Patel scythed through the visitors with an 11-wicket haul. The powers that be have understood the fragility of these set of Indians against spin, and a deck like that might backfire badly on them.

So, it is imperative for the Indian batters to find their range against England spinners, who might also bring in off-spinner Shoaib Bashir, who had reconnected with the rest of the team on Sunday after the visa mess.

"I don't know what kind of pitch will be there (for the second Test). Whatever it is, they



need to regroup quickly as England has smelled the blood. This England side is different from what we saw last time," a former India batter told PTI on conditions of

anonymity.
"Under Ben Stokes and
Brendon McCullum, England
have redefined the approach to Test cricket and they are a bold outfit mentally too, unafraid to take risks. It may bring in some bad results but it also gives them a higher chance of winning.
"So, India cannot afford to take

a step back in Vizag and allow them to build a 2-0 lead, from which it will be difficult to come back."

India's failure was two-fold in Hyderabad. Veterans R Ashwin and Ravindra Jadeja in the company of Axar Patel failed to rattle England on a slow-turning pitch, allowing them to pile 420 in the second innings on the back of Ollie Pope's sensational 196.

When their turn came to chase 231, the Indian batters surrendered to the guiles of left-arm spinner Tom Hartley in the second innings as the debutant walked away with seven wickthese young batters is that they try to dominate spinners playing big hits. But they have to understand that working the ball around for singles or twos are also a way to impose yourself on spinners, a more risk-free method," the former India player said.

"Cinderella stories are rare in sport but this was truly epic from a young man who has single-handedly reignited the passion of cricket followers in the Caribbean and all over the world," added one of Australia's most successful captains.

In fact, while he was cleared of having not suffered a fracture to his toe after copping a blow

from a Mitchell Starc, Joseph had to take the field on the final day of the Test wearing teammate Zachary McCaskie's jersey after covering his name

with a tape. Unclear of his participation, Joseph had not carried his whites to the ground.

Meanwhile, former West Indies bowler and renowned commentator Ian Bishop termed the victory as the 'most remark-

able Test win' yet. 'What a remarkable moment for Shamar Joseph and West Indies cricket. The most remarkable Test win that I can put my mind on, given the con-

text, (sic)" he wrote on X.
