7 Indians who faced death row in Qatar return home

Indian officials escort former Navy personnel to New Delhi by passenger flight; eighth person also released, but awaits clearance; Prime Minister Modi to travel to Qatar tomorrow after his UAE visit

Eight Indian Navy veterans who had been in Qatari custody since August 30, 2022 were released on Sunday in Doha. Indian officials escorted seven of the eight former death row prisoners to New Delhi by a passenger flight during the early hours of Monday.

The development was followed by the announcement that Prime Minister Narendra Modi will visit Qatar on Wednesday afternoon on his way back home from the United Arab Emirates where he will pay a two-day visit during February 13-14.

"We are happy to have seven of those Indian nationals back. The eighth Indian has also been released

and we continue to work with the Qatar government to see how quickly his return to India would be possible," said Foreign Secretary Vinay Mohan Kwatra.

The details of the case in which the men were arrested were not shared with the media by either side while the Indian officials maintained that the case was "sensitive". The men

were given the death penalty by a lower court in Qatar on October 26, 2023. Subsequently, a court of appeals in Doha struck down the death penalty on December 28.

Diplomatic issue
The case of the eight Indian Navy veterans kept India-Qatar relation on tenterhooks as the matter

became an issue of diplomatic tug of war and their cause of the arrest was never publicised. The men had earlier appealed against the death sentence of a lower court in Doha that was subsequently commuted to a sentence of varying periods for the eight individuals.

Appreciating the decision of the Qatari legal authorities to release the Indians, Mr. Kwatra said, Prime Minister Narendra Modi "personally supervised all developments".

Earlier, there were expectations that the eight men would be freed ahead of Ramzan or Id. However, the announcement has come a day prior to Mr. Modi's UAE visit.

T.N. Governor Ravi refuses to deliver customary address

Tamil Nadu Governor R.N. Ravi on Monday triggered a fresh row in the ongoing rift between him and the State government by refusing to read out the customary inaugural address of the Legislative Assembly for 2024 and at one point walked out of the House.

Mr. Ravi announced his decision after reading the first paragraph of the address prepared by the government that wished "happiness, prosperity and well-being" in the new year and quoted a couplet from *Tirukkural*.

Later in the day, the Raj Bhavan, in a release, said the Governor "with due regard to the constitutional proprieties expressed his inability to read the address as it contained numerous passages with misleading claims and facts

and reading them would have amounted to Governor's address becoming a constitutional travesty".

After Mr. Ravi tersely ended his speech by citing reasons to justify his stand, Speaker M. Appavu read the prepared address in Tamil in entirety in Governor's presence.

Jailed Minister Senthilbalaji resigns from T.N. Cabinet

Jailed Tamil Nadu Minister without portfolio V. Senthilbalaji, who was arrested in June 2023 by the Enforcement Directorate in an alleged money laundering case, resigned from the Cabinet on Monday.

While well-placed sources in the government confirmed that he had sent his resignation to the Chief Minister from the Puzhal Central Prison, at the time of filing this report, there was no official communication.

Cash-for-job 'scam'
The case has its roots in an alleged cash-for-job scam in the Metropolitan Transport Corporation, which took place when he was Transport Minister in the Jayalalithaa Cabinet. Before his arrest, Mr. Senthilbalaji was holding the portfolios of Electricity, and Excise and Prohibition.

NDA govt. wins Bihar trust vote; Opposition walks out

The National Democratic Alliance (NDA) government led by Chief Minister Nitish Kumar won the floor test in the Bihar Assembly on Monday with the support of 129 MLAs. Three legislators of the Opposition Rashtriya Janata Dal (RJD) voted in favour of the government amid a walkout by all non-NDA MLAs. The government needed the support of at least 122 MLAs to win the majority test in the 243-member Assembly.

Ahead of the trust vote, Bihar Assembly Speaker and RJD leader Awadh Bahari Choudhary, who had earlier refused to resign, was removed with 125 MLAs voting in favour of

the motion and 112 opposing it. Deputy Speaker Maheshwar Hazari of the JD (U) then chaired the House.

After the House passed the resolution for the removal of the Speaker, Mr. Kumar moved the motion seeking trust vote for the new NDA government he

had formed with the BJP on January 28. The motion was passed 129-0 through voice vote after the Opposition walked out from the House.

Sharif, Bilawal start coalition talks in Pak.

Pakistan's two largest political parties were on Monday wrangling over who will be the Prime Minister after an inconclusive poll last week forced them to join forces and try to form a coalition government. Independent candidates backed by Imran Khan formed the largest group of 93 members in parliament.

Nawaz Sharif's Pakistan Muslim League-Nawaz (PML-N) and Bilawal Bhutto Zardari's Pakistan Peoples Party (PPP) opened formal talks to form a coalition government, with a statement from the PML-N saying the meeting was "constructive".

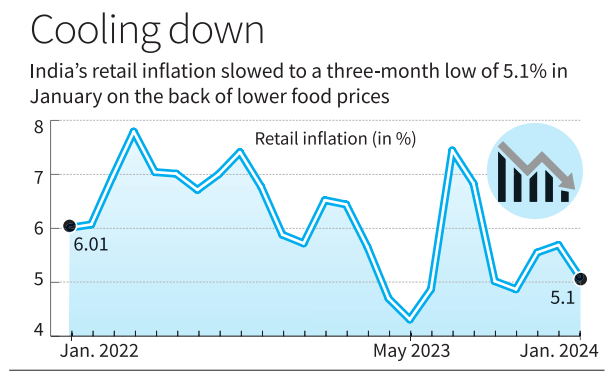
Retail inflation eased to a 3-month low of 5.1% in Jan.; food prices sticky

India's retail inflation eased to a three-month low of 5.1% in January from 5.7% a month earlier, with food price rise cooling a bit to 8.3% compared with 9.5% in December 2023.

January's headline inflation pace is slightly higher than the 5% average projected by the Reserve Bank of India (RBI) last week for the current final quarter of 2023-24.

Any interest rate cut hopes will have to wait till at least August if not longer, as the Central bank expects inflation to average



5% in the April to June quarter as well, before it hits its stated inflation target of 4% in the next quarter.

While overall inflation faced by urban consumers

dropped to 4.92% from 5.5% a month ago, food inflation remained sharp at 9%, sliding a tad from 10.4% in December. By contrast, rural consumers faced food inflation of

Four convicts in Soumya murder case granted bail

The Delhi High Court on Monday granted bail to four convicts serving life imprisonment for the murder of TV journalist Soumya Vishwanathan.

Noting that the men – Ravi Kapoor, Amit Shukla, Baljeet Malik and Ajay Kumar – had been in custody for 14 years, the court suspended their sentence till the pendency of their appeals challenging their conviction.

Vishwanathan was shot dead in the early hours of September 30, 2008 while she was returning home from office on Nelson Mandela Marg. A special court had on November 26, 2023 awarded life imprisonment to the four men and three years in jail to another.

AAP's PAC to meet today as talks with Congress drag on

The Aam Aadmi Party's political affairs committee (PAC) will meet on Tuesday to decide its candidates for the Lok Sabha poll, amid talks with the Congress on seat sharing in Delhi remaining inconclusive so far.

According to AAP sources, the party's highest decision-making body will hold discussions on candidates for Gujarat, Haryana, and Goa.

Senior party leader Gopal Rai on Monday said discussions are still on with the Congress over seat sharing in Delhi, which sends seven members to the Lok Sabha.

Talks between both parties, which are part of the

Opposition's INDIA bloc, for seats in the Capital have dragged on for over a month now. Leaders of both parties had met on January 12 last time.

While speaking in Punjab during an event on Sunday, Delhi Chief Minister Arvind Kejriwal had claimed that people of the city have decided to vote for his party candidates in all seven seats, stoking speculations that both the Congress and AAP may go solo in the Capital.

Earlier, both Opposition alliance partners had decided against a tie-up in Punjab.

The Congress has also maintained that while they are preparing to contest all seven seats, the possibility of an alliance can't be ruled out.

Farmers' march: drones deployed, public meetings banned for a month

Singhu, Tikri, Ghazipur borders completely sealed; RAF companies deployed to prevent rioting; rigorous inspection of vehicular traffic from neighbouring States to prevent protesters from entering city; commuters advised to use metro services

The Delhi police on Monday imposed a complete ban on public gatherings across the city, citing the risk of "social unrest" and "violence" due to the farmers' proposed Tuesday march to Parliament to seek minimum support price (MSP) for crops.

The order issued under Section 144 of the CrPc by Police Commissioner Sanjay Arora prohibits the gathering of four or more people and will remain in force till March 12.

Meanwhile, the police completely sealed the Singhu, Tikri and Ghazipur borders with neighbouring Uttar Pradesh and Haryana by placing multiple layers of barbed wire, concrete barricades, and metal spikes to stop farmers from entering the Capital. Teams of the Rapid Action Force (RAF)

have been deployed to prevent any kind of rioting while drones are being used to keep vigil at border points, an official said.

Major prohibitions

The order said the protesters are likely to use tractor-trailers as mode of transport for entering Delhi, "which will inevitably be a great hazard on roads". All traffic originating from ad-

joining States will be subjected to rigorous inspection, it added.

The order said there will be a prohibition on provocative actions, slogans, speech or messages through verbal, written or electronic means, which may incite or inflame passions leading to the breach of public order. An officer said, "One should use Delhi Metro services to commute

within the city."

The call for the 'Delhi Chalo March' has come more than two years after farmer bodies withdrew their year-long agitation against the Centre's now-repealed farm laws.

Tens of thousands of farmers had then set up makeshift camps at city borders. At least 700 people died during the protest, according to farmer bodies.

Hold fresh talks, Rai urges Centre

AAP Delhi convener Gopal Rai on Monday urged the Centre to hold consultations again with the farmers marching to Delhi over their demands. Speaking to reporters, Mr. Rai said the security measures taken by the BJP government at the Centre and in neighbouring Haryana were "more cruel than that during the colonial era".

While withdrawing their stir, farmer bodies – mostly from Uttar Pradesh, Haryana, and Punjab – had set a condition that the Centre would bring a law guaranteeing MSP for crops. They are also demanding complete debt waiver and pension for farmers and farm labourers.

'Protocol breached': HC quashes JNU PhD student's rustication

The Delhi High Court has quashed an order by Jawaharlal Nehru University (JNU) rustivating a PhD student for two semesters and declaring her "out of bounds" from the campus.

In its order, dated February 7, the court set aside the action taken by the university against Swati Singh, a student at the Centre for Russian Studies, calling it an "unsustainable breach of the statutory protocol". The order to rusticate Ms. Singh was issued on November 8, 2023, after a proctorial inquiry found her guilty of allegedly manhandling a woman security guard and misbehaving with other guards at the gate of the JNU Convention Centre in August that year.

On November 16, an or-

der from JNU's Assistant Dean of Students directed Ms. Singh to vacate her hostel room and she was evicted eight days later.

Ms. Singh, also the president of the Democratic Students' Federation, had last December challenged both orders in the High Court over her "unjust rustication and eviction".

The court ordered JNU to reinstate Ms. Singh and allot her a hostel. It, however, said it shall not prevent JNU from proceeding against her, if it so desires, strictly in compliance with law and the statutes governing the university.

Ex-Maharashtra CM Ashok Chavan quits Cong., casts shadow on its fortunes in RS polls

In a jolt to the Congress in Maharashtra, former Chief Minister Ashok Chavan resigned from the party on Monday, casting a shadow on its fortunes in the Rajya Sabha polls in the State slated for February 27.

The move came amid growing speculation about the 65-year-old leader switching loyalties to the BJP, and days after senior State Congress leaders Milind Deora and Baba Siddique quit the party to join the ruling *Mahayuti* alliance, comprising the BJP, Shiv Sena and NCP.

Mr. Chavan, along with a few Congress MLAs, is expected to join the BJP in the presence of Union Home Minister Amit Shah later this week. Speculation is rife that he may se-

cure a Rajya Sabha berth. However, the leader said he has not decided to join any party yet. "The decision to quit is a personal one. I will clear my stand on joining a party after 48 hours," he said, adding that he is not in touch with any Congress MLAs.

Mr. Chavan, son of the late Defence Minister and two-time State Chief Minister, Shankarrao Chavan, submitted his resignation to State Congress chief Nana Patole. The veteran politician, who represented the Bhokar Assembly constituency, also met Assembly Speaker Rahul Narwekar and tendered his resignation as an MLA.

Later in the day, Mr. Chavan refuted claims that the White Paper recently tabled in Parliament prompted him to resign. It had mentioned the Adarsh building scam due to

which he had to step down as Chief Minister in 2010.

Six seats in State

Of the six Rajya Sabha seats in the State, the BJP, with 104 MLAs in the 288-member Assembly, will stake claim to three seats, while its allies NCP and Shiv Sena will claim one each. The Sena has 39 legislators, while the NCP claims to

have the support of 41 MLAs. The Sena and the BJP also have the support of several Independent legislators.

While the Congress, which has the largest strength (43 MLAs) in the Opposition Maha Vikas Aghadi (MVA) alliance, was expected to win the sixth seat, Mr. Chavan's exit has cast a cloud on its hopes.

While Congress leader Prithviraj Chavan and the party's Solapur MLA, Praniti Shinde, claimed that the party's flock remains united, BJP State chief Chandrashekhar Bawankule said there is no need for his party to split the Congress to win the sixth seat.

"I do not think Mr. Chavan's exit will impact our fortunes in the polls. The BJP is trying to portray the Congress as an unstable party, but we are strong. These are the BJP's tactics of pressure and blackmail," Ms. Shinde said.

Mr. Bawankule clarified that there is no proposal yet that Mr. Chavan will be sent to the Rajya Sabha if he joins the BJP. "I do not think there will be much of a contest in the RS polls. The BJP has the numbers to win three seats, the Ek-nath Shinde-led Sena camp and Ajit Pawar's NCP

have the numbers to win one seat each. The Congress can win the remaining seat by taking support from the Sharad Pawar-led NCP and Uddhav Thackeray's Shiv Sena (UBT)."

Asked about Mr. Chavan's potential entry into the party, senior BJP leader and Deputy Chief Minister Devendra Fadnis said, "Aagey aagey dekho hota hai kya (Wait and watch what happens). I learned about Mr. Chavan from the media. However, I am confident that a few key figures will switch to the BJP."

There is strong speculation that three more Congress MLAs — Mohan Hambarde, Jitesh Antapurkar, and Vishwajit Kadam — are likely to leave the party.

Not surprising: Patole
The news of the resignation, however, did not come as a surprise to the

State Congress chief. "It has been in the works for years, and the high command has been informed about it repeatedly. Nanded district, Mr. Chavan's hometown, has a significant population of Muslims and Dalits, traditionally strong supporters of the Congress. While leaders may change, our grassroots cadre remains intact," Mr. Patole said.

The State Congress president, who rushed to Delhi after the development, said the current political battle revolves less around ideology and more around apprehensions of the ED, CBI, and I-T Department. "It's clear that the primary concern seems to be investigative agencies and nothing else," Mr. Patole said.

The discord between Mr. Chavan and Mr. Patole likely influenced his decision, a senior leader from

Congress said. "Mr. Chavan always expressed dissatisfaction with Mr. Patole's role as State party chief, his decisions, and consistently held him responsible for the fall of the erstwhile MVA government," the party leader said.

Congress general secretary (communications) Jai-ram Ramesh, without naming Mr. Chavan, said an exit by betrayers "opens up vast new opportunities to those whose growth they have always stunted".

'BJP low on confidence'

Addressing a rally at Chhatrapati Sambhajanagar, Mr. Thackeray said Prime Minister Narendra Modi and the BJP have low self-confidence ahead of the Lok Sabha election. The Shiv Sena (UBT) president also questioned their need to relentlessly poach leaders from Opposition parties.

Sisodia gets interim bail to attend niece's wedding

A Delhi court on Monday granted three-day interim bail to senior AAP leader Manish Sisodia, arrested in the excise policy case, to attend his niece's wedding. Special Judge M.K. Nagpal granted the relief to Mr. Sisodia from February 13-15. The Central Bureau of Investigation (CBI) had arrested the former Delhi Deputy Chief Minister on February 26, 2023 over alleged corruption in the formulation and implementation of the now-scrapped Delhi Excise Policy 2021-22. The Enforcement Directorate (ED) arrested him on March 9 from Tihar jail in a related case of money laundering. PTI

Body of ex-Chennai mayor's missing son recovered in H.P.

Days after the ill-fated vehicle in which former Chennai mayor Saidai Duraisamy's son Vetri Duraisamy, 45, was travelling in fell into the Sutlej river in Himachal Pradesh, his body was recovered on Monday, the police said. "The divers recovered the body of Vetri Duraisamy, around 3 km downstream from the spot where the vehicle fell into the river on February 4. The body was sent for post-mortem to Indira Gandhi Medical College and Hospital in Shimla," said Kinnaur's Deputy Superintendent of Police (Headquarters), Naveen Jalta. Mr. Jalta said the body will be handed over to the family after the post-mortem.

Rail-road blockade over Kokborok script called off

The indefinite rail-road blockade in Tripura was called off on Monday evening after the State government assured that students would be allowed to write Kokborok language papers in the upcoming Class X and Class XII exams in both Bengali and Roman scripts, a State Minister said. The blockade was called by Tipra Indigenous Students Federation, the students wing of Tipra Motha, the main opposition party in the northeastern State. Kokborok, an indigenous language spoken by nearly 24% people of Tripura, does not have a script. Students generally write papers for the language in the Bengali script. PTI

Mithun discharged from hospital, to resume shooting

Veteran actor Mithun Chakraborty got discharged from hospital on Monday afternoon, with the BJP leader asserting that he was "absolutely fine" and would soon resume shooting for upcoming films. Mr. Chakraborty, 73, was admitted to a private hospital here on February 10, after he complained of severe chest pain. He underwent a series of clinical tests, including an MRI, a senior official of the medical facility said. Earlier in the day, senior doctors and therapists had reviewed his health condition. "There is actually no problem, I am absolutely fine. I have to keep control of my food habits," the popular actor said. PTI

T.N. Governor's 'address' by Speaker flays Central govt.

Speech prepared by State govt., which Ravi refused to deliver, highlights achievements under DMK rule, slams Modi govt. on GST regime, seeks funds for cyclone relief and Chennai Metro Rail project

The speech prepared by the Tamil Nadu government for Governor R.N. Ravi's address to the Assembly, which he refused to read, was critical of the Central government on the GST regime and the non-release of funds for the Chennai Metro Rail project.

The State government vowed that it would never allow the implementation of the Citizenship (Amendment) Act in the State, citing the "grave threat" that the ideal of unity in diversity faced. It also highlighted the need for funds to mitigate the havoc caused by the recent cyclone and floods in parts of the State.

A majority of the 48-page speech, subsequently read out in Tamil by Speaker M. Appavu, focused on the achievements of the State under the DMK government and over the decades in various spheres.

The speech said State governments relinquished their fiscal autonomy and agreed to the implementation of the Goods and Ser-

vices Tax (GST) hoping that they would receive adequate compensation till the new system could generate revenues equivalent to those of the pre-GST era.

However, the termination of the GST regime by the Centre meant that the State was facing a revenue shortfall of ₹20,000 crore per year. "We urge the Union government to continue the compensation regime," the speech read.

'Reneged on promise'

The address expressed disappointment that the Union government had reneged on its promise to provide its share as per a

50:50 equity arrangement for phase II of the Chennai Metro Rail project by delaying approval for more than two years, while according sanction for similar projects in other States at the same time. "We urge the Union government to approve the project as originally envisaged," it said.

'Could have stayed away'

Addressing the media at the Secretariat, Law Minister S. Regupathy said the Governor could have chosen not to come to the Assembly if he felt that the text of his address was against his conscience.

He said if the Governor

had raised objections to the text, claiming that it was not the truth, the State government was prepared to give a response.

The Governor's actions will only strengthen the Opposition-led INDIA bloc in the northern States, Mr. Regupathy added.

Raj Bhavan statement

Hours after the Governor walked out of the House, the Raj Bhavan issued an official communication stating that the Assembly Speaker with his "unbecoming conduct lowered the dignity of his Chair and grace of the House".

"While the Speaker went on his tirade against the Governor, the Governor, with due regard to the dignity of his office and the House, left the House," the communication said.

When the Speaker concluded the address, the Governor rose for the national anthem, as scheduled, it said. "However, the Speaker, instead of following the schedule, launched a tirade against the Governor and called him a follower of Nathuram Godse and more," the release added.

Less than 1% of Gujarat budget earmarked for OBCs: Cong.

The Opposition Congress on Monday termed the BJP government in Gujarat as "anti-OBC" for allegedly allocating less than 1% of the 2024-25 budget outlay for the segment that represents 52% of the State's population.

Speaking in the Assembly during the general discussion on the State budget, Congress Legislature Party leader Amit Chavda demanded caste census in Gujarat. "Recently, there was a controversy about whether PM Narendra Modi belongs to the OBC category. I don't want to go into that. But, I want to say the BJP government's policies have been anti-OBC ever since Modi was the CM. You have allocated only ₹2,900 crore for the OBCs out of a total budget of ₹3.32 lakh crore for the 2024-25," Mr. Chavda told the House.

BJP announces its 2 candidates for RS polls from Rajasthan

The Bharatiya Janata Party on Monday announced its two candidates from Rajasthan for the upcoming Rajya Sabha biennial elections for three seats in the State. The ruling BJP is set to get two of the seats, while the Opposition Congress will get one, on the basis of their respective strength in the State Assembly.

The two BJP candidates are State vice-president and former Minister Chunnilal Garasiya and former Sumperpur MLA Madan Rathore. Mr. Rathore was elected an MLA twice, in 2003 and 2013, and served as BJP's Deputy Chief Whip in the Assembly. He was earlier the chief of Pali Central Cooperative Bank.

Mr. Garasiya, a low-profile BJP leader hailing from Udaipur district, is the tri-

bal face of the party. He was elected an MLA twice, in 1990 and 1993, from Udaipur Rural constituency and he served as a Minister of State for Tribal Area Development. He was also national president of the BJP's Scheduled Tribe Morcha.

The BJP has 115 and the Congress 70 MLAs in the 200-member State Assembly. A minimum of 67 votes will be required to win one Rajya Sabha seat in the event of a contest.

Ex-PM's term ending

The terms of office of Congress MP and former Prime Minister Manmohan Singh and BJP MP Bhupendra Yadav will come to an end on April 3. Besides these two, one Rajya Sabha seat has become vacant after the resignation of BJP's Kirodi Lal Meena following his victory in the 2023 Assembly election.

Assam govt. wants to curb evangelism, working to bring anti-polygamy law in State: CM

Assam Chief Minister Himanta Biswa Sarma on Monday said that his government wants to curb evangelism in the State apart from aligning a proposed anti-polygamy law with Uttarakhand's Uniform Civil Code (UCC).

On February 10, the Assam Cabinet approved the Assam Healing (Prevention of Evil) Practices Bill, 2024, to address the issue of fraudulent magical healing practices in the name of treatment. The Bill prescribes imprisonment and fines for engaging in illegal practices under the guise of treatment or magic healing.

"Magical healing is a dicey subject used to convert tribal people. We are going to pilot this Bill because we believe the religious status

move inspired from the UCC announced by the Uttarakhand government.

Meanwhile, a radical Hindu group named Kumbha Surakshya Parishad, translating into Family Safety Council, has asked church-run schools in Assam to remove all Christian symbols that it claimed are used subtly to influence students for conversion.

Ultimatum to schools

The group set a 15-day deadline for missionary schools for February 7 to remove the idols and photographs of Jesus and Mary apart from churches located within their compounds. Denying the charges of conversion, Guwahati-based Archbishop John Moolachira said threats from radical groups have made it difficult to manage school and educational activities.

Blast in firecracker storage unit for temple fete kills two

25 persons injured and 50 houses severely damaged in explosion near Kochi: Collector says temple authorities had not taken permission to store or display firecrackers; four booked

Two persons were killed and over 25 others were injured in a blast that ripped through an illegal firecracker storage unit at Choorakadu during the festival at Puthiyakavu Devi Temple in Thripunithura near here in Kerala on Monday.

The explosion occurred around 10.30 a.m at the unit housed in a single-storey building of the temple administration at Nadama Thekkumbhagam village. The stored items were meant for a fireworks display on Monday evening.

The deceased were identified as Vishnu, 27, a native of Thiruvananthapuram, who was reportedly part of the team of workers assembling firecrackers, and Divakaran, 55.

The Department of Fire and Rescue Services and the police say that a possible short circuiting from a van that was carrying raw materials for the firecrackers may have triggered the

massive blast.

Nearly 50 houses in the vicinity were severely damaged.

The Hill Palace Police booked Sajeesh Kumar, the Puthiyakavu devaswom president; Rajesh, devaswom secretary; Sathyan, treasurer; and Adarsh, who had taken the contract for supplying the firecrackers. Adarsh was critically injured in the incident.

Ernakulam Collector N.S.K. Umesh said the temple authorities had not taken permission from the district administration for storage of firecrackers and display of fireworks.

Forest officials fail to capture jumbo on Day 2

For the second day on Monday, the Rapid Response Team of the Forest Department encountered difficulties in the search for the wild elephant Belur Makhna that trampled a farmer to death in Wayanad, Kerala, on Saturday.

Forest officials spotted the animal at the Mannundi forest area, but the animal entered a swampy area inside the forest, hindering the efforts to tranquillise it.

Though the tracking

team again spotted the animal at the Chempakappara forest, it could not be tranquillised due to the thick undergrowth in the area, a source said.

As many as 2,000 frontline forest staff, including the Rapid Response team from the sanctuary, Nilambur South Forest Division, and Mannarkad North Forest Division, were mobilised for the operation. Four trained elephants and a forest veterinary team also attended the combing.

Meanwhile, the sighting of a tiger in a human habitat at Vadanakkavala, near

Pulpally, on Monday morning triggered panic among the residents. A farmer and his wife who were working on their plantation saw the tiger chasing a wild boar into their plantation. The tiger stayed on the plantation for hours.

A team of forest officials rushed to the spot and found the tiger inside the plantation. They are camping at the site.

A few days ago, a tiger was sighted at Anappara, near the area. The officials had set up two cages at Surabhikkavala and Tannithervu after two domestic

animals were killed, suspected in tiger attacks.

Karnataka offers help

Karnataka Minister Dinesh Gundu Rao said that his government would give all help to mitigate the human-wildlife conflict in Wayanad.

Speaking after inaugurating a public meeting at Kalpetta on Monday in connection with the Samaragni march led by the Congress, he said as the issue was a sensitive and difficult one, coordination between the governments was the need of the hour.

U.P. police arrest four for issuing 'fake' halal papers

The Uttar Pradesh Special Task Force on Monday arrested four office-bearers of the Halal Council of India (HCI), an organisation allegedly issuing fraudulent halal certificates. Those arrested were Maulana Habib Yusuf Patel, the head of the organisation; Zakir Hussain Chauhan; Maulana Muidshir Sapadia and Mohammad Tahir, all hailing from Mumbai.

In November 2023, after enforcing a complete ban on the production, storage, distribution and sale of halal-certified food products in the State, U.P. transferred the investigation of a case registered at Hazratganj police station in Lucknow against four firms, including HCI, for alleged irregularities in certification of products, to the Special Task Force.

It was Bharatiya Janata Yuva Morcha office-bearer Shailendra Kumar Sharma who had alleged that some companies certified certain products fraudulently to increase their sale among people from a certain community.

An FIR was registered under various sections, including 120B (criminal conspiracy), 384 (extortion), 420 (cheating), 467 (forgery), of the IPC.

Telangana devotees robbed in Ayodhya

A group of devotees from Telangana's Karimnagar district, who had gone to Ayodhya to worship at the Ram temple, were reportedly robbed of their gold chains weighing about 1,200 grams in a crowded street on Sunday.

According to the devotees, miscreants have snatched away their gold chains while they were walking through a main

street on their way to the temple.

They reportedly staged a sit-in near police station seeking action by the police to trace the chain-snatchers and recover their stolen gold chains.

BJP national general secretary and Karimnagar MP Bandi Sanjay Kumar spoke to the authorities in Uttar Pradesh, from Karimnagar, on phone and requested them to immediately investigate the incident,

CMRL case: Centre files statements in HC

Illegal payments to the extent of ₹135 crore to various political functionaries of Kerala State and certain other entities, including Exalogic Solutions Pvt. Ltd., a company owned by Veena T., daughter of Kerala Chief Minister Pinarayi Vijayan, by Cochin Minerals and Rutile Ltd (CMRL) necessitated a probe by the Serious Fraud Investigation Office (SFIO), the Centre told the High Court of Karnataka on Monday.

A statement in this regard was submitted before the court during the hear-

ing on a petition filed by Exalogic.

"An offence of such scale and grave nature that directly affects public interest would definitely merit an investigation by the SFIO," it has been contended in the statement.

Justice M. Nagaprasanna, who heard the arguments by advocate Arvind P. Datar on behalf of the Exalogic and Additional Solicitor-General of India Arvind Kamath, reserved the order on the petition.

Further, the MCA has alleged in the statement that Exalogic has 'not come to the court with clean hands'.

Pakistan in turmoil

Instability will follow any attempt to subvert the mandate for Imran Khan

Pakistan's elections, on February 8, were not held on a level-playing field. Former Prime Minister Imran Khan, arguably the most popular politician, has been in jail since May 2023, facing multiple cases and serving convictions. His party, the Pakistan Tehreek-e-Insaf (PTI), was barred from using its symbol on the ballot paper, forcing it to field independent candidates. Many of its leaders were also in jail or on the run, while others were forced to quit politics or defect to another party. What Pakistan saw in the run-up to the elections was a systematic effort by powerful quarters to dismantle Mr. Khan's political vehicle. Pakistan Muslim League-N (PML-N) leader Nawaz Sharif, once the nemesis of the army, who returned from exile in London, led his party's campaign with the establishment's blessings. But if the generals thought these measures would destroy the PTI's political leverage and catapult their favourites to power, they were proven wrong by voters. Independents won 101 of the 265 seats (93 went to PTI-linked candidates), the PML-N secured 75 seats while the Pakistan People's Party (PPP) won 54, and the Karachi-based Muttahida Qaumi Movement-Pakistan took 17. To form a government, 134 seats are needed.

This does not mean that the PTI, whose independent candidates form the largest bloc, would be able to form the next government. When it was evident that no bloc had an absolute majority, Nawaz Sharif called on every party, barring the PTI, to form a unity government. With Army Chief Gen. Asim Munir backing Mr. Sharif's call, what followed was an in-principle agreement between the PML-N and the PPP "to work together for political stability". All these developments point to political manoeuvring aimed at stitching together a unity government that will keep the PTI and Mr. Khan out of power. The independents could also come under pressure to switch to the coalition parties. The PTI, which has already alleged electoral irregularities, has called for street protests, triggering memories of the widespread clashes in May 2023 after Mr. Khan's arrest. The military may have wanted to turn the page of Mr. Khan's challenge and create a new political reality through the electoral process, but the results have underscored his popularity and public anger towards the establishment. For a long-term solution, the generals should make peace with Mr. Khan and allow the spirit of the results to prevail — an unlikely outcome. As political parties that finished second and third are moving ahead with their plans with blessings from the establishment, public discontent and distrust would remain the unresolved issues. With the PTI's challenge from the streets, Pakistan could face another cycle of instability and chaos.

The real travesty

A Governor who profoundly disagrees with State govt. should not stay in office

The Governor's customary address to the legislature at the first session of every year is being increasingly politicised. More often than not, those responsible for such unseemly controversies overshadowing the solemn occasion are the incumbents in Raj Bhavan. In the latest instance, Tamil Nadu Governor R.N. Ravi has expressed his inability to read out the address prepared by the DMK-run government, citing what he termed "misleading claims and facts" in numerous passages. Reading them out, he claimed, would have made the Governor's address "a constitutional travesty". Compounding this constitutional mischief with a partisan claim, he sought to make much of the fact that the national anthem is played only at the end of the address and not at the beginning also. Anyone who understands the Governor's role in a parliamentary democracy will know that it is the one declining to read out the address prepared by an elected government who reduces the address to a travesty. Governments are run by parties that contest elections on a political platform, and it is only to be expected that they would seek to trumpet their achievements, real or exaggerated, in policy statements. It is the role of the political opposition and the people to judge the content of the address, and not that of the Governor.

A simple test to ascertain the tenability of Mr. Ravi's claim that he declined to read out the customary address on factual and moral grounds is to raise the question whether either the President or a Governor in a Bharatiya Janata Party-ruled State would ever do so. He did not spell out what exactly the misleading or factually wrong points were, but it is not constitutionally sustainable to claim that the Governor's address should contain no criticism of the Centre or make no policy pronouncements against the Centre's policies. However, his point that the Speaker should not have launched a tirade against him after reading out the Tamil version of the Governor's prepared speech is justified. Such conduct by constitutional functionaries detract from the Assembly's dignity. The larger issue is still the propensity of Governors to act as political agents of the ruling party at the Centre. It is an unfortunate feature of India's constitutional system that the country is never short of grey eminences eager to occupy gubernatorial office, but once appointed, they are equally eager to enter the political thicket. It is as if they believe that their duty is to obstruct and undermine State governments run by political adversaries. The real travesty is not in a formal address containing questionable claims, but in a Governor who disagrees profoundly with its policy while remaining in office.

Gandhiji breathed his last in 1948 with 'Hey Ram' on his lips. Lord Ram was an influence on Mohandas Karamchand Gandhi since his childhood. As the Mahatma noted in his autobiography, that being of the Vaishnava faith since birth, visiting the temples of Rama and Krishna was his habit. But the temples did not instil faith in the boy Gandhi. He noted, "But what I failed to get there, I obtained from my nurse, an old servant...Rambha, that was her name, suggested as a remedy for this fear, the repetition of Rama-nama (the name, Rama)." It became an infallible remedy for him for the rest of his life. However, the Rama-nama which he refers to is no longer the idol to be found in a temple, nor a recitation as a ritual. Instead, it was something deep within the heart.

Rooted in spirituality

Gandhi brought religion into politics. But his religion had its roots in spirituality. Gandhian scholar Raghavan Iyer notes in his book, *The Moral and Political Thought of Mahatma Gandhi*, that Gandhi sought to make politics religious and religion practical. In this effort, he built upon a neglected strand of Indian tradition — the path of karma yoga or spiritual realisation through social action. This was action of the kind associated with classical heroes such as Rama and Janaka, and reaffirmed in modern India by Vivekananda and Aurobindo.

Gandhi aimed to work for the purification of politics and reform formal religion. He gave new meaning to Rama, Rama-nama and *Ramarajya* in his discourse. His own journey of continuous self-purification was by chanting Rama-nama from the depth of his heart in the form of prayer.

In the *Harijan*, issue dated March 18, 1933, Gandhiji referred to three questions raised by an 'iconoclast schoolmaster' and answered them.

The first was: "Is it necessary for a Hindu, following the life of Shri Ramachandra, also to go and see his image in the temple? Is *darshan* better than action?"

The second: "If we bow our head or join our hands before a living person, he replies in return, but the image does not. Then what is the use of doing it? What is the use of writing letters to one who never replies?"

The third: "The person, whose image a Hindu adores, might have committed some wrongs in his lifetime. Will not the adorer be harmed by

The politicisation of religion, which does not augur well for the country, is the reverse of what Gandhi stood for

copying those wrongs, which he is likely to copy if he worships his image?" [*The Collected Works of Mahatma Gandhi*, Volume 54, pp.111-112, Art.125-Posers]

Gandhi held it unfortunate that Rama who should be inside the self is sought in the image. Yet, Gandhi would not disturb the "simple faith" that saw Ram only in the temple. Gandhi's response was as follows: "It is not necessary for any Hindu to go to a temple to worship (the image of) Ramachandra. But it is for him who cannot contemplate his Rama without looking at his image in a temple. It may be unfortunate, but it is true that his Rama resides in that temple as nowhere else. I would not disturb that simple faith."

But deed, or action, was more important than the *darshan*. Mute worship constitutes the letter to god. God is not only in the temple. Gandhi wrote that he did not make any distinction between temple, mosque and church.

On the third question, he wrote, "Though my reason and heart long ago realised the highest attribute and name of God as Truth, I recognise Truth by the name of Rama. In the darkest hour of my trial, that one name has saved me and is still saving me" [*The Collected Works of Mahatma Gandhi*, Volume 54, p.112].

In all of Gandhi's speeches, articles and letters, Rama, Rama-nama and Tulsidas's *Ramcharitmanas* (Ramayana) have been mentioned, commented on and invoked hundreds of times.

Gandhi's Rama

Who is Gandhi's Rama? Is he a Hindu god? He has clarified this several times. In his prayer meeting on April 4, 1946, at Birla House, Delhi, Gandhi said the following. "I laugh within myself when someone says that Rama or the chanting of Rama-nama is for the Hindus only, and that how can Mussalmans (Muslims), therefore, take part in it? Is there one God for the Mussalmans and another for the Hindus, Parsis or Christians? No, there is only one omnipotent and omnipresent God. He is named variously, and we remember Him by the name which is most familiar to us. My Rama, the Rama of our prayers, is not the historical Rama, the son of Dasaratha, the King of Ayodhya. He is the eternal, the unborn, the one without a second. Him alone I worship, His aid alone I seek, and so should you. He belongs equally to all. I, therefore, see no reason why a

Musalman or anybody should object to taking His name. But he is in no way bound to recognise God as Ramanama. He may utter to himself Allah or Khuda so as not to mar the harmony of the sound" [*The Collected Works of Mahatma Gandhi*, Volume 83, p.364].

Gandhi knew the deep and serious implications of upholding Rama as a role model and Rama-nama as a cure for all ills in India where people from many religions live and where the Hindu-Muslim conflict is more than a century-old and the schism was deepened by the British with intent. Hence, he was always careful not to visit temples, mosques and churches. But he used the symbols from Hindu traditions and the religion to which he was born.

In 1929, at a public meeting in Bhopal, he said, "I warn my Muslim friends against misunderstanding me in my use of the word *Ramarajya*. By *Ramarajya*, I do not mean Hindu Raj. I mean by *Ramarajya*, a divine raj, the Kingdom of God. For me, Rama and Rahim are one and the same deity. I acknowledge no other God but the one God of Truth and righteousness." This was Gandhi's religion in politics and public life.

Gandhi further wrote: "Whether the Rama of my imagination ever lived or not on this earth, the ancient ideal of *Ramarajya* is undoubtedly one of true democracy in which the meanest citizen could be sure of swift justice without an elaborate and costly procedure. Even the dog is described by the poet to have received justice under *Ramarajya*."

The present day

It is important to record Gandhi's Rama, Rama-nama and *Ramarajya* in today's context. The politicisation of religion is the reverse of what Gandhi stood for. It does not augur well for the country. The Prime Minister of a country, which by its Constitution is a secular state, should have sent enormous good wishes on the occasion of the consecration of the Ram Temple built on the basis of a judgment of the Supreme Court. India claims to be a multi-religious and multicultural society and a Prime Minister appearing partisan to one religion, notwithstanding his religion, faith and dedication, has not sent out healthy signals. This is a celebration in a place where Gandhi's Rama is not likely to be found.

Periodic Labour Force Surveys). Female enrolment in higher education has gone up by 28% in the last 10 years. In terms of enrolment in science, technology, engineering, mathematics (STEM) courses, the share of women is a significant 43%, which is one of the highest enrolment rates in the world. Even within rural India, there is a participation of over nine crore women in 83 lakh self-help groups, improving the socio-economic conditions in rural areas. All these provide a glimpse of women-led development that India is witnessing.

The state of the Indian economy today

The state of the Indian economy today and its prospects have to be based on mathematics and statistics. We can get a reality check on the economic growth rate by examining the three conclusions that emerge today based on data published by the National Statistical Office. This helps us analyse the Modi government's economic performance as disclosed in Parliament and subsequently published in the media.

What the data say

First, India's GDP growth rate declined annually from 2016-17, and fell below 3.5% in the fourth quarter of 2019-20. This four-year continuous decline from a 7% growth rate to 3.5% rate has never been acknowledged by the government. Second, it is essential to recognise that since 2020, Prime Minister Narendra Modi's widely publicised 'vikas' or development model in reality achieved the so-called "Hindu rate of growth" in GDP, which had been "achieved" during the Congress's socialist period of 1950-77. Third, in P.V. Narasimha Rao's and Manmohan Singh's tenures as Prime Minister, India departed from the socialist path and the GDP growth rates rose for the first time to 6%-8% per year and over a 15-year period i.e., between 1991-96 and 2004-2014 (with the usual cyclical ups and downs). That is, it took Rao and Dr. Singh to understand and reform the Indian economic system, reduce state participation, and increase incentives for capital and labour providers, and achieve a higher and faster growth rate.

What is alarming since Mr. Modi assumed office is the serious and continuous decline in the GDP growth rate. The decline had begun in 2016 and continues even today. The Modi government has thus failed to structure economic policy coherently. Incoherence prevailed during the 2014-2023 period and will perhaps continue in the future as well.

Furthermore, not only has the GDP growth rate been declining since 2016, but brazen announcements of rosy predictions were and are being published annually in the media, with outrageous claims made by Mr. Modi. One such claim made in 2019 was that India will become a \$5 trillion economy by 2024. This implied a doubling of the GDP in five years or, in other words, a 15% annual growth rate of GDP. There has been no policy structuring presented to achieve this aim nor has anyone in the government shown willingness to debate it on public fora.

Post-COVID-19, we hear and read in the media that the growth rate of GDP is around 6% + annually. But this is misleading and deliberately so because what is not disclosed is that the growth rate includes recovery as well, since 2020-22. Hence, if we calculate the GDP growth rate between 2019-20 and 2022-23, two normal years, it works out to less than 4% per year for the period. The Modi government was elected democratically. Hence, it is obligated to disclose facts transparently to the people.

In this decade of weak demand and relatively excess supply, resources mobilised by the government should be largely through indirect taxes and also through the liberal printing of currency notes to generate demand from non-rich citizens. The annual interest paid on fixed-term savings in the bank accounts of the middle class should be higher, at 9% or so. The interest rates on loans issued to small and medium industries should be no more than 6% on the loans. These essential reforms need to be carried out to generate non-inflationary demand.

A new economic policy

"Modinomics" has been an unstructured flop. No announced macroeconomic goal has been achieved by the government till date. Thus, India urgently needs a new economic policy that is based

on clearly structured and stated objectives and priorities, and a strategy to achieve the targets, with an intelligent and transparent resource mobilisation plan to finance the policies. At present, from the Finance Ministry, we only have an incoherent hotchpotch of public announcements with no accountability.

The market system is not a free-for-all or ad hoc measure. It is structured with rules of transactions. A market system with transparent and minimal regulation works since the principal drivers are incentives and domestic savings whose deployment for innovation pushes the GDP growth rate. Even a totalitarian state such as China understood this. During Deng Xiaoping's tenure as paramount leader, it allowed the socialist economic system to die, and the economic market-based system to wash in, even while maintaining the system of political dictatorship.

The trade-offs through affirmative action, social security, and safety nets are essential for creating a stake for the poor in the system and level the playing field to create hope, ensure transparency, accountability, trusteeship [philanthropy] as well as corporate governance to legitimise profit-making that will drive the market system. Deregulation should also not mean that we reject government intervention for safety nets, affirmative action, market failures, and creating a level-playing field.

Democratic institutions have to be empowered to guard against public disorder arising from rapid deregulation, as it happened in Russia post-1991. Russia underwent chaos and misery, which meant dictatorship returned for the Russians, and with it came a loss of human rights and democratic values. The current slow slide to autocracy would lead to what has happened in Russia.

Telangana's education paradox

While gross enrolment ratio in school is poor, students do well in competitive exams

Telangana presents a rare paradox in the education sector. Its students perform exceptionally well in the All India Joint Entrance Examination every year. In 2023, 11 out of 43 students scored 100 percentile, the highest among all States. But the Annual Status of Education Report for 2022 makes for grim reading. The State also has the highest share of students in the 14-18 group who are not in the education system. Ironically, the students from the State who crack national competitive exams are from the same age group.

Other States with poor social indicators are better off than Telangana. While 22.1% of children in the age group of 14-18 in Telangana were out of the education system, the national average was 13.2%. School students in the State don't have skills that match their counterparts in other parts of the country. For instance, nationally, 43.3% of students could do basic arithmetic calculations, while in Telangana, only 19.75% could do so in the 14-18 age group.

Low investment in education by successive governments lies at the heart of the problem. The State has 3,274 junior colleges of which only 420 are managed by the State government. But it has 1,349 privately run junior colleges, most of them in urban areas. The result is that many students have to travel long distances to reach college. The State also runs other residential junior colleges and facilities, but the admission for them is through a competitive exam. This also keeps a high

share of students out of the education system.

The interim Budget presented by the incumbent Congress government appears to recognise both the quality of education and the funding gap for the sector. "Our government's biggest priority will be school education. Apart from providing the required funds for various facilities and schemes on a regular basis, the government has decided to set up digital classrooms in the schools," said the Finance Minister, Mallu Bhatti Vikramarka, in his maiden Interim Budget speech. Funding has been raised from ₹18,955 crore, earmarked in the 2023-24 Budget, to ₹21,839 crore – a substantial increase of 15.21%. But this is not enough. Telangana has consistently under-spent on the education sector over the past decade. The budgetary outlay for education in 2014-15 was 10.89%. If the State had maintained the same pace of sectoral outlay, the education budget for 2024-25 should have been ₹30,044.53 crore.

When the Telangana Rashtra Samithi came to power, it used the slogan of 'KG to PG' free education for the poor. But the investment required to fulfil the promise was never made. The State managed to build only one show-piece facility in Sircilla, the Assembly constituency of former Municipal Administration and Urban Development minister K.T. Rama Rao. Even this was

not developed with State funding, but with monies under Corporate Social Responsibility from a building conglomerate.

NGOs in the State have been highlighting the abysmal state of educational infrastructure by sharing information and photographs of schools without boundary walls and of cattle roaming around in dysfunctional washrooms. The high dropout rate among girls of the 14-18 group is directly linked to the absence of hygienic toilet facilities.

The quality of education has been affected by the slow pace of recruitment in the education sector which has scuppered the hopes of lakhs of aspiring teachers. In 2019, the State government appointed eight serving Indian Administrative Service officers as in-charge vice-chancellors as an ad hoc measure after the tenure of the vice-chancellors ended. The universities which had IAS officers as vice-chancellors included Kakatiya University, Jawaharlal Nehru Technological University-Hyderabad, and Osmania University. Only in May 2021 did the universities get academicians as full-fledged vice-chancellors. It was clear that the State cared little about educational institutions.

One of the United Nations' Sustainable Development Goals is to "ensure inclusive and equitable quality education and promote lifelong learning opportunities for all". It is clear that Telangana will not achieve this goal in time. It will also be unable to achieve the goal of ensuring 50% Gross Enrolment Ratio goal in higher education by 2030, a stated goal of the Union government. It is time for the Telangana government to follow through on its promises in education.

A record number of global voters exercise right in 2024

Many countries have a low score in the index that measures free and fair polls; India ranks somewhere in the middle

Over 50 countries in which close to 45% of the people in the world reside have gone to the polls or will go to the polls this year. This only includes those countries which conducted or will conduct national-level polls this year or are part of the nations which choose the European Parliament. Countries conducting local elections have been ignored. With the world's population on the rise and many countries having elections this year, estimates indicate that 2024 could see the highest number of votes polled in history.

Most of these elections are concentrated in Asia, Europe, and Northern America. Some countries from Africa and South America also choosing their leaders this year. **Map 1** shows the countries which are going to the polls or have already completed elections this year. The countries in Europe that are only voting for the European Parliament and are not choosing their country's government have been highlighted with a different colour.

An assessment of how free and fair the elections are in these countries shows that democracy is on the retreat in many of them. Only a few countries showed improvement in this area. To measure the fairness of elections, **Chart 2** arranges countries according to their scores in the free and fair elections index 2022. This is prepared by the V-Dem Institute based on expert assessments. It captures the extent to which election violence, government intimidation, fraud, large irregularities, and vote buying are absent in a country. It ranges from 0 (least free and fair) to 1 (most free and fair). The bigger the size of the circle in the chart, the higher the voting population of the country.

Comoros, the archipelagic

country in Africa, fared the worst in the 2022 index. According to news reports, President Azali Assoumani was re-elected for the fourth term in January. The Opposition termed the poll "fraudulent". Voter turnout was very low at 16% as the Opposition boycotted the polls. Countries in the subcontinent including India, Bangladesh, and Pakistan were either middling or in the lower half of the index. The two major parties in Pakistan are fighting over who will be Prime Minister, with Imran Khan, one of the candidates for the post, in prison. On the day of the polls, there was a mobile Internet shutdown and the results were delayed. Recently, a Mayor election in Chandigarh, India, was heavily criticised by the Supreme Court for the manner in which a BJP candidate was declared as winner. In the videos, the presiding officer appears to be defacing ballots which the Chief Justice of India called a "mockery of democracy".

Fellow Asian countries such as Russia, Uzbekistan, Indonesia, Cambodia, and Mongolia also rank relatively low in the index. Earlier this month, in Russia, Boris Nadezhdin, who opposes the invasion of Ukraine, was not accepted as a candidate for the presidential election in March. Of the one lakh signatures of supporters he is supposed to get to prove his worth as a candidate, 9,000 were rejected by the Election Commission as invalid. India, with a score of 0.53 is right in the middle of the index.

Chart 3 shows the change in the free and fair elections index between 2012 and 2022. Comoros, India, Hungary, Bangladesh, Poland, and El Salvador are among the countries where the index has deteriorated the most in the past decade. Only countries which showed at least some degree of decline in the index or improvement are depicted in the chart. Uzbekistan, Romania, and Togo are countries which have shown improvement in the index in the last decade.

Democracy on the decline in many nations

Map 1: The map shows the countries going to the polls or have already completed elections in 2024

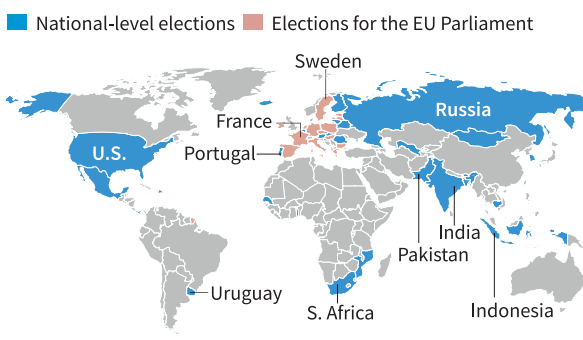


Chart 2: The chart shows the free and fair elections index, 2022. The bigger the size of the circle, the higher the voting population of the country

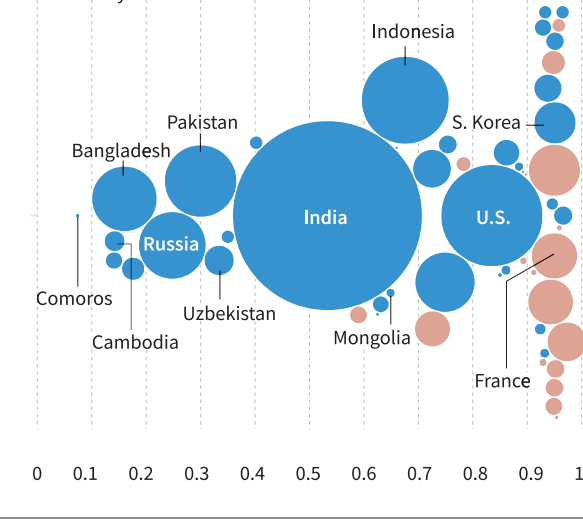
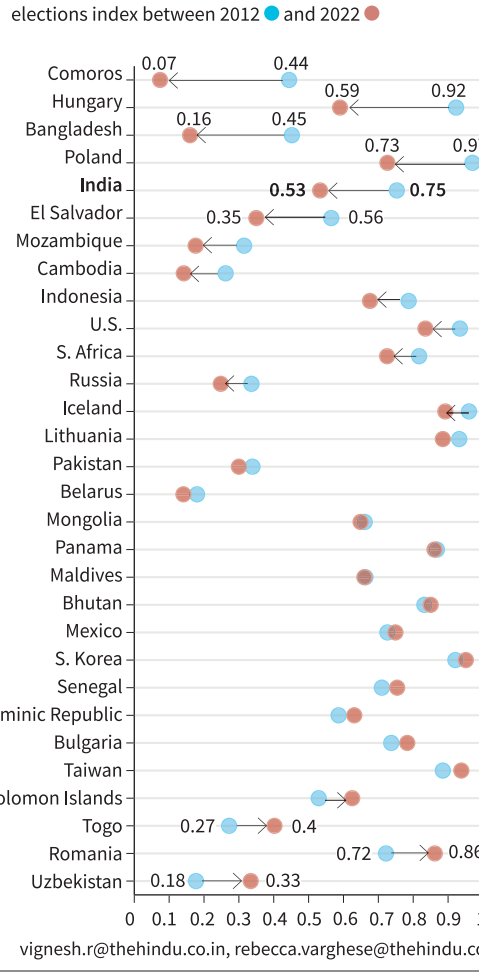


Chart 3: The chart shows the change in the free and fair elections index between 2012 and 2022

Trunk automatic exchanges for more towns

Madras, Feb. 12: Trunk Automatic Exchanges (TAX) would be installed at Coimbatore, Madurai and Tiruchi during the Fifth Plan, Mr. Janakiraman, Post Master General, Tamil Nadu Circle said here to-day.

Mr. Janakiraman said besides this, the capacity of the TAX at Madras would also be increased. Already Bangalore and Coimbatore had been connected to this, providing inter-dialling facility.

Work had also been commenced on the coaxial scheme linking Coimbatore, Tirupur, Erode, Salem and Bangalore. A similar scheme to link Madurai with Virudhunagar, Tirunelveli, Tuticorin, Nagercoil and Trivandrum had also been approved. Madras would also be linked with Tiruchi via Pondicherry.

These systems were likely to be completed during the Fifth Plan.

A microwave scheme linking Madurai, Kodaikanal, Theni and Coimbatore was expected to be completed during 1974-75, he said.

Mr. Janakiraman said a wide-hand microwave project linking Madras with Bombay and Trivandrum via Bangalore, Mangalore and Panjim would be commissioned by 1976-77. Under this project, a spur route linking Madras with Tirupathi had also been provided and expected to be commissioned during 1974-75.

Mr. Janakiraman said the number of new Savings Bank accounts in October 1973 was 19,000 and it shot up to 50,000 in November of the same year. The deposits had also risen from Rs. 2.5 crores in April 1972 to Rs. 5.4 crores in November 1973.

New Railway in East Africa

Nairobi, Feb. 12: Sir Robert Coryndon opened at Eldoret on Monday the new Uasin Gishu Railway, which has been completed as far as Eldoret. 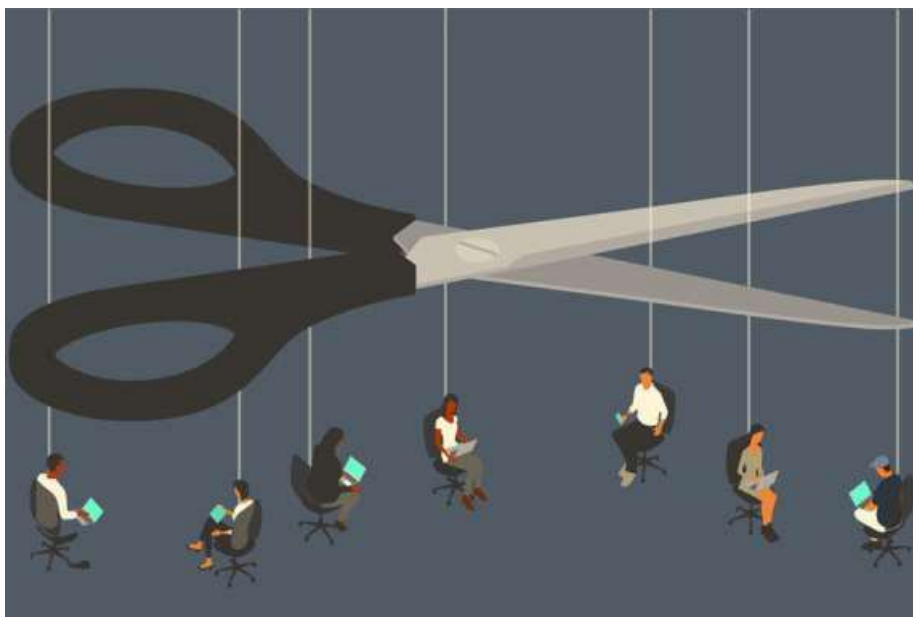

This is the second of a two-part series on the Union Budgets under the UPA and NDA governments.

The National Democratic Alliance (NDA) regime has done little to address the major supply side factors driving food inflation, beyond imposing ad hoc export bans. While cash transfer schemes like PM-Kisan or the distribution of free foodgrains to poorer households can provide much needed income support and relief, they can neither improve agricultural productivity nor modernise storage and marketing of food items like vegetables, pulses and cereals, whose prices are driving food inflation today. The only method conceived by the NDA to address these issues was to facilitate a wholesale corporate takeover of India's food and agricultural economy by enacting three farm laws in September 2020, which had to be eventually rescinded following a year-long protest by north Indian farmers. Since then, the NDA-II government has remained as clueless as the UPA (United Progressive Alliance)-II was, in dealing with food inflation and agriculture.

The second problem with UPA's growth story was that while exports grew rapidly, imports grew even faster, partly due to rising global crude prices, which worsened the current account balance and increased external vulnerability. During the NDA regime, both export and import growth declined, which impacted economic growth adversely but improved the external trade balance. Further, during the NDA decade, net FDI inflows increased as a share of GDP but remittance inflows, which remained significantly higher than net FDI inflows, declined compared to the UPA decade. The end-result has been mixed.

The fall in India's foreign exchange reserves during NDA-I could be reversed during NDA-II, but the rupee has continued to depreciate vis-a-vis the dollar. The rupee-dollar exchange rate, which fell from ₹43 to ₹60 per dollar during the UPA rule has fallen further to ₹83 during NDA's tenure. In the context of the post-pandemic surge in global inflation last year, the rupee depreciation has only imported the inflationary trend into the domestic economy.

The problem of NPAs

The third problem with UPA's higher growth and private investment phase was

that it led to rising big ticket corporate defaults, initially concealed through debt restructuring, which ultimately left a huge pile of legacy Non-Performing Assets (NPAs) in the banking system. The Modi government is claiming credit for restoring the health of Public Sector Banks (PSBs) by reducing the Gross Non-Performing Assets (GNPA) stock significantly. The fact remains that while cumulative NPA reduction under the NDA rule through all recovery channels, including the Insolvency and Bankruptcy Code was around ₹10.8 lakh crore (till March 2023), NPA write-offs have amounted to over ₹14.8 lakh crore in the same period (Table 1).

The PSBs, which accounted for over ₹10.65 lakh crore of these NPA write offs had to absorb substantial losses because of NPA provisioning, making net losses between 2017-18 and 2019-20. Simultaneously, since 2017-18 massive doses of capital was infused into PSBs and financial institutions like the EXIM Bank, the Industrial Development Bank of India (IDBI) and the India Infrastructure Finance Company Limited (IIFCL), in order to bail them out. As disclosed in the Receipt Budgets, the Centre's total debt burden on account of these recapitalisation bonds have increased to ₹2.90 lakh crore by 2023-24, and their annual interest expense of over ₹19,000 crore is being met through the central government's revenue expenditure since 2019-20. Bank recapitalisation under the UPA rule, which was of a much smaller magnitude, was audited by the Comptroller and Auditor General of India (CAG), covering the period between 2008-09 to 2016-17. However, bank recapitalisation executed under the NDA rule has not been audited by the CAG so far. Such an audit is necessary to evaluate the massive NPA write offs by the PSBs and conclude whether private sector debt defaults have been subsidised through the public exchequer.

Income and employment

The efficacy of Union Budgets needs to be judged in terms of their impact on the lives of ordinary people. The Finance Minister has claimed in the Budget speech that under NDA rule "people are living better and earning better, with even greater aspirations for the future. Average real income of the people has increased by fifty per cent." However, how true is this claim? Official data shows that real per capita income in India, estimated by the inflation-adjusted Net National Income (NNI), registered a growth of 50.3% during the ten years of UPA rule (Table 2). During NDA's ten year rule, real per capita income grew by 43.6%, reflecting a slowdown in inflation adjusted income growth across India.

UPA vs NDA: macroeconomic indicators

The efficacy of Union Budgets need to be judged in terms of their impact on the lives of ordinary people. These tables look at the average income and employment status of the average Indian citizen

The NDA government often cites the annual Periodic Labour Force Survey (PLFS) findings to claim a reduction in the unemployment rate between 2017-18 and 2022-23. However, comparable estimates from the NSS 68th round on Employment and Unemployment Situation in India, shows that unemployment rates, estimated by both current weekly status and adjusted usual status, grew very sharply between 2011-12 to 2017-18 (See Table 3). Moreover, while the unemployment rates declined between 2017-18 and 2022-23, the open unemployment rates of 2022-2023 were still higher, not only vis-a-vis the NSS 68th round of 2011-12, but compared to all the eight previous NSS rounds conducted since 1972-73. The open unemployment rates have never been so high in India in the last 50 years. Unemployment was particularly high among the urban youth aged 15 to 29 years and among those with an educational level of secondary and above. Within those employed, the share of casual workers show a declining trend both in rural and urban areas, while the proportion of self-employed have increased progressively. In 2022-23, self-employed workers and helpers in own account enterprises made up 63% of the rural labour force and almost 40% of the urban labour force. The share of regular wage/salaried workers has declined in rural areas and increased in urban areas between 2017-18 and 2022-23. However, the share of those without any social security benefit has increased within the salaried workers category.

Even as agriculture's share in Gross Value Added (GVA) has declined to 14.4% in 2023-24, there has been an increase in the share of workers engaged in agriculture between 2017-18 and 2022-23. The share of workers engaged in informal non-agricultural enterprises has also increased since 2011-12. These trends in employment status from the PLFS data point towards growing informalisation of the labour force, contrary to official claims of increased formalisation.

Skilled but not employed

The Finance Minister had claimed in the Budget speech that the government's "Skill India Mission" has trained 1.4 crore youth and 54 lakh youth have been up-skilled and reskilled. However, the dashboard in the official site of the PM Kaushal Vikas Yojana shows that out of 1.10 crore certified candidates, only 24.51 lakh, that is around 22%, have been "Reported Placed". Such excess supply of skilled workers in the economy and growing informalisation is working as a dampener on wage and earnings growth. PLFS data further show that the average earnings of casual labour in non-public work to be ₹8,547 in 2022-23, that of self-employed workers to be ₹13,347 and that of regular wage/salaried workers to be ₹20,039. While casual labourers' average earnings has grown by around 49% in five years since 2017-18, and regular wage/salaried workers by 19%, average earnings of self-employed workers rose by 8.5% only in five years. With annual retail inflation rate averaging 6% during NDA-II's tenure, less than 2% annual growth in average earnings for the self-employed clearly indicate a decline in their real earnings. 57% of India's labour force engaged in self-employment, are certainly not "living better and earning better", as the Finance Minister would want us to believe. It is their hopes and aspirations that stand betrayed.

The political preferences of first-time voters in Delhi

Data suggests a significant preference for the Bharatiya Janata Party among first-time voters when it comes to running the government at the national level. The study also dissects specific issues that resonate with the younger generation

A recent study done by the Lokniti-CSDS among 1,290 first-time voters (47% young men and 53% young women) in Delhi, delves into the intricate realm of their political preferences. The study not only explores their choice of party for governance at both national and State levels but also dissects the specific issues that resonate with the younger generation. Recognising the strategic importance of engaging with this group, political parties are actively initiating efforts to reach out to millions of first-time voters. This outreach seeks not only to establish a connect but also to secure their support for the upcoming 2024 Lok Sabha elections.

On governing States and the nation

The data suggests a significant preference for the Bharatiya Janata Party (BJP) among first-time voters when it comes to running the government at the national level. The BJP has a substantial lead with 70% support, indicating a widespread belief among first-time voters that the BJP is best suited for national governance. The Congress and the Aam Aadmi Party (AAP) lag significantly behind in this context (Table 1). However, when it comes to governance at the State level, particularly in Delhi, the dynamics shift. AAP secured the preference of 49% of the youth, closely followed by the BJP at 33%. Meanwhile, the Congress garnered a minimal mention, with only 3% of young voters expressing support for the party (Table 1).

Upon examining specific issues relevant to the youth, it becomes evident that the Bharatiya Janata Party (BJP) stands out as the preferred choice for addressing youth-related challenges and creating employment opportunities. In contrast, other political parties have limited support in this regard. Interestingly, a notable three in ten voters expressed that no party adequately prioritises these critical issues (Table 2). However, when it comes to providing quality education, a distinct competition emerges between the AAP and the BJP. An almost equal number of young voters perceive both parties as strong contenders in this crucial area.

On gauging young respondents' opinion on the Narendra Modi government we asked them what work done by the Modi government did they like the most. Development emerged as the most appreciated aspect, garnering 20% approval, followed by 11% acknowledging the government's efforts in protecting religious interests. Other mentions include 6% approval for maintaining law and order, 5% for initiatives to enhance women's security, and 4% each for reducing unemployment, improving education, and aiding the underprivileged (Table 3).

On the contrary the most disliked work of the Modi government reveal diverse concerns. For 17% of first time voters it was an increase in communalism. Following closely, 15% expressed discontent with the issue of price rise, while 12% were critical of the government's handling of increasing unemployment. A 3% disapproval rate is observed for multiple aspects, including a

rise in corruption, the belief that the government did not work for the benefit of the poor, concerns about the education sector, and the increase in crimes against women (Table 4).

On the temple inauguration

In exploring the perspectives of first-time voters on critical issues, we inquired about their opinions on the caste Census and their stance on the inauguration of the Ram Mandir.

With respect to the caste Census, the data indicates an equal divide regarding the need for conducting a caste Census in India. While 48% favoured the idea of conducting a caste Census, 46% believed it to be unnecessary (Table 5).

With the recent inauguration of the Ram Mandir at Ayodhya, we asked first-time voters how they felt about the construction of the new temple. More than two thirds (67%) expressed a deep sense of pride and another one sixth (15%) indicated being somewhat proud, suggesting an overall positive mood. However, there was a notable one sixth – 8% who reported not feeling much pride, and an additional 8% expressing no pride at all regarding the construction of the temple. (Table 6).

A further question was posed regarding the significance of the grand celebration, questioning whether it was truly essential or if its inauguration was strategically aligned with the upcoming 2024 Lok Sabha elections to secure a favourable vote bank. On this matter, the younger generation expressed divergent opinions, with a nearly equal split between those viewing it essential and those asserting its connection to political motives (Table 7).

Upon examining the vote preferences of the young who are planning to vote in the upcoming Lok Sabha elections, two thirds (67%) expressed their intent to vote for the BJP. The Congress party garnered the preference of 8%, while AAP secured the support of 7%. The collective mention of all other parties amounted to 4%. Notably, 16% of respondents chose not to disclose their voting intentions. The findings of the study emphasise the continuously growing popularity of Mr. Modi, a discernible factor that significantly shapes the voters' preference in favour of the BJP.

Will stop Modi juggernaut in Bihar: Tejashwi Yadav

RJD leader asks if the Prime Minister can guarantee that Nitish Kumar will not switch sides again; he comes down hard on the Chief Minister for snapping ties with the grand alliance in the State

Rashtriya Janata Dal (RJD) leader Tejashwi Yadav on Monday came down hard on Bihar Chief Minister and Janata Dal(U) leader Nitish Kumar for joining hands with the BJP-led National Democratic Alliance (NDA).

Launching a scathing attack on Mr. Kumar for snapping ties with the Mahagatbandhan (grand alliance), Mr. Yadav quoted the Chief Minister as saying "Mann nahi lag raha tha (was not liking it)" after tendering his resignation.

"We were not with you to sing and dance to entertain you, we had supported you to do work," Mr. Yadav said. The RJD and the Congress were part of the grand alliance.

The RJD leader said he had never witnessed a person taking oath as Chief Minister nine times, of which three were in a single term. Mr. Yadav also criticised BJP leader Vijay Kumar Sinha, saying that he too had

made a new record of sorts by becoming Deputy Chief Minister, Speaker, and Leader of the Opposition in the same term.

'Respectable person'
He compared Mr. Kumar to King Dashrath (father of Lord Ram) and warned him to be aware of the "Kaikayi" in his fold.

"Nitishji was always a respectable person for me and will remain respectable in future as well. Many

times, he used to tell me that I was like his son, and I too respected him as my guardian. I used to respect him like King Dashrath who always promoted me. There must be some compulsion the way Dashrath had in form of Kaikeyi due to which he deserted you. You should be aware to find who is Kaikeyi in your team," Mr. Yadav said.

He stressed that the people of Bihar wanted to know the reason for the

frequent flip-flops. "When you had snapped ties with the BJP you said that you will prefer to die rather than be with the BJP. You had also said that you are not interested in becoming Prime Minister and your only goal was to unite Opposition to defeat the dictatorship government of the BJP in the 2024 Lok Sabha poll," Mr. Yadav said.

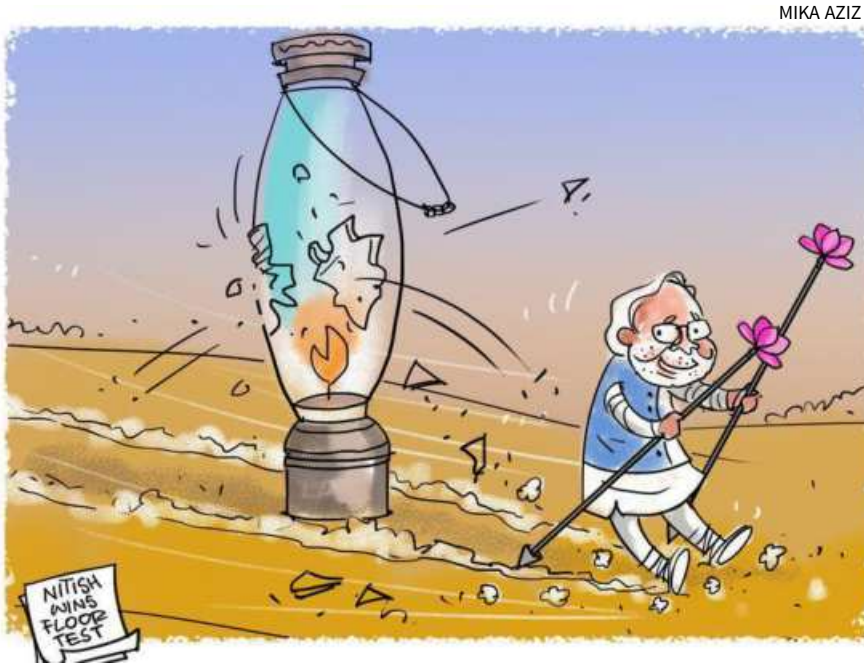
The RJD leader said the BJP MLAs always make big claims about "Modi ki guarantee" and asked whether Prime Minister Narendra Modi can guarantee that Mr. Kumar would not make another U-turn.

Odisha to give ₹1,000 to all families under PDS

In the backdrop of upcoming elections, the Naveen Patnaik government on Monday announced to provide one-time livelihood assistance of ₹1,000 in cash to each of the over 95.90 lakh families covered under the Public Distribution System (PDS).

The government also declared launch of 'SWAYAM' under which ₹1 lakh of interest-free bank

loans will be provided to all rural unemployed youths aged between 18-35 years (18-40 years for special ca-

tegor) for initiating new business venture.

It is to be noted that 95.90 lakh families comprising 3,35,98,401 members have been covered under the PDS in the State. The government will spend ₹959.05 crore towards the payment of assistance. The State government had disbursed similar assistance during the COVID-19 pandemic.

The government has also decided to provide free of cost two jute carry bags

of 20 kilogrammes and 10 kg capacity to each of the PDS families for their daily use at a cost of ₹278.69 crore.

As far as 'SWAYAM' scheme is concerned, rural youths having family income less than ₹2 lakh are eligible for receiving ₹1 lakh loan. To cover 1 lakh eligible rural youths initially, the government would spend ₹448 crore out of its own budget and the scheme will be operational for a period of two years.

80% of people have not benefited from BJP rule, says Rahul

Criticising the BJP's focus on religious symbolism, Congress leader Rahul Gandhi said on Monday that while the ruling party spoke of "Hindu Rashtra", nearly 80% of the population had not benefited from its rule.

Cong. cuts short yatra in U.P., cites Board exams

Will build police station on recovered land in Haldwani: CM

Days after the violence in Uttarakhand's Haldwani over the demolition of an allegedly "illegally built" madrasa and mosque that left five persons dead, Chief Minister Pushkar Singh Dhami on Monday said a police station would be built on the land "freed from encroachment".

In another development, the Haldwani Municipal Corporation served a recovery notice to Abdul Malik, the owner of the ma-

drasa and mosque at Banbhoolpura demolished by the administration on February 8, demanding ₹2.44 crore in damages. The notice issued by the Haldwani Municipal Corporation stated that Mr. Malik, who the police say is mastermind of the violence, has to deposit the amount to the civic body within three days (February 15). He has been fined for damage to vehicles including tractors, goods carriers, etc., and equipment such as helmets and crowbars.

"After our teams demol-

The Haldwani civic body served a recovery notice to Abdul Malik, the alleged mastermind

ished the structures built by you illegally on government land and were returning back, your supporters engaged in arson and damaged/destroyed/looted properties of the Municipal Corporation and caused loss to government property. Pay the amount within the due date or the

amount will be recovered as per the law," the notice issued to Mr. Malik, who has been arrested, states.

Speaking at a rally in Haridwar, Mr. Dhami said the government wants to send a clear message to anarchist elements that those who try to disturb the peace of "Devbhoomi" (Land of Gods) will not be spared. "There was a garden in Banbhoolpura which was encroached upon. That encroachment has been removed and several acres of land was recovered," said Mr. Dhami.

"From the banks of the mighty river Ganga, I announce that a police station will be built at that place," Mr. Dhami said.

Meanwhile, the police also suspended arms licences of 127 persons of Banbhoolpura to avoid the misuse of the weapons in case of any untoward situation.

'Normalcy returning'
With Haldwani city showing signs of returning to normalcy, the district administration and the police conducted a peace meet-

ing with representatives of all communities. People demanded relaxation of the curfew in Banbhoolpura too but District Magistrate (DM) Vandana Singh said the administration will assess the law and order situation before announcing any relaxation.

Markets and educational institutions in the city opened on Monday while curfew was lifted in the rest of Haldwani late on Saturday. People were seen crowding food joints and parks as businesses operated as usual.

Court extends ED remand of Hemant Soren by three days

A special PMLA court on Monday extended the Enforcement Directorate (ED) remand of former Jharkhand Chief Minister Hemant Soren by three days in a money laundering case linked to an alleged land scam, lawyers said.

Mr. Soren, the Jharkhand Mukti Morcha (JMM) executive president, was on February 7 remanded to five days of ED custody by the special PMLA (the Prevention of Money Laundering Act) court.

He was arrested on January 31 after a seven-hour grilling by the Central investigative agency in the money laundering case.

He resigned as the Jharkhand Chief Minister before the arrest.

SC extends interim bail granted to Minister's son

The Supreme Court on Monday extended the interim bail granted to Union Minister Ajay Kumar Mishra's son, Ashish Mishra, in the 2021 Lakhimpur Kheri violence, which claimed eight lives. A Bench of Justices Surya Kant and K. V. Viswanathan directed the top court registry to obtain a report from the trial court on the progress of the case and adjourned the matter. On September 26, 2023, the SC had relaxed the bail conditions of Mishra to enable him to look after his mother and for the treatment of his daughter. The case pertains to an incident of violence on October 3, 2021 at Tikunia in Lakhimpur Kheri district of Uttar Pradesh. PTI

NCB busts international drug cartel, arrests nine accused

The Narcotics Control Bureau (NCB) has busted an international drug cartel having links in and around Delhi, Rajasthan, Punjab, and Dubai. Among those involved were Indian, Mexican, Canadian, and British nationals. The agency has arrested nine persons, including three alleged Mexican Meth chemists. Based on a tip-off, its Delhi zonal unit had seized about 2.95 kg of methamphetamine at DHL on January 17. "During further course of investigation, two consignors of the parcel were apprehended from Jaipur. The arrested persons disclosed that they collected Meth from a Delhi-based trafficker on a regular basis and used to send the parcels to Australia, as per the direction of their handler," said the agency on Monday.

Press bodies condemn attack on journalist

The Press Club of India and the Indian Women's Press Corps on Monday demanded action against those involved in the attack on senior journalist Nikhil Wagle allegedly by the members of a political party in Maharashtra's Pune on February 9. They also sought withdrawal of criminal charges against the journalist.

"We appeal that the draconian charges against Mr. Wagle for promoting enmity, mischief, and defamation be dropped and urge the Maharashtra government to ensure that the perpetrators of violence are sent a strong message. No one should be allowed to get away with violence," they said in a statement.

A three-judge Bench headed by Chief Justice of India D.Y. Chandrachud found no harm in the appointment of Deputy Chief Ministers, reasoning that they were after all Members of Legislative Assemblies (MLAs) of the States and Ministers of State governments.

"Deputy CM's are first and foremost Ministers in the government of the State. A person who holds the office of the Deputy Chief Minister must at any

Hygiene, sanitation rating system for hotels, resorts, homestays yet to take off

States silent on Swachhata Green Leaf Rating, which was launched in November last year by the Union Tourism Ministry; Centre exploring ways to incentivise scheme to encourage participation

A government-initiated rating system for the hospitality sector, aimed at ensuring world-class hygiene and sanitation at hotels, resorts, and homestays, has become a non-starter, with no State opting for it so far.

Barring a pilot project in Jammu and Kashmir, there has been no response from the States or the Union Territories despite the Union Tourism Ministry sending three communiqués so far, the last one being in the first week of February, sources said.

The ranking scheme – Swachhata Green Leaf Rating – was launched in November last year by the Union Tourism Ministry in collaboration with the Department of Drinking Water and Sanitation.

As part of the initiative, the State teams of Swachh Bharat Mission-Gramin (rural) and the Tourism Department are to organise workshops on the concept, process, and desired outcomes for the stakehol-

ders. Owners and operators of the lodging services are encouraged to adopt good practices for improved and safe sanitation facilities, faecal sludge management, segregation of solid waste at sources, and promotion of alternatives to single-use plastic.

Safe sanitation

According to the concept paper of the scheme, it is proposed to launch the Swachhata Green Leaf Rating system at all hospitality facilities in the country with or without restaurants.

ble tourism practices in India," the vision statement of the document read.

A senior official of the Tourism Ministry told *The Hindu* that the government was exploring possibilities to incentivise the scheme at some point to encourage participation.

Rural areas

On the face of it, 'Opportunity Cafe' could pass off as yet another eatery in a city that loves food, but the place is one of its kind, considering it is run by young people who otherwise rarely get to join the social mainstream.

Young adults who have intellectual disabilities or have grown up in rescue homes are the ones responsible for the functioning of this non-profit cafe that opened last month on Dum Dum Road.

"The most satisfying part so far of setting up this cafe was the six months of rigorous training before the inauguration. Our society

SC extends interim stay in investigation against ED officer

The Supreme Court on Monday extended its stay order of criminal proceedings by the Tamil Nadu Directorate of Vigilance and Anti-Corruption (DVAC) against Enforcement Directorate (ED) officer Ankit Tiwari in a graft case.

A Bench headed by Justice Surya Kant ordered the interim relief to continue even as Tamil Nadu government sought time to file a response to a petition filed by the ED against the State.

The Central agency has challenged the proceedings against Mr. Tiwari. It has argued that the action against Mr. Tiwari, an ED officer in Tamil Nadu, was a tit-for-tat by the State for money laundering and corruption cases lodged by Central agencies against Ministers and ensuing raids on them. It has sought a transfer of the case from DVAC.

Tamil Nadu, represented by Additional Advocate-General Anand Tiwari, has stated that Mr. Tiwari was caught red-handed accepting a bribe of ₹20 lakh from a doctor in Dindigul district.

On January 25, the top court had stayed both the DVAC and the ED from probing the case against

Mr. Tiwari. The Bench had directed the material collected so far in the investigation to be placed on record before it.

On Monday, Mr. Tiwari sought two weeks for Tamil Nadu to file a response to the ED petition.

On January 25, the top court had suggested a mechanism to screen if political vendetta or vindictiveness was not the actual reason behind Centre unleashing the ED on officials and Ministers in non-BJP-ruled States.

"We should explore a fair and transparent mechanism or a body which will look into the inter-State ramifications and keep intact the object of punishing the guilty while preventing vindictive arrests," Justice K.B. Viswanathan, on the Bench, had proposed in the previous hearing.

Efforts on to clear Aadhaar hurdle in Assam: CM

Chief Minister Himanta Biswa Sarma on Monday said efforts were on to enable some 27 lakh people in Assam, who have been unable to acquire Aadhaar cards as their biometrics were locked during the process of updating the National Register of Citizens.

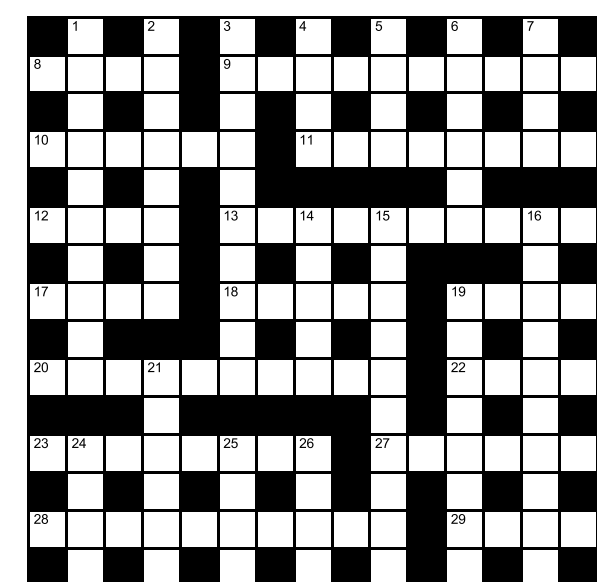
Mr. Sarma, in response to a question in the State Assembly, said he hoped "something positive" would emerge from his consultations with the Centre, but his government may have to approach the Supreme Court for a solution.

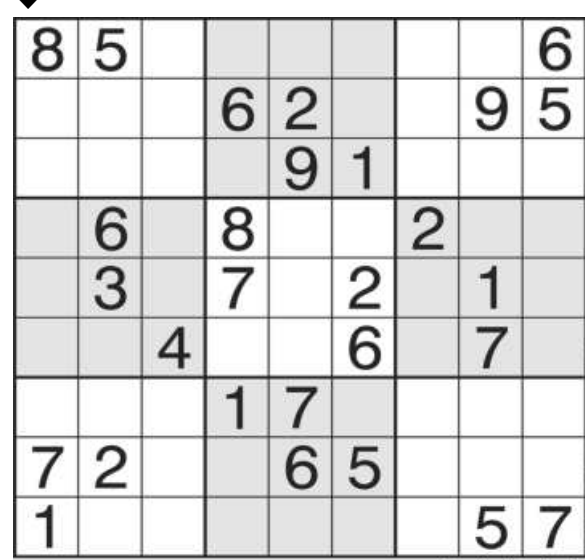

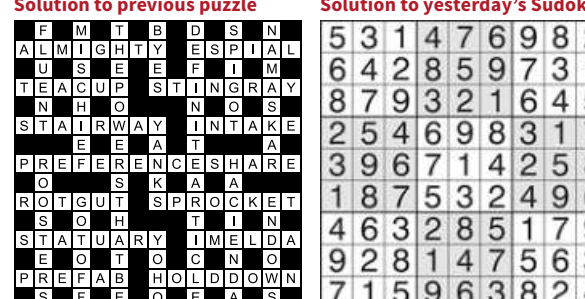

In his Saraswati Vandana poem, Suryakant Tripathi Nirala says, "O mother tear apart the shackles of darkness in our heart And let a river of light flow absorbing differences and darkness". This is very relevant at the onset of Vasant Panchami, a festival with immense religious and social significance in our society, said Prof. Kumool Abbi in a lecture.

It is the festival of Saraswati puja in West Bengal, Tripura, Assam, Odisha and Bihar and many other places. Goddess Saraswati is the embodiment of knowledge, art, music, aesthetics and harmony. In the Shanti Parv in the epic Mahabharata, she is called the mother of the Vedas. The effulgent Saraswati illumines and removes nescience and darkness. Vasant Panchami is commemorated on the Magh Sud, that is the fifth day of the bright lunar fortnight (Sukla paksham) of the month Magha in the lunisolar calendar.

In many parts, Vasant Panchami heralds the end of winter and the beginning of spring. It signifies a preparation for Holi and a readiness for the harvesting of crops. This is when yellow mustard flowers are in full bloom. The occasion is celebrated with sounds of dhol, the pulsating bhangra, flying of colourful kites, the making of yellow rice and wearing yellow coloured clothes.

Political parties in Pakistan wrangle over premiership

Talks between PML-N and PPP reach nowhere as both parties want their candidate for top job; Shehbaz Sharif and Bhutto Zardari are being touted as PM-contenders by both parties

Pakistan's two largest political parties were on Monday wrangling over who will be Prime Minister after an inconclusive election last week forced them to join forces and try to form a coalition in a parliament dominated by independents.

Former Prime Ministers Imran Khan and Nawaz Sharif both declared victory on Friday, with independent candidates backed by the jailed Mr. Khan forming the largest group of 93 members of a total of 264 seats for which results were declared.

However, Mr. Khan cannot become Prime Minister from jail and his grouping cannot form a government as they nominally ran as independents as his party was barred from standing.

Mr. Sharif's Pakistan Muslim League-Nawaz (PML-N) was the largest recognised party with 75 seats and the Pakistan Peoples Party (PPP) of Bilawal Bhutto Zardari, the son of

assassinated former premier Benazir Bhutto, was second with 54.

The two parties opened formal talks late on Sunday to form a coalition government. PML-N and PPP officials, however, said their talks were snagged over which leader would take the top job. However, a PML-N source said it was "most likely" that Shehbaz Sharif, 72, who held the post for 16 months until August, will be chosen.

The PPP has always maintained Bhutto Zardari as its political scion, and if successful, the former Foreign Minister will become Pakistan's youngest premier since his mother Benazir.

67 Palestinians killed, two Israelis rescued in Gaza raid

Israeli forces rescued two hostages early on Monday, storming a heavily guarded apartment in a densely packed town in the Gaza Strip and extracting them under fire and covering airstrikes that local officials said killed at least 67 Palestinians.

Israeli military spokesman said Adm. Daniel Hagarai led special forces broke into a second-floor apartment in Rafah under fire at 1:49 a.m. on Monday, accompanied a minute later by airstrikes on surrounding areas. He said Hamas militants were guarding the captives and that members of the rescue team shielded the hostages with their bodies as the battle erupted.

The plight of the hostage-

es has profoundly shaken Israelis, and the rescue in Rafah briefly lifted the spirits of a nation still reeling from Hamas' cross-border raid last year that started the war.

Israel has described Rafah — a city on the southern edge of the Gaza Strip where 1.4 million Palestinians have fled fighting elsewhere — as the last re-

maining Hamas stronghold in the territory and signaled that its ground offensive may soon target the city.

In Gaza, the operation unleashed another tragedy in a war that has killed 28,340 Palestinians in the territory, displaced over 80% of the population and set off a massive humanitarian crisis.

Stop delivery of F-35 parts to Israel, says Dutch court

The Netherlands must stop delivering parts for F-35 fighter jets used by Israel in the Gaza Strip after a Dutch court on Monday ruled there was a "clear risk" the planes would be involved in breaking international humanitarian law.

The Appeals Court in The Hague sided with a group of human rights organisations that argued the parts contributed to violations of law. "The court therefore orders the State to put an end to the further export of Israel within 7 days". The U.S.-owned F-35 parts are stored at a warehouse in the Netherlands and shipped to several partners, via existing export agreements.

Maldives parliament votes to postpone general election

The Maldives' parliamentary election, which was scheduled for March 17 this year, is set to be postponed after the legislature voted to defer the polls, citing the Ramadan month.

The People's Majlis or parliament on Sunday voted for the amendment to the country's General Elections Act to commence the parliamentary election ten days after the month of religious significance in the Sunni Muslim nation.

The opposition Maldivian Democratic Party (MDP) and its breakaway, The Democrats, together backed the amendment, citing concerns over a possible drop in voter turnout during the month of fasting and prayer from March 10, 2024, to April 9, 2024.

According to local media reports, MDP legislator Mohamed Shifau proposed the amendment, which was approved with 46 votes in the now 80-member House. Most government MPs abstained from voting. Male-based publication *The Edition* reported.

Constitutional validity
However, the development has raised questions over the constitutional validity of postponing the elections to mid-April. Speaking to media persons in Male on Sunday, a senior official of the Election Commission of Maldives raised concern over this.

"When the Bill says 10 days after Ramadan, that barely allows us enough time to complete the exercise within the 30 days stipulated in the Constitution," he was quoted as say-

ing, in *The Edition*.

Meanwhile, the MDP has had to put its earlier pledge, to impeach President Mohamed Muizzu, on hold after the government moved the Supreme Court on the matter.

Muizzu's impeachment
The MDP had based its decision to impeach the incumbent on his foreign policy moves "putting the Indian Ocean Region in danger", and his "attempts to curtail" the legislature.

The MDP, which has 42 seats in the 80-member People's Majlis, joined forces with The Democrats — with 13 seats — and was confident of its numbers. However, the top court suspended a recent amendment to the standing orders that permitted vacant seats from being included while counting total votes.

Although the development gave some political reprieve to President Muizzu, his government faces major economic challenges. In its recent report, the International Monetary Fund noted that the Maldives is at high risk of debt distress. More recently, the country's Inland Revenue Authority flagged a significant shortfall in government revenue.

Unionist party pushes back against Irish unity referendum

The leader of the Democratic Unionist Party (DUP) of Northern Ireland pushed back against the assertion of Irish republicans from Sinn Fein that Northern Ireland would have a referendum on reunification with the Republic of Ireland before 2030.

"Well, look, how would you expect Sinn Fein to react to a document that says 'Safeguarding the Union' and is coloured red, white and blue?" DUP leader Jeffrey Donaldson told the foreign press in London as he held up a copy of the agreement with the U.K. government, whose cover had the same colour scheme as the Union Jack.

Following its publication on January 31, the DUP agreed to enter into a power-sharing agreement with Sinn Fein to govern Northern Ireland, bringing the devolved government back to life after two years. The DUP had quit the arrangement in 2022, unhappy with post-Brexit trading arrangements between Northern Ireland and the rest of the U.K.

The new government, which came together on February 3, is led by the politically equal posts of First Minister (Sinn Fein's Michelle O'Neill) and Deputy First Minister (the DUP's Emma Little-Pengelly).

"Of course they're going to talk about United Ireland to reassure their base," Mr. Donaldson said, pointing out that Sinn Fein, while being the largest party in Northern Ireland, gets less than 30% of the vote. In the last elections for the Assembly or Stormont,

Sinn Fein beat the DUP by two seats to get 27 seats with a 29% vote-share as opposed to the DUP's 21.3%.

Mr. Donaldson, whose DUP party is unionist, or wants to be part of the U.K., said the U.K. offered a "far more inclusive" context than a united Ireland could and that consistently it was only 30% of those surveyed in polls who were for Irish unification.

Survey results

A December 2022 Ipsos poll for the *Irish Times* showed 27% of Northern Irelanders surveyed wanted to be part of a united Ireland, while 66% of those surveyed in Ireland wanted Northern Ireland to join their country.

The 1998 Good Friday Agreement, which brought peace to the island of Ireland after three decades of violent struggle, mandates that the Secretary of State for Northern Ireland, a British functionary, will call for a 'border poll' on Irish reunification if it is "likely" that the majority of those voting would vote for a united Ireland.

Sinn Fein, formerly the political wing of the militant Irish Republican Army (IRA), has been polling ahead of other parties in Ireland. However, its lead dipped to a three year low (28%) in an *Irish Times*/Ipsos poll last week. "Challenge is something I embrace," Sinn Fein leader Mary Lou McDonald said last week in London, as she acknowledged her party would reflect on the poll numbers and work harder.

Mr. Donaldson said he believed Northern Ireland would still be part of the U.K. in 25 years.

Paytm confirms resignation of director at banking arm

Paytm on Monday confirmed media reports of an independent director at its banking arm having resigned. Manju Agarwal resigned from the board of Paytm Payments Bank on Feb. 1 due to personal commitments, the company said in an exchange filing. The payments firm on Friday said it would form an advisory committee on compliance and regulatory matters, a week after India's central bank ordered Paytm Payments Bank to wind down most of its operations. REUTERS

SC issues notice on GST's anti-profiteering provisions

The Supreme Court on Monday issued notices to the Union of India, the GST Council and the Central Board of Indirect Taxes and Customs, on the constitutional validity of anti-profiteering provisions under the GST regime. The court was urged to examine the issue by advocate Abhishek Rastogi on the ground that the provisions cannot be endless and they are manifestly arbitrary and vague in the absence of a methodology to determine the extent of deemed profiteering.

Chemplast Sanmar reports ₹60 cr. Q3 standalone net loss

Chemplast Sanmar Ltd. reported Q3 standalone net loss of ₹60 crore against a net profit of ₹57 crore in the year-earlier period due to dumping by China and other countries. Revenue from operations slid to ₹439 crore from ₹630 crore, the specialty chemicals manufacturer said in a statement. "Q3 performance ran into heavy weather due to further correction in PVC prices on account of dumping from China and other countries," said MD Ramkumar Shankar.

'Low-cost airline SpiceJet to cut jobs, save \$12 mn annually'

Indian low-cost carrier SpiceJet said on Monday that it has started adopting measures to reduce its workforce, aiming at saving ₹1 billion (\$12 million) annually.

According to a media report, the cash-strapped airline would lay off 1,400 staff, or around 15% of its 9,000-strong workforce.

No confirmation

The carrier, however, did not confirm the number of jobs being cut.

SpiceJet said it took the measures as part of its tur-



around and cost-cutting strategy following fund infusion to help in the revival of its grounded planes.

The airline, once India's second-largest, has so far raised ₹7.44 billion as part of a ₹22.50 billion fundraising effort by selling shares and warrants.

Industrial output witnessed mild recovery in December

Manufacturing sector's growth picks up pace from a seven-month low of 1.2% to 3.9%; 12 of the 23 segments tracked by the IIP recorded an up tick in Dec., which was double the number in Nov.

India's industrial output growth recovered from an eight-month low of 2.4% in November 2023 to 3.8% in December 2023, with the manufacturing sector's growth picking up pace from a seven-month low of 1.2% to 3.9%.

A dozen of the 23 manufacturing segments tracked to compute the Index of Industrial Production (IIP) recorded an up tick in December, double the number of sectors that grew in November.

In recovery mode

Industrial output growth recovered from an eight-month low of 2.4% in November 2023 to 3.8% in December 2023

■ Consumer durables production recovered in December, albeit aided by a 11.2% dip recorded a year earlier

■ Consumer non-durables also bounced back from a 3.6% contraction in November to rise a moderate 2.1% in December

Consumer durables production recovered from a 5.4% contraction in November to grow 4.8% in December, albeit aided by a 11.2% dip recorded a year earlier. On a sequential basis, durables' output jumped 7.75% from November 2023 levels, which

marked the lowest production levels since June 2021.

Consumer non-durables also bounced back from a 3.6% contraction in November to rise a moderate 2.1% in December. Output levels were, however, 13.1% higher than November.

Noting that the average IIP growth in the Oct.-Dec. 2023 slowed to 5.9% from 7.8% in the previous quarter, CRISIL's Dharmakirti Joshi said consumption demand is expected to remain soft as transmission of interest rate hikes and RBI's regulatory measures dampen credit growth.

'No review on the cards for Paytm Payments Bank curbs'

Dismissing the prospects for a review of the decision to impose curbs on Paytm Payments Bank's operations after February 29, Reserve Bank of India (RBI) Governor Shaktikanta Das said on Monday that the banking regulator takes such decisions after serious consideration and in public interest, not in a casual manner.

Speaking after a meeting of the RBI's central board, Mr. Das stressed that protecting customers and maintaining financial

stability are prime considerations for the central bank's actions.

Mr. Das reiterated that the central bank will issue an FAQ (Frequently Asked Questions) document this week to allay concerns of the payment bank's customers and ensure they don't face any inconvenience due to the curbs. Last month, the RBI had directed the payments bank

to cease taking fresh deposits and a few other key operations after February 29, citing "persistent non-compliances and continued material supervisory concerns in the bank."

"We take all decisions after a lot of consideration and analysis. It's not as if we decide today and start reviewing it tomorrow," the Governor said, indicating that a review of the curbs on the entity is not on the table. "Decisions are not taken in a casual manner. These decisions are taken in the most serious manner in public interest."

LIC increases stake in SBI Cards to 5.02%

Life Insurance Corporation of India's (LIC) shareholding in SBI Cards and Payments Services crossed 5% with the insurer, as an investment function, acquiring recently a little more than three lakh shares in the non-banking financial company at an average cost of ₹716 per share.

The shareholding has risen from 4.99% to 5.02% (47,410,710 to 47,711,794 equity shares) following the open-market purchase.

RuPay, UPI rolled out in Mauritius, Sri Lanka

RuPay cards and Unified Payments Interface (UPI) connectivity between India and Mauritius, as well as UPI connectivity between India and Sri Lanka were established on Monday to deepen financial integration and to facilitate digital payments among citizens of the three countries, the Reserve Bank of India (RBI) said.

An Indian traveller to Mauritius will now be able to pay a merchant in Mauritius using UPI. Similarly, a Mauritian traveller will be able to pay a merchant in India using the Instant Payment System (IPS) app of Mauritius.

Further, with the adoption of RuPay technology, the MauCAS card scheme of Mauritius will enable banks in Mauritius to issue RuPay cards domestically. Such cards can be used at ATMs and PoS terminals locally in Mauritius as well as in India. "Indian RuPay cards would also be accepted at ATMs and PoS terminals in Mauritius," the RBI said in a statement.

The digital payments connectivity with Sri Lanka will enable Indian travellers to make QR code-based payments at merchant locations in Sri Lanka using their UPI apps. The projects had been developed and executed by NPCI International Payments Ltd. (NIPL) along with partner banks / non-banks from Mauritius and Sri Lanka, under the guidance of RBI.

'Pilots calling in sick forced Akasa Air to cancel 10 flights'

Pilots on 'sick leave', weather and operational reasons reportedly led to a number of cancellations and delays in Akasa Air flights in the last 48 hours.

As per data, at least 10 Akasa Air flights were cancelled on February 10 and 12, while 17-18 other flights were delayed. While the airline expressed regret, it simultaneously underlined that it now has 600 pilots and there was no shortage.

Vinay Dube, founder and CEO, Akasa Air, asserted that the airline did not have shortage of pilots.

"Akasa Air is sufficiently

staffed with over 600 pilots, enough to operate more than double the size of our current fleet," he said. Akasa Air, with an average on-time performance (OTP) of 83.7% in 2023, had at least 17 flights delayed on February 11, sliding its average OTP to 73.5%. At least 25 flights had late landings.

According to information, over 10 flights were cancelled on February 11 and 12. Sources said the issue was due to some pilots calling in sick. The airline operates 800 weekly flights making it approximately 115 daily flights.

Devdutt Padikkal, the stylish left-handed bat, has received his maiden call-up after K.L. Rahul — his Karnataka senior — has been ruled out of India's third Test versus England, to be played here from Thursday.

"Rahul has reached 90% of match fitness and is progressing well under the supervision of the BCCI Medical Team," Jay Shah, the BCCI secretary, wrote in a statement.

"He will continue his recovery process at the National Cricket Academy (NCA) in Bengaluru to be completely match-fit for the fourth and fifth Test."

Rahul and Ravindra Jadeja — both of whom had missed the second Test after getting hurt during India's loss in Hyderabad last

month — had been named in the squad for the last three Tests pending fitness clearance.

While India's squad that reassembled here on Sunday had its first training session at the stadium on Monday, Rahul is understood to have undergone a fitness test at the NCA. With the selectors and the team-management, in consultation with the BCCI medical team, deciding to not risk a player, the selection committee unanimously zeroed in on Padikkal being given a maiden Test call-up.

Interestingly, chief selector Ajit Agarkar witnessed Padikkal's sensational 151 for Karnataka against Tamil Nadu in the Ranji Trophy's high-profile southern derby over the last four days.

It is understood that Jadeja appeared to be fit during Monday's net session which was played behind closed doors, with no media person being allowed to

watch the team train.

It will be interesting to see if Padikkal is made to wait for his India cap, with Sarfaraz Khan being the front-runner to replace Shreyas Iyer in India's mid-

dle-order. Sarfaraz was brought in as Rahul's replacement ahead of the second Test and has been retained in the squad with Shreyas being dropped. Meanwhile, England

leggie Rehan Ahmed was stopped from exiting the Hirasar airport — on the outskirts of the Kathiawari city — due to lack of multi-entry visa upon England's arrival here on Monday.

England's squad spent the week-long break in Abu Dhabi before arriving here on Monday. It was noticed that Rehan had a single-entry visa so the England squad waited at the airport in the afternoon before the formalities were completed.

It is understood that with the help of local authorities, Rehan was granted a two-day visa at the earliest and the remaining paperwork will be completed well in time before the scheduled start of the match.

Leach ruled out

Rehan will be crucial to England's plans with Jack Leach, supposed to be the leader of the spin attack, having been ruled out of the remainder of the series. After sustaining a knee injury in Hyderabad, Leach missed the Visakhapatnam Test and has headed back home. The England camp has not named a replacement for Leach.

World marathon record holder Kelvin Kiptum and his coach Gervais Hakizimana died in a traffic accident on Sunday, former Kenyan Prime Minister Raila Odinga said on social media platform X.

Kenya's minister for sports Ababu Namwamba said on X, "Devastatingly sickening!! Kenya has lost a special gem. Lost for words."

Kiptum, 24, set the world record at the Chicago Marathon in October with a time of 2:00:35 to surpass the record of 2:01:09 set by his compatriot Eliud Kipchoge in Berlin in 2022.

Kiptum smashed the London Marathon course record earlier last year and was determined to make magic again in Chicago as he sped up through the 35-kilometre mark before thrusting his arms in the air to cheers from the crowd down the final stretch.

"We are shocked and

deeply saddened to learn of the devastating loss. On behalf of all World Athletics, we send our deepest condolences to their families, friends, teammates and the Kenyan nation", said World Athletics president Sebastian Coe.

"It was only earlier this week in Chicago, the place where Kelvin set his extraordinary marathon world record, that I was able to officially ratify his historic time. An incredible athlete leaving an incredible legacy, we will miss him dearly," added Coe.

Safety worries for balconies ahead of the Paris Olympic Games

Real estate experts in Paris have warned about the danger of people cramming on to balconies around the City to catch a glimpse of the Olympics in July and August.

The National Real Estate Federation (FNAIM) has alerted local authorities to the risk of collapses and accidents unless balconies that are often designed for two or three people are checked beforehand for their structural soundness.

The issue is set to be particularly pressing for residential blocs that overlook the river Seine, which athletes will sail down during a spectacular opening ceremony being planned by organisers on July 26.

"We need to be absolutely sure that the balconies can take the weight and that handrails are well sealed in to avoid any sort of incident," Olivier Princivalle, head, FNAIM in the Paris region, said.

Rare but sometimes deadly

Accidents involving balconies are a rare but sometimes deadly occurrence in France, with two people left seriously injured in the southeast of Paris in May last year when their fifth-floor balcony gave way. Four people died in the central City of Angers in 2016 when a balcony collapsed during a party.

The Paris Olympics from July 26 to August 11, followed by the Paralympics from August 28 to September 8, are set to take place at locations across the City of Light

where many buildings are hundreds of years old.

The issue of balcony safety underlines the immense organisational complexity faced by local authorities as they prepare the first Games in Paris in 100 years.

The opening ceremony – the first time a summer Olympics has begun outside of a stadium – represents a huge challenge for French police who have been asked to secure a 6km stretch of the river that will be used during the parade.

The Paris police department said that checking balconies did not fall under its responsibilities, but it was working with the industry and its partners to address the issue.

Under French law, building owners or managers have

responsibility for checking their structures, but "something can slip through the cracks", a French source with knowledge of the preparations said on condition of anonymity.

Advance warnings about security and transport restrictions during the Games have led many Parisians to plan holidays during the event, sometimes in order to rent out their homes for high prices to foreign visitors.

"Don't leave this summer, don't leave! That would be a mistake," Mayor Anne Hidalgo urged the City's inhabitants on Sunday as she inaugurated the only new permanent Olympics sports arena to be built in inner Paris. "It's going to be incredible."

What's the next step for Qatar's Asian Cup star Akram Afif?

With his flowing curls and thrilling attacking play, it was no surprise that Akram Afif was likened to Liverpool star Mo Salah at the Asian Cup.

With eight goals, including a hat-trick in the 3-1 win over Jordan in the final, the Qatar forward was the leading scorer and most valuable player as his team won back-to-back titles.

But once the celebrations are over, Afif will return to Al Sadd in Qatar, rather than a team from one of Europe's top leagues.

Europe beckons?

In reality, he is a long way off the quality of Salah – one of the world's top players. But based on his performances at the Asian Cup, it is hard to imagine Afif couldn't make a career for himself outside of his homeland, even if not at one of Europe's leading clubs.

Is it simply the case that in an age when scouting networks have never been more extensive, Afif has slipped through the net? Not quite.

After all, he was a youth player with Villarreal at the start of his career and had spells in Spain and Belgium before returning to his homeland.

That move doesn't seem to have stopped him from developing his game.

He outperformed the likes of Tottenham's Son Heung-min and PSG forward Lee Kang-in at the Asian Cup, and, unsurprisingly, the

question of whether he would look to try again in Europe was a consistent theme during Qatar's run to the title.

"It's not me who has to decide, other parties have to decide," Afif said after the final.

"There are so many factors. I'd love to become a professional (in Europe). If it's meant to be, it's meant to be." The 27-year-old Afif was part of Qatar's Aspire Academy, which develops athletes. He joined Villarreal in 2016 and had loan spells with Sporting Gijon in Spain and Eupen in Belgium.

He returned to his homeland to Al Sadd in 2018 and the following year won the Asian Cup with Qatar, providing 10 assists, a tournament record.

Those performances didn't pave the way for a high profile move and he was part of Qatar's disappointing performance at the 2022 World Cup as the host nation was eliminated after three-straight losses in the group stage.

As a whole the Asian Cup showcased the talent that lies outside of elite club football in Europe. Iraq's Aymen Hussein was the second highest scorer.

Of the two finalists, only one player was based in Europe – Jordan's Mousa Tamari, who plays for Montpellier in France.

It points to the possibility that there is talent in parts of Asia that remains largely untapped in terms of scouting from Europe.

Earth-wide telescope confirms black hole's shadow is 'real'

The Event Horizon Telescope is a global network of radio telescopes that work together. In 2019, it produced the first image of a black hole, the one at the centre of the M87 galaxy. The network has confirmed what it observed and shared evidence of movement in the black hole's neighbourhood

Scientists have unveiled new details of a colossal black hole 53 million lightyears away first photographed by the earth-wide Event Horizon Telescope (EHT) in 2017. The feat provided the first visual evidence that black holes exist, confirming a fundamental prediction of general relativity.

In a new paper published on January 18, EHT scientists have reported capturing details at the level of the behemoth's event horizon – the boundary beyond which light from the other side can't reach an observer – showcasing the formation of a distinct ring around it.

The EHT's previous run had revealed the black hole's 'shadow', a result of the event horizon's gravitational effects and a signature of its presence. The picture also helped constrain the black hole's mass and find that its size and shape align with the predictions of the general theory of relativity. The image was hailed at the time as a matter of "astonishment and wonder" for revealing "a part of the universe that was off limits".

The new data, obtained after improving the telescope's coverage and resolution, reiterated the shadow's size and shape.

"The primary finding is the confirmation of the black hole 'shadow'," Venkatesh Ramakrishnan, a postdoctoral researcher at the Finnish Centre for Astronomy with the European Southern Observatory, wrote in an email to *The Hindu*. "So this shows us as a first step that we are not biased towards making the black hole appear."

Dr. Ramakrishnan has been part of the EHT collaboration since 2017.

Many telescopes as one

The EHT is not a single telescope but a worldwide network of radio telescopes that work together to study a common object in space. They benefit from a technique called very-long baseline interferometry, where the data each telescope collects about the object is correlated with data from the others using extremely precise clocks.

In this setup, the maximum distance between the telescopes defines the network's resolution.

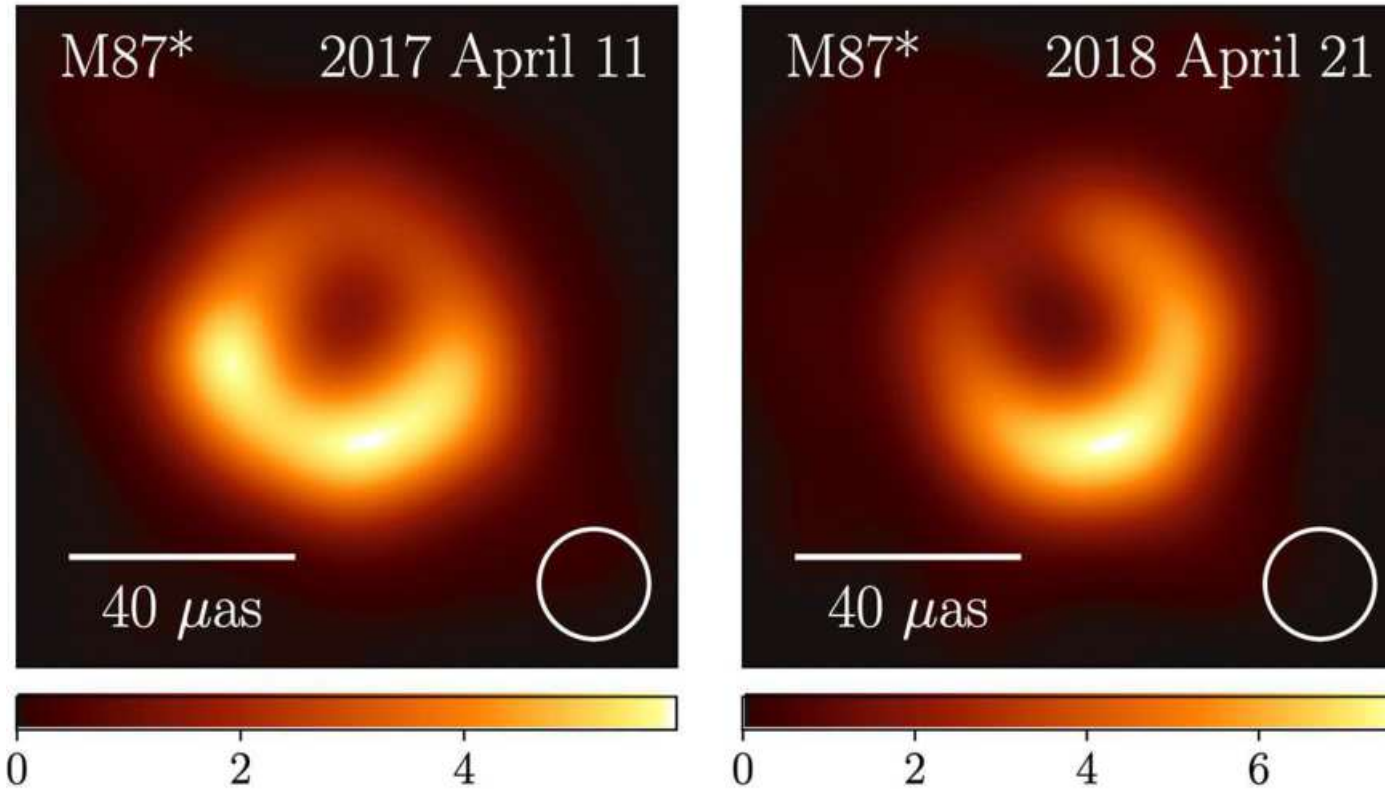
In 2017, the EHT reported detecting a bright, asymmetric ring of light consistent with the presence of a supermassive black hole. Independent analyses of EHT data also supported the ring's presence.

Based on these observations, scientists improved the EHT by increasing its data-recording rate, its ability to track spatial information, and by adding the Greenland Telescope to the array. The last one "improved the resolution of the EHT in the north-south direction," Dr. Ramakrishnan said.

Piecing the data together

In the new campaign, the EHT had nine stations gathering data across six observation days in April 2018, in four frequencies.

Then the scientists correlated the datasets with each other to increase the

signal-to-noise ratio. This task and subsequent processing happened at centres in Germany and the U.S.

When comparing the 2017 observations with the new results, they observed significant changes in the closure phase – a measure of the relationship between three telescopes in an array.

Specifically, they found that the way telescopes worked together during the 2018 observations differed from that during the 2017 observations. In this difference, scientists can track shifts in the configuration or structure of the black hole.

The team further used general relativistic magnetohydrodynamic (GRMHD) simulations to create models of the M87 black hole. These models incorporate the way the black hole's gravity influences spacetime around it using Einstein's theory of general relativity. By comparing the simulated black hole with the actual one, scientists gained valuable insights into the intricate dynamics near the event horizon, such as an effect called lensing.

Gravitational lensing

The findings confirmed the presence of an asymmetric ring structure approximately 42 microarcseconds wide. This is like observing a grain of sand from 25 km away.

They also revealed its diameter hadn't changed much between observations in 2017 and 2018 – meaning the black hole's gravity bent light consistently over time to form the observed ring.

This is in line with a prediction from the general theory of relativity that light around a black hole is strongly lensed. Objects with a lot of mass bend spacetime more around them. When light travels in this region, its path is bent in the same way a magnifying glass does. Images carried by the light thus appear to be

larger than they really are, and this phenomenon is called lensing.

This is also why, as the team found, the ring's southwest corner appears brighter than other parts. The black hole is rotating, dragging the spacetime around it along the direction of its rotation and rendering more light in some areas.

In technical parlance, the observations matched predictions for a shadow formed by lensed emission around a Kerr black hole (i.e. a rotating black hole) with a mass of around 6.5 billion times that of the Sun.

The M87 galaxy is also associated with a prominent jet of high-energy particles extending from the black hole into space. Scientists believe the jet is connected to the black hole's accretion disk, a belt-like structure of matter spiralling into the black hole.

Scientists observed that parts of the accretion disk and the jet appeared to be shifted by about 30 degrees between 2017 and 2018 – meaning these structures had changed their position or orientation over time.

"The 30-degree change can be attributed to the spin of the black hole," Dr. Ramakrishnan said. "Now this can't be firmly established yet from two images taken two years apart, but such an expectation was already established in a paper published a few years ago."

This shift is involved in a complex

interplay between the accretion disk and the formation of the jet. For example, models like the GRMHD suggest the observed shift could correspond to variations in the magnetic field structure. This in turn can render observable changes in the radiation emitted by matter in the disc.

By studying these subtle changes, scientists gain valuable insights into the hidden physics that controls the relationship between the accretion disk, the jet, and the magnetic environment around the black hole.

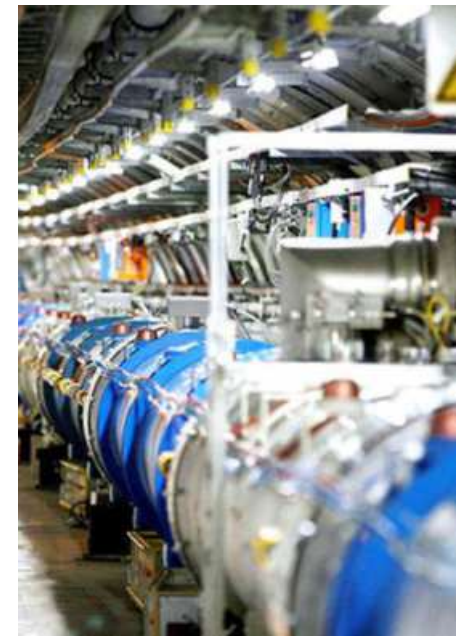
Running the EHT to photograph black holes millions of lightyears away is a time-consuming task requiring meticulous observations.

The new results have reaffirmed the features of the black hole reported in 2019, including a very stable ring-formation process and other physical characteristics. The findings also were consistent across two observation periods and multiple frequencies, speaking to their reliability.

Examining how we measure the ring's diameter shows that our observational techniques are continually improving. Image-based techniques to study objects in space tend to underestimate diameters compared to direct modelling methods. And the EHT's finer measurement of the ring's diameter suggests this gap between the two techniques is closing. Future work could further reconcile the discrepancy and the EHT's overall performance.

Dr. Ramakrishnan also said the telescope collaboration is planning "a so-called 'movie project' in 2026, when we will track the black hole over a month or two to see the brightness changes along the black hole".

Scientists plan to build even larger atom-smasher by 2040

Scientists at the world's largest atom smasher have expressed confidence about moving forward with a multibillion-euro project to build a larger and more powerful particle collider that could help unlock more mysteries of the universe.

Leaders of the European Organisation for Nuclear Research, or CERN, said planning is on track for its envisioned Future Circular Collider, which is estimated to cost 15 billion Swiss francs (\$17.2 billion) and will probably start operating in a first phase by 2040.

But nothing is certain yet, aside from the interest from mostly European and Western countries that bankroll CERN, which is home to the Large Hadron Collider.

That project is perhaps best known for helping confirm the subatomic Higgs boson in 2012 after a decades-long quest for what was described as "the missing cornerstone of physics."

The aim is to boost energy levels of the particle collisions to 100 TeV, or 100 trillion electron volts, about eight times more powerful than the Large Hadron Collider's 13 TeV

"The Future Circular Collider is a possible facility. I'm saying 'possible' because we are today at the level of feasibility study. It's not yet an approved project," said Fabiola Gianotti, the CERN director-general.

She said review committees had not turned up any "technical show-stoppers" for the project so far.

She touted the proposed collider as "a wonderful instrument to improve our understanding of fundamental physics" and a driver of innovation in areas like cryogenics, superconducting magnets, vacuum technologies and detector-instrumentation technologies that could offer socioeconomic benefits for society.

However, the science that the future collider could generate remains largely unknown.

"It's true that at the moment we do not have a clear theoretical guidance on what we should look for," Gianotti said.

The laboratory that already houses what CERN leaders call the world's biggest machine uses a network of magnets to accelerate particles through a 27-kilometre underground loop along the French-Swiss border and slam them together, capturing and interpreting the results of the collisions to help explain how fundamental physics works.

A briefing last week on the new collider included some proposed changes to the original plan announced in 2019. Among them: the loop will be 91 kilometres instead of the 100-kilometre circuit first envisioned.

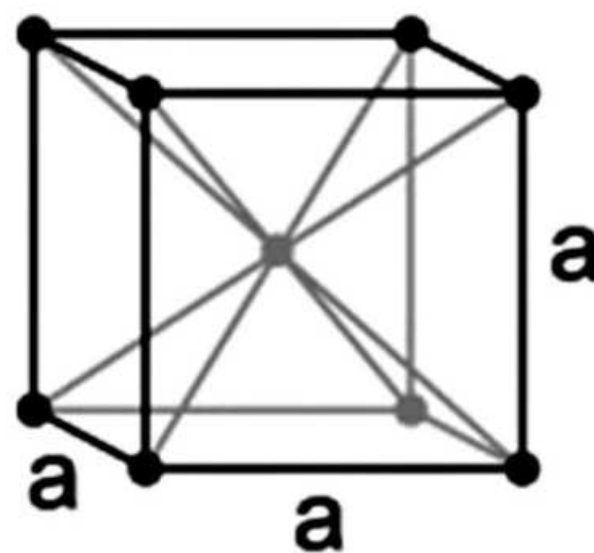
