# New ECs take charge; Supreme Court refuses to + stay their appointments

by Justice Sanjiv Khanna, the petitioners – including Association for Democratic Reforms and Congress leader Jaya Thakur and others, represented by senior advocates Kapil Sibal, Vikas Singh, and advocate Prashant Bhushan – said the enactment of the new law, which gives the Union government a dominant role in the selection and appointment of Election Commissioners, had worked to its advantage. However, the Bench relied on a technical point that legislative enactments are not "normally" stayed. The court adjourned the case to March 22. Listing out the series of circumstances which raised suspicions about the process, advocate Prashant Bhushan said that the government had deliberately advanced the meeting of the high-profile selection committee by a day to time the appointments ahead of the court hearing on Friday. The petitioners argued that this law had been enacted to get the better of a March 2023 Supreme Court judgment in the Anoop Baranwal case, which had called for a fair and transparent appointments' mechanism, with

The Supreme Court agreed to hear on March 19 a slew of petitions to stay the operation of the controversial Citizenship (Amendment) Act (CAA) and its rules notified earlier this week, which fast-track the grant of Indian citizenship to non-Muslim migrants from Afghanistan, Bangladesh, and Pakistan.

"The Act was enacted in 2019. They wait for fourand-a-half years and notify the rules just days ahead of the elections... Once the process of grant of citizenship starts under this Act, it

cannot be reversed. Please hear our applications for stay," senior advocate Kapil Sibal urged a three-judge Bench headed by Chief Jusadvocate Haris Beeran. Mehta, appearing for the Union government, said listing the case early, on March 19, was "absolutely the prerogative of the court".

"However, none of these petitioners have the *locus* standi to say whether or not the Centre can grant citizenship... That may be kept in mind... Whether it is now the first day or the last day before the elections, the petitioner [represented by Mr. Sibal] need not go into that. This is a constitutional court," Mr. Mehta objected strongly. The court said all 237


petitions would be listed on March 19.

Former bureaucrats Gyanesh Kumar and Sukhbir Singh Sandhu assumed charge as Election Commissioners on Friday, a day after their selection by a high-powered panel chaired by Prime Minister Narendra Modi. The Supreme Court refused to intervene immediately on a petition urging a stay on their appointments, on the grounds that the hurry and lack of transparency shown by the government has sent a wrong message that the two retired IAS officers are "favourable" to the regime in power.

This is the first time that Election Commissioners have been appointed in accordance with the new Chief Election Commissioner and Other Election Commissioners (Appointment, Conditions of Service and Term of Office) Act, 2023, which was brought in by the government last December, and which replaces the Chief Justice of India with a Cabinet Minister in the selection panel chaired by the Prime Minister.

He had told the media that he was provided the names of shortlisted candidates only 10 minutes prior to the appointment. This was a violation of Section 6 of the 2023 Act, which required the selection panel members to be given ample opportunity to make a considered deciregarding sion the candidates.

Mr. Kumar and Mr. Sandhu were appointed following vacancies created by the sudden resignation of EC Arun Goel, and the retirement of EC Anup Chandra Pandey.

"It has been 10 years that J&K has not seen an Assembly election. There have to be elections in J&K and it is a golden opportunity. The ECI should restore democracy fully in J&K. Let it announce the dates of both Parliament as well as Assembly elections," Mr. Abdullah said. His statement comes as the ECI is set to announce the poll schedule for the Lok Sabha and some State Assemblies on Saturday.

### Congress MLA joins AAP in Punjab ahead of election

Ahead of the Lok Sabha election, Congress party MLA and the Deputy Leader of the Opposition in Punjab Raj Kumar Chabbewal on Friday quit the party and joined the Aam Aadmi Party (AAP). Mr. Chabbewal, a prominent Dalit leader was inducted into the party fold by AAP State chief and Chief Minister Bhagwant Mann. Mr. Chabbewal also said he has quit as a legislator from the Chabbewal Assembly constituency in Hoshiarpur district. Mr. Chabbewal is likely to be fielded from the Hoshiarpur Lok Sabha seat by the AAP, said sources. He is the second prominent Congress leader, after former MLA from Bassi Pathana Gurpreet Singh GP, to join the AAP recently.

# Court rejects Kejriwal's plea challenging ED summons in Delhi excise policy case

The CM has skipped eight summonses between December 2023 and March 2024 in two cases saying they were 'illegal' and 'politically motivated'; Magistrate Court to take up both today

Sessions Court here on Friday refused to stay the summons issued by a Magistrate Court to Delhi Chief Minister Arvind Kejriwal on the basis of the complaints filed by the Enforcement Directorate (ED) for not appearing before the agency for questioning in the Delhi excise policy case

Special Judge of the Rouse Avenue court, Rakesh Syal, rejected the plea filed by Mr. Kejriwal, which had challenged the summons and sought a stay on the proceedings against him in the Magistrate Court. He said that the Chief Minister may file an application before the Magistrate Court to seek exemption from appearing before the probe agency.

Last week, Additional Chief Metropolitan Magistrate Divya Malhotra had summoned Mr. Kejriwal on March 16 in two separate complaint cases filed by the ED. In its complaints,

the Central agency had said that the Aam Aadmi Party (AAP) national convener had skipped eight summonses issued to him between December 2023 and March 2024 in a money-laundering case linked to the now-scrapped Delhi excise policy.

The Magistrate Court is expected to take up both complaints on March 16.

#### 'Bound to comply'

The AAP chief has, on multiple occasions, termed the

multiple ED summonses "illegal" and "politically motivated", and has alleged that the probe agency, in cahoots with the ruling Bharatiya Janata Party, is planning to "arrest" him ahead of the Lok Sabha election. The Magistrate Court,

had, however, noted that Mr. Kejriwal is "legally bound" to comply with the ED's summons, but has "purportedly failed to do so"

During the hearing, se-

nior advocate Ramesh Gupta and advocate Rajiv Mohan, who appeared for the Delhi CM, said that their client had not skipped any summons for "personal reasons", but on account of being a public servant.

The counsel for the ED said that Mr. Kejriwal had joined the proceedings in the Magistrate Court on February 17 via videoconferencing and had assured the court that he would appear before it in person on March 16. But only two davs before the court date, he filed a plea in the Sessions Court challenging the summons.

Incidentally, Mr. Kejriwal had also told the court that he could not appear before it any time before March 10, on account of the ongoing session of the Delhi Assembly, which was then slated to have finished by the first week of the month.

Hours before the Sessions Court's order, however, the Delhi government extended the Assembly session until March 22.

The minority-based All India United Democratic Front (AIUDF), Assam's third largest party, on Friday announced its list of candidates for the upcoming Lok Sabha election.

The party is contesting three of the 14 parliamentary seats in the State. These are western Assam's Dhubri, southern Assam's Karimganj, and central Assam's Nagaon where Muslims are a major voting force.

A statement issued by the AIUDF said the party chief Badruddin Ajmal will seek re-election from the Dhubri seat.

The police have arrested four more persons in connection with the manufacturing and supplying spurious 'life-saving' cancer and chemotherapy drugs. The total number of arrests

in the case has now climbed to 12. On Tuesday, seven members of the fake drug racket were arrested, including the kingpin, Neeraj Chauhan, 38. A day later, the police arrested Aditya Krishna, 23, an alumnus of the Indian Institute of Technology (Banaras Hindu University), in connection with the case.

The four accused, who were arrested from Delhi and Gurugram on Wednes-

#### The gang is believed to have sold fake chemotherapy drugs worth o<u>ver ₹25 crore</u> over the past 2 years

day and Thursday, are accused of stealing chemotherapy drugs from the hospitals where they worked and selling them for a commission to Mr. Chauhan.

"We believe that the gang mixed some genuine medicines with fake ones to deceive their clients. An investigation is being carried out to find how members of the gang stole drugs from the departments where they worked," said a senior officer.

The police have frozen

•••

14 bank accounts in connection with the case and seized a total of ₹92.81 lakh. An officer said that the gang is estimated to have sold spurious chemotherapy drugs worth more than ₹25 crore over two years.

#### New arrests

Rohit Singh Bisht, 36, was arrested from Dwarka on Wednesday. He sold stolen vials of chemotherapy drugs Keytruda and Opdyta to Mr. Chauhan for ₹65,000 and ₹35,000, respectively. Mr. Bisht has a diploma in general nursing and 10 years of experience in the field.

Jitendra, 33, worked in a bone marrow transplant unit at an oncology department. He was caught red-

handed by the police when he came to supply three vials of chemotherapy drugs to Mr. Chauhan. "These were drugs meant for patients at the hospital where he worked," said a senior officer.

Majid Khan, 34, worked as a senior staff member at a chemotherapy daycare unit in Gurugram. Mr. Khan was paid a commission of ₹4,000-₹5,000 for each vial he stole from his workplace. He was arrested from his house in Jaipur on Thursday.

The fourth accused, Sajid, 33, worked at an oncology department of a Gurugram-based hospital.

He has a diploma in general nursing and was arrested for supplying drugs to Mr. Majid.

The law did not come into force during the subsequent four years and two months.





# U.S. probing Adani Group over potential bribery, says report

#### **Reuters** BENGALURU

The United States has widened its investigation of Adani Group to focus on the conduct of its founder, Gautam Adani, and whether the company may have engaged in bribery, Bloomberg News reported on Friday.

Prosecutors are digging into whether an Adani entity or people linked to the company, including Mr. Adani, were involved in paying officials in India for favourable treatment on an energy project, the report said, citing people with direct knowledge of the matter.

The U.S. Attorney's office for the Eastern District of New York and the Justice Department's fraud unit in

Washington are handling the investigation and are also looking at Indian renewable energy company Azure Power Global, the report added.

"We are not aware of any investigation against our chairman," Adani Group told Bloomberg News

Adani Group, Azure Power, and the DOJ did not immediately respond to Reuters' requests for comments. The Attorney's office could not be immediately reached.

Adani Group's stocks and bonds saw a massive selloff early last year after U.S. short-seller Hindenburg Research issued a report that alleged improper governance practices by the group. The Indian firm has denied the allegations.



# Many top electoral bond donors were under scanner of ED, I-T Department

n analysis of firms which feature among the top purchasers of electoral bonds throws up many curious patterns. One of the common links is that a significant number of companies in the top donor list were under the scanner of the Enforcement Directorate or the Income Tax (I-T) Department at some point of time in the past five years. In some cases, these companies bought a chunk of the bonds in the days following such searches.

Future Gaming and Hotel Services PR was the largest donor to political parties through the electoral bond route, with a cumulative sum of ₹1,368 crore. In May 2023, the ED carried out searches at the residence of Santiago Martin, a well-known lottery magnate and managing director of the company, in Chennai

The ED also conducted searches at the business premises of the company in Coimbatore under the provisions of the Prevention of Money Laundering Act (PMLA). A year earlier, on April 2, 2022, the ED attached movable assets worth ₹410 crore under the PMLA in a case of lottery scam against the company and its subsidiaries. Interestingly, five days later, on April 7, 2022, the company made a significant purchase of electoral bonds worth ₹100 crore, marking

Keventer Agro, a company which shares its email domain with Madanlal and MKJ Enterprises, ran into controversy following a public interest litigation (PIL) petition filed by West Bengal Congress unit chief Adhir Ranjan Chowdhury after the State government's sale of its stake in Metro Dairy to Keventer Agro in 2017. The West Bengal government divested its 47% shares in Metro Dairy to Keventer Agro Ltd. for ₹85 crore in 2017.

In the same year, a Singapore-based private equity fund picked up 15% shares of Keventer Agro for ₹170 crore. Currently, Mayank Jalan is the managing director of Keventer Agro and also a director of Metro Dairy.

The ED started an investigation into the divestment of the West Bengal government's stake in Metro Dairy in 2019. Summons were issued to several officials of the State government. including H.K. Dwivedi, who was the State's Finance Secretary in 2017, when the shares of Metro Dairy were divested. Summons were issued to State officials, including Mr. Dwivedi, in June 2020 and March 2021. In February 2021, searches were conducted by the ED officials at the office of Keventer Agro Ltd. in Kolkata in connection with the probe.

The investigation lost steam after the Calcutta High Court in June 2022 dismissed the PIL plea filed by Mr. Chowdhury alleging lack of transparency in the divestment. The Supreme Court in September 2022 upheld the Calcutta High Court order.

### Assam CM threatens legal action against Congress MP

Assam Chief Minister Himanta Biswa Sarma threatened legal action against Congress MP Pradyut Bordoloi on Friday for alleging that the State government has signed a Memorandum of Understanding with a company that gave donation to the BJP through electoral bonds. "The allegations levelled by Pradyut Bordoloi is devoid of any facts and are entirely baseless," Mr. Sarma posted on X. Earlier, Mr. Bordoloi, the Nagaon MP, reposted a tweet of a person who alleged that the Assam government had signed an MoU with a firm and shared a donors' list, in which the firm's name figured, along with amounts donated to the BJP. Responding to the CM's tweets, Mr. Bordoloi said that he welcomed any such move to prosecute him. He also added that the CM should not forget that the electoral bonds "scam" had been unearthed on the direction of the SC to invite public probity which is integral to democracy. PTI

### Pak. agency bought bonds after Pulwama attack: RJD

Senior RJD leader Manoj Jha on Friday alleged that the data on electoral bonds had proved that the ruling Bharatiya Janata Party (BJP) at the Centre was "the most corrupt political party in the history" of the country. Mr. Jha, the RJD national spokesperson, also claimed that the data flew in the face of the "nationalistic pretensions" of the BJP, while lending credence to the charge that the Central investigating agencies were being misused for political ends. "The data show that shortly after the Pulwama terror attack, a Pakistani agency purchased electoral bonds. So much for the nationalistic pretensions of the BJP, which stands exposed as the most corrupt party in the history of Independent India," Mr. Jha said. The Rajya Sabha MP also pointed out that "a private company was raided by the ED and, a few days later, it ended up purchasing electoral bonds. Anybody can join the dots and make out what the party has been up to". PTI

# 'Huge assumption to link ED searches with bond purchases'

In a blistering attack on Prime Minister Narendra Modi over the electoral bonds scheme, Congress leader Rahul Gandhi on Fridav accused Mr. Modi of "running the world's largest extortion racket".

He alleged that the funds amassed through the now-scrapped scheme were used to split political parties like the Shiv Sena and the Nationalist Congress Party in Maharashtra, and to topple Opposition governments.

Congress president Mallikarjun Kharge demanded a Supreme Court-monitored inquiry, while the party's communications chief Jairam Ramesh alleged that companies which donated to the BJP were granted government contracts in a *quid pro quo* arrangement.

Interacting with media in Thane at the end of day 62 of his Bharat Jodo Nyay Yatra, Mr. Gandhi said that the opaque electoral bonds system was designed to benefit the ruling party.

"Now it turns out that this is a way of extorting

Terming it criminal extortion from corporate India, the Wayanad MP said that he was not making allegations, but stating facts. "Months after a contract is given or days after the CBI or ED raids take place, the companies suddenly start giving electoral bonds to the BJP. Certain companies which never donated money to the BJP, have got cases filed by the ED, CBI, and then the corporates donate money to the party. It's upfront," Mr. Gandhi said.

The Congress leader alleged that the Enforcement Directorate (ED) and the Central Bureau of Investigation (CBI) had morphed into BJP and RSS entities.

Asked by The Hindu about certain companies which bought electoral bonds and have projects in Congress-ruled Karnataka and Telangana, Mr. Gandhi said, "There is no correlation between the electoral bonds and the contracts given by the Congress or other Opposition parties' governments in States."

### Govt. notifies rules to improve film certification process

The Central government has notified the Cinematograph (Certification) Rules, 2024, in order to improve the process of certification of films for public exhibition. "These new rules aim to streamline and modernise the film certification process for the digital age, keeping pace with the emerging technologies and advancement in the film sector," the Information & Broadcasting Ministry said on Friday. The rules introduce age-based categories of certification by further subdividing the existing UA category into three age-based categories: seven years (UA 7+), 13 years (UA 13+), and 16 years (UA 16+), instead of 12 years.

### U.P. Police arrest three in question paper leak case

The Uttar Pradesh police on Friday arrested three persons accused of leaking the question paper of the cancelled constable recruitment examination. Director-General of Police Prashant Kumar said the accused were former employees of a company that transported question papers. 

The wealth one enjoys, or the poverty in which he is steeped are but the consequences of his past deeds - noble or wicked as the case may be.


We cannot say when the karmas will start giving results.

# **Food factor**

#### Inflation is impacting personal consumption and hurting growth

he latest retail inflation data, yet again, underscores how volatile food prices continue to hold hostage not only broader inflation but also the lynchpin of economic growth, namely, personal consumption. While February's headline Consumer Price Index (CPI)based reading remained virtually unchanged from the preceding month, at 5.09%, the pace of food price gains computed from the Consumer Food Price Index accelerated by 36 basis points to 8.66%. Vegetable prices continued to remain the biggest concern, with the third-heaviest food category in the food and beverages sub group of the CPI registering 30.3% inflation year-on-year, a disconcerting 315 basis points acceleration from January's reading. And inflation in cereals, the largest weight among foods in the CPI, also remained high at 7.6%, just marginally slower than the preceding month's 7.83% pace. Among vegetables, the potato-onion-tomato triumvirate, which is the most-widely consumed group nationwide and constitutes more than a third of the weight in the category, led the charge. Potato prices moved from an almost 2% year-on-year deflation in January to a 12.4% inflation, onion logged 22.1% inflation and tomato's price gains quickened by close to 400 basis points to a sixmonth high of 42%. A look at the Department of Consumer Affairs' daily price monitoring dashboard shows little respite on this front, with average retail prices of potato, onion and tomato reigning 21.3%, 41.4% and 35.2% higher, respectively, as on March 14 from a year earlier.

Clearly, the government's supply side measures, including a three-month-old ban on export of onions, has had little impact on cooling prices of these politically sensitive food inputs. And the outlook too is far from reassuring. Onion output in the 2023-24 horticulture crop year is seen more than 15.6% lower than last year and production of potato is projected to log an almost 2% deficit as in the Ministry of Agriculture and Farmers Welfare's First Advance Estimates released on March 7. The water storage data from the Central Water Commission, showing live storage at 150 reservoirs across the country as on March 14 at 40% of capacity, and trailing both the 10-year average and the year-earlier levels, also does not portend well for summer-sown crops. This is particularly so in the southern region, where the storage deficit compared with the 10-year average is a most acute 29%. Reserve Bank of India Deputy Governor Michael Patra aptly summed up the risks to the economy from persistently high food inflation in his statement to the Monetary Policy Committee last month when he observed: "private consumption, which accounts for 57% of GDP, is languishing under the strain of still elevated food inflation. This is particularly telling in rural areas. Inflation has to be restrained to its target for growth to be inclusive and sustained." Policymakers have their task cut out if the economy i

It's 'Ra-Ra-Ras-Putin' in the Russian election

he Russian presidential election (March 15-17, 2024) is the country's eighth presidential election since the dissolution of the USSR. Vladimir Putin is contesting for a fifth term, also the first time after the 2020 constitutional amendment nullifying his previous terms. He was first elected in 2000 and then re-elected in 2004, 2012 and 2018, with a brief interlude from 2008-2012 when he was the Prime Minister, making his trusted man Dmitry Medvedev the President. Mr. Putin remained the de facto ruler, and it was to avoid the constitutional requirement that forbade the sitting President to seek a third consecutive term.

#### No serious opponent, the future

In this election, the outcome of which is a foregone conclusion, given that there is no serious contender in the foray, he will be in power for the next six years. He can be re-elected in 2030 and technically remain in power until 2036. Mr. Putin will contest as an independent candidate in 2024. The other three contenders, Nikolai Kharitonov (in his 70s) of the Russian Communist Party, Leonid Slutsky (in his 50s) of the nationalist Liberal Democratic Party of Russia, and Vladislav Davankov (40) of the New People Party, are also in the race. Mr. Kharitonov was a distant second in the 2004 election. All three candidates are considered to be very close to Mr. Putin and have been supportive of the Kremlin's policies, which includes the invasion of Ukraine. In a way, they are puppets in the well-orchestrated drama of the Russian presidential election.

The only serious opposition presidential candidate, Boris Nadezhdin, a critic of the Russian war with Ukraine, was debarred by the Central Election Commission of the Russian Federation. Speaking to CBC News, Mr. Nadezhdin said, "Elections in Russia now are not fair and not free, but I don't know another way to challenge the politics and power in Russia." Another most prominent Putin opponent, Alexei Navalny, died in a high-security Arctic penal colony in February 2024, with his supporters alleging that he had been murdered and that Mr. Putin was behind it. Predictably, the Kremlin refuted this allegation and, interestingly, did not explain what led to Navalny's death.

Then what is the rationale behind such an exercise? What does it say about the Russian political system and political culture? And how will it impact Russian foreign policy, Europe in particular and world politics in general? Abbas Gallyamov, a political scientist and former speech writer for Mr. Putin, has described the election as

What makes Vladimir Putin tick, in his bid for a fifth term, is his role as arbiter in the political culture of Russia

where "multiple choice is replaced with a simple, dichotomic one: 'Are you for or against Putin?' And has said that it will be a referendum on the issue of the war and a vote for Putin will become a vote for the war." "The current election will not offer even a semblance of competition to Mr[.] Putin, much less give a limited stage to any critical opponent as past elections sometimes did. It will not be an election, but a plebiscite on the loyalty to Putin," says Ms. Masha Lipman, a Russian journalist.

In a poll by the Levada Centre (it is known for its reliability) in January 2024, it concluded that mass opinions over the Russia-Ukraine war (Russia calls it special military operations) in favour of Russia remain high. For instance, 85% of Russians approved Mr. Putin's actions; there was 77% approval of the military's actions. Despite the approval ratings, war fatigue is setting in, but it is less than what it is in Ukraine. With the progress of the conflict, the goalposts of the war are also shifting. It started as a war against "Nazism" in Ukraine, but has gradually shifted to a war on the West. But the initial goal is touted as the ultimate objective of the war.

#### Why Putin is still popular

The resilience shown by the Russian economy in the face of sustained western sanctions is credited to Mr. Putin's leadership. Scholars have attributed this success to the "Military Keynesianism" of Mr. Putin. The shot-up demand for military hardware in the face of a war of attrition has spurred the growth of the military-industrial complex. This has led to increased military contracts and import substitution in response to sanctions. This has also created a demand for skilled labourers and a support base that has benefited from the war.

The Ukraine war is projected as a western plan to weaken Russia and impose western cultural hegemony over it. Historically, Russia has projected itself as a fortress of liberal-conservative values that trace their origin to the Russian orthodox church. The idea of "Moscow-Third Rome" is one of the Kremlin theological theories and it projected itself as a true representative of conservative Christian values. Liberalism and its value of individualism present a threat to the communitarian and social values of Russia and the preservation of traditional Russian values, being projected as if the West is attacking it.

The common perception that Mr. Putin completely controls the affairs of the Russian state is a half-truth. Mr. Putin is the lynchpin around which Russian politics revolves, but there is the entrenched control of the Russian elites. and Mr. Putin is the arbiter of different interest groups. These interest groups are made of the bureaucracy, the business elite and local political elites, and their complete loyalty towards Mr. Putin is needed to ensure their survival. They are certainly competing for favour, and it is dependent on loyalty towards Mr. Putin. In a way, there are two social contracts – i.e., one between state and citizen and the other between the state and elites.

#### **Russian political culture**

One probable reason for Mr. Putin's iron fist-like control over the Kremlin is the political culture of Russia. Russians are invariably described as the enablers of their own autocracy. Western accounts portray supporters of democracy as a small minority in Russia, amidst a majority that is supposed to be inclined to authoritarianism. This attitude relates to the Russian history of autocratic regimes, political culture and the absence of a democratic government. In a counter to this cultural determinism, Russian authoritarianism is described by some scholars as circumstantial, a result of the unfortunate coincidence of Russia's Soviet past, democratic opening with institutional disintegration, economic disruption and political uncertainty. A section of scholars believes that Russians are both authoritarian and democratic at the same time, which Levada dubs as "Russian doublethink". Russian scholar Richard Sakwa has rebutted the historicism of these scholars - the past, like facts, is created in the eyes of the beholder. There are many Russian pasts that reflect its European and Asian identities.

Any monocausal explanation for the current state of the Russian political system flies in the face of a nuanced understanding of Russia. As Churchill famously said about Russia, in 1939, it is a "riddle, wrapped in a mystery, inside an enigma". This is a statement that still holds true, signifying Russia as the intimate 'other' of the West. It amalgamates many elements, some rooted in Russia's culture, history, and precarious geopolitical position. Political leadership does have an important place in all this. Doomsday prophecies of western scholars should be taken with a pinch of salt. The resilience shown by the Russian state in the face of heavy-handed economic sanctions and the efforts on the part of the West to isolate Moscow give Russia a prominent place on the world stage. Russia's efforts to galvanise the support of anti-western countries and expose the double standards of the West seem to be successful.

## Homecoming

#### A.P. is set for a three-cornered contest after the TDP's return to the NDA

he Bharatiya Janata Party (BJP) pulled off a major tactical victory in Andhra Pradesh as it welcomed back an estranged ally, the Telugu Desam Party (TDP) and a former Convenor of the ruling National Democratic Alliance (NDA) in New Delhi and former Andhra Pradesh Chief Minister N. Chandrababu Naidu. With a vote share of only 0.84% in the Assembly election in 2019, the BJP was all but written off in the State. It was perceived as the party that reneged on its promise to extend the Special Category Status (SCS) by another five years. While many viewed the TDP's exit from the NDA just months ahead of the 2019 elections as too little too late, given the widespread discontent against the alliance for 'betraying' the State, the TDP managed to poll almost 40% of the votes, despite contesting on its own, but won only 23 of the 175 seats in the Assembly. While actor-turned politician Pawan Kalyan's Jana Sena Party (JSP) garnered around 6%, winning one seat, the BJP, that contested on its own in 173 of the 175 seats, drew a blank. The five-cornered contest gave the Yuvajana Sramika Rythu Congress Party, and its leader Y.S. Jagan Mohan Reddy an impressive 50% vote share and a brute majority of 151 seats in the Assembly.

While the exit of Y.S. Sharmila from the YSRCP – she is Mr. Jagan Mohan Reddy's younger sister - has given the Congress a lifeline in the State, and has become the Chief Minister's Achilles heel, the TDP remains the main opposition. The pre-dawn arrest of Mr. Naidu by Andhra's Crime Investigation Department on September 9, 2023, over corruption allegations in the Andhra Pradesh State Skill Development Corporation case has won the 73-year-old, three-time former Chief Minister considerable sympathy among the State's people. It remains to be seen if the anti-Jagan votes will be split between the Congress-led United Progressive Alliance and the NDA, possibly delivering a win for YSRCP, or if there could be considerable shift in the incumbent's vote base (minorities, Dalits and Backward Castes, who might view Ms. Sharmila as a bearer of the YSR legacy) and give the TDP the advantage in a three-cornered contest.

# The crime that enraged Puducherry

On March 2, a nine-year-old child, who had gone out to play, went missing from her neighbourhood in the Union Territory. Three days later, her body was found in a drain. **Rajesh B. Nair** reports on the crime that brought the residents of the city to the streets, and the agony of the family who knew the accused

> y all accounts, Nithya (name changed to protect identity), 9, was a cheerful child. She studied at a primary school in Puducherry, a coastal city in the Union Territory of the same name, bordering Tamil Nadu in the south. Her father says she enjoyed playing sports and the freedom of walking or cycling along the narrow lanes of her neighbourhood, located at one end of Beach Road, where houses are densely packed together. She would buy biscuits or sweets from small shops. Like many children her age, she was curious. On March 2, Nithya went out to play. She should have been gone only a short while, but she did not return. Her sister, 11, was the last to see her. Her parents filed a missing complaint. Two days later, when the police found no leads, her parents hit the streets, along with relatives and residents of the neighbourhood, in protest. They staged a blockade on the arterial Mahatma Gandhi Road, demanding that the police make more of an effort in tracing the child. The protesters dispersed only when the police assured them that they would intensify their search and find the girl soon. When yet another day passed without any signs of progress in the investigation, the agitation began to snowball. Campaigns seeking justice for the girl began trending on Facebook and X (formerly Twitter). Cadres of Opposition parties, including the Dravida Munnetra Kazhagam, the Congress, the Left parties, the Viduthalai Chiruthaigal Katchi, and the All-India Anna Dravida Munnetra Kazhagam, joined the protesters on the morning of March 5. Lieutenant Governor Tamilisai Soundararajan and Home Minister A. Namassivayam, who belongs to the Bharatiya Janata Party (BJP), held meetings with senior police officers to review progress in the case. The same afternoon, the child's body, with her hands and feet tied, was found in a drain a few metres from her house. The discovery came as a shock to the city. S. Sundhari, a resident of Nithya's neighbourhood, says, "We have heard that such atrocities happen to girls in different parts of India. But we never thought it would happen to a child in our locality." However, according to data furnished by the Puducherry police, the Union Territory with a population of nearly 14 lakh people recorded 164 cases pertaining to crimes against women last year. Of these, 92 cases were registered under the Protection of Children from Sexual Offences (POCSO) Act, 2012; 30 on charges of molestation; and nine on charges of rape. The day the body was found, the police held two men from Nithya's neighbourhood on charges of kidnapping and murder. The victim's family says they knew the accused. Namassivayam announced that a Special Investigation Team had been constituted under Senior Superintendent of Police Kalaivanan to probe whether more people were involved in the case. Earlier, this week, the post-mortem report revealed that the child had

"Everyone here knows one another," says Sundhari. "Usually, we tell our children to be cautious while mingling with strangers. Now, it is scary that we have to teach them to be wary of people known to them too."

#### The day she disappeared

On March 2, at 8 a.m., Nithya's parents left her at home with her sister and went to work. Nithva's mother works at a health centre as a help and her father owns a mini truck which he drives mainly to transport fish from the harbour to various markets. It was Saturday, a non-working day for primary schools. The parents routinely left their daughters at home except on Sundays, when the mother would take the day off. The police say Nithya stepped out to play soon after. She returned home to eat lunch before leaving the house again. At around 5 p.m., Nithya's mother came home and only found her older daughter. When there was no sign of Nithya for some time, she went around the locality in search of her, gripped by dread. She went with a few relatives to the police station and lodged a complaint. She then called her husband to inform him that their daughter was missing. "I came home immediately," Nithya's father recalls. "We searched all the areas near our house. Soon, it was night. We thought she may have been kidnapped as there have been reports of child kidnapping cases in recent times." After registering a case of kidnapping, the police and the girl's relatives combed through the entire area. They navigated their way first through the narrow lanes and then the wider adjacent ones, marked by posh houses, large guest houses, and hanging bougainvillea. They went to the beach, searching for her near stalls and amid the slippery rocks withstanding the force of the waves. The CCTV footage from the area also did not show any signs of Nithya. "We initially restricted the search to the child's residential area, but there was opposition from the relatives. They strongly believed that the girl had been abducted and taken elsewhere. So, we extended our search beyond Puducherry," says a police officer, who was part of the initial investigation.

Three days after the search, the police finally found the partly decomposed body of the child in a drain. The injuries on her body indicated that she had met a brutal end.

#### Men known to her

During the days between the time Nithya went missing and her body was found, the police came under some flak. Residents in the neighbourhood felt that the response to the missing complaint had been lukewarm. They wanted the police to cast the net wider, but the investigators seemed keen on searching the neighbourhood first.

Under pressure, the police intensified their investigation and picked up some suspects for questioning. One of them was Kakka alias Karnas, 19, a school dropout. Karnas lives with his mother and siblings some 50 metres from Nithya's house.

When he was interrogated, the police say Karnas admitted that he had taken the child to the house of Harikrishnan alias Viveganandan, 56, a dairy farmer, when she was playing. Viveganandan, too, lives a stone's throw away from her house. "He used to give Karnas money to buy alcohol and cannabis," says a neighbour. "Karnas would often go to his house to party." Srinivas says the police will file the charge sheet in 5-6 weeks. The government has also decided to approach the district court to fast-track the trial once the charge sheet is submitted.

Former Lieutenant Governor of Puducherry Kiran Bedi believes that the Puducherry government should not allow more liquor outlets and should reduce its dependence on revenue from liquor. "There is also need for better rehabilitation centres, including in prisons," she says.

#### Educating the child

Following the incident, the people of Puducherry have questioned the effectiveness of policing, especially the weakness of the 'beat system'. Under this system, every constable is assigned an area and is mandated to frequently visit it to learn about the issues that the people face.

"In recent times, we have seen a weakening of the beat system. We don't see anyone patrolling these areas. Senior officers do not conduct field visits. If senior officers did that, inspectors and the constabulary would be on their toes," says Raghu Chandran, a resident.

But Assistant Professor of Criminology at Rashtriya Raksha University, Puducherry Campus, Shivalaxmi Arumugham, says this is not a viable solution. "Although the police do instil fear among the people, we cannot have them around at all times. Community or public vigilance is also important. And any suspicious activity should be reported immediately," she says. Her colleague, Nethaji Subash, adds that only a collaborative exercise will enhance public safety.

The accused confessed that they raped and murdered the child and dumped her body in the drain behind Vivaganandhan's house, according to the police. The confession was corroborated by medical evidence. The post-mortem was conducted at the Jawaharlal Institute of Postgraduate Medical Education and Research in Puducherry.

Based on these statements, the police arrested Karnas and Viveganandan under Section 6(1) of the Protection of Children from Sexual Offences Act, 2012; the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989; and under several sections of the Indian Penal Code including 363 (punishment for kidnapping), 342 (punishment for wrongful confinement), and 302 (punishment for murder). The two men have been remanded to judicial custody and lodged in separate cells at the Central Prison in Kalapet, around 15 kilometres from Puducherry town.

While Karnas stayed put in the locality after allegedly committing the crime, Viveganandhan left for Kottakuppam in Villipuram district, about 2 km away. They police say he, too, knew the child. Neither of these men had a criminal past, but both of them were known to get into trouble. Neighbours say Viveganandan was once beaten up by the residents for his "inappropriate behaviour with women." They allege that his wife left him because she was disgusted with his attitude towards women. Karnas, they say, used to fight with his mother for money after getting drunk. He would also smoke cannabis and get into brawls with the residents of the locality.

Nithya's father recalls seeing the two accused spend their evenings at the same place where his daughter's body was recovered. "I have seen Karnas and his friends smoking *ganja* near the drain. Sometimes, Viveganandan would join them. We warned them several times not to smoke and drink in public places," he says.

While political parties and residents link the crime to substance abuse, the police say there is no evidence. "We can't say the murder is directly linked to drug addiction and alcoholism. But when Karnas was arrested, he was high. It took him hours to get sober," says a police officer.

The Director General of Police, B. Srinivas, says the police are making efforts to prevent the sale of drugs. So far, they have focussed on cracking down on the supply chain and on sources from other States. There is no organised drug cartel operating from Puducherry, he adds.

"Drug addiction is a social menace which has to be prevented through awareness. While strong enforcement is the responsibility of the police, it is also necessary that various sections of society and government departments come together to create awareness," he adds, in officialese.

"It will also lead to a better relationship between the police and community," he says. "Regular meetings between the police and the residents would help create awareness about crimes and also help people identify potential offenders."

Arumugham adds that it is important for people to know that those who abuse children are often known to them. "These offenders are often from the family or the neighbourhood. Educating children is important. They should know that they can report anything that makes them uncomfortable. Education is also important for parents. If they see behavioural changes in their child, they should speak to the child. This way, we can prevent atrocities," she says.

In any society, children should be able to play outside or roam around without fear, says child rights activist Vidyaa Ramkumar. "It is the child's right to play or roam around alone or with friends in the neighbourhood. This is important for the child's development. But adult supervision is definitely required," she says.

Before Nithya was cremated, Chief Minister N. Rangasamy announced a compensation of ₹20 lakh to the family. Representatives of the National Commission for Scheduled Castes and Scheduled Tribes visited them with a cheque of ₹7.12 lakh. A delegation of the BJP, led by party in-charge for the Union Territory, Nirmal Kumar Surana, went to the victim's house on March 14 and gave the family compensation of ₹5 lakh.

Money cannot take away from the family's grief, though. Nithya's father recalls how he saw Karnas even when he was searching for his daughter on March 2. "He was near my house," he says, shaking with anger. "He even used to buy sweets and ice-cream whenever he saw my child. I had no idea that he had such a beast in him."

# When temple PRASAD leaves a bitter aftertaste

The Simhachalam Temple's grand expansion has cast a shadow over the local hamlet that houses 70 families of the Konda Dora tribe. Temple officials embarked on a relocation mission in 2003 under the Pilgrimage Rejuvenation and Spiritual Augmentation Drive, shifting 60% residents out of the hamlet. Those who put their foot down and stayed back continue to fight for basic amenities, finds V. Kamalakara Rao

lacking essential amenities like electricity, drainage systems, and government services. During temple events, their area is completely sealed with sidewalls in a bid to conceal them and their challenging living conditions from visitors, espe cially VVIPs, they say.



#### The stark contrast

Dedicated to Lord Narasimha, the fourth incarnation of the Hindu god Vishnu, depicted as halfman, half-lion, this temple holds great religious importance and is among the oldest in the country.

According to the tribals, the temple management has not only tried to grab the burial ground but also their hamlet, known locally as ST Colony, or Scheduled Tribe Colony, named after their legal status given by India's Constitution. This settlement, home to about 250 people from 70 families of the Konda Dora tribe, has existed for centuries, they say.

Situated approximately 100 metres from the main entrance of the temple, the hamlet falls within the jurisdiction of Simhachalam village in Adavivaram gram panchayat of Visakhapatnam Rural mandal. It is topographically part of Visakhapatnam city, which Chief Minister Y.S. Jagan Mohan Reddy plans to make the State's executive capital. However, despite the hamlet's vast history and importance, the tribal residents find themselves cramped out, their tranquillity disturbed.

Temple officials state that attempts to relocate the tribals began in 2003 under the Centre-sponsored scheme, PRASAD (Pilgrimage Rejuvenation and Spiritual Augmentation Drive), aimed at temple development. As part of the initiative, 193 families in the hamlet were identified for relocation to the Gosala area at the bottom of the hill. Although 60% of them were moved, the remaining continue to hold onto their roots but at a price – they are struggling with civic and other issues. They express a profound sense of isolation,

"The temple is literally next door. We can hear and see every activity in the temple like Suprabhatam, the first ritual to wake up the Lord. The temple is decorated with flowers for every occasion and vibrantly illuminated. But our hamlet which is next to the temple is always in the dark. We did not want to leave during the relocation drive due to our love for the Lord and attachment to our place, but we didn't expect such bitter circumstances," says J. Devudamma, a tribal resident of Simhachalam.

The hamlet is perennially littered with garbage and silt, resulting in malodorous streets. In a nutshell, the settlement stands in sharp contrast to the delightful fragrance permeating the temple area.

#### The original settlers

Delving into the history, K.V. Narasimham, a resident of the ST Colony who works as a homeguard in the Police department, says his ancestors originally resided on the same hill in the Chintapaka area near the Madhava Swamy temple, a small structure on the same hill, about 500 metres from the ST Colony. His ancestors were brought to the temple to serve as security personnel, he says.

"That's how they decided to settle here. The elders used to collect forest produce from the hills and sell it on the temple ghat roads in those days, but now our people are doing menial jobs as sweepers and sanitation workers at the temple, or selling flowers to visitors," he adds.

However, some others, including former sarpanch Pasarla Prasad, contend that the hamlet belonged to the hill tribes, who were the initial inhabitants. Subsequently, as the temple developed and roads were laid, people started going up the hill to worship the Simhachalam temple



deity. According to them, the tribe called Boyina Durgadu stumbled upon the temple and started worship

The Simhachalam hills, where the hamlet is situated, serves as a natural barrier, safeguarding the city from calamities like cyclones. Located on the west side of the core city, this geographic feature attracts environmentalists and ornithologists for activities such as bird watching and trekking. Despite the temple's widespread fame, the tribal village adjacent to it remains unknown to the world.

The hamlet has 50 houses. Typically, two or three families share a single house since only a few have metered electricity connections. Every Thursday, the residents visit the weekly market at the foot of the hill to buy groceries.

Men here maintain familial ties in Narsipatnam, Kotavuratla, Chodavaram, Devarapalli, Koonam, Madugula, and Paderu tribal regions of the erstwhile Visakhapatnam district. While young women often seek grooms in those areas and settle there, the men usually find local girls to marry. Outsiders are hesitant to marry brides to the men here, citing the hamlet's poor infrastructure such as damaged houses and roads.

#### Slip between the cup and lip

Under the Jawaharlal Nehru National Urban Renewal Mission (JNNURM) scheme, attempts were made to get 77 houses sanctioned for the residents. Beneficiaries were identified in 2008 during Mukesh Kumar Meena's tenure as commissioner of Greater Visakhapatnam Municipal Corporation (GVMC), says P. Vasantha Kalyani, who was corporator of 72nd ward then.

"The process was abruptly halted after officials found out that the temple authorities had already arranged for houses for the tribals as part of the relocation drive under the PRASAD scheme," she explains.

During the monsoon, the houses and stairways become narrower due to mud accumula-

• • •

tion from the hill. The slope allows rainwater to enter their settlement, leaving them miserable. Those without access to water and other basic facilities resort to collecting water from streams and gathering firewood for cooking. The hamlet is also prone to snake encounters due to the densely forested hills.

"We get seasonal fevers, but we don't worry about it. It is because our body has adapted to the climatic conditions here. The only problem is the lack of infrastructure," says Kundi Prasad, 50, who works as the sweeping supervisor of the temple on a contractual basis.

Communist Party of India (Marxist) leader T.V. Krishnamraju, who is advocating for tribal rights, says the temple authorities have built some houses on the hill and spent crores of rupees in the name of cottages, which remain unused. He suggests repurposing the structures for tribal housing with minor repairs or renovation.

#### **Property rights**

He points out that the GVMC appears to have stopped collecting house tax from tribals here, raising concerns about their property rights. "Payment of taxes is the proof of ownership of properties. But, as tax is not collected, people are worried about their rights on the hamlet here," Krishnamraju asserts.

The issue of tax collection has been brought to the notice of the current GVMC corporator (98th ward) Pisini Varaha Narasimha, who promises to address it with the officials concerned. "If this is true, it will be brought to the notice of GVMC officials and justice will be given to the people. However, shifting the tribals from there is completely the lookout of the temple management," he explains.

Executive Officer of the Simhachalam Devasthanam, S. Srinivasa Murthy clarifies that there is currently no directive to evict the ST Colony residents: "There has been no progress on the previous proposals of evacuation of the tribals in the hamlet. It is true that his predecessors had requested to shift them from the present place to another area for the temple development under the PRASAD scheme, but now, there is no movement in that proposal. However, we are willing to listen to them."

Sources say the reluctance to disturb the residents stems from their adaptation to living conditions and the climate, making them well-suited for temple security. Expressing frustration, a tribal resident, requesting anonymity, says, "Let them relocate us to a place with proper facilities or ensure essential services where we are right now. But first, they should stop treating us as lesser mortals."

# The long, bumpy road from 'drone didis' to 'lakhpati didis'

Fertiliser companies have taken the lead in facilitating and funding the first leg of a Central government programme that will train 1,000 women to own and operate drones for spraying pesticides. Maitri Porecha reports from Haryana, on the initial challenges of the scheme for women's entrepreneurship

Raji is one of the initial 1,000 drone didis selected by fertilizer companies from across India to be trained under the Central government's Namo Drone Didi scheme to fly agricultural drones connecting that will spray fertilizers over crops. Armed with a pilot's licence from the Directorate General of Civil Aviation (DGCA), they are meant to be seen RAM RAJI as changemakers. In November last year, Prime Minister Narendra Modi announced the decision to engage 15,000 women from rural self-help groups (SHGs), at an outlay of ₹1,261 crore, to cover the cost of drones and battery sets. This amount has not yet been spent, says a Central government official working closely with the scheme. Over two months after the announcement, PM Modi interacted with the first 1,000 drone didis on March 11. However, officials say exact modalities and the future road map are still unclear. "The government has planned for another 6,000 drone didis to be trained in 2024-25, and another 8,000 in 2025-26," the official says.

#### **Influencer marketing**

The Haryana government will foot the bill for the service provided by the drone *didis*, promising them ₹400 for every acre sprayed. No other State has offered this. "In Punjab, Uttar Pradesh, Andhra Pradesh, and Telangana, farmers must spend their own money for spraying," the Central government official says.

Raji was given a target of 257 acres in Julana block over two months. Her counterpart, Kavita Dhull, 35, in Rohtak district, had a target of 800 acres, of the 4,000 acres to be covered exclusively by drone *didis* out of the total two lakh acres.

Kuldip Singh Hooda, 40, is among a minority of 1.000-odd farmers in Dhamar village, Rohtak district, who has a substantial landholding of 15 acres. Most others own land between two and four acres. "I had registered to get 15 acres sprayed. However, the drone didi who came sprayed six acres and said she didn't have the time to do the rest. No one came again to spray the other nine acres," he says.

another landowner. "I don't have enough money to build my own house, buy a tractor, or send my children to a good school. What use are drones for me?" he says.

#### The women's challenges

Dhull makes her way down a bumpy kuccha road of Dhamar village along with her assistant, who drives the electric autorickshaw, and then helps her unload the heavy metal box that contains the 25-kg drone.

"I cannot venture into the fields alone, because of safety concerns. I need a helper who can drive the EV. The vehicle does not easily reverse, and has even toppled over. The drone weighs nearly 30 kg after being loaded with fertilizer and water. It takes two people to lug it around," Dhull says. She pays her assistant ₹15,000 a month. "There is no provision for helpers in the scheme," she says.

As soon as she covers three acres, she exhausts one charged battery set needed to fire up the drone. She simultaneously charges another set in her EV to cover more ground. Dhull ends up charging four battery sets each day to finish her day's work on the field. "I spend nearly ₹500 to ₹600 each day on fuel to run the generator that charges the battery sets." She isn't sure how the job will work out economically in the long run.

#### Costs to companies

The official adds that the cost of training the first batch of drone *didis*, equipping them with the drone and its components (four battery sets, a generator), and an electric autorickshaw is being borne by fertilizer companies like Indian Farmers Fertiliser Cooperative Limited (IFFCO) and Coromandel International Limited (CIL).

"IFFCO is supporting training and supply of equipment worth ₹42 crore at the rate of ₹14 lakh per woman, including the electric autorickshaw for 300 drone didis, while CIL is supporting another 200," the official adds. IFFCO has cited this expense as "benefits to farmers" in its books.

Among other companies that have assured a joint supply of 500 additional drones are Krishak Bharati Cooperative (KRIBHCO), Indian Potash Limited (IPL), Matix, Indorama India Private Limited, Brahmaputra Valley Fertilizer Corporation Limited, and the public-sector National Fertilizers Limited.

"The cost for each set of equipment (including a drone, four battery sets, a generator; excluding the electric autorickshaw) is ₹10 lakh, of which the Ministry of Agriculture and Farmers Welfare has agreed to fund up to ₹8 lakh, while ₹2 lakh will have to be arranged by the SHG," says the of-

However, in 40 days of work, between January 14 and February 25, Raji has been able to cover only 180 acres, averaging 4.5 acres per day, where she was supposed to cover six to eight acres every day. She is helped by her brother-inlaw, who drives the electric autorickshaw and assists her in operating the drone. "We are incurring EV charging costs and labour costs and are spending from our own pockets. We hope the promised reimbursement comes through in March," Raji says.

The Drone Didi project is a subset of the Centre's Lakhpati Didi programme, for women from SHGs to earn an annual household income of ₹1 lakh. The aim is for the women to be influencers at home and in their communities, shifting the focus from social and financial inclusion to entrepreneurial success. The Prime Minister, through his Sunday radio broadcast, Mann Ki Baat, often refers to 'lakhpati didis'. The term also found mention in Finance Minister Nirmala Sitharaman's Budget speech this year, and appears in government advertisements.

#### **Farmer trials**

To encourage farmers to apply to get their crops sprayed via drones, Haryana's Agriculture Department, along with fertilizer companies, announced enrolment through the online portal, Meri Fasal Mera Byora. Farmers would also get a

rice crops were destroyed due to heavier than usual rain during the monsoon, between July and August. "Half our annual income has been washed away," says Manjit Hooda, another farmer from Dhamar village. Manjit says he had tried registering on the portal, but his application did not go through; no one contacted him either.


For farmers to avail themselves of the subsidy, their farm will have to fall under the earmarked acreage allotted to drone *didis*, or else they will have to shell out ₹400 per acre. Many who are debt-ridden or those with small landholdings prefer to do the job manually, themselves or through less-expensive hired labour.

Traditionally, farmers procure granular urea in sacks, each sack of 50 kg at a subsidised rate of ₹268. Labour costs for manual application is between ₹80 and ₹100 per acre, making the cost of fertilizer purchase and application no more than ₹368 per acre. If they choose to use the waterbased medicine through spray cans, the application is still ₹200 per acre, half of what the drone didis charge. "Drones then will only be useful on large plantations like that of coffee, tea, or sugarcane, to make it cost-effective," the government official says.

"A big landowner can afford drones, but there are only five to 10 such rich farmers in the village," says Harinder Singh, in his mid-40s, who

#### **Push for pesticide**

India uses 3.5 lakh metric tonnes (MT), or 65 crore bags, of granular urea annually, of which 2.95 lakh MT is met with domestic production. while the remainder is imported. The Central government then extends ₹2.45 lakh crore in subsidy to make granular urea bags affordable for farmers. Only 7.42 crore bottles of liquid nano urea have been manufactured in the last two years. Manufacturing liquid nano urea costs ₹225 per bottle, while granular urea costs ₹2,000.

"Our vision is to augment the capacity of nano urea production to 48.5 crore bottles annually by 2026-27, so that we can reduce our dependence on the import of expensive granular urea," the government official explains. However, liquid nano urea (which is sprayed by drones or by the knapsack method) cannot completely replace traditional granular urea, as farms need fertilizers thrice in every crop cycle. Liquid can be sprayed only once, as only granular urea is effective at the sowing stage, and a fertilizer can only be used at the roots once the flowering begins, they add.

Many questions remain to be answered. "For instance, who will have the ownership of the drone? Will it be with the individual, the SHG she belongs to, the village organisation (VO) under which the SHG comes, or the cluster level federation (CLF) that consists of many village organisations?" says a source working in the Namo Drone Didi implementation committee. Again, there isn't clarity around future earnings. Will the money be the woman's or will some of it flow to the SHG, VO, or CLF?


Last year, the Agriculture Ministry had floated a proposal for procuring 300 drones under Krishi Vigyan Kendras (KVKs), centres attached to agricultural universities that conduct research. "While some KVKs are using drones, others are not. Before announcing another drone-related scheme, it would have been important to understand the learnings of KVKs while using drones," an official from the Agriculture Ministry added. "Also, farmers are free to buy their own drones, so imagine if a few farmers band together to buy their drone, it will eat into the business of drone didis," the official adds.

Meanwhile, Dhull has sprayed nearly 600 acres in Rohtak, and is now waiting for her money to be reimbursed by the Harvana government for her services. Now that the wheat is flowering, there is a lull in work for two months. "Let's see when we will get paid," she says.

mit. Trees are flowering unevenly, forcing them to apply the chemicals in parts.

"We are turning to the chemicals knowing well that they are deadly. But we have little choice. Pesticides are a must for our survival," Ashiq says.

Farmer-activist V.P. Nijamudheen says the banned pesticides include the dreaded endosulfan, linked to birth abnormalities in the village population close to the cashew plantations in Kasaragod district. These pesticides are illegally produced and smuggled in unlabelled containers from other States and are sprayed in secret. The use of endosulfan was prevalent at Muthalamada until it was banned by the Supreme Court in 2011. Although Kerala had banned endosulfan in 2005, it was available in other States until the Supreme Court imposed a pan-India ban. Some veteran farmers say that there's still no pesticide as effective as endosulfan.

The farmers agree that pesticide companies have made handsome profits from Muthalamada. A pesticide dealer, on condition of anonymity, says that the number of chemicals he sells in Muthalamada has increased manifold over the past four to five years. several studies, they have failed to win the confidence of farmers. The dozen-odd orchards chosen by the scientists for their study in Muthalamada about two years ago still sport their boards.

"The farmers don't trust anyone. That's perhaps why only 15 of them turned up when the Agriculture department convened a seminar here the other day," says Nijamudheen. He is peeved that the department has always ignored the farmers' demands. "Mango is still not considered an agricultural crop, and the farmers get no subsidy or compensation for crop loss," Nijamudheen says.

The farmers' demand to appoint a special officer for Muthalamada has fallen on deaf ears, and the government's promises of setting up a mango hub at Muthalamada has not been fulfilled. "It is the change in weather pattern that has upset Muthalamada. We are helpless about the untimely rains. Erratic weather has upset the flowering of trees" says Nizam

t is like our lives, deprived and desolate," mumbles K. In this hilly, dry land bordering Tamil Nadu, Ashiq has taken 2,000 mango trees across 40 acres on lease for the past decade. Crop loss has become a regular feature since 2018 – the adverse impact of unpredictable weather changes. Last year, the showers Muthalamada got in November and December dashed the expectations of farmers, who own or lease anything between two and 500 acres of land. The loss is so heavy that the farmers say they will be happy to get 15% yield in the current season.

The weather in Kerala has been erratic since the floods of 2018, which saw large-scale devastation and deaths across the State. Rains became untimely and summers, hotter in the past six years. This time around, unseasonal rain in the flowering time of the fruit played spoilsport.


More than two-thirds of the 40,000-tonne yearly produce of mangoes from Muthalamada that ripen by January and February, the earliest variety of the season, reach the wholesale markets of Delhi, Mumbai, and Ahmedabad, the largest mango markets in the country.

#### Early harvesting has mangoes in demand

In Muthalamada, where the hot weather is ideal for mango, with temperatures going up to 40°C when it is winter in most of north India, flowering begins in November and mangoes are exported well ahead of harvesting in the other regions in the country. "It is this early harvesting that makes Muthalamada mangoes much in demand in the North," says J.M. Hafees, a mango exporter.

Muthalamada and its neighbouring villages – Elavanchery, Kollangode, Perumatti, Pattancheri, Vadakarapathy, Eruthempathy, Kozhinjampara, and Nallepilli – are all in the rain shadow, and mango-producing. Ten wards of Muthalamada panchayat alone have more than 4,000 hectares of orchards, and 90% of them lie to the south of the Pollachi-Vadakkanchery road. This is about 80% more than the other mango-producing villages.

A. Shaik Musthafa, a farmer-cum-trader, who has been in the business for 14 years, says it is the worst-ever season. "We used to get up to 15 tonnes of mangoes from an acre. Now I am afraid



Muthalamada produces a wide variety of mangoes such as Alphonso, Banganapalli, Sindhooram, Totapuri or Kilimooku or Kilichundan, Kalapadi, Mallika, Naduselai, Neelam, Rumani, Malgoa, and Gudadath. However, Alphonso continues to be the leader, bringing two to three times the price of other varieties. Banganapalli, Sindhooram and Totapuri are the key varieties covering two-thirds of the total crop.

However, over the years there has been a dip in the quality and size of the mangoes. If three or four Sindhooram mangoes made up a kilo earlier, it takes up to six mangoes now, says Ashiq. Sindhooram, a variety grown in south India that has a sweet-tangy taste, was not in demand earlier, but has seen an increase in uptake up north over the past six years, says Ashiq.

#### **Combatting insect attacks**

Besides variable weather, massive attacks by pests and insects have scythed the fortunes of Muthalamada. As the attacks increased, there has been a concurrent increase in the use of pesticides, sometimes harsher ones, often beyond the permitted limits, as some of the farmers adMany have been luring farmers by offering attractive credits. Farmers turn to those companies as they find no help from the Agriculture department.

"The department has failed the farmers. There hasn't been any effective intervention from the department. Nothing will happen even if the Krishi Bhavans [agricultural offices] are shut down for a year. They have become irrelevant," says V. Mohan Kumar, general secretary of the Mango Farmers and Merchants Welfare Association (MFMWA) at Muthalamada.

"We have been able to control the spread of the COVID-19 virus. But I fail to understand how we have not learnt to control some visible pests, including thrips. That's the failure of our Agriculture department," he says vehemently.

But Deputy Director of Horticulture Nizam S.A. says the department has been doing its best to help the farmers. "Scientists have identified mainly two types of pests in Muthalamada – planthoppers and thrips. They have a found a solution to the issue, and trials are currently on in Muthalamada," says Nizam. He says a project to help the farmers export their produce to foreign countries by doing away with middlemen is on the anvil. "It can fetch a minimum 30% extra income for the farmers."

Although scientists and researchers from Kerala Agricultural University, Mannuthy, conducted

According to Berin Pathrose, entomologist from the College of Agriculture, Vellanikkara, who studied the thrips attack at Muthalamada a few years ago, a holistic approach is needed to address the crisis. "Excessive application of pesticides can kill the natural enemy population of pests. An integrated pest management approach is needed for Muthalamada," he says. He attributes the abnormal flowering of mango trees in the past five years to an increase in the presence of thrips.

Abraham Thomas, a scientist who studied the pest attacks of Muthalamada about 10 years ago, suggests that the farmers install pheromone pest traps. Although 10,000 such traps were arranged for distribution, the idea did not find traction and farmers continued to increasingly fall back on the assurances of pesticide manufacturers. "We still don't know how thrips came here. We never had that menace until five years ago. We even suspect that it came through some chemical," says Shaik Musthafa.

Farmers agree that mindless application of plant growth enhancers such as cultar, too, has contributed to the crop fall. If applied excessively and carelessly, cultar can destroy mango trees. A plantation near Chulliyar Dam recently withered away due to careless hormonal application, says Nijamudheen. Some farmers who take the plantations on lease resort to cultar application secretly as plantation owners oppose it.

#### Muthalamada in limelight


Locals say that Muthalamada shot to fame as a mango country thanks to a fruit trader from Palakkad named Abdul Azeez. "We remember him whenever we talk of mangoes," says Nijamudheen. Equipped with the knowledge he acquired from other States as a trader, Azeez bought a dozen-odd acres at Muthalamada and planted budded mango saplings in the eighties. In five years, he started getting a good yield. Although many others followed Azeez's path, some failed.

Some farmers have mortgaged their orchards to the traders who control the wholesale markets in north India. This is a trap some of them have walked into, says Nijamudheen. "Muthalamada is silent now, like a funeral home," says Mohan Kumar.

Every February and March, the 100-odd sheds in the Kamprath Challa area in Muthalamada would bustle with farmers, agents, and traders. When crates of mangoes would flow into the sheds from the orchards during the day, workers would be busy packing them at night. It would be a festive season for Muthalamada. But today, the mango sheds are almost deserted. And the farmers are despondent.

Meanwhile, Gaza's Hamas-run Health Ministry said on Friday that Israeli fire killed 20 persons and wounded 155 waiting to receive desperately needed aid in the besieged territory, but Israel said the reports were "erroneous".

In February last year, Sri Lanka's Board of Investment cleared the company's \$442-million project at two wind energy-rich sites in the island's Northern Province.

"The project expects to add 250 MW in Mannar and 234 MW in Pooneryn to the national grid," Sri Lanka's Minister for Power and Energy Kanchana Wijesekara said on social media platform 'X' on Thursday, following a discussion with Adani Green's executive director Sagar Adani on a power purchasing agreement that is yet to be finalised.

The Sri Lankan government aims to meet the country's growing energy demands with 70% renewable energy by 2030. The ambitious target will require investments totalling over \$11.5 billion, according to official estimates.

Meanwhile, environmentalists and residents of Mannar fear that the Adani wind energy project could spell danger to the biodiversity of the area and impact people's livelihoods that are tied to the coastal environment.

# 'Nervous system disorders now top cause of illness'

Conditions affecting the nervous system - such as strokes, migraines and dementia- have surged past heart disease to become the leading cause of ill health worldwide, a major new analysis said on Friday

More than 43% of the global population experienced a neurological condition in 2021, the analysis found.

The study was carried out by hundreds of researchers led by the U.S.-based Institute for Health Metrics and Evaluation (IHME), which has become a global reference for health statistics.

Lead study author Jaimie Steinmetz of the IHME said the results showed that nervous system conditions are now "the world's leading cause of overall disease burden". Cases of these conditions have soared by 59% in the last three decades, she said, with the increase mainly driven by the fact that the world's population was ageing fast.

The researchers looked at how 37 different neurological conditions affected ill health, disability and premature death across 204 countries and territories from 1990 to 2021. This data was used to estimate how many years of healthy life were lost to each condition, called disability-adjusted life years (DALYs). More than 443 million years of healthy life were lost to nervous system disorders globally in 2021, an 18% increase from 1990, the study found. However, if the population's age and growing size was adjusted for, DALYs and deaths from these conditions actually fell by around a third, the researchers said.

# Will fight Israel alone, Hezbollah tells Iran as all out war looks imminent

**7** ith ally Hamas under attack in Gaza, the head of Iran's Quds Force visited Beirut in February to discuss the risk posed if Israel next aims at Lebanon's Hezbollah, an offensive that could severely hurt Tehran's main regional partner, seven sources said.

In Beirut, Quds chief Esmail Qaani met Hezbollah leader Sayyed Hassan Nasrallah, the sources said, for at least the third time since Hamas's deadly October 7 attacks on southern Israel and Israel's devastating retaliatory assault on Gaza.

The conversation turned to the possibility of a full Israeli offensive to its north, in Lebanon, the sources said. As well as damaging the Shia Islamist group, such an escalation could pressure Iran to react more forcefully than it has so far since October 7, three of the sources, Iranians within the inner circle of power, said.

Over the past five months, Hezbollah, a sworn enemy of Israel, has shown support for Hamas in the form of limited volleys of rockets fired across Israel's northern border.

At the previously unreported meeting, Mr. Nasrallah reassured Mr. Qaani he did not want Iran to get

sucked into a war with Israel or the United States and that Hezbollah would fight on its own, all the sources said. "This is our fight," Mr.

Nasrallah told Mr. Qaani, said one Iranian source with knowledge of the discussions.

Calibrated to avoid a major escalation, the skirmishes in Lebanon have nonetheless pushed tens of thousands of people from their homes on either side of the border.

Israeli strikes have killed more than 200 Hezbollah fighters and some 50 civilians in Lebanon, while attacks from Lebanon into Israel have killed a dozen Israeli soldiers and six civilians.

In recent days, Israel's counter-strikes have increased in intensity and reach.

Israeli Defence Minister Yoav Gallant indicated in February that Israel planned to increase attacks to decisively remove Hezbollah fighters from the border in the event of a Gaza ceasefire, although he left the door open for

diplomacy. Israeli security sources have said previously that Israel did not seek any spread of hostilities but added that the country was prepared to fight on new fronts if needed.

Iran and Hezbollah are mindful of the grave perils of a wider war in Lebanon, two of the sources aligned with the views of the government in Tehran said, including the danger it could spread and lead to strikes on Iran's nuclear installations.

The U.S. lists Iran as a state sponsor of terrorism and has sought for years to rein in Tehran's nuclear program. Israel has long considered Iran an existential threat.

Two U.S. sources and an Israeli source on request of anonymity, said Iran wanted to avoid blowback from an Israel-Hezbollah war.

The Beirut meeting highlights strain on Iran's strategy of avoiding major escalation in the region while projecting strength and support for Gaza West Asia across the

#### In Israel's sights

hostages. Israel's retaliatory assault in Gaza has killed more than 31,000 Palestinians and laid waste to the coastal enclave.

# Russians vote in presidential election that holds little suspense

Russia began three days of voting on Friday in a presidential election that is all but certain to extend President Vladimir Putin's rule by six more years after he stifled dissent.

At least half a dozen cases of vandalism at polling stations were reported, including a firebombing.

The election takes place against the backdrop of a ruthless crackdown that has crippled independent media and prominent rights groups and given Mr. Putin full control of the political system.

It also comes as Moscow's war in Ukraine en-

ters its third year. Russia has the advantage on the battlefield, where it is making small, if slow, gains.

Ukraine, meanwhile, has made Moscow look vulnerable behind the front line.

tered candidates or statebacked advisory bodies can assign observers to polling stations, decreasing the likelihood of independent watchdogs. With balloting over three days in nearly 1,00,000 polling stations in the country, any true oversight is difficult anyway. 'The current elections

will not be able to reflect the real mood of the people," Golos, Russia's renowned independent election observer group, said in the report.

"The distance between citizens and decision-making about the fate of the country has become greater than ever."

Senegal's top Opposition leader was expected to address supporters on Friday in his first public speech hours after being released from prison and ahead of the country's March 24 election in which he has been barred from running.

Ousmane Sonko's release late on Thursday night, after months behind bars, triggered a mix of jubilation and political uncertainty on the streets of the capital, Dakar. His supporters are waiting to see whether authorities will reverse their decision and allow him to run in the presidential election.

A charismatic former tax collector and mayor of the southern city of Ziguinchor, Mr. Sonko is seen as the main challenger to President Macky Sall's ruling party. His key ally, Bassirou Diomaye Faye, who was also freed from prison late on Thursday, has been named the Opposition's presidential candidate. Their release follows Mr. Sall's decree to exonerate political prisoners, including hundreds who were arrested in the violent protests last year.

The protests have rocked Senegal's image as a pillar of stability in West Africa, where dozens of coups and attempted coups have taken place in recent decades.

Dakar was thronged overnight with thousands of people singing and dancing as convoys of supporters drove around tooting horns and young people piled onto motorbikes and trucks.

Fresh graffiti on Dakar streets on Friday morning rallied in support of Mr. Sonko.



# Technology combined with behavioural analysis can prevent financial frauds: Das

#### The Hindu Bureau MUMBAI

Technology, combined with behavioural analysis, can go a long way in spotting anomalies in consumer behaviour and help in understanding and preventing frauds, Reserve Bank of India Governor Shaktikanta Das said while speaking at the annual conference of RBI Ombudsman in Mumbai.

Suspicious consumer behaviour that could be monitored include transactions during odd hours, transactions against usual patterns and unauthorised beneficiary additions.

He said, however, that YK

on the flip side the utilisation of such technologies without appropriate safeguards may lead to com-

promise in customer data. "The possible issues that may arise include invasion of privacy or subtle manipulations based on consumer profiling to nudge [the customer] into certain services that may not be the right fit," he said.

"Appropriate safeguards need to be put in place in this regard," he further said.

Mr. Das also said that Artificial Intelligence (AI) capabilities are currently being utilised to complement customer service through

personalised interaction, chatbots and virtual assistants tailored to specific products.

Its deployment in prevention of frauds, identity verification, vulnerability mitigation and data protection were, however, at nascent stages, he added.

Mr. Das said that under the Integrated Ombudsman Scheme, the Ombudsman has been entrusted with the responsibility of upholding the trust of or-

dinary citizens. "The RBI Ombudsman is expected to provide an independent and impartial avenue to citizens for their unresolved grievances. They have the power to facilitate delivery of fair redress of customers' grievances," he said.

"There have been significant improvements in the implementation of the integrated Ombudsman framework of the Reserve Bank after the launch of RB-IOS, 2021," he added.

States & Union Territories (UTs) seem to be in a tearing hurry to raise monies before the close of FY24. This also comes in the backdrop of expected an-

nouncement of General Election dates on Saturday. As many as 17 States and UTs are expected to mop up ₹50,206 crore cumulatively at an auction of State Government Securities (SGS) to be conducted by

the RBI on March 19. The amount is substantially higher than the ₹27,810 crore they had planned to mop up, going by the Indicative Calendar of Market borrowings.

The amount will also be the highest that they have raised at a weekly auction in FY24 so far. As many as 20 States and UTs had raised ₹45,160 crore (the second-highest amount raised in FY24) collectively

on February 27. Venkatakrishnan Srinivasan, Founder & Managing Partner, Rockfort Fincap LLP, said such a large weekly SGS auction size had not been witnessed before. States & UTs raise ₹35,000-37,000 about crore usually at the weekly

#### **RBI** auctions. **VRR** auctions

Meanwhile, the RBI conducted a variable rate repo (VRR) auction on Friday. The RBI received bids from banks for drawing sevenday funds aggregating to ₹76,560 crore against the notified amount of ₹75,000 crore. It allotted funds amounting to ₹75,001 crore at a weighted average rate of 6.65%.

A year since withdrawal of COVID-19 restrictions in China, the country has increased iron ore buying from India. Nearly 92% of Indian iron ore exports, or 40.40 million tonne (mt), for the 11-month period (April-February) of FY24, had gone to China.

In percentage terms, this is the highest ever shipment over a seven year-period (between FY18 and FY24) and second highest in volume, after 11M FY21 when exports to China stood at 47.73 mt.

In the 11M period of FY24, India's exports of iron ore stood at 44.23 mt, up 162% y-o-y. Shipments to China increased nearly 200%.

#### **Key feedstock**

Iron ore is a key feedstock raw material for steel-making.

Over the last seven years, about 83% of Indian exports went to China, data collected from research firm BigMint show.

For instance, in 11M FY18, 82% shipments were to China (17.6 mt out of 21.31 mt), which fell to 78% next fiscal (10.51 mt out of 13.79 mt). It rose to 80% (27 mt out of 34 mt) and 90% respectively, in FY20 and FY21. It dropped to 88% in 11M FY22 (20.84 mt out of 23.65 mt) and fell further to 81% (14 mt out of 17 mt) last fiscal.

Apart from China, some of the other countries to which iron ore was exported, albeit in much smaller quantity, were Malaysia

and Indonesia – between 0.58 mt and 1 mt. Exports to West Asian nations like Saudi Arabia, Qatar and the UAE were less than 0.2

Trade sources told businessline, that Chinese ironore imports in the first two months of 2024 rose by more than 8% y-o-y, as steelmakers there restocked to meet production needs. The world's largest iron ore consumer brought 210 mt in these two months.

Call for export check Incidentally, industry bodies, particularly secondary steel makers, have

been seeking restrictions on exports. In a letter to the Union Steel Minister Jyotiraditya Scindia, the industry body Federation of Iron Mineral

Industries (FIMI) pointed out that export of iron ore and pellets had "not actually gone up" since shipments were badly affected by the export duty that was in force between May and November of 2023. According to R.K. Shar-

ma, Secretary General, FI-MI, export of iron ores is mainly for fines which are of lower grade, about 58% iron content. And, these have no use in the domestic market.

"In mining of ore, lumps are generated to the tune of 25-30% and the rest are fines. Fines are kept in the mining lease area. Non-removal of these fines generally lead to environmental hazards; while accumulation of fines also impact lump production that actually impact availability for the steel sector," he explained.

The Centre, though, has not announced any such curbs, but a senior Ministry official said, they continued to track the situation. (The writer is with The

# From crossovers to cash-grabs, where is the fight business headed?

There was no doubting the authenticity of the Anthony Joshua-Francis Ngannou boxing bout — it even enhanced Joshua's standing in the heavyweight ranks - but the same can't be said of the upcoming 'clash' between Mike Tyson and influencer-turned-boxer Jake Paul

rancis Ngannou was expected to put up a fight. In his professional boxing debut just five months earlier, Ngannou sent Tyson Fury – an established fighter – to the canvas in the third round.

Ngannou, a former UFC mixed martial arts (MMA) heavyweight champion, more than held He did what his own over 10 rounds. It was only a controversial split decision in Fury's favour that ruined a memorable night for Ngannou.

The impressive performance earned Ngannou FRANCIS NGANNOU a bout against Anthony Joshua, another fighter of high pedigree. Joshua, a two-time world champion, is on a comeback trail, having suffered back-to-back losses to Oleksandr Usyk.

Joshua even had a few words of encouragement for his opponent. "When I saw the fight with Tyson Fury, I thought, 'I want some of that'. Ngannou is a great champion and this doesn't take anything away from his capabilities. I told him not to leave boxing. He's

I think that's what a knockout is about. I don't feel any pain," Ngannou said.

#### The heavyweight picture

Fury, incidentally, was ringside at Riyadh. Fury dismissed claims that Joshua was now the world's top heavyweight fighter. "Usyk will have something to say about that, considering he beat Joshua twice. Usyk and I have an undisputed world championship fight coming up, and Joshua had a show fight. For actual real boxing, Usyk and I will fight for the number one and two positions," Fury told DAZN Boxing.

"I had a bad performance against Ngannou. This is no secret. Joshua was fantastic. He lit Ngannou up with a perfect right hand. That's what a boxer should do. But if Joshua fights me after I have defeated Usyk, that will be a different game," Fury added.

If all the stars align, Joshua could next take on the winner of Fury-Usyk. Fury and Usyk will meet on May 18 in Saudi Arabia for all the belts, and will face each other in a rematch later in the year. The long-awaited Joshua-Fury fight would electrify the world of heavyweight boxing, but for this to happen, Fury must first get past the supremely proficient Usyk.

Even with Ngannou's novice status in the boxing world, there was no doubting the authenticity of this professional bout.

This is in contrast to another fight that was announced a few days earlier. At 58, former heavyweight champion Mike Tyson will enter the ring to take on social-media-influencer-turned-boxer Jake Paul in a live Netflix special.

Tyson last fought in 2020, in an exhibition match against another former world champion, Roy Iones Ir.

Paul rose to stardom around a decade ago, posting prank videos on his YouTube channel. In 2020, he made his professional boxing debut, and has since won nine and lost one fight. His wins have come against a former NBA basketball player in Nate Robinson, and retired MMA stars including Ben Askren, Tyron Woodley and Anderson Silva.

This is hardly a serious resume, though it must be said that Paul rakes in huge revenue through these fights.

#### A circus act?

It is not clear yet if Tyson-Paul will count as an exhibition or a professional fight. Either way, the news has not gone down well with boxing purists, who claim that this resembles a circus act which degrades the rich history of the sport.

"My sights are set on becoming a world champion, and now I have a chance to prove myself against the greatest heavyweight champion ever, the baddest man on the planet and the most dangerous boxer of all time. This will be the fight of a lifetime," Paul said.

Tyson hyped the fight by stating that he will "finish" Paul.

field.

When the duo squared off a week ago at Riyadh, it was Joshua who sent a message loud and clear. The Briton dismantled Ngannou, delivering a destructive second-round knockout. Joshua floored Ngannou in the first round with a straight right, establishing his dominance early.

The next round signalled an early end to the night, when Ngannou walked into a monstrous blow. The frightening big right hand of Joshua put Ngannou to sleep. It took a few moments and



out punch.

"[Joshua] was quite special because he stopped me. He did what Tyson Fury couldn't. It wasn't my day, and he was just way better than me. It sucks, but it's the game. I didn't feel the punch.

"He's grown significantly as a boxer over the years, so it will be a lot of fun to see what the will and ambition of a kid can do with the experience and aptitude of a GOAT. It's a full circle moment that will be beyond thrilling to watch; I started him on his boxing journey on the undercard of my fight with Roy Jones and now I plan to finish him," Tyson said.

The fight, scheduled to be held on July 20 at AT&T Stadium in Arlington (Texas), is unlikely to witness serious action. Tyson and Paul, however, are likely to laugh all the way to the bank.

n radio during an England women's cricket match some time back, Alex Hartley's co-commentator told her that one of her records was going to be broken. "Normally I am in the record books for things like the most expensive bowling figures," she said. The commentators' box broke into hearty laughter.

Hartley has indeed made her presence felt on the BBC's iconic Test Match Special. The former World Cup-winning left-arm spinner also entertains listeners with her popular podcast 'No Balls', which she presents alongside her former teammate Kate Cross.

Hartley is, of course, in the headlines these days more for her coaching. She is the spin coach of Multan Sultans in the Pakistan Super League. The franchise's fast bowling coach is also a woman – Cath Dalton from Ireland; as is the general manager – Hijab Zahid.

The strong female presence in the support staff seems to be working for the Sultans. They qualified for the knockout stage with three games to spare.

Not surprisingly, that was one of the topics Hartley talked about in the latest edition of 'No Balls', which went on air just a few days before the International Women's Day. "It is such a relief actually," she said. "There was a little bit of criticism around us going into the competition; we got rid of six of our key players and had a revamp in the staff, no Andy Flower. We have the first two female coaches in Pakistan as well as the first female general manager." Though she retired as a cricketer last year, at the age of 29, Hartley remains very much part of the game in her different avatars. Excerpts from an interview with The Hindu:

You retired rather young. You played a key role in England's World Cup win in 2017, but do you think you could have done more?

No, I don't have any regrets. You know, I tried my hardest for as long as I could. And I feel nice when I look at who has taken my place in the England team.

Sophie Ecclestone, the world's No. 1 bowler.

She became the world's best bowler at the age of 20. I did everything I could for that England team, and to get there into that team. And I am very proud of it.

#### How do you look back at your international career? You made your debut against Pakistan...

My debut was rubbish. I didn't bowl very well. I have blocked it out of my memory. I didn't think I would ever play for England again.

But a year later, you were England's second-highest wicket-taker at the 2017 World Cup. Winning that World Cup must be the high point of your career.

Without a doubt. There isn't a day that would even come close to that.

And you took India's most important wicket. It was Harmannreet Kaur's first game after her sensational innings in the semifinal against Australia. She was batting on 51 and India was looking pretty good at that time.

How did you enjoy commentating on the men's World Cup in India for the listeners back home and in Australia?

Very much. It was great travelling all over India.

No. I fell into it, to be honest. It was never something that I thought I would do. I just tried it one day for the Lancashire versus Worcestershire game and then became part of the BBC commentary team. I love it, though I am still not sure whether I will get to do it for the next match.

#### Your podcast is doing well.

Yes it is doing great. We have been doing it since 2019, I think.

#### How did the idea take shape?

Somebody literally tweeted me and Kate Cross saying, you should do a podcast. And we thought: Let's do that, yeah. I had just lost my England contract, so it was, you know, a bit of fun for me to be able to do that. And, yeah, we are still doing it to this day.

Yes, she has. I also like watching Smriti Mandhana. She is unreal, isn't she? She has got great technique. And Shafali Verma is another Indian cricketer I enjoy watching. A male Indian cricketer I like to watch is Yuzvendra Chahal. He is a lovely bowler. I am a massive RCB fan. He was there for a while before going to Rajasthan.

### The shifting pattern of the classical format

The pattern of Test cricket has changed over the decades: there has been a clear shift towards decisive results and shorter Tests. The data show that between the 1920s and the 1990s, a third to almost a half of the games finished in draws. The Tests during these decades were typically longer. In the 1960s, for instance, there were on average 2409 balls or about 401 six-ball overs per Test. This has reduced significantly since the 2000s. The average Test over the last three decades has ranged between 1832 balls or 305 six-ball overs (2020s) and 1975 balls or 329 six-ball overs (2000s): at an over-rate of 90 per day, the average Test in these decades has not entered the fifth day.

### Ice-capades

The recent IBSF Bobsleigh World Championship in Winterberg, Germany, had exactly what you would expect of athletes trying to slide swiftly on ice: bone-rattling action. Sleds, as a mode of transport, have been around for

centuries, but it wasn't until the 1860s that the modern sport of bobsleigh was invented.

A few thrill-seekers in Switzerland attached two sleds together and fashioned a basic steering mechanism. Wealthy tourists wanted to try it, but their appetite for danger was considerably smaller, and so a

protective chassis was added to the sleigh

Today's bobsleigh competitions feature contestants making timed runs down narrow, twisting, banked tracks. The sport has advanced technologically: the vehicles have become lighter and more aerodynamic over the years.

Modern tracks — made of concrete and coated with ice are required to have at least one straight section and one 'labyrinth' (three turns in quick succession without a straight). At speeds of up to 150 kmph, the risk of injury is high, and major accidents (some fatal) have been reported.
