

## It's official: 'Statio Shiv Shakti' approved as name of Chandrayaan-3 landing site

The International Astronomical Union (IAU) working group for Planetarv System Nomenclature has approved the name "Statio Shiv Shakti" for the landing site of Chandrayaan-3's Vikram lander. The approval was given on March 19. Planetary nomencla-

ture, like terrestrial nomenclature, is used to uniquely identify a feature on the surface of a planet or satellite so that it can be easily located, described,

and discussed. The Gazetteer of Planetary Nomenclature "contains detailed information about all names of topographic and albedo fea-

tures on planets and satellites [and some planetary ring and ring-gap systems] that the IAU has named and approved from its founding in 1919 through the present time".

cal figures prior to the 19th century." The citation in the gazetteer for the name of the landing site of the Vikram lander reads: "Compound word from Indian mythology that depicts the masculine ["Shiva"] and feminine ["Shakti"] duality of nature."

On August 26, 2023, Prime Minister Narendra Modi announced that the point where the moon lander of Chandrayaan-3 touched down would be called "Shiv Shakti".

"In Shiv, there is a resolution for the welfare of humanity and Shakti gives us the strength to fulfil those resolutions," Mr. Modi had said while announcing the name.

#### 'VBA's decision to snap tie-up with Sena (UBT) unfortunate

A day after Vanchit Bahujan Aghadi (VBA) chief Prakash Ambedkar said the alliance with Shiv Sena (UBT) doesn't exist any longer, Sanjay Raut, MP of the Uddhav Thackeray-led party, termed it a "one-sided and unfortunate" decision. Talking to reporters in Mumbai on Sunday, Mr. Raut said when the alliance was announced more than a year ago, the upcoming Lok Sabha election was not on the agenda. "The alliance was made with good intentions. Mr. Ambedkar should have discussed with Mr. Thackeray before making such an announcement," he said, adding that the VBA chief should reconsider the decision. PTI

#### SP MLAs who cross-voted for **BJP get Y-category security**

Four Samajwadi Party MLAs who cross-voted for the BIP in the February 27 Raiya Sabha elections in U.P. have been allocated Y-category security, a senior government official said on Sunday. He added that the four MLAs who got Y-category security are Abhay Singh (Gosaiganj), Manoj Kumar Pandey (Unchahar), Rakesh Pratap Singh (Gauriganj), and Vinod Chaturvedi (Kalpi). These four MLAs, alongside three other party legislators - Pooja Pal, Rakesh Pandey, and Ashutosh Maurya – had cross-voted for the BJP in the Rajya Sabha elections, leading to BJP candidate Sanjay Seth defeating Samajwadi Party nominee Alok Ranjan. Maharaji Prajapati, another MLA, had abstained. PTI

#### SKM govt. in Sikkim corrupt, glad alliance is over, says BJP

## **DMK, AIADMK and BJP** to be locked in battle in **9 LS seats in Tamil Nadu**

Triangular contest in Chennai North, Chennai South, Vellore, Tiruvannamalai, Namakkal, Nilgiris (SC), Pollachi Coimbatore, Perambalur constituencies; BJP, Congress to directly compete in 7 seats

ith major parties and alliances having announced their respective list of candidates (barring the Congress for two seats) for the Lok Sabha election in the Tamil Nadu, as many as nine of the total 39 constituencies will witness a three-cornered fight between candidates contesting on the symbols of the 'Rising Sun' (of the DMK), the 'Two Leaves' (of the AIADMK) and the 'Lotus' (of the BJP).

Seeman's Naam Tamilar Katchi (NTK) is set to contest in all 39 constituencies in the State as a lone ranger. The electoral battle in Chennai North, Chennai South, Vellore, Tiruvannamalai, Namakkal, Nilgiris (SC), Coimbatore, Pollachi, and Perambalur will be between candidates of the

DMK, the AIADMK and the BJP. Notable candidates in the three-cornered contest in Chennai South are the incumbent MP Thamizhachi Thangapandian of the DMK, who will face J. Jayavardhan of the AIADMK, who had emerged victorious in 2014, and Tamilisai Soundararajan of the BJP. In Chennai North, sitting MP Kalanidhi Veerasamy will compete against Royapuram R. Mano of the AIADMK and R.C. Paul Kanagaraj of the BJP. In Coimbatore, Ganapathy P. Rajkumar of the DMK will face Singai G. Ramachandran, who heads the AIADMK IT wing, and BJP State president K. An-

namalai. An intense contest is in the cards in the Nilgiris (SC) seat where former Union Minister and incumbent MP. A. Raja will compete against Union MoS for Fisheries L. Murugan of the BJP and D. Lokesh Tamilselvan

## Parties focus on women voters ahead of twin polls in Haryana

Subsidised LPG cylinders, monthly doles to meet kitchen expenses and the arrangement for free legal and medical consultation - these are some of the promises political parties in Harvana are making to woo women voters in the run-up to the Lok Sabha and Assembly polls.

The parties are also holding conferences to win over the support of women voters, who in the past decade played a crucial role in deciding the fate of the

elections while rising above caste lines in a patriarchal society.

The Indian National Lok Dal (INLD) women cell general secretary Sunaina Chautala claims that her party pioneered in launching all-woman conferences in the State, with its 'Hari Chunari Chaupals' initiative way back in 2015.

She expects women to play a pivotal role for the revival of her party, which saw its support base eroding over the years and suffering a schism following a feud in the Chautala family leading to the formation

of the Jannayak Janta Party (JJP) ahead of the 2019 Haryana Assembly poll.

"Unlike men, who mostly vote on caste lines, women tend to vote more on socio-economic issues affecting them such as crime rate, unemployment, and inflation, she said.

Meanwhile, the JJP – the INLD's breakaway faction - too has its eyes firmly set on women voters.

"The party has already delivered on its promise of 50% reservation for women in panchayats and one-third reservation in the allotment of fair price

shops," said JJP spokesperson Deep Kamal Saharan.

He insisted that the INLD's 'Hari Chunari Chaupals' campaign was, in fact, the brainchild of JJP legislator Naina Chautala, the first women from the Chautala family to enter active politics in 2014.

#### JJP holds 'chaupals'

## Survivors of bonded labour in Maharashtra: unshackled, yet the scars run deep

On a warm morning in March, 100-odd residents of Manavseva Project, a shelter home at Arangaon, 11 km from Ahmednagar town in western Maharashtra, are basking in the sunshine after breakfast. Built on a two-acre plot, the home is run by Shree Amrutvahini Gramvikas Mandal, an NGO founded by Dilip Gunjal.

Among the residents are men and women rescued by the State police after they were lured by traffickers or contractors with the promise of work with good pay and food, but forced into bonded labour. Siraj Shaikh, administrative officer of the NGO, says the shelter home is the only refuge for rescued bonded labourers in Ahmednagar. He says most of them are not able to communicate well as they are still recovering from the trauma of living in inhumane conditions, and being beaten, drugged, and forced into working for long hours with little food or water.

Rani (name changed) offers a hug and a handshake. However, she finds it hard to speak. Shaikh says the police suspect that her captors applied lead oxide or shendur (Marathi word for vermilion) on the tip of their tongue as part of their harsh methods to squeeze out more work from her, causing speech impairment.

Rani is one of the 23 people rescued by the Belvandi police from farms in Ahmednagar district since May 2023. Hailing from places such as Chandigarh, Chhattisgarh, Uttar Pradesh, Bihar, Tamil Nadu, Telangana, Karnataka, Odisha, West Bengal, and Maharashtra, none of them could speak at the time of rescue as they were numb and disoriented after being drugged by their captors with narcotics like cannabis, the police say.

#### 'Low reporting of cases'

According to December 2018 data from the Ministry of Labour and Employment, of the 3.13 lakh bonded labourers rehabilitated in the country, 1,404 were from Maharashtra.

However, NGOs, the police, and activists on the ground say not many cases of bonded labour are reported in the State owing to lack of awareness of this form of modern slavery, which has been illegal in India since 1976, when the Bonded Labour System (Abolition) Act came into force. Section 2 (g) of the Act defines bonded labour as "the system of forced, or partly forced, labour under which a debtor enters,

or has, or is presumed to

have, entered, into an

tor". The National Crime Records Bureau data show only four cases of bonded labour were reported in

Maharashtra in 2022. Police Inspector Sanjay Thenge, who joined the Belvandi police station in 2023, says the prevalence of bonded labour in Ahmednagar's Shrigonda taluka came to light during an investigation into an unclaimed body found stuffed in a gunny bag in a well. Police records spanning 10 years showed that there were 71 reported cases of unidentified bodies disposed of in a similar manner in the taluka. The sacks were retrieved from wells only when they raised a stink, he says.

Based on a tip-off, he raided four locations and freed six bonded labourers. "The accused told us that they engaged the bonded labourers in harvesting sugarcane from

September to April in the district, and sent them for begging in Mumbai and Pune during the holiday and festival seasons. So far, 21 traffickers, 19 men and two women, have been arrested and prosecuted," says Thenge, who was recently transferred to the Rahuri police station.

Following the rescue, the Belvandi police approached Gunjal's NGO as the government shelter home for survivors of human trafficking and bonded labour is in Yerawada Central Jail, Pune, and it is inconvenient to travel

three hours by road every time there is a court hearing in the trial, which might take months or even years to conclude. Else, the survivors have to remain in the police lock-up.

#### Stricken with fear

Each rescued person has survived extremely traumatic situations, affecting their mental health, says Dr. Suresh Vilas Gholap, medical officer at the NGO. Several survivors like Karan Kumar, 21, are not in a state to completely recall how they ended up in bonded labour. A native of



Bhainso village in Chhattisgarh's Janjgir-Champa district, he initially says he walked to Maharashtra with a bunch of friends, and then states that someone took him and a bunch of boys in a truck and brought them to the Hyderabad railway station. After being forced to beg there for a few days, they were brought to Mumbai, then Pune, and finally Ahmednagar. The police say he was rescued on May 2, 2023 from Shrigonda taluka after arresting a trafficker named Pilaji Bhonsle.

Sidheshwar Mahendranath Roy, 40, from Jalpaiguri district in West Bengal, who was freed from the captivity of his trafficker, Dalkhush Mukida Kale, on December 18, 2023, too can't clearly remember how he reached Ahmednagar. "I left my home 27 years ago. These men were monsters. They would beat me, mess with my head by giving me some narcotic substances, and keep an eye on me even during toilet breaks. I did not take a bath for months until I was rescued," he says.

#### Longing for home

"Will you please convince my wife and sons to accept me and take me back home?" says Bhausaheb Haribhau More, 41, from Chanai village in Maharashtra's Beed district, who was brought by a mukadam (contractor) to

work in the sugarcane fields in Ahmednagar around a year ago.

"I was made to work from dawn to dusk without a toilet break and just twothree hours of sleep in a makeshift hut made of plastic sheets that collapsed with the slightest breeze. I had to sustain myself for a day with just dry bhakri (unleavened flatbread made of jowar or bajra) and crushed chilli." Shaikh says More's cap-

tors, Ashok Bhonsle and Jangya Kale, have been arrested, and the NGO is trying to counsel his family to accept him. "They see him as a burden, but we are telling them that he can do small jobs and secure aid from the government to restart his life," he says.

#### Struggle for aid

Those rescued from bonded labour are entitled to compensation ranging from ₹1 lakh to ₹3 lakh under the Central Sector Scheme for Rehabilitation of Bonded Labourer, 2021. An immediate aid of ₹30,000 is to be provided after an FIR is registered and bonded labour release certificates are issued by District Magistrates or Sub-Divisional Magistrates. The remaining amount is provided once the case is set-

tled in court. Though all freed workers at the shelter home have secured release certificates, most of them haven't received any aid vet. "We have reached out to the district administration multiple times. The problem is that none of them have identity proofs to open a bank account. We are going to apply for their Aadhaar cards. The District Collector has issued a letter to fast-track the process," says Gunjal.

The initial aid is not issued in most cases, says a Mumbai-based lawyer, who did not wish to be named. "Full compensation also takes time as it is not given until the accused is convicted. There is a corpus with the district administration that can be used to provide the initial aid."

Efforts are in progress to rehabilitate the rescued workers, says Mathura Jadhav, a volunteer at the home. Once they are able to carry out basic chores on their own, vocational training will be imparted, says Shaikh. He adds that another NGO, Pratham, has been conducting free skill development workshops for all the residents of Manavseva Project.

The home is completely reliant on donations, says Gunjal. "If the voluntary contributions stop, then we will be able to run the home for a maximum of six months with our personal funds. After that, we will have to shut down."

RO Synthetic Aperture Radar (NISAR) satellite has been delayed as a key component of the satellite has been sent back to the United States of America.

The satellite was scheduled to be launched in the first quarter of 2024. However, now the launch readiness date will be determined at the end of April.

According to the NASA, a special special coating needs to be applied to hardware components on the satellite's 39-foot-diameter (12-meter) radar antenna reflector, which is among the space agency's

primary contributions to the mission. It said that the addition of the special coating is a precautionary step to mitigate any temperature increases that could potentially affect the deployment of the reflector. "Testing and analysis identified a potential for the reflector to experience higher-than-previously-anticipated temperatures in its stowed configuration in flight," it said.

It added that during operations, the reflector will transmit and receive microwave signals to and from Earth's surface, enabling the NISAR to scan nearly all the planet's land and ice surfaces twice every 12 days to collect data.



### **BSP** declares 25 candidates for Lok Sabha election

Bahujan Samaj Party (BSP) on Sunday declared 25 candidates for the 2024 Lok Sabha election in Uttar Pradesh.

The party gave Mohammad Irfan Saifi a ticket from Moradabad, Mujahid Hussain from Amroha, Majid Ali from Saharanpur, Zeeshan Khan from Rampur, Anis Ahmad Khan alias Phool Babu from Pilibhit, Shaukat Ali from Sambhal, and Abid Ali from Aonla, etc.

The BSP ticket distribution focused on Muslim outreach with seven out of 25 candidates hailing from the minority community. The BSP, a Dalit-centric party, denied tickets to two sitting Lok Sabha members - Haji Fazlur Rehman from Saharanpur and Malook Nagar from Bijnor. In the 2019 Lok Sabha polls, the BSP contested 37 parliamentary seats in an alliance with Samajwadi Party and won 10 seats -Saharanpur, Bijnor, Nagina, Amroha, Ambedkar Nagar, Shravasti, Lalganj, Ghosi, Janupur, and Ghazipur.

Uttar Pradesh is politically the most crucial State in India with 80 Lok Sabha seats.

## **JD(U) releases list of 16** candidates, drops 2 MPs

Six of the candidates in Bihar are from the Other Backward Classes and five from the Extremely Backward Classes; the party has also given ticket to turncoats Lovely Anand and Vijay Lakshmi

he Janata Dal(U) on Sunday released a list of 16 candidates for the Lok Sabha election, and provided a caste break-up, in a reflection of the impact that last year's caste census has had on the State's politics. Two MPs have been dropped, while two turncoats have been given ticket, with preference given to backward class leaders.

Six of the 16 candidates are from the Other Backward Classes (OBCs) and five from the Extremely Backward Classes (EBCs), which together comprise 63% of Bihar's population; three candidates are from upper castes, which make up only 15% of the population; and one each from Mahadalit and Muslim communities. Two of the candidates are women.

In the seat-sharing deal within the State's ruling National Democratic Alliance, the BJP was allotted 17 seats, while the JD(U) got 16, and the Lok Janshakti Party (Ram Vilas) got five. The Hindustani Awam Morcha (Secular) and the

Rashtriya Lok Morcha were each allocated one seat of the State's 40 Lok Sabha seats. HAM(S) chief Jitan Ram Manjhi and RLM president Upendra Kushwaha are likely to contest from the Gaya and Karakat parliamentary seats, respectively.

#### 2 MPs dropped

In 2019, the NDA had swept the election in Bihar, winning 53% of votes and 39 of the State's 40 seats. The BJP and JD(U) had contested 17 seats each, leaving six seats to the then-undivided Lok Janshakti Party. The JD(U) had lost the lone seat of Kishanganj to the Congress.

**Eye on details** 

This time round, the JD (U) has decided to drop two MPs: Kavita Singh from Siwan and Sunil Kumar Pintu from Sitamarhi. Two turncoats - Lovely Anand, who recently joined the JD(U) from the Rashtriya Janata Dal (RJD); and Vijay Lakshmi Kushwaha, the wife of Ramesh Singh Kushwaha, former RLM MLA from Ziradei, who has returned to the JD (U) - have been given ticket from the Sheohar and Siwan Lok Sabha seats, res-

pectively. In 2019, BJP leader Rama Devi had won the Sheohar Lok Sabha seat, but as the constituency has been allocated to the JD(U) this time, the party has fielded Ms. Anand, wife of Anand Mohan Singh, an upper caste strongman from the Kosi area.

New and old faces In the Sitamarhi seat, JD(U) leader and chairman of the Bihar Legislative Council Devesh Chandra Thakur has been fielded in place of MP Sunil Kumar Pintu. Mr. Pintu is currently a JD(U) member, but was earlier in the BIP. From Kishanganj, the JD(U) has fielded Mujahid Alam, who was earlier the MLA from Kochadhaman, but had been defeated in the 2020 Assembly election by All India Majlis-E-Ittehadul Muslimeen MLA Izhar Asfi. Apart from these four, the remaining 12 are JD(U) MPs, who are being fielded again.

Meanwhile, in the Opposition Mahagatbandhan camp, RJD leaders Lalu Prasad Yadav and his younger son Tejashwi Yadav are scheduled to reach Delhi by Sunday evening for a final round of talks with their ally, the Congress. RJD sources told The Hindu that it was willing to spare six seats, while Congress was demanding nine.

**INDIA** intact, will cross 272 seats: Jairam Ramesh

The INDIA bloc is intact despite Bihar Chief Minister Nitish Kumar's "somersault" and Trinamool Congress supremo Mamata Banerjee deciding to be Mamata Banerjee, senior Congress leader Jairam Ramesh has said, rejecting as "hollow" Prime Minister Narendra Modi's pitch against the Opposition on corruption.

In an interaction with editors of the Press Trust of India, he said the Opposition will unitedly cross the halfway mark of 272 in the elections, and oust the BJP from power.

Mr. Ramesh spoke on a range of issues, including electoral bonds, the arrests of Delhi Chief Minister Arvind Keiriwal and Iharkhand Mukti Morcha leader Hemant Soren and also addressed speculations around Rahul Gandhi and Priyanka Gandhi Vadra potentially contesting the Lok Sabha election from Amethi and Raebareli, respectively.

On Opposition unity, he said all 28 parties were together up to December 19, "but Nitish Kumar did a somersault and Mamata Banerjee decided to be Mamata Banerjee".



#### Ex-IAF chief, ex-YSRCP leader join BJP ahead of LS election

Former Indian Air Force (IAF) chief R.K.S Bhadauria joined the BJP on Sunday along with former MP and YSRCP leader Varaprasad Rao in the presence of Union Minister Anurag Thakur and party general secretary Vinod Tawde. Mr. Rao, a leader hailing from Tirupati, is likely to get BJP ticket from that seat as part of the party's seat-sharing agreement with the Telugu Desam Party and Jana Sena Party. The former Air Chief, who is being considered for a seat in Uttar Pradesh, said his new innings gave him a chance to contribute to nation-building. He termed the last eight to 10 years of his service as a "golden period", praising the steps taken by the Modi government to boost self-reliance.

#### Jarange asks Marathas to select candidates for LS poll

Ouota activist Manoj Jarange-Patil on Sunday appealed to the Maratha community to choose 'Independent' candidates for the Lok Sabha election before March 30. The Maratha community holds sway over 17 to 18 Lok Sabha constituencies in Maharashtra, he claimed. With their influence, they can garner the support of not only Muslims and Dalit communities but also a wider section of the society, Mr. Jarange-Patil said, addressing a meeting of the Maratha community members, who had come from across the State, in Jalna district. Elections to the 48 Lok Sabha seats in Maharashtra will be held in five phases. "I don't know politics and am not interested in it," Mr. Jarange-Patil said. 

#### Exclude post-2003 items from Bhoishala survey: plea to ASI

A Muslim organisation has approached the Archaeological Survey of India (ASI) amid its ongoing survey at the contentious Bhojshala-Kamal Maula Mosque complex in Dhar urging it to exclude any items added to the premises post-2003. Following directives from the Madhya Pradesh High Court, the ASI team, accompanied by senior police and administrative officials, continued the survey for the third consecutive day at the disputed complex. #### Nine mosques in U.P. covered with tarpaulin ahead of Holi

At least nine mosques in Uttar Pradesh's Aligarh and Sambhal districts have been covered with tarpaulin sheets ahead of Holi to prevent them from being smeared with colours, the police said on Sunday. ## Anti-piracy Act has been a great enabler, says Navy chief

The law empowers Navy and Coast Guard to board, seize, and arrest pirates and their vessels on the high seas; Admiral Kumar says the force has been ensuring 'optimal deployment' of assets

he Maritime Anti-Piracy Act, enacted in 2022, has been a "great enabler", said Indian Navy chief Admiral R. Hari Kumar as the Navy completed 100 days of Operation Sankalp in the Gulf of Aden.

"This [the Act] has empowered us to visit, board, search and seize. Any suspicious vessel, craft, or fishing boat or dhow that we suspect, we board, inspect, and if we find piracy triggers like skiffs, weapons, or ammunition, then we take action to ensure that they don't proceed with their mission," Admiral Kumar said in response to a question from The Hindu during a press conference on Saturday.

There are very few countries which have an Act like this, he stated.

In the past 100 days, as part of Operation Sankalp, the Navy has carried out over 1,000 boardings. Admiral Kumar said that

"In our earlier operations, whenever we captured [pirates], there was hardly any place where you could take them for handing over," he noted, and only the Yellow Gate police station in Mumbai (Mazgaon) was nominated for handling them.

But now all coastal police stations have been empowered.

"We have this anti-piracy Act which has been a great enabler for the security forces, particularly for the Navy, since we are involved in anti-piracy operations," Admiral Kumar said.

Talking about salient features of the Act, maritime expert Pooja Bhatt

said the Maritime Anti-Piracy Act empowers the Indian Navy and the Coast Guard to board, seize, and arrest pirates operating on the high seas, in the Exclusive Economic Zone (EEZ) and beyond, and Indian courts can prosecute the perpetrators with life imprisonment, fine, or both. "However, the Act also

considers the offence as extraditable, where India has signed such treaties with those countries. India has an agreement with Somalia where Somalian pirates have been extradited since 2017," Dr. Bhatt added. According to the Act, it

was enacted "to give effect to the United Nations Convention on the Law of the

Sea (UNCLOS) relating to the repression of piracy on the high seas and for matters connected therewith". India ratified UNCLOS in 1995.

#### 'Addressing threats'

Since mid-December, as part of Phase 2 of Operation Sankalp, the Indian Navy saw the deployment of over 5,000 personnel at sea, over 450 ship days (with over 21 ships deployed), and 900 hours of flying by the maritime surveillance aircraft to address threats in the maritime domain.

"As of yesterday (Friday), we had 11 submarines operating simultaneously in the sea, with more than 35 ships and over five aircraft deployed in different parts of the Indian Ocean Region," Admiral Kumar said adding, "So we are making sure that our assets are deployed in an optimal manner to ensure that it covers the area of interest and gives us the best information so that the maritime domain awareness and the requisite degree of transparency is achieved."

## Punjab CM meets kin of Hooch victims as BJP attacks him

Punjab Chief Minister Bhagwant Mann on Sunday visited Gujran village in Sangrur district to meet the families of those who died due to suspected consumption of spurious liquor. At least 21 people have

died in the incident. Mr. Mann said the police have registered a murder case in the incident.

"FIR under Section 302 (of the IPC) has been registered against 10 accused. Killing somebody by giving poison is a murder," he said.

The Chief Minister added that those involved in selling spurious liquor will be nabbed.

"We are trying to find out if these accused have more links in Punjab. If there are more gangs selling spurious liquor, they will also be arrested and booked under Section 302," Mr. Mann said.

The Punjab Police said that two more people had been arrested in the case. With this, a total of 10 people have been arrested so far, Deputy Inspector-General (Patiala Range) Harcharan Singh Bhullar said. Earlier, Union Minister

Anurag Thakui Anurag Thakur hit out at

Mr. Mann over the issue. Addressing a press con-

ference at the BJP's national headquarters in New Delhi, Mr. Thakur said it was shameful that Mr. Mann was stationed in Delhi and did not "utter a word about the incident, nor initiate an investigation".

"Chief Minister Mann stays put in Delhi to what he terms a fight for jailed accused in the excise policy case - Manish Sisodia. Sanjay Singh, and now Arvind Kejriwal - but when 21 people in his constituency died after consuming illicit liquor, his government is protecting liquor trad-

ers," said Mr. Thakur. He declared that the people of India would never approve of the "somnolent" Punjab government and the Delhi government running from jail. (With PTI inputs)

## **Bharat Biotech commences** clinical trials of Spanish tuberculosis vaccine in India

Clinical trials of the Spanish tuberculosis (TB) vaccine MTBVAC have begun in India.





## FAITH Holi heralds joy, purity

The festival of Holi is significant as it heralds the onset of spring and the end of a bleak winter. Celebrated on the last full moon day of the Hindu Luni solar calendar, the date varies with the lunar cycle. The night before Holi bonfires are lit in a ceremony known as Holika Dahan, also called choti Holi. People congregate near the fire and sing and dance as symbolically it signifies the victory of good over evil, said Prof. Kumool Abbi in a lecture.

The pure ritual of Holika Dahan subsumes all negativity and rancour and heralds joy, purity and gaiety. The ritual is traced back to King Hiranyakaship, father of Prahalad. He was a demonic and egotistical asura who secured boons bestowing special powers to prevent him from being killed. His son remained a steadfast devotee of Vishnu, thereby angering his father, who persecuted him endlessly. Cruelly, Prahalad's aunt Holika tricked him into sitting in a fire with her. While the fire destroyed her, Vishnu, the upholder of dharma, saved Prahalad. Vishnu took the form of Nrisimha and annihilated Hiranyakaship. Thus the ritual bonfire signifies the triumph of good over evil.

The next day, Holi, known as Dhuli, is celebrated with delight and lively colours are sprinkled everywhere. Delicacies such as gujiya, mathri and thandai are served (with bhang in certain localities). Holi is celebrated in other regions of Asia and Caribbean countries like Guyana, Surinam, Trinidad and Tobago. The festival also celebrates the love of Radha and Krishna as can be seen in Garg Samhita, a work by sage Garga and is important in Vrindavan and Mathura.

# Can 'good sounds' help coral islands recover from bleaching?

limate change is the most serious environmental problem facing the world today. One of the main reasons for this is the global warming caused by the extraction of coal and oil, which have been underground for millennia, and burning them for industrial and non-industrial purposes to generate energy. The effects of these activities were exacerbated by other causes of global warming, such as deforestation.

Global warming has many consequences, including rising sea levels and changes in the frequency of extreme weather. Another is the destruction of coral reefs. India's Lakshadweep islands for instance are islands formed on such reefs.

#### Coral reefs have started to die

Coral reefs are built by a type of organism that, when it accumulates, forms reefs and islands. They live in large colonies. Corals have a symbiotic relationship with microscopic algae called zooxanthellae, which live in the corals' tissues. Life becomes tough when the temperature of the water around them rises. When it does, the corals expel the zooxanthellae. An important visual symptom of these effects is that the colour of the coral reef changes, and subsequently they die off in droves. This event is called bleaching.

However, not all coral bleaching events are due to warm water. Ocean acidification - which is when the pH of the water drops as more carbon dioxide dissolves in it - is another well-known cause. More acidic water reduces the availability of calcium minerals that the corals need to build and repair their exoskeletons.

In many parts of the world, coral reefs have started to die due to global warming experienced over the years. The U.S. lost half of its coral reefs in the Caribbean in one year in 2005 due to a large-scale bleaching event after warm waters around the Virgin Islands and Puerto Rico expanded southward. When scientists collated satellite data of the region from the previous 20 years, they were able to confirm that the 2005 event exerted more thermal stress than those in the previous 20 years combined.

Their submergence is a certainty now; the only question is when it will happen. Therefore, it is very scary that the coral reefs themselves are being destroyed and, axiomatically, any chance of saving the corals can and does become a source of hope.

It is against this background that about 5,000 scientists gathered in New Orleans, in the U.S., in February this year for the American Geophysical Union's biennial 'Ocean Sciences' meeting. Here, Amy Apprill, a scientist at the Woods Hole Oceanographic Institute in Massachusetts and who studies coral reefs, provided information about a study she had been part of.

number of genetically identical polyps. Each polyp is a sac-like animal, usually a few millimeters wide and a few centimeters tall. It has a set of tentacles surrounding a mouth-like opening. Polyps are gregarious: they like to socialise.

Every polyp also sheds an exoskeleton at its bottom and over many generations this discarded substance accumulates to form a large structure up to several metres wide. The polyps organise their lives around this structure. A coral reef is formed when a large number of polyps collects in this way. Polyps use sound to communicate with each other. Naturally, the sound of a healthy colony will differ from that of an unhealthy colony. Dr. Apprill and her team used this distinction in their new study. sounds. They conducted a series of field studies in the Virgin Islands of the U.S., where they quantified the settlement rates of three species of corals with two different breeding strategies.

They found that in degraded coral reefs, the settlement rate increased when such sounds were played (using a novel underwater speaker system). They also reported that the settlement rate was higher closer to the speaker and reduced as one moved away from the speaker, indicating the impact of the sounds played.

Finally, it would be a mistake to think the researchers have solved the reef settlement problem posed by climate change. Their study was just an experiment. If what they did is tested repeatedly and at least a good fraction of instances are successful, then we can decide that their technique can help in practice. But we still don't know what problems might arise when this project is implemented on a large scale to save coral reefs. We also need to find out the volume

## Abel Prize: a Nobel for mathematicians

The Abel Prize for 2024 has been awarded to French mathematician Michael Talagrand for "contributions to probability theory and functional analysis, with outstanding applications in mathematical physics and statistics".

Every year, the King of Norway awards the Abel Prize to at least one scholar who has made a significant contribution to mathematics. The Government of Norway has been presenting the prize since 2003, and has modelled it after the Nobel Prizes, awarded in neighbouring Sweden, including a cash prize of 9 million Norwegian kroner (approximately Rs 7 crore) for the laureates.

This said, the idea for the prize was first floated back in 1899, after the Norwegian mathematician Marius Sophus Lie found out that Alfred Nobel's will didn't include a prize for mathematics. The year 1899 was also the birth centenary of Niels Hendrik Abel, a famous Norwegian mathematician after whom the prize came to be named. The Abel Committee selects each year's winners.

Dr. Talagrand's work in particular has been credited with "making random processes more predictable," as one *Nature* article put it. According to his biography on the Abel Prize website, Dr. Talagrand couldn't see in one eye as the result of a genetic condition. A

decade later, when he developed trouble in his other eye, he became scared and studied hard at school, eventually discovering his knack for mathematics.

### **Questionable conduct**

Centre should be worried by Governors' reluctance to follow the Constitution

he conduct of the Tamil Nadu Governor, R.N. Ravi, has been constitutionally questionable for quite some time now. In the latest instance, his refusal to allow the re-induction of K. Ponmudy into the Tamil Nadu Cabinet has been exposed as unwarranted. Following some strident criticism from the Supreme Court, Mr. Ravi administered the oath of office and secrecy to Mr. Ponmudy, whose conviction in a corruption case was recently stayed by the Court, resulting in his eligibility to be a Member of the Legislative Assembly being restored. Mr. Ravi had taken the legally untenable stand that it would be against "constitutional morality" to re-induct Mr. Ponmudy based on the stay of conviction. In the Governor's interpretation, the order of the twojudge Bench, staying the conviction recorded by the Madras High Court, was only by way of interim relief, and that it meant that the conviction was "existent, but made non-operative" and did not amount to its being set aside. The interpretation was quite questionable, as the legal consequences that flow from a criminal conviction in a corruption case – loss of eligibility for being a legislator and, therefore, for being a Minister stand suspended as soon as the conviction is stayed. Parliament and the State legislatures restore the membership of those convicted as soon as the conviction is stayed, even if their seats had been declared vacant. The Governor's confusion of "morality" and principles of good governance with legality seemed deliberate.

As Mr. Ravi's propensity to find new ways to get under the skin of the DMK regime becomes more apparent, two things stand out: his reluctance to accept the limitations of his office and the Union government's failure to act on the increasing instances of its Governors being pulled up by the Court. On an earlier occasion, the Court had noted that he had disposed of Bills pending with him only after his prolonged inaction was questioned by the Court. In the latest instance, he gave enough cause for the Court to ask, "If the Governor does not follow the Constitution, what does the State do except come to a constitutional court?" Things have come to such a pass that only a vocal court can discipline them. Given the plurality of litigation concerning the conduct of Governors, it is disconcerting that the Centre does not see any scope for remedial measures, when it ought to be its duty to replace Governors who are pathologically averse to following the Constitution. The only explanation is that their conduct is driven, not by constitutional norms, but by the political assignment given to them by those appointing them.

Unbreakable India and Bhutan have forged closer ties at a time of regional challenges me Minister Narendra Modi's visit to Bhutan last week, while productive, was largely symbolic. Bhutan's Prime Minister Tshering Tobgay's lengthy bilateral with Mr. Modi a week earlier in Delhi, obviated the need for such a second back-to-back visit. The announcement of India's doubling of support for Bhutan's Five Year Plan, from ₹5,000 crore to ₹10,000 crore, was significant, but has been under discussion, and could have been made later, post the elections as well. The highlight of the visit, of Bhutan's King conferring Bhutan's highest civilian award on Mr. Modi, had been announced in 2021 for India's support during the COVID-19 pandemic, and also need not have been done right now. The fact that Mr. Modi went ahead with the visit, despite India's electoral Model Code of Conduct in place, his campaign schedule, and inclement weather in Bhutan nearly derailing the programme, indicates how important it was. The symbolic messaging was threefold: first, that India is fully committed to Bhutan's development, particularly the upcoming Gelephu Mindfulness City, a project likely to benefit from India's increase in financial support to its neighbour. Second, Bhutan is an integral part of India's infrastructure initiatives for road, rail, integrated check points, and also for energy exchanges on India's grid, both of which are pushing sub-regional trade and travel among India, Bangladesh, Bhutan and Nepal. Third, that India is mindful of Bhutan's increased engagement with China, for the boundary agreement they hope to forge soon, but that it does not intend to give Beijing space in areas of engagement such as trade and investment, where China has made inroads with India's other close neighbours. As a result, Foreign Secretary Vinay Kwatra may have feigned disinterest when he brushed aside a question on the China-Bhutan boundary talks, but they are important. China-Bhutan talks about the possible swap of land at Doklam to Bhutan's west are, in fact, seen as a threat to India's Siliguri Corridor, whereas China's claim to areas on Bhutan's east could imperil India's border connectivity projects in Arunachal Pradesh. Recent reports, which the Ministry of External Affairs has not denied, indicate that Bhutan may have even asked India to go slow on those projects until its boundary talks with China are complete. As a result, the most important message from Mr. Modi's sojourn was one of a united front at a time of change. Accepting his award, Mr. Modi called India-Bhutan ties "unbreakable". India and Bhutan will need to emphasise that lock-step even more in the days ahead to retain the permanence of their ties in the face of economic and social turmoil within their countries, as well as the challenge in the neighbourhood.

TB control in India calls for person-centred solutions

lobally, and in India, tuberculosis (TB) continues to loom large as a public health challenge impacting millions. Despite ambitious goals set by India's health authorities to eliminate TB, the challenge is huge and progress is not fast enough. Access to efficient and high quality care - diagnosis, treatment and support – is still not available to every person suspected to have TB or diagnosed with the disease. As India grapples with the complexities of controlling TB, we need a paradigm shift urgently – one that places those affected and their lived experiences at the centre of tackling this ancient disease.

At the core of this shift lies a fundamental recognition: the needs and the interests of patients and communities must be prioritised



within the care paradigm and the health-care system. This principle, echoed by survivors,

communities, health experts and policymakers, underscores the need for a person-centred approach to TB care and management.

#### **Understanding lived experiences**

Perhaps our greatest gap has been in understanding the lived experiences of the affected individual fighting and surviving TB. Too easily, we assume their needs, their challenges, and their expectations. In no other service paradigm are the voices of end users ignored. We have, at times, been guilty of over-medicalising this disease, as doctors and public health folks often do. We have often forgotten to see TB as a human crisis, a gendered crisis, an economic challenge, and a social and environmental one as well.

Over the years, this has been changing, with the emergence of strong TB survivor advocates who have stridently worked to put the needs of

Even though World TB Day (March 24) has passed, recognising the needs and the interests of patients and communities must form the basis of disease affected communities on the table. They have sought change in key areas and governments have listened and modified their own approach to meet community needs. A case in point is nutritional support, which while limited, is an important step. Further, the growing focus on patient support, addressing stigma, and gendered aspects of TB has also been important.

Is this enough? Not entirely. To provide high quality, person-centred care, we need to bridge the gap between policy intent and on-the-ground realities. For instance, India needs to prioritise targeted interventions aimed at improving and expanding access to TB diagnosis and treatment. We need to expand the reach of TB testing facilities, particularly in rural and underserved areas, and ensure the availability of free, affordable and quality-assured TB drugs. Molecular testing is the gold standard and less than a quarter of symptomatic patients are getting that as their first test. Recent reports of drug and diagnostics stockouts are troubling and unacceptable.

#### Care needs to be more humane

Additionally, we need to focus on efforts to make care more humane. Hence, mental health support and gender responsive care become critically important. Efforts are also needed to strengthen community-based TB care models, empowering frontline health-care workers to deliver comprehensive care which addresses not just treatment but also social, economic and mental health needs and is closer to where patients live. This is important as survivor narratives tell us the stigma, discrimination and mental stress they go through, not to mention the side-effects of treatment.

By supporting frontline TB workers, strengthening supply chains and procurement mechanisms, decentralising TB services and empowering local communities, India can reduce

stigma, overcome barriers to access and enhance treatment outcomes.

While TB can affect people of any class, religion, ethnicity, and socioeconomic status, it disproportionately affects the most marginalised in society, including children, the urban poor, prisoners, and people living with HIV/AIDS. The disease has gone beyond being a health crisis alone. It is an economic crisis which by some estimates, costs India billions in losses each year and pushes families and communities into debt and poverty.

Addressing the socio-economic determinants of TB requires a multi-sectoral approach. Poverty alleviation, improvement in nutritional status, well-ventilated housing and better air quality will all contribute towards reducing TB. Recent research has shown that nutritional supplementation reduced TB incidence substantially in household contacts of adults with microbiologically confirmed pulmonary TB. By tackling the underlying root causes of TB, India can make significant strides towards eliminating the disease and improving the overall health and well-being of its population.

#### **Tapping technology**

Leveraging technology and innovation holds promise in enhancing TB care efforts in India. The adoption of AI and digital health solutions for TB diagnosis, adherence and surveillance can revolutionise the way TB care is delivered and accessed in the country. By investing in developing better vaccines, we can hope to ultimately eliminate this airborne disease.

The path to TB elimination in India requires a concerted effort to prioritise person-centred care, address social determinants of health, and embrace innovation. By adopting a holistic and person-centred approach, India can overcome the barriers that stand in the way of TB control and create a healthier future for all its citizens.

Actionable ideas for TB control

very day, 3,500 people worldwide lose their lives to tuberculosis (TB), and around 30,000 people become infected with TB bacilli, according to World Health Organization (WHO) estimates. India alone accounts for 27% of global TB cases. This is jarring, given that TB is a detectable and curable disease and TB diagnosis and treatment protocols have been a part of existing health systems for a long time.

World TB Day, on March 24, commemorates Dr. Robert Koch's discovery of Mycobacterium tuberculosis (the bacteria that causes tuberculosis) in 1882. Despite its discovery then, possible treatments using streptomycin in 1943 and the discovery of antibiotics such as isoniazid and rifampicin in the 1950s and 1960s, the war against the pathogen is far from been won, and there are multiple challenges to be overcome in combating the disease.

First, early detection. Given TB's aetiology, early detection is the key. Symptoms are often





## The right diagnosis for tuberculosis

uberculosis, commonly known as TB, is a disease which continues to impact millions globally. Ending the TB epidemic by 2030 is among the health targets of the United Nations' Sustainable Development Goals. Last year, Prime Minister Narendra Modi said that India is working towards eliminating TB five years ahead of the global 2030 target. This is an ambitious time frame. How well-positioned is India to achieve this?

A macro view suggests that India has done exceptionally well so far. A strong political intent is driving the right policies. In fact, in November 2023, the World Health Organization (WHO) acknowledged India's success on two major fronts: in reducing TB incidence by 16% from 2015 to 2022 (close to double the pace at which global TB incidence is declining) and in reducing TB mortality by 18% during the same period, keeping in line with the global trend.

#### The weakest aspect

However, as Dr. Madhukar Pai, Dr. Puneet K. Dewan, and Dr. Soumya Swaminathan pointed out in 'Transforming tuberculosis diagnosis' in Nature, globally, diagnosis continues to be the "weakest aspect of TB care". According to the WHO's 'Global Tuberculosis Report 2023', for the first time globally, 7.5 million patients were diagnosed with TB in 2022; yet there remained a large gap of some 3.1 million people who probably fell ill with TB but were not diagnosed and reported to national TB programmes. As the article surmised succinctly, "If we cannot find TB, we cannot treat TB. And if we cannot treat TB, we cannot end TB".

So, how do we find TB? We can detect it largely by leveraging and optimising the systems and processes already in place, as well as by quickly deploying newer proven technologies that take diagnosis as close to the point of care as possible.

Take, for instance, the first step

people may have infectious TB and may even be transmitting it. X-ray imaging is a quick and efficient way to find these patients. X-ray technology has advanced dramatically. Now, we not only have portable hand-held devices, but also software driven by Artificial Intelligence that can read digital X-ray images and detect possible TB with a high degree of certainty. This must be used on a wider scale so that we can find and absorb

potential patients into the care cascade faster. While X-rays are

good screening tools, it is imperative to detect TB bacteria in the patient with absolute certainty. The age-old sputum microscopy test has its limitations which are addressed by the newer molecular tests that are rapid, accurate, and even detect resistance against drugs. To be sure, India has scaled up molecular diagnostic capacity significantly. The NAAT (nucleic acid amplification test) machines in India have gone up from 651 in 2017 to more than 5,000 in 2022. But the utility of these tests is limited due to their high costs and issues with accessibility. Moreover, a large number of existing technologies including molecular testing are reliant on sputum collection and testing. This comes with its own challenges. First, it may not be as easy for everyone, especially young children, to produce sputum. Second, sample transportation, especially in remote and hilly districts, remains a challenge. During the COVID-19 pandemic, when an alternative to

nasopharyngeal swabs was introduced in the form of simpler nasal swabs, saliva, and self-collection, the testing coverage greatly increased. We must therefore be on the lookout for newer technologies and approaches to diagnosis.

#### Other collection techniques

It is time to actively explore other collection techniques such as tongue swabs which can be a true game changer. Here, the sample is extracted by simply rubbing the swab in the oral cavity. This augments our point-of-care testing abilities and also reduces the costs for overall diagnosis of TB. We could also better utilise another invaluable resource: PCR machines, which served us well during the COVID-19 pandemic. These are already fitted with the right diagnostic technology and can get to the last mile across the

country effectively. Newer technologies such as the urine LAM Bfight test can also be used to detect cases in the general population

effectively. This is a rapid test which is easily performed. It can help in screening for both pulmonary TB (lungs) and extra-pulmonary TB (organs other than the lungs).

The TB diagnostics pipeline is rich with several new innovative tests on the anvil. However, to maximise these tests, their rapid validation and adoption under the programme is critical. To ensure we truly reach the last mile, point-of-care testing and diagnosis is imperative. The good news is we already have a diagnostic framework that is forward-looking. We need to simply improve implementation and be more proactive in deploying new technologies. We need to ensure that new technologies are streamlined and rolled out faster and build capacity at the sub-district level to conduct such tests as needed. Minor re-adjustments will make a major contribution to India's TB elimination drive.

## Things fall apart; can AAP hold?

Kejriwal's arrest has put the AAP in a difficult position and the Congress in a quandary

olitics in the national capital has come a full circle with the arrest of Delhi Chief Minister Arvind Kejriwal on corruption charges by the Enforcement Directorate (ED). Mr. Kejriwal, who rose to power a decade ago by launching scathing attacks over corruption against the Congress, and particularly former Delhi Chief Minister Sheila Dikshit, now finds himself having to prove his and his party's "kattar imandar" (very honest) credentials and that too from prison.

#### An uneasy alliance

While Mr. Kejriwal's Aam Aadmi Party (AAP) faces its biggest challenge yet, just before the Lok Sabha elections, the Congress too finds itself in a predicament. The party, which ruled Delhi for 15 years before the AAP rode to power in 2015, has no seats in the Delhi Legislative Assembly and no representation from Delhi in Parliament. In this context, the 4-3 seat-sharing arrangement for Delhi's seven Lok Sabha seats under the Indian National Developmental Inclusive Alliance (INDIA) bloc can be seen as an attempt by the Congress to stay in the political mix in Delhi. This alliance is an uneasy one, however, given that the two parties are rivals elsewhere. In Punjab, for instance, the AAP and Congress have chosen to fight it alone; this is where the AAP came to power defeating the Congress in 2022. While the cadre of both the parties are still awaiting instructions from their leadership on how they plan to support each other after being bitter rivals for so many years, the factor that Delhi

#### unites them is a dominant opponent in the form of the Bharatiya Janata Party (BJP).

On the night of March 21, when the ED whisked away Mr. Kejriwal from outside his residence, it was Ms. Dikshit's son Sandeep Dikshit, a vociferous critic of Mr. Kejriwal, who was present outside his house, along with other Congress leaders, expressing solidarity and calling the arrest "illegal". The irony is that the alleged Delhi liquor scam that is being probed by Central agencies was an issue that was raked up by the Congress. In 2022, Ch. Anil Kumar, who was the Delhi Congress president, was among the first to file a complaint with the Delhi Police alleging a "multi-crore" scam in the formation and implementation of the policy. Other Congress leaders such as party treasurer Ajay Maken have also raised allegations of corruption against Mr. Keiriwal, attacking him for spending public funds on building a lavish residence and office.

Reacting to Mr. Kejriwal's arrest, Congress leader and former President of India Pranab Mukherjee's daughter Sharmistha Mukherjee posted on X (formerly Twitter) that "karma catches up". She said, "He and [the] Anna Hazare gang were responsible for making [the] most irresponsible, baseless and wild allegations against [the] Congress including Sheila Dikshit saying he has "trunk loads" of evidence against her. No one has seen the 'trunk' so far." However, leaders from both parties have said that they will

respect the "alliance dharma" and put aside their differences to fight the BJP. They believe that they will have a mathematical advantage if they do not split the anti-BJP votes.

#### Jubilance in BJP

Meanwhile, the BJP remains confident. Union Home Minister Amit Shah, while addressing an event in Delhi's Dwarka recently, commented on the alliance saying "0+0 is still zero" and expressed confidence that the BJP will win all seven seats for a third consecutive time. The mood at a Holi Milan organised in the Delhi BJP office a day after the arrest of Mr. Kejriwal was jubilant with leaders saying corruption has been "slayed" as Mr. Kejriwal, his former Deputy Chief Minister Manish Sisodia, former Health Minister Satvendar Jain, and Rajya Sabha MP Sanjay Singh are all in jail.

The AAP has spent the weekend reacting angrily to Mr. Kejriwal's arrest. It has deputed Cabinet Ministers Atishi, Saurabh Bharadwaj, and Gopal Rai to take stock of the situation along with Rajya Sabha MP Sandeep Pathak. All of them have been reiterating that Mr. Kejriwal will continue to be the Chief Minster even if he is in jail. The Congress is yet to announce its candidates for its three seats. Meetings on how both these parties are going to tackle the elections are yet to be conducted. On March 31, the AAP, Congress, and other Opposition parties are scheduled to hold a rally at Ramlila Maidan against Mr. Kejriwal's arrest. Mr. Kejriwal, who has often publicly called top leaders of the parties that will be present at the rally "corrupt", will find solace in seeing them show up for him.

he year 2024 is being hailed as the biggest year for democracy, with 45% of the global population preparing to exercise their voting rights or having already cast their ballots. It thus becomes imperative to assess how women are represented in politics and and leadership roles.

Women's representation in political spheres improved in the latter half of the 20th century, with significant progress made in many nations in securing voting rights and parliamentary seats, and in climbing to the highest political offices. However, this has been uneven. And despite substantial gains, women continue to constitute a minority in most parliamentary bodies and are rarely seen in top political leadership positions.

Data compiled by political scientist Svend-Erik Skaaning and colleagues show that until the mid-19th century, universal suffrage was virtually non-existent for both men and women across the world (Chart 1). However, a stark divergence then emerged, as men in certain nations were granted voting rights while women were excluded. New Zealand broke this pattern by extending universal suffrage to women in 1893.

The gap between male and female political participation widened in the early 20th century, despite women gaining suffrage in more countries, as men's voting rights expanded even further. By the onset of World War II, men had the right to vote in one out of three countries, while women did in only one out of six countries.

The gap then rapidly closed when the voting rights discrimination against women ended in many countries, and both women and men gained the right to vote in many others. Chart 1 shows the share of countries where both

In the early 20th century, women were largely absent from national parliaments, according to data based on the Varieties of Democracy (V-Dem) project. Norway first saw women enter parliament in 1907; nearly 10% of the country's parliamentary seats were occupied by women (Chart 2). But the latter half of the 20th century witnessed a significant surge in the number of women entering parliament. This trend accelerated in the late 20th and early 21st centuries. Rwanda's parliamentary composition surpassed the 50% mark for women's representation in 2008, setting a remarkable precedent. In the same year, countries such as Argentina, Cuba, Finland, and Sweden had between 40% and 50% women parliamentarians.

However, despite the progress, women's political representation has been limited and uneven. Women make up about half of all the representatives in only a few countries. As of 2022, in close to 60 countries, the share of women in parliament was 20% or less. And in three countries, there are no woman (Chart 3). The chart shows the share of seats in the lower or single chamber of the legislature held by women as of 2022.

While women's representation in parliament is important, so is their representation in a country's highest political office. Data from V-Dem shows that at any given point in time, almost all political chief executives have been men (Chart 4). Here, the term "chief executive" means the head of state or head of government, depending on who has more power. There has been a slight increase in the share of countries led by women in the last three decades. However, the share of countries where woman occupy the post of chief executive is still less than 10%.




Chart 1: The chart shows the share of countries with universal right to vote. Figures in %




#### Rebel troops' bid to overthrow Amin fails

Kampala, March 24: Rebel troops to-day appeared to have lost a machinegun and mortar battle to overthrow General Idi Amin's military regime. Government information organs remained silent after the fighting ended about dawn, giving rise to speculation that Gen. Amin had fled. But a newsman saw Gen. Amin driving an open, unescorted jeep along Kampala's main street about noon. Several friends were in the jeep with him.

Uganda Radio later broadcast a message said to be from Gen. Amin, asserting that conditions were back to normal. The message blamed the infighting on a false report that an invading force was trying to kill the General and take over the country.

Tanks and armoured cars patrolled Kampala this morning. Most soldiers withdrew to their barracks by mid-afternoon, leaving armed guards of Uganda Radio and the Information Ministry. Groceries were closed and a few civilians were on the streets.

Uganda Radio giving the Government's explanation said military police, members of the Mulire battalion and paratroop students had created "strong points" in Kampala following the false report of an impending invasion.

The broadcast said Gen. Amin spoke to the rebels this morning and told them that the officer who had spread the rumour later shot himself and "the others have run away."

Gen. Amin offered condolences to relatives of soldiers and others killed in the fighting, Uganda Radio said. The radio added that Gen. Amin told the Mulire battalion that if they were dissatisfied with his command, they should kill him or dismiss him, rather than "keep the good people of Kampala up all night running around."

## On the resurgence of mumps in Kerala

Is Kerala the only State witnessing an alarming increase in the number of mumps cases in children and adolescents? Why have there been many school-based outbreaks in the State? Why has the mumps vaccine been excluded from the Universal Immunisation Programme?

#### EXPLAINER

#### <u>C. Maya</u>

The story so far: umps, an acute viral infection which historically affects children, has been spreading like wildfire in Kerala, for the past few months. Not just Kerala, a resurgence in cases was being reported from several States, including Maharashtra, Telangana and Andhra Pradesh as well. Cases which began appearing sporadically around November 2023 in the Malappuram and Kozhikode districts of Kerala, have since then spread to Palakkad and Thrissur too, resulting in major community outbreaks. The case tally this year alone has reached 15,637, as on March 22, with 6,675 cases being reported this month. Such an uncontrolled surge in cases could lead to an increase in the number of complications of mumps, like meningoencephalitis or pancreatitis, public health experts fear.

Is it a cause for concern? Mumps is a self-limiting, airborne viral disease and presents as fever and headache in mostly children and adolescents, with painful swelling of the salivary glands (parotid glands) on both sides of the face. There is no specific treatment and the patient recovers with rest and symptomatic management in about two weeks. With only half of the infected children developing the classical disease and close to 30% remaining asymptomatic, cases mostly go unreported, indicating that the reported cases are a gross underestimation of the actual cases in the community. From the view point of public health, measles, which can cause significant morbidity and mortality, has always been considered a priority, rather than mumps. However, with cases being reported in epidemic proportions, several cases arising from the complications of mumps like encephalitis, epilepsy, aseptic

public awareness about the disease and the importance of isolation is the most important tool in bringing down the transmission of the disease. Mumps is primarily being reported in un-immunised children and adolescents and hence improving general immunisation cover is important. Transmission of the disease begins before the symptoms actually manifest and isolation of the patient for a full three weeks is necessary to limit the spread of the disease.

Health officials reckon that one of the reasons for the large number of school-based outbreaks in Kerala is because children were allowed back to school as soon as there was symptomatic relief, before the three weeks isolation period was up. They hope that there will be a break in transmission and a drop in new cases once schools close for the summer break.

What should be the strategy ahead? According to the World Health Organization (WHO), vaccination strategies targeting mumps control should be closely integrated with existing measles elimination and rubella control.

The IAP for one, has always advocated the use of MMR (Mumps-Measles-Rubella) vaccine in UIP, which has been available in the private sector for a long time. There are no studies from India on the effectiveness of the mumps vaccine. But globally, the protection from two doses is estimated to be between 70-95%, if the coverage is high. In 2014, Kerala, as part of its own initiative to protect children from Rubella, had replaced the second dose of measles vaccination given at 18 months to infants in UIP, with MMR. However, in 2017, when the Centre introduced Rubella vaccine in the UIP, replacing the two doses of measles given at nine months and 15 months with the MR vaccine (Measles-Rubella), Kerala also followed suit. meningitis and acute pancreatitis, have been reported at Kozhikode Medical College hospital. Why is the mumps vaccine not part of the national immunisation schedule? Despite being a vaccine-preventable disease, mumps has never been a part of the Universal Immunisation Programme (UIP) because of the disease's no-mortality profile and the perception that it has low public health significance. However, the Indian Academy of Paediatrics (IAP) has always maintained that the public health significance of mumps has been underestimated mainly because of the poor documentation of clinical cases, its complications and patients' follow-up data as well as the lack of published studies. There is no nationally representative data on incidence of the disease. There is very little information on the actual long-term morbidity profile of the disease, even though the disease is known to have some impact on reproductive organs.

# What are the new rules for elephant transfers?

What were the provisions regarding the ownership and transfer of elephants earlier? Why do experts and activists say that the law with respect to protecting elephants from trafficking has become lax?

#### The story so far:

he Centre has notified a set of rules called the Captive Elephant (Transfer or Transport) Rules, 2024 that liberalises the conditions under which elephants may be transferred within or between States.

What are the rules around the transfer and transport of elephants?

Elephants are, according to the provisions of the Wildlife Protection Act, a Schedule 1 species and therefore, be it wild or captive, cannot be captured or traded under any circumstances. Section 12 of the Act allows Schedule I animals to be translocated for 'special purposes' such as education and scientific research. They can also be translocated for population management of wildlife without harming any wild animal and collection of specimens for recognised zoos/museums. Captive elephants because of their historical role in forest management, timber transport, presence in estates of erstwhile royal families and in temple precincts for religious purpose can be owned and therefore come under a special category. However, strict rules guide the transfer of such elephants. Section 40 (2) of the Wildlife Protection Act, 1972 prohibits the acquisition, possession and transfer of a captive elephant without the written permission of the Chief Wildlife Warden of the State. Until 2021, however, these laws explicitly said that such transactions ought not to be of a 'commercial nature'. The Environment Ministry in 2021 brought in an amendment that allowed the transfer of elephants for 'religious or any other purposes'. Such a broad interpretation, activists and researchers said, could accelerate trafficking and illegal commercial transactions. A standing

committee, led by former Environment Minister, Jairam Ramesh, opposed this section but it was passed into law.

What do the updated rules say? These rules provide new relaxations under which captive elephants can change owners or be transferred. These include, for instance, situations when an owner is no longer in a position to maintain the elephant or when a state's Chief Wildlife Warden "deems it fit and proper" to transfer the elephant in circumstances which call for better upkeep of the elephant. Before a transfer within the State, an elephant's health has to be ratified by a veterinarian, and the Deputy Conservator of Forests has to establish that the animal's current habitat and prospective habitats are suitable. The Chief Wildlife Warden on receipt of such documents may choose to reject or approve the transfer. If the transfer involves moving the

elephant outside of a State, similar conditions apply. Before a transfer is effected, the "genetic profile" of the elephant has to be registered with the Ministry of Environment, Forest and Climate Change. Earlier rules required that an elephant being transferred from say, Assam to Gujarat would need permissions from the Chief Wildlife Wardens of every State that the elephant would pass through in the process of being ferried by road. Now only the originating and recipient States' permissions are required.

What do the updates mean? The Wildlife Protection Act is essentially a prohibitive law. It puts in a variety of restrictions to curb the trafficking of wild animals. However independent researchers say that with regard to elephants the law has become lax. The establishment of India's largest private zoo in Jamnagar, Gujarat which is affiliated to the Reliance Foundation, has brought some of these questions to the fore. The facility, which is a rescue centre and ostensibly exists to rehabilitate traumatised and injured elephants, among other wildlife, hosts a reported 200 elephants and controversially also hosts "healthy animals," according to a recent journalistic investigation published in the periodical Himal Southasia. There are also concerns that some of these elephants aren't captive but sourced from the wild.

# Digital financial frauds in India: a call for improved investigation strategies

A recent report by the Indian Cybercrime Coordination Centre revealed that digital financial frauds accounted for a staggering ₹1.25 lakh crore over the last three years. Such fraud networks must be recognised as a serious crime and bail may be restricted by the Courts

ybercrime poses a burgeoning threat in India, impacting millions of individuals and organisations. According to the National Crime Records Bureau (NCRB), cybercrimes in India in 2023 resulted in a staggering loss of ₹66.66 crore, with 4,850 reported cases. A recent report by the Indian Cybercrime Coordination Centre (I4C) revealed that digital financial frauds accounted for a staggering ₹1.25 lakh crore over the last three years. According to the National Cybercrime Reporting Portal (NCRP), in 2023, at least ₹10,319 crore was reported to be lost by victims of digital financial fraud. The Parliamentary standing committee on Finance in its report on "cyber security and rising incidents of cyber/white collar crimes" mentioned that the domestic fraud as reported by the SE (Supervising Entities) in FY'23 was ₹2537.35 crore. According to the report, the number of complaints received in 2023 alone was 6.94 lakh.

Some of the problems faced during investigations are highlighted here with solutions for both prevention and detection of online financial frauds. app screen/banking website or the victim will be conned into installing a screen sharing app. The scammers can also convince the victims over phone to give out those details. When these details are used on official banking apps this gives the fraudsters access to even the Fixed Deposits/Recurring Deposits which are also siphoned out in most cases. (c) by taking card details and

convincing the victim to share OTP.

#### After the scam

After a fraudster empties a victim's bank account, the money undergoes a series of circulations in broadly three stages. The first stage is a temporary account into which the fraudsters transfer victims' money. This account will be used to receive money from various other victims as well. From here, the money is then transferred into a second stage account. The second category of accounts are a group of accounts among which money is circulated. There are a lot of middlemen who are money circulators. Their task is only to receive money from first level bank accounts for a nominal cut. The victim's money is then split into small parts and then circulated within these accounts, by a person who is sitting in a different corner of the country. After sufficient churning, the money is then transferred into a third stage account which is a sink account. This can be a bank account, an e-wallet etc. Here, the total defrauded amount from a group of victims is re-collected. The money is then withdrawn in a large chunk through conventional methods of either ATMs/cheques or e-wallet cash outlets such as an e-wallet payments bank.

apps. As soon as a UPI ID, password or OTP is entered in a different device, an alert must be generated in a previous device with no further action being allowed until it is approved by the person. Secondly, the screen share facility must be disabled. Banking and financial apps must disable screen-sharing to run on top of them. And finally, in the bank statement, all banks/NBFCs/SEs must be mandated to provide comprehensible data. Currently only partly printed numbers are shown which even knowledgable customers are unable to understand. The transaction description must contain the receiver's account/mobile or any other identifying number irrespective of it being within the same bank or to an outside bank.

One of the biggest hindrances law enforcement agencies face is in following the money trail. The siphoned off money hops across bank accounts and wallets within minutes but supervised entities/banks/NBFCs/wallets are not able to give the required details to agencies with the same speed. Most of the crime is reported after 24 hours of the commission. Due to stress and most victims end up deleting much of the evidence from their devices/phones. By the time a money trail is established the money is already withdrawn from the system and there is no way to either identify the person or recover the money.

investigating officers. Most tech-savvy officers are often held back only because they do not get the data in a usable format. (b) The International Mobile Equipment Identity (IMEI) must be recorded. All banking and financial apps must be mandated to save IMEI details of the device being used. Fraudsters use fake mobile numbers and fake bank accounts which span across different States with the goal of adding layers to increase anonymity and preventing agencies from prosecuting them. Thus, the IMEI becomes crucial evidence in determining the device and its location. Recording IMEI will make for stronger evidence in establishing a device and its connection to fraudsters in a court of law.

#### The road ahead

The Bharatiya Nagarik Suraksha Sanhita 2023 which is set to replace the Indian Penal Code of 1861, recognises 'organised crime' as a "continuous unlawful activity". Digital financial frauds are very much covered in this definition. Law enforcement agencies face a lot of difficulties in conducting interstate raids and arrests. It requires a large team and coordinated effort. Interstate digital financial fraud networks must be recognised as a serious crime and bail may be restricted by the Courts. Additionally, digital frauds create a considerable amount of black money when seen from a macro-economic perspective. In conclusion, cybercrime being a subset of crime in general can be dealt like conventional offences, albeit with a different set of tools. Instead of a specialised unit, if the fintech and telecom industries are mandated to take certain preventive steps in their technology and provide data in a manner which enables speedier investigation, the prevention, detection, recovery and conviction will be much more effective. While various names have been given to diverse types of frauds, the general *modus operandi* of a fraudster is any one of the following: (a) convincing the victim to send money, either by impersonation (fake WhatsApp/FB/Insta, social media profiles) or by giving them a false promise of greater return (investment, crypto, held up custom package etc.)

(b) by taking credentials such as Unified Payments Interface ID (UPI), Personal Identification Number (PIN), One-Time Password (OTP) or Internet banking ID/password from the victim and then using the same on other apps/websites and transferring money without the knowledge of the victim. For this the customer will either be given a fake link which looks exactly like a UPI

#### Speeding up information access

Certain basic changes to the form of data provided to enforcement agencies can help in minimising delays:

(a) the banks/NBFCs/SEs must be mandated to provide data in a predetermined format with all the terms explained. The data must be given in a CSV or XLSX file. For example, the CDR (Call Data Record) shared to enforcement agencies has a fixed format and fixed file types, such as .CSV or .XLSX. 

I invest only in mutual funds and not equity shares. I buy directly from the AMCs' through their websites.

I have three SIPs (systematic investment plans), which are smoothly deducted from my accounts.

I wanted to sell some of the units and I went to the AMCs' websites where I bought directly.

When I clicked on the redemption option, in all three AMCs, it says "your mutual fund units are not redeemable here as they are in demat". My queries are:

1) Investors like me want to buy directly from an AMC to save on commission but why are the AMCs not giving a redemption option?

Is it wrong to have converted the units into demat?

2) The NSDL sends monthly statements and has an app called SPEEDE. In this app, too, there is an option to enable redemption, but when you click to activate it asks you to contact the DP.

3) When I contacted DP, the answer is – give redemption form physically. I feel this is an unwanted hassle. In a way, the investment is online, but redemption doesn't happen online the same way without an intermediary. How to rectify this? Please advise. DR. HEMAKUMAR

Your hassle is understandable. But unfortunately, you were not aware of the implications of converting MF units into demat. Let us deal with them one by one. First, it is neither efficient or necessary to hold mutual fund units in demat unless you want to hold your funds and stocks in one place. Since you have stated you do not have shares, you could have kept your mutual funds in a non-demat form.

#### **Cumbersome exercise**

Second, there was no need for you to go to an individual AMC to buy their 'direct' plans. In fact, it is a cumbersome exercise since you need to visit each website for any transaction and

ou would be hearing a lot, about the runup in prices of small and mid-cap equities and the stress test the Securities and Exchange Board of India (SEBI) asked Mutual Funds to conduct on small and mid-cap funds. This article will help you make sense of what is happening.

Market capitalisation is the total value all shareholders have assigned to a firm listed on the stock exchange. It is computed by multiplying the market price of a share with outstanding shares.

As an illustration, the market price of MRF Ltd. is about ₹1,40,400, subject to daily fluctuations. This does not mean MRF is the most valuable stock in the country; it is the priciest. The most valuable firm in the market viz. the one with the highest market cap is Reliance Industries. "The market cap of Reliance was ₹16.4 lakh crore in December, which had risen in March, along with a rise in stock price. While there may be many parameters for categorising firms, market cap is popular. As the size of a business grows, the market assigns a higher value. That is referred to as large cap in the market. When the size of a business is small, only a limited number of stockholders are interested in it and the value is relatively lower. That is referred to as small-cap stock. In between, there are mid-cap stocks. Now the question is, what is the definition of large- or small-cap stocks. Equity analysts/fund managers have estimates and assume a number, beyond which the company is classified as a large-cap or mid-cap. For categorisation, there is a definition from SEBI that is applicable to mutual funds but can be taken as a proxy for the entire market. The definition counts the top 100 listed stocks, as per market cap, as large-cap stocks. The next 150 i.e. from stock number 101 to 250,

are categorised as mid-cap. Beyond this, all stocks are classified as small-cap.

To give you a perspective, the stock ranking number 100 (border line of large- and mid-cap) as on December 2023 had a market cap of ₹67,000 crore. The one ranking 250 (border line of mid- and smallcap) had a market cap of ₹22,000 crore.

As per market terminology, there is another category viz, micro-can, Firms

Now that you have invested, saved and paid your taxes, let's see how you start early for the next financial year.

It's a good practice to invest the maximum in your Public Provident Fund (PPF) in one shot on the first bank working day of April.

#### Icing on the cake

This way, the investment earns interest for the entire year. It gives about the best returns among taxsaving instruments and compound interest is the icing on the cake.

But the real advantage in this is to peg the investment target date so that you are prepared ahead of time. If you are starting a new investment, say a life insurance policy, let the renewal be on your birthday or that of one of your family members.

Or on the wedding day. Hard to forget (for your own good!) and a clear date to plan for.

Going back to the previous instalment of CoverNote on how to cross over to the new regime, you have to start thinking of all such investments on their own merits.

Life insurance, health insurance, ELSS, tax-saving fixed deposits or the palette of small-savings schemes, each has its relative position in the returns matrix, and viewing them for what they are minus the tax saving is important.

#### **One-time commitment**

Remember to start considering them as one-time vs. repetitive commitments.

You can buy fresh national savings certificates for the next few years and stop and walk away if the tax-break is withdrawn. But if you commit now to a life policy with long-term premium payments, you will not get tax breaks when the system changes and this is a commitment you can't abandon!

The life policy is valuable IF you ave thought it through for what it

There are now plenty of platforms with good user experience to buy direct plans of MFs.

And, if those do not instil confidence, then there are MF Central (a joint platform by the RTAs) and the mutual fund association MFU (AMFI's MF Utility) platforms to transact online in one place for all your funds.

Third, if you had chosen to demat your units, for whatever reason, you should have made sure you do it with a brokerage platform that offers the facility to buy and redeem direct plan units online.

There are places where you can demat units but not transact online. They serve no purpose in these cases.

The AMCs are right in saying that your units must be sold through the exchange if they are in demat form.

They can process them directly only if it is in a non-demat form.

#### **Two options**

You have two options at this point. One option now is for you to move to an online brokerage platform by transferring the demat units. This is a one-time task and easy to handle.

Else, you can convert these back to physical units. Unlike converting physical units into demat, there's no online process for switching demat units back to physical form (rematerialisation) with the NSDL or the CDSL.

You'll need to visit your Depository Participant (DP) in person and submit a physical request.

Expect to fill out a rematerialisation form specific to the RTA (like CAMS/ Karvy) handling your mutual fund house. This process, according to media reports, typically takes two-four weeks to complete.

Health insurance is also going to lose its tax benefits. It is costly today, and is getting costlier and the loss of the tax-break will be a difficult blow to take.

On the flip side, Section 80 also offers tax breaks on donations to specified charities. If 80G goes, please don't withhold future donations. There are always those who need a helping hand and causes that need to be upheld.

In the reckoning of a life well lived, what you give away is what you truly keep in your credit.

# Jindal expands canvas with electric vehicles and paint ambitions

JSW Group chairman Sajjan Jindal wants to recreate a Maruti moment in EVs and scale up the Group's fledgling paints business; but the entry of a commodity company like JSW into the consumer-focused automotive and paints segments already dominated by large players has puzzled many

Chairman, Sajjan Jindal, making cars has been a childhood passion. "I built my first car in a garage when I was 12 years old. It was a small car and I used to go around it in our factory in Hisar, Haryana," says the 63- yearold industrialist. However, Jindal's passion took a back seat as he decided to join the family business of making steel.

But 52 years later, after building the world's seventh-largest steel company, excluding China, Mr. Jindal is now making his automotive dream a reality. Last week, the JSW group outlined its strategy to corner a 33% market share in the electric vehicle segment through a joint venture with China's SAIC Motor, the owner of MG Motors

"This idea of making cars in India by the JSW Group always remained in my head and during 2015-16 when the new technology for electric vehicles came in, I thought that this is an opportunity to enter this business," he said.

To start with, JSW Group, along with other investors,, MG Motor India dealers and employees will invest ₹5,000 crore for a 51% stake in JSW MG Motor

India while the remaining 49% will be held by Chinese state-owned SAIC Motor. The joint venture plans to roll out a new model every three to six months. "We are all set to recreate a Maruti moment. I recall in 1984 when Maruti first launched its vehicle there was so much excitement and everybody wanted to own one. Today, they have 50% market share," he said.

#### A large canvas

Auto is not the only market where Jindal is looking to disrupt. Mr. Jindal is eyeing multiple new areas of growth including a significant play in the ₹70,000 crore paints industry, and EV battery manufacturing to capitalise on the boom-

In the paints segment, JSW is eyeing a capex of ₹750-1,000 crore over the next 2-3 years as it looks to up production capacities by 2 lakh kilo litres (kl) per annum and a plan to corner a market share of 8-10% over the next three years. JSW Paints, the Group's latest venture, is on course to cross revenue

#### Banking on headroom

But this does not worry JSW group. "As they always say, good things take time to start," Mr. Jindal said. His confidence comes from the fact that these markets have a huge headroom for growth. According to experts, the paint segment grows at 1.5 times the GDP growth. This provides enough scope for new market entrants to establish their presence without necessarily impacting the current pecking order.

Similar solutions will emerge for charging electric cars," Mr. Jindal said adding that his group company JSW Energy will also be partnering with a few start-ups to put up charging stations

at major locations. "We believe in scale and are going to churn the whole industry and create some sort of a disruption in the industry," he said.

When Maruti drove into India 40 years ago it changed the auto industry and brought in very efficient lightweight cars. The Ambassadors and the Fiats went into oblivion, he said. "I believe with MG we can recreate the same moment in the new energy vehicle space. That is why JSW, a commodity player with presence in steel, cement and energy, has come into this B2C consumer product," he explains.

They stated that being disrespectful, non-inclusive, unethical, cut-throat, and abusive has by far the largest negative impact on how employees rate their company's culture in Glassdoor reviews.

#### The manifestation

Language, volume, and meeting participation are three key indicators of a team or organisation's leadership culture. The WFH world has given us a good glimpse into many enterprises, town halls, and meetings. The higher volume, single voice partici-

pation and the cuss words were indicative of the disrespectful, non-inclusive, and abusive world of some of the organisations our family and friends work for.

#### Matter of heart

One of the oldest medical iournals, Lancet, published a study by Mika Kivimaki that said a combination of high psychological demands combined with little control of decisionmaking leads to physiological strain. They followed up for a mean of 13.9 years and concluded that job strain increased the risk of mortality.

It's time organisations introduced WATCH if we want to curb this malaise.

## **Poland scrambles F-16s amid Russia's air strikes on Ukraine**

Since Russia invaded Ukraine, there have been a number of intrusions into Polish airspace.

## Ukraine says it struck two near Crimea

The Ukrainian military said it hit two large Russian landing ships in attacks on the annexed Crimean peninsula early on Sunday, as well as a communications centre and other infrastructure used by the Russian Navy in the Black Sea.

The statement did not say how it hit the targets, but a Moscow-installed official in the region reported a major Ukrainian air attack and said air defences had shot down more than 10 missiles over the Crimean port of Sevastopol.

Mikhail Razvozhayev, the Russian-installed governor of Sevastopol, said on the Telegram messaging app that transport infrastructure including passenger boats and buses were partially damaged in the overnight attacks.

Authorities in Chad said on Sunday they had barred 10 candidates, including two fierce opponents of the military regime, from standing in the presidential election on May 6.

The constitutional court said the candidates' applications - namely those of outspoken opponents Nassour Ibrahim Neguy Koursami and Rakhis Ahmat Saleh – had been rejected because they included "irregularities"

Ten other candidates remain in the race - most prominently the current junta leader Mahamat Idriss Deby Itno and his Prime Minister Succes Masra, a former opponent whose participation has been denounced by the Opposition as a front for plurality.

#### The **Opposition** accuses the junta of putting up a front of plurality and a democratic poll

"It is a candidacy under the pretext that we need

other candidates against Deby to say that there is a democratic game," agreed political scientist Kelma Manatouma of the University of N'Djamena.

#### Change of stance

General Deby Itno was proclaimed President by a junta of 15 generals in 2021 following the death of his father Idriss Deby Itno, who had ruled the Sahel country with an iron fist for more than three decades.

The new President promised to hand power back to a civilian government

within 18 months and told the African Union he would not stand for election as President. But he then extended the transition period by two more years and on March 2 officially announced he would run for the top office.

Mr. Masra, a former opposition leader, signed a reconciliation deal with the junta leader earlier this year. The Opposition says his

candidacy is a ploy to give a veneer of pluralism to an election that Mr. Deby Itno is certain to win, since his main rivals are dead or in exile.

The constitutional council also announced it was opening a preliminary investigation for alleged forgery and use of forged documents against Mr. Koursami over suspicions with papers in support of his candidacy.

Ecuador's youngest mayor, Brigitte Garcia, and an adviser were found shot dead in a car early on Sunday, said police in the South American country, which is in the grips of a wave of violence that authorities blame on drug trafficking.

National police said they were investigating the deaths of Garcia, the 27year-old mayor of San Vicente, and Jairo Loor, after the discovery of their bodies in the province of Manabi. Both suffered gunshot wounds, police said in a statement.

Garcia is the latest political figure in the country to be killed following the assassination of presidential candidate Fernando Villavicencio last August.

## Sirisena to be quizzed over Easter bombings

The war began when Hamas launched an unprecedented attack from Gaza that left about 1,160 dead in Israel, mostly civilians.

Israel's military has waged a retaliatory offensive against Hamas that has killed 32,226 people, according to Gaza's Health Ministry. Palestinian militants seized about 250 Israeli and foreign hostages during the October 7 attack on Israel but close to 130 still remain in Gaza.

## U.S. forces engage six Houthi drones

U.S. forces engaged six Houthi unmanned aerial vehicles (UAV) over the southern Red Sea after the group launched four antiship ballistic missiles toward a Chinese-owned oil tanker, the U.S. Central Command said on Saturday. ## **Rescue efforts on** as rain and storms kill 20 in Brazil

Rescuers in boats and aircraft raced against the clock on Sunday to help isolated people in Brazil's mountainous southeast after storms and heavy rains killed at least 20 people.

With more rain predicted on Sunday, the deluge pounded the States of Rio de Janeiro and Espirito Santo, where authorities described a chaotic situation due to flooding. The death toll rose there from four to 12 on Sunday as rescuers advanced.

The most affected municipality is Mimoso do Sul, a town of almost 25,000 inhabitants located in the south of Espirito Santo, where at least 10 people died in floods, though officials fear the toll may yet rise. State Governor Renato Casagrande described the situation as "chaotic," saying that so far it has not been possible to assess the damage in some of the more isolated areas, with fears the toll could yet rise. Search teams rescued a girl buried for more than 16 hours in the city of Petropolis. Her father, who was found dead next to her on Saturday, had "heroically protected the girl with his body," a neighbour said.

The deluge came as Brazil, South America's largest country, suffers through a recent string of extreme weather events, which experts say are more likely to occur due to climate change.

Such tragedies "are intensifying with climate change," President Luiz Inacio Lula da Silva said in a post on X, adding that thousands had been left homeless by the storm. He expressed sympathy for the victims, and said his government was working with state and local authorities to "protect, prevent and repair flood damage."

## As Russians mourn concert attack, relatives wait for word of their kin

With rescuers continuing to search the damaged concert hall for survivors a day after the deadliest attack on Russian soil in years, cultural events were cancelled, flags were lowered to half-staff and television entertainment were suspended as the country observed a day of national mourning

ter an attack that killed more than 130 people at a suburban Moscow concert hall waited for news of their loved ones as Russia observed a day of national mourning on Sunday. Events at cultural insti-

tutions were canceled, flags were lowered to halfstaff and television entertainment and advertising were suspended, according to state news agency RIA Novosti. A steady stream of people brought flowers to a makeshift memorial near the burnt-out concert hall.

"People came to a concert, some people came to relax with their families, and any one of us could have been in that situation. And I want to express my condolences to all the families that were affected here and I want to pay tribute to these people," Andrey Kondakov, one of the mourners who came to lay flowers at the memorial, said.

"It is a tragedy that has affected our entire country," kindergarten employee Marina Korshunova said. "It just doesn't even make sense that small children were affected by this event." Three children were among the dead. The attack, which has

#### 'No response'

Igor Pogadaev was desperately seeking any details of his wife's whereabouts after she went to the concert and stopped responding to his messages.

He hasn't seen a message from Yana Pogadaeva since she sent her husband two photos from the Crocus City Hall music venue. After Mr. Pogadaev saw

the reports of gunmen opening fire on concertgoers, he rushed to the

in the numerous ambulances or among the hundreds of people who had made their way out of the venue. "I went around, searched, I asked everyone, I showed photographs. No one saw anything, no one could say anything," Mr. Pogadaev said in a video message.

He watched flames bursting out of the building as he made frantic calls to a hotline for relatives of the victims, but received no information.

As the death toll mounted on Saturday, Mr. Pogadaev scoured hospitals in the Russian capital and the Moscow region, looking for information on newly admitted patients.

But his wife wasn't among the 154 reported in-

jured, nor on the list of 50 victims authorities have already identified, he said.

The Moscow Region's Emergency Situations Ministry posted a video on Sunday showing equipment dismantling the damaged music venue to give rescuers access.

Meanwhile, President Vladimir Putin appears to be trying to tie Ukraine to the attack, something its government firmly denies. Russian media broadcast videos that apparently showed the detention and interrogation of the suspects, including one who told the cameras he was approached by an unidentified assistant to an Islamic preacher via a messaging app and paid to take part in the raid.

Kyiv strongly denied any

involvement, and IS's Afghanistan affiliate claimed responsibility.

IS, which fought against Russia during its intervention in the Syrian civil war, has long targeted Russia. In a statement posted by the group's Aamaq news agency, the IS Afghanistan affiliate said that it had attacked a large gathering of "Christians" in

Krasnogorsk. The group issued a new statement on Saturday on Aamaq, saying the attack was carried out by four men who used automatic rifles, a pistol, knives and firebombs. It said the assailants fired at the crowd and used knives to kill some concertgoers, casting the raid as part of the Islamic State group's ongoing war with countries that it says are fighting against Islam. In October 2015, a bomb

planted by IS downed a Russian passenger plane over Sinai, killing all 224 people on board, most of them Russian vacationers returning from Egypt.

The group, which operates mainly in Syria and Iraq but also in Afghanistan and Africa, also has claimed responsibility for several attacks in Russia's volatile Caucasus and other regions in past years. It recruited fighters from Russia and other parts of the former Soviet Union.

Mr. Putin didn't mention IS in his speech to the nation, and Kyiv accused him and other Russian pol-

iticians of falsely linking Ukraine to the assault to stoke fervor for Russia's fight in Ukraine, which recently entered its third year. But U.S. intelligence officials said they had confirmed the IS affiliate's claim.

"ISIS bears sole responsibility for this attack. There was no Ukrainian involvement whatsoever," National Security Council spokesperson Adrienne Watson said in a statement.

#### 'Information shared'

The U.S. shared information with Russia in early March about a planned terrorist attack in Moscow, and issued a public warning to Americans in Russia, Ms. Watson said.

The raid happened just days after the Russian leader cemented his grip on the country for another six years in a vote that followed the harshest crackdown on dissent since the Soviet times.

Some commentators on Russian social media questioned how authorities, who have relentlessly suppressed any opposition activities and muzzled independent media, failed to prevent the attack despite the U.S. warnings.

White House press secretary Karine Jean-Pierre said in a statement that the U.S. condemned the attack and said that the IS is a "common terrorist enemy that must be defeated everywhere."

Hungary 'projects' new tales <sup>+</sup> for children in old filmstrips

A pro-Kurdish candidate, who lost his arm in prison during a police raid after a hunger strike in 2000, has turned three decades of social activism into a fight against the anti-migrant sentiment dominating local elections in Turkiye.

Veli Sacilik, 47, is fighting anti-refugee rhetoric which dominates the campaign for municipal elections on March 31 in the city of Bolu in northwestern Turkiye. Standing for the pro-Kurdish Dem (Peoples' Equality and Democracy Party) party, Mr. Sacilik wants to "offer a democratic alternative" for his city which he says is "stuck between racism and a rent economy".

The debate on Turkeiye's 3.3 million Syrian refugees has virtually disappeared since the May 2023 presidential election, except in Bolu, where Mr. Sacilik's opponents have built their campaign on anti-migrant sentiment. One such opponent is the outgoing mayor Tanju Ozcan of the main opposition CHP party, known for displaying an anti-Syrian refugee banner at Bolu's entrance.

Despite Syrian refugees making up just 1.2% of the city's population, Mr. Ozcan has tried to pursue anti-migrant policies including a failed attempt to charge them ten times more for water or to withdraw business permits. "Tanju Ozcan is a populist. If you don't fight against wars and for the environment, you can't solve immigration issues," said Mr. Sacilik,

Tablets and mobile phones may have to be prised from the fingers of children elsewhere, but in Hungary storytime can be all about a 100-year-old piece of tech – filmstrip.

"We're together, it's cozier than the cinema yet it's better than a book," said the 44-yearold lawyer.

Filmstrip – a centuryold storytelling medium that was killed off in the West by the video cassette in the 1980s - is not just hanging on in Hungary, it is

thriving with a new wave of enthusiasts charmed by its slower-paced entertainment. Printed on rolls of film, the still images were never meant to move.

"Between the 1940s and the 1980s filmstrips were used worldwide as a visualisation tool in education and other fields," Levente Borsos, of Seoul's Hankuk University of Foreign Stu-

dies, said. But while it was surpassed by more advanced technologies in the West, it became a popular form of

home entertainment in the Soviet bloc where TVs and videos were harder to come by.

When communism collapsed, filmstrip began to disappear - except in Hungary, where the since privatised Diafilmgyarto company survives as the country's sole producer.

"Continuous filmstrip publishing and slide shows at home can be considered a Hungarian peculiarity, a special part of the country's cultural heritage," Mr. Borsos said.

## Paris museum takes visitors back 150 years to the birth of Impressionism

The Orsay Museum in Paris is marking 150 years of Impressionism from Tuesday with an unprecedented reassembling of the masterpieces that launched the movement, and a virtual reality experience that

takes visitors back in time. Using VR technology, visitors to Paris 1874: Inventing Impressionism can take a plunge into the streets, salons and beauty spots that marked a revolution in art.

Through VR helmets, they can walk alongside the likes of Claude Monet, Edgar Degas and Paul Cezanne on April 15, 1874, when, tired of being reject-

ed by the conservative gatekeepers of the official art Salon, these rebellious young painters put on their own independent show, later seen as the birth of Impressionism.

#### Strong 'impression'

The Orsay has brought together 160 paintings from that year, including dozens of masterpieces from that show, including the bloodred sun of Monet's Impression, Sunrise, credited with giving the movement its name, and his Boulevard des Capucines where the

exhibition took place.

In rapid, spontaneous brushstrokes, the Impressionists captured everyday scenes of modern life, from Degas's ballet dan-

cers to Camille Pissaro's countryside idylls to Auguste Renoir's riverside party in Bal du Moulin de la Galette.

They came to define the

excitement and restlessness of a new, modern age emerging out of a devastating war with Prussia and a short-lived Parisian revolt a few years earlier. "The Impressionists wanted to paint the world as it is, one in the midst of major change," said Sylvie Patry, co-curator of the exhibition.

"They were interested in new subjects: railways, tourism, the world of entertainment... They wanted to put sensations, impressions, the immediate moment at the heart of their painting," she added. Thanks to loans from

adopted new styles. the National Gallery in

Washington and other museums, it is the first time that many of the paintings – including Renoir's The Parisian Girl and The Dan*cer* – have hung together in 150 years.

"The story of that exhi-

bition is more nuanced than we think," said Ms. Patry. "The artists all knew each other and had begun painting in this different style from the 1860s."

Impressionism did not take off immediately: only some 3,500 people came to the first show, compared with 3,00,000 to the Salon, and only four paintings were sold out of some 200 works. It would take several more exhibitions in the following years for the movement to make its mark.

The Orsay exhibition runs to July 14 and moves Washington from to September.





Their key roles are receiving serve, digging attacks, and making passes from the second row to set up the team's offence.

However in India, liberos have remained in the shadows and have not been given due credit.

K. Anand, the libero of Delhi Toofans in the recently concluded Prime Volleyball League (PVL) in Chennai, has been an exception to the rule. Toofans lost to Calicut Heroes in the final. In fact, it was a great performance given that it was the team's debut in the PVL.

The 21-year-old from Kerala has been a game-changer with his exceptional digs. His acts of jumping high and celebrating a point made the crowd involved with the game. To put it short, he was the livewire of Toofans.

In fact, after seeing one of his diving photos and of Anand's on twitter, former South African cricketer Jonty Rhodes wrote: "At least you (Anand) managed to get into the same frame as the ball – I need to work on my reach!"
