Tariff regulator snubs revenue projections at Adani airport in Thiruvananthapuram

The Adani- controlled Thiruvananthapuram airport's projection of revenue from non-aeronautical services such as the sale of food and beverages - used to subsidise costs levied on airlines and passengers - is just a "minuscule" 12% of the norm, according to the country's airport tariff regulator. In fact, it is only a third of what the airport earned before privatisation.

At least 21 lakh SIM cards have been activated using fake proof of identity or proof of address documents, according to an analysis carried out by the Department of Telecommunications (DoT). In an alert sent to Bharti Airtel, MTNL, BSNL, Reliance Jio, and Vodafone Idea, the DoT provided a list of suspicious subscribers and called for an urgent re-verification of their documents, and disconnection

of those found to be bogus. A fresh pan-India analysis of 114 crore mobile phone connections by the DoT's Artificial Intelligence & Digital Intelligence Unit (AI&DIU) has shown that invalid, non-existent, fake, or forged documents were used to support applications to activate at least 21 lakh SIM issued by various telecom service providers. A majority of these numbers are suspected to be in use for committing various types of cyber crimes or online frauds.

It was found that in 1.92 crore cases, an individual had subscribed for too many mobile connections, crossing the permitted limit of nine SIM cards across service providers across the country. This included connections that were "erroneously" categorised as individual instead of bulk connections.

The nationwide analysis was taken up as part of the Sanchar Saathi, a citizencentric initiative that empowers citizens to know the mobile connections issued in their name and seek disconnection of any SIM card that they that not applied for.

The Supreme Court on Tuesday asked self-styled yoga guru Baba Ramdev to personally appear in a contempt case initiated against Patanjali Ayurved for publishing misleading advertisements in violation of the Drugs and Magic Remedies (Objectionable Advertisements) Act, 1954 despite an undertaking given to the court in November last year.

A Bench of Justices Hima Kohli and Ahsanuddin Amanullah issued a show cause notice to Baba Ramdev to file his response against initiating contempt proceedings against him.

The Bench further directed Acharya Balkrishna, the Managing Director of Patanjali Ayurved, to be present in the court along with Baba Ramdev for the next hearing on April 2.

The court ordered the presence of Balkrishna after learning that he did not file a response to the show cause notice issued to him on February 27. The Bench brushed aside the explanations offered by senior advocate Mukul Rohatgi, appearing for Patanjali, for not filing a reply.

The Bench indicated that Baba Ramdev should be heard in the case as he had endorsed the Patanjali advertisements prohibited by the court on November 21, 2023.

The Bench had issued show cause notice to Patanjali and Balakrishna on February 27 for violating an assurance given to the Supreme Court on November 21, 2023 that they would refrain from advertising or branding its products as "permanent re-

lief" for diseases such as obesity, blood pressure, asthma, etc, in violation of the 1954 Act.

On November 21, the court directed the company to not make any "casual statements" to the print or electronic media about the efficacy of their medicinal products or indulge in any disparaging statements about other disciplines of medicine such as allopathy.

However, a press conference was held by Baba Ramdev, on November 22, the very next day of the Supreme Court order.

"This court is prima fa*cie* of the opinion that he has also violated the provisions of the Drugs and Magic Remedies (Objectionable Advertisements) Act, 1954," the court observed.

In the February hearing, the petitioner, the Indian Medical Association, had described Baba Ramdev's association with Patanjali as "everything and nothing at the same time".

"In November, we had specifically said there should be no violation of any law. That means that there should be nothing misleading, especially advertisements of drugs manufactured and marketed by you. But you are still advertising your products as a 'permanent relief'," Justice Kohli had told Patanjali's lawyers at the time.

JD(U) leader Ashraf Fatmi quits, likely to rejoin RJD

Janata Dal (United) general secretary and former Union Minister Mohammed Ali Ashraf Fatmi on Tuesday resigned from the party to protect his "moral values". Mr. Fatmi is likely to return to the Opposition Rashtriya Janata Dal (RJD) with the hope of contesting the upcoming Lok Sabha poll from Darbhanga or Madhubani constituency. As per the seat-sharing arrangement finalised among NDA allies on March 18, the Madhubani and Darbhanga seats both went to the BJP. Mr. Fatmi has won the Darbhanga seat four times so far. He had joined the JD(U) ahead of the 2019 Lok Sabha poll.

'Not feasible to hold Civils exam in Manipur hill districts'

The Manipur government on Tuesday informed the Delhi High Court that it was not in favour of setting up examination centres for the 2024 Civil Services (Preliminary) Examination (CSE) in Churachandpur and Kangpokpi districts of the violence-hit State. A letter written by Manipur Chief Secretary was handed over to the court, which was hearing a plea by Zomi Student Federation seeking to set up examination centres in the hill districts of Manipur for the coming CSE. As per UPSC's notification issued in February, Imphal is the only centre in Manipur where the CSE could be held. The High Court would hear the matter again on March 22.

M.P. student preparing for exams kidnapped in Kota

A 20-year-old student from Madhya Pradesh's Shivpuri was allegedly kidnapped in Kota, Rajasthan, where she was preparing for competitive examinations, the police said on Tuesday. According to the police, the student's father received her pictures and videos on his mobile on Monday along with threats and demand of ransom of ₹30 lakh, after which he approached the police. Meanwhile, Union Minister Jyotiraditya Scindia, who is BJP candidate for Guna-Shivpuri Lok Sabha seat, also spoke to Rajasthan Chief Minister Bhajan Lal Sharma and requested a speedy probe into the matter to ensure the safe release of the student.



Vrindavan temple moves HC over funds withheld by U.P. govt.

A petition in the Allahabad High Court said that the annuity of nine temples in Vrindavan town in Uttar Pradesh had been withheld for the last four years by District Magistrate and Senior Treasury Officer, Mathura. The High Court noted that it is "painful" that temples and trusts have to knock the doors of the court for getting their dues released from the U.P. government.

The Bench was hearing a petition filed by Thakur Rangji Maharaj Virajman Mandir, a temple built in 1851 AD, seeking the court's intervention to get its payment of the annuity under Section 99 of the U.P. Zamindari Abolition

(UPZA) and Land Reforms (LR) Act. The petitioner told the court that the an-

nuitv amounting to ₹9,125,07 had not been released to nine temples due to lack of permission by the Board of Revenue. However, the government submitted that ₹2,23,199 had been paid and now a balance of ₹6,89,308 remained.

The Commissioner/Secretary of the Board of Revenue, in a personal affidavit, told the court that a fund of over ₹6 lakh could not be released to the temples due to paucity of "This court is funds. pained to note that temples and trusts have to knock on the doors of the Court for getting their dues released from the State Government, which should

have automatically flowed from the Treasury of the State into the account of temples," the court noted. The court further noted that from perusal of the personal affidavit of Com-

missioner/Secretary, Board of Revenue, it transpired that no effort had been made by the officer concerned for the last four years for getting the annuity transferred into the ac-

count of the temples. "The temple authorities are running from pillar to post for getting their dues released from these government officials, which is strange," the court added, while issuing summons to the Secretary of the Board of Revenue for an explanation.

The court will hear the matter on March 20.

Cong. asked to leave Assam's Barpeta LS seat for Left Front

Seventy-seven educationists, intellectuals, cultural and literary activists in Assam have asked the Assam Congress unit to leave the Barpeta Lok Sabha seat to the Left Front so that a key ally of the BJP can be defeated.

In a letter to APCC president Bhupen Kumar Borah on March 17, the signatories said the party should withdraw its candidate for the Barpeta seat in favour of the Communist Party of India-Marxist (CPI-M) to defeat the Asom Gana Parishad (AGP) candidate.

The Congress denied a ticket to Barpeta's incumbent MP Abdul Khaleque and fielded Deep Bayan, the former president of the Assam unit of Seva Dal.

The CPI(M) is one of four Left Front constituents of the 16-party United Opposition Forum, Assam headed by Congress. The others are CPI, CPI (Marxist-Leninist) Liberation, and All India Forward Bloc. "Such a liberal and realistic approach on your part will not only take the image of your party in Assam to greater heights but will also ensure the defeat of the BJP and its allies and remove them from power," the signatories wrote.

The Congress has left two of Assam's 14 Lok Sabha constituencies to its allies. These are Dibrugarh and Lakhimpur.

visit to Kerala within a week as part of the BJP's election campaign. He had addressed a rally in Pathanamthitta on March 15. BJP leaders said Mr. Modi would visit the State again to campaign for the party's key candidates in April.

The roadshow started at 10.45 a.m. from the Anjuvilakku Junction. Thousands

of BJP workers lined up on both sides of the road and cheered for the Prime Minister.

There are several interesting facts about this particular launch – Agnibaan SOrTeD – will be India's first launch from a private launchpad, India's first semi-cryogenic engine powered rocket launch and the world's first single

piece 3D printed engine designed and built indigenously.

Founded in 2017 by Srinath Ravichandran, Moin SPM, and Satya Chakravarthy, Agnikul Cosmos became the first company in

the country to sign an agreement with Indian Space Research Organisation (ISRO) under the IN-SPACe initiative to have access to the space agency's expertise and its facilities to build Agnibaan in De-

essor at the Department of Aerospace Engineering at the Indian Institute of Technology, Madras, told The Hindu, "This would be India's first liquid oxygenkerosene rocket flight in India, from India's first privately developed launchpad, in Sriharikota."

"More importantly, we would be flying our patented world's most integrated single piece 3D printed rocket," he added.

He further explained, "This is a sub-orbital launch but it is not a sounding rocket. It has the full stack of closed loop and a safety radius from the launchpad calculated <u>The Hindu Bureau</u> from some tens of thousands of simulations of worst case scenarios."

He pointed out that the next step post the mission would be post-flight analysis of all the subsystem performance. The immediate future plan is to get ready for the orbital flight.

Agnikul's rocket is the second privately-developed rocket in India. In 2022, Vikram-S, India's first privately-developed rocket, lifted off from a launchpad in Sriharikota.

BENGALURU The Karnataka High Court on Tuesday stayed the op-

eration of a circular issued by the Union government banning 23 breeds of 'ferocious and dangerous' dogs. However, the court clarified that the stay of the cir-

cular, issued on March 12 by the Animal Husbandry and Dairying Department of the Centre, would be limited only to Karnataka.

Justice M. Nagaprasanna passed the interim order on a petition filed by Bengaluru residents. The High Court also directed the Centre to produce those documents, based on which the circular for banning the dog breeds was issued, for examining the prior consultation process.

The circular stated that all those who have reared these breeds as pets should sterilise the dogs to stop further breeding.

The Centre's counsel told the court that the circular was issued based on a direction issued by the Delhi HC asking the department to consider the representation of the PIL petitioner for banning certain dog breeds.

Noticing that the Delhi HC's order was "unequivocal in directing that all the stakeholders must be consulted before consideration of representation for banning dog breeds ... ", Justice Nagaprasanna said that there is a need to examine the documents for the decision-making process to ascertain whether the Kennel Club of India was consulted, as consultation with all stakeholders was essential.

BJP leaders protest 'assault' on shopkeeper, detained

A closer look at the electoral bond data indicates several firms in the pharmaceutical sector that purchased the bonds were under the scanner of the Enforcement Directorate or the I-T Department at some point in the past five years; some were also in the cross hairs of U.S. FDA over quality control

n March 15, The Hindu reported that many top purchasers of electoral bonds had also been under the scanner of the Enforcement Directorate or the Income Tax (I-T) Department at some point in the past five years. A closer look at the electoral bond data released indicates more such companies, especially in the pharmaceutical sector.

For example, on July 6, 2022, the I-T Department searched more than 40 offices of the Bengalurubased pharmaceuticals major Micro Labs Ltd., which makes Dolo 650.

Officials also searched the residences of its owners. In the same month, the Indian government said the searches revealed "substantial incriminating evidence" of unethical practices and freebies to medical professionals to

the tune of ₹1,000 crore. The same month, the National Pharmaceutical

Pricing Authority (NPPA) asked the Indian Pharmaceutical Alliance (IPA) to investigate the matter. The NPPA is an independent regulator attached to the Department of Pharmaceuticals in the Ministry of Chemicals and Fertilizers, and is responsible for pricing drugs to keep them affordable. In September, the IPA cleared the company in a report to the NPPA, declaring the "₹1,000crore expenditure on single brand Dolo 650 on freebies in one year" to be "not

correct". A month later, Micro Labs purchased electoral bonds worth ₹6 crore, an additional set worth ₹3 crore on November 15, 2022, and another worth ₹7 crore on October 9, 2023, taking the total tally to ₹16 crore.

In April 2022, Hetero Drugs Ltd. and Hetero

In late 2022, the FDA rapped Lupin for allegedly subpar drug-making conditions at some of its facilities in India. On January 25, 2023, it purchased bonds worth ₹18 crore.

Natco purchased bonds worth ₹25 lakh on October 5, 2019, and in October and November 2023, worth ₹32 crore. On August 5-9, 2019, the FDA inspected a Natco facility near Hyderabad and concluded with six "observations". Natco responded that it would specify corrective actions in two weeks. At another facility in Rangareddy district on October 9-18, 2023, the FDA reportedly found unclean equipment.

In another example, on November 11, 2022, Mankind Pharma Ltd. purchased bonds worth ₹24 crore months ahead of its IPO in May 2023, with a value of ₹4,326 crore. Two days later, the I-T Department raided Mankind's premises over allegations of tax evasion.

Former police officer gets life term in fake encounter case

The Hindu Bureau MUMBAI

The Bombay High Court on Tuesday sentenced to life imprisonment former Mumbai Police Inspector Pradeep Sharma for the fake encounter killing of Lakhan Baiya, alias Ramnarayan Gupta, an alleged aide of convicted gangster Chhota Rajan, in 2006.

The court also upheld the life sentence awarded to 13 more people in the case. Twelve of them are former police personnel -Dilip Palande, Nitin Sartape, Ganesh Harpude, Anand Patade, Prakash Kadam, Devidas Sakpal, Pandurang Kokam, Ratnakar Kamble, Sandeep Sardar, Tanaji Desai, Pradeep Survavanshi and Vinayak Shinde - and one a civilian, Hitesh Solanki.

Gupta was killed on November 11, 2006 at Nana Nani Park in Versova in northwestern Mumbai.

It is alleged that a police team led by Sharma, who was known as an 'encounter specialist', picked up Gupta and his friend Anil Bheda from their home at Vashi in Navi Mumbai. He

vernment's decision. In a statement issued in Washington on Monday, U.S. Senator Ben Cardin said that he was "deeply concerned" by the Indian government's decision to notify the "controversial" CAA and its "potential ramifications" for India's Mus-

lim community. 'Shared values'

"Making matters worse is the fact that it is being pushed during the holy month of Ramadan (Ramzan). As the U.S.-India relationship deepens, it is critically important that our cooperation is based on our shared values of protecting the human rights of all persons, regardless of religion."



The Ministry of External Affairs (MEA) declined to comment on the remarks by the U.S. Senator.

Last week the MEA had responded sharply to the U.S. State department statement on the notification of rules for the CAA. In response to the State department's concerns, MEA spokesperson Randhir Jaiswal had said there were no grounds for concern on the treatment of minorities in India, calling the U.S. spokesperson's comments "misplaced, misinformed and unwarranted", and accusing the U.S. administration of practicing "vote bank politics".

Congress manifesto to focus on 25 guarantees, justice plank

CWC approves manifesto, which is likely to include section on poll bonds; party plans to translate it into every major language; Kharge says BJP will meet its 'India Shining' moment in 2024 too

sserting that the BJP's guarantees for the 2024 Lok Sabha election would be another "India Shining" moment, the Congress Working Committee (CWC) on Tuesday urged its office-bearers to ensure that the party's 25 guarantees and the five pillars of justice or paanch nyay reached every household in India.

After a three-hour discussion, the CWC approved the manifesto that will also include a section on electoral bonds. Former party chief Rahul Gandhi told the closed-door CWC meeting that the electoral bond scheme had "exposed the BJP's corruption and extortion tactics".

Sources said Mr. Gandhi specifically spoke on the issue of electoral bonds and said it showed the BJP's corrupt face and that it needed to be taken to the people. The meeting decided to bring electoral bonds as an issue to be countered in the party's manifesto.

They requested leaders from every State to get involved in the transla-

Congress committee clears Adhir, Kharge's son-in-law for LS poll

Congress leader Adhir Ranian Chowdhury is among the candidates whose names were cleared by the party's Central Election Committee (CEC) on Tuesday.

The CEC also cleared the name of Radhakrishnan D., son-in-law of Congress president Mallikarjun Kharge, as the party's candidate from Gulbarga. Mr.

Kharge had represented the seat in 2009 and 2014, but lost it in 2019. A final decision on a candidate for the Chandi-

garh Lok Sabha seat has been put on hold as there are two former Union Ministers among the three contenders. The CEC is headed by

Mr. Kharge and includes top leaders, including former party chief Sonia Gandhi and Rajya Sabha MP K.C. Venugopal. Though there is no official word on the CEC's deliberations, sources said it cleared candidates for 14 seats from Karnataka, 12 seats from West Bengal, and three from Telangana in its third meeting.

In Karnataka, the candidatures of Rajiv Gowda from North Bengaluru,

Mansoor Ali Khan from Bengaluru Central, and Sowmya Reddy from Bengaluru South have been cleared.

In West Bengal, Mr. Chowdhury will contest from his seat of Baharampur. The MP from Malda South, Abu Hasem Khan Choudhury, will make way for his son Isha Khan Choudhury.

In Telangana, the panel cleared candidates for Chevella, Malkajgiri, and Secunderabad seats.

The CEC also discussed candidates for seats in Arunachal Pradesh, Sikkim, West Bengal, Puducherry, Andaman and Nicobar Islands, Chandigarh, and the remaining seats in Karnataka. Discussions on the remaining seats in Rajasthan, Madhya Pradesh, and Guj arat have been postponed.



Hemant Soren's sister-in-law and MLA Sita Soren joins BJP

In a significant political development, Jharkhand Mukti Morcha (JMM) legislator Sita Soren, sister-in-law of former Chief Minister Hemant Soren, resigned from the party and joined the BJP in Delhi in the presence of the party's national general secretary Vinod Tawde and Jharkhand in-charge Laxmikant Bajpai. Ms. Soren was the JMM MLA from Jama in Dumka district. She is the wife of Durga Soren, the late son of IMM chief Shibu Soren. "I was feeling neglected and isolated in the party. I have also become aware of a conspiracy being hatched against me and my family. I'm left with no choice but to tender my resignation," Ms. Soren alleged. She voiced her disappointment, indicating a deviation from the party's core values by accommodating people whose principles do not align with its ethos.

No voting arrangement for those who fled Manipur

People who fled the ethnic violence in Manipur and took refuge in the neighbourhood, specifically Mizoram, will be able to vote in the Lok Sabha election only if they return to their home State. Manipur's Chief Electoral Officer Pradeep Kumar Jha said no voting arrangement had been made for people who left the State after the ethnic violence broke out last year. Some 12,000 Kuki-Zomi people took shelter in Mizoram, the government in Mizoram had claimed ahead of the Assembly election in November 2023. On March 16, Chief Election Commissioner Rajiv Kumar said the poll panel notified a scheme to allow the displaced voters of Manipur to exercise their franchise from their respective camps. Mr. Jha, however, told journalists that the scheme was limited to Manipur's territorial jurisdiction.

Taranjit Singh Sandhu, former + Ambassador to U.S., joins BJP

Former Indian Ambassador to the United States Taranjit Singh Sandhu joined the BJP on Tuesday. He is likely to contest the Lok Sabha election from Amritsar, where he has been reaching out to people since he retired from the foreign service a few months ago. Mr. Sandhu joined the BJP in the presence of the party's national general secretaries Vinod Tawde and Tarun Chugh. Mr. Sandhu's grandfather, Sardar Teja Singh Samundri, was a freedom fighter, and one of the founders of the Shiromani Gurudwara Prabhandhak Committee. His father, Bishan Singh Samundri, was the founder Vice-Chancellor of the Guru Nanak Dev University. The BJP is hoping that Mr. Sandhu's lineage, experience as a diplomat, and local connections in Amritsar will help the party win the seat, where it has had a run of bad luck.

Sharad's NCP faction gets trumpet symbol

The Supreme Court on Tuesday allowed the Sharad Pawar faction to contest Lok Sabha and State Legislative Assembly polls under the 'trumpet' party symbol and the name 'Nationalist Congress Party-Sharadchandra Pawar'.

A Bench headed by Jusce Surva Kant further asked the Election Commission not to allot the 'trumpet' symbol to any other party or Independent candidate. The court permitted the breakaway Nationalist Congress Party (NCP) led by Maharashtra Deputy Chief Minister Aiit Pawar to continue using the clock

symbol, the original symbol of the undivided NCP, for the present.

However, the group has been directed to issue a public notice in newspapers in English, Marathi and Hindi editions declaring that the issue regarding the 'clock' symbol was sub judice in the Supreme Court, and his group was allowed to use the symbol "subject



to the final outcome of the proceedings" in court.

The Bench passed the order on a plea by the Sharad Pawar group seeking to restrain the Ajit Pawar faction from using the 'clock' symbol for the polls, as allotted by the Election Commission, on the grounds that it was disrupting the level playing field.

Civil society organisation wants to make farmers' woes an electoral agenda

Paras resigns from Union Cabinet, slams BJP for 'injustice'

Union Minister Pashupati Kumar Paras resigned on Tuesday and accused the BJP of doing "injustice" to his Rashtriya Lok Janshakti Party by not including it in the seat-sharing arrangement in Bihar for the Lok Sabha election. The announcement

came at a press conference a day after the BJP-led National Democratic Alliance (NDA) announced its seatsharing pact, giving five seats, including Hajipur, to the Chirag Paswan-led Lok Janshakti Party (Ram Vilas). Mr. Paswan is the nephew of Mr. Paras.

"I was waiting for the announcement of seat sharing among the NDA allies which was announced on March 18. I've been grateful to the Prime Minister but my party and I faced injustice. As such, I am resigning as Minister from the Union Cabinet," Mr. Paras told mediapersons in Delhi. Asked about



his plans, Mr. Paras, who is the Hajipur MP, added, "I will decide this after discussions with party leaders and workers."

However, the buzz in the political circles is that Mr. Paras may be joining the Rashtriya Janata Dal (RID), which is part of the **Opposition Indian National** Developmental, Inclusive Alliance, and contest from Hajipur against his nephew. Mr. Paswan, the MP from Jamui (reserved) seat, had expressed his desire to contest from the Hajipur seat "to retain the political legacy" of his father the late Ram Vilas Paswan.

Remarks on 'Shakti' proof of Congress's anti-women, anti-Hindu stand, says Modi

For the second successive day, the BJP and Prime Minister Narendra Modi attacked the Congress party and Wayanad MP Rahul Gandhi over his remarks on Shakti, making the issue an important theme in the party's campaign for the Lok Sabha election.

In Salem, the Prime Minister alleged at a public rally that the Congress and its allies, including Tamil Nadu's ruling Dravida Munnetra Kazhagam (DMK), were out to "destroy Shakti" but asserted that "they will get destroyed" instead.

Mr. Modi was referring to Mr. Gandhi's remarks, made at the conclusion of the Bharat Jodo Nyay Yatra in Mumbai on Sunday, when he had raised concerns about electronic voting machines and Central investigative agencies, in the context of the Opposition's struggle against the

might of the State, noting that "there is a word 'shakti' (might) in Hinduism ... "

Constituents of the IN-DIA bloc "would never speak ill about any other faith but would not lose a second in abusing the Hindu religion," Mr. Modi said. "The election campaign has started, but the INDI alliance's plan came out in their first rally in Mumbai. Their manifesto, ill intentions have come out. At Shivaji Park in Mumbai, the INDI alliance openly declared they will destroy 'Shakti' which is faith.

What does 'Shakti' mean in Hinduism - everybody in Tamil Nadu knows that," he said, even as 11 women dressed as "goddesses" joined him on stage.

BJP spokesperson Ravi Shankar Prasad held a press conference on the same issue in Delhi. "The Congress under Rahul Gandhi's leadership is no longer the Congress of the doctrine and ideals of Mahatma Gandhi. This is a Congress party led by a divisive mind, Maoist, and anti-Hindu thoughts," he said.

Lokpal asks CBI to probe cash for query case against Mahua

Lokpal, the anti-corruption body, on Tuesday directed the CBI to probe the cash-for-query allegations against Trinamool Congress leader Mahua Moitra who was expelled from Lok Sabha last year. CBI has been asked to submit findings before Lokpal within six months. The CBI, however, submitted that the allegation that Ms. Moitra received ₹2.75 crore cash in two tranches from businessman Darshan Hiranandani in 2019 and 2021 "is not substantiated as sufficient evidence could not be collected due to the limited scope of the inquiry," the order said. The CBI added that a probe is required to unearth the truth of this allegation of a serious nature.

2023 was the 'hottest year' on record, confirms WMO

In line with observations by climate agencies, the World Meteorological Organisation has officially confirmed 2023 to be the hottest year on record. "The State of Global Climate Report", published on Tuesday, stated that the global average near-surface temperature was 1.45 degrees Celsius (with a margin of uncertainty of ± 0.12 degrees Celsius) above the pre-industrial baseline. It was the warmest 10-year period on record. The previous, joint warmest years were 2016 at 1.29 ± 0.12 degrees Celsius above the 1850-1900 average and 2020 at 1.27 ± 0.13 degree Celsius.

SC directs States to give ration cards to 8 cr. workers

The Supreme Court on Tuesday took exception to the delays in the implementation of its April 2023 order to provide ration cards to about eight crore migrant workers registered in the eShram portal but not covered under the National Food Security Act. The portal has 28.6 crore registrants. Of this, 20.63 crore are registered on ration card data.

A Bench led by Justice Hima Kohli directed ration cards to be given to the remaining eight crore migrant and unorganised sector workers registered with the eShram portal in two months. The court was acting on the arguments raised by advocates Prashant Bhushan and Cheryl D'Souza for activists Anjali Bhardwaj, Harsh Mander and Jagdeep Chhokar. Mr. Bhushan had argued that there could be more than 10 crore workers left outside the protective umbrella of the Food Safety Act as the statistics were based on the 2011 census. The court had said last year that it was the duty of a welfare state to include migrant worker on the ration card roll expeditiously.

Railways earned ₹1,230 crore from cancelled waiting list tickets in span of three years

Reply to RTI query shows that the number of such cancellations rose from 2.53 crore in 2021 to 5.26 crore in 2023; former official calls for recalibration of waitlisted slots that are on offer

he Indian Railways clocked earnings of ₹1,229.85 crore from cancelled waiting list tickets between 2021 and 2024 (till January), a reponse to a query under the Right to Information Act has revealed.

The Railway Ministry response to the RTI application filed by Madhya Pradesh-based activist Vivek Pandey also showed that earnings from this source have increased year on year.

For instance in 2021, a total of 2.53 crore tickets on the waiting list were cancelled and the Railways earned ₹242.68 crore. This number rose to 4.6 crore tickets being cancelled in 2022 and the earnings soaring to ₹439.16 crore. In 2023, 5.26 crore tickets that were waitlisted were cancelled and the Railways cashed in ₹505 crore as a result. In 2024, in the month of January alone, 45.86 lakh tickets were

cancelled, leading to earnings of ₹43 crore for the Railways.

"It is very clear that with limited capacity, the Railways is unable to cater to demand. They should gauge the demand pattern and avoid offering too many waiting list tickets," a former Railway official told

The Hindu. "For instance, an 18coach train has 720 seats in the sleeper compartment, and the Railways allots a waiting list of 600. There will be no scope for accommodating such a large number, and tickets are bound to get cancelled so they should recalibrate their waiting list thresholds," the former official pointed out.





Changing cancer nomenclature can improve treatment outcomes: doctors

Precision oncology allows doctors to find the genetic mutations responsible for a tumour in many cases and target them with drugs. We also know not all cancers from the same organ share the same mutations. Taking these advances together, doctors have articulated a need to reclassify cancers by their genetic features

he way we classify metastatic cancers may need to be revamped, scientists have said, proposing in its place a classification system that places the molecular characteristics of the cancer over the tissue of origin.

Traditional approaches to treating cancer – including surgery and radiation – target the organs in which the tumour is present. This practice formed the basis of classifying cancers after the organ in which they originate. But most deaths due to cancer are the result of the disease metastasising beyond the organ of origin; individuals with metastatic cancer are almost always treated systemically with drugs that enter the blood.

What motivates the need for change?

With technological improvements, doctors are also able to find which genetic mutations are responsible for a tumour in many cases, and target them with drugs. All cancers from the same organ don't always share the same mutations, and these mutations aren't limited to cancers of a single organ.

This development in precision oncology requires cancers to be classified based on their molecular and genetic characteristics rather than the organ in which they originate, a team of researchers from France has written in a paper. This way, according to them, cancer patients can also access life-saving drugs sooner.

Fabrice André, a medical oncologist at Gustave Roussy in France and lead author of the commentary, told this author that oncologists spend a lot of time testing new drugs in clinical trials in a sequential manner, leading to "delay in treatment access".

Has sequential testing caused delays?

There is evidence to support this view. A 2012 clinical trial in the U.S. investigating the drug nivolumab included people with different types of cancers, including melanoma and kidney cancer. Nivolumab targets the receptor of a protein found in some tumours. It ameliorated symptoms in individuals with tumours with that particular protein.

The next logical step would have been to test nivolumab with people with tumours that expressed the protein irrespective of where the cancer originated. But since cancers are classified based on their organ of origin – breast, kidney, lung, etc. – researchers had to conduct trials one after the other for each type of cancer.

with tumours expressing that particular protein couldn't access nivolumab because the drug hadn't been trialled for their specific type of cancer.

Most drugs tested in clinical trials in the past decade have a similar story.

How else can the new scheme help?

Naming cancers according to their biology rather than their anatomy "will reduce the time needed to run clinical trials," said Dr. André, "because you only need a few randomised trials, instead of testing the drug in each disease defined by the organ of origin."

Consultant medical oncologist and haemato-oncologist at Mumbai Oncocare Centre Kunal Jobanputra agreed.

A trial for a drug targeting a particular genetic mutation will cover all cancer types with those mutations. "A positive effect could be that it will take less time for the trials to happen," he said. The revamped classification system could also help patients understand the rationale behind their treatment, according to Dr. André. This can confuse patients, he said. "Naming cancers with biological mechanisms would decrease such heterogeneity, and will also help the patient to better understand the rationale for his/her therapy."

Physicians often educate their patients about the molecular characteristics of their cancers, Dr. Jobanputra said. "When the connotation changes, the prognosis changes, the cost of treatment changes. "We are moving towards a more

personalised [treatment] approach," he added.

What will it take to reclassify drugs?

Some change has also been evident over the last few years in regulatory agencies' approval for certain drugs.

In 2017, for example, the U.S. Food and Drug Administration (FDA) approved the use of the drug pembrolizumab to treat people carrying a certain mutation regardless of the organ in which the cancer originated.

Following this, the FDA has also approved some other drugs to be used based on their biological targets.

For the various cancers to be reclassified in this way, regulatory agencies, scientific groups, and insurance companies will also need to clarify *when* a drug should be approved based on its molecular target.

The FDA is working on a guideline to

of cancers instead of memorising the characteristics of primary tumours.

Are there hurdles to implementing?

Finally, this proposed change for classifying cancers can't happen unless patients can access tests that reveal molecular alterations in their tumour.

This is particularly relevant in the Indian context, where we must take the proposed change with a pinch of salt, Dr. Jobanputra said, since most patients can't afford genetic testing. These tests currently cost ₹ 7,000-40,000 in Indian labs and up to ₹ 3 lakh abroad. The availability and accessibility of genetic tests should be wider. "Only then can we jump to this diagnostic nomenclature."

The proposed classification system is also not without faults, Dr. Jobanputra added. Unless trials conducted based on molecular signatures have a significant number of patients with each type of cancer, they could generalise the results for all cancers.We can't entirely do away with organ-level information either because disease location is an important factor in the outcome regardless of the genetic mutations, he continued. For example, lung and brain cancers with the same mutations will still behave differently.But "if done properly," the new nomenclature "can improve accessibility of drugs," he said, even if this change will come only gradually.

A particularly important requirement is for institutions to establish teams that will focus on analysing patients' molecular profiles irrespective of the cancer type, the researchers wrote in their paper. Medical students must be trained to understand the molecular basis come only gradually.

Dr. André agreed. "It will probably take some decades. There is some important research to be done in terms of trial methodology before moving into that direction."

QUESTION CORNER

How cooling a car is a drag on mileage



air-conditioner (AC) works by moving heat from an 'inside' space to 'outside'. It achieves this using a refrigerant, a substance that absorbs heat when exposed to the 'inside' and releases it when exposed to the 'outside'. The refrigerant needs to be pressurised before it can absorb heat, which is achieved using a compressor.

In a traditional (non-electric) car, the energy to run the compressor comes from the engine. That is, the AC is another load on the engine aside from running the car itself. As a result, the engine consumes more fuel, but not all the fuel contributes to moving the car: some goes to running the AC. And as a result, the number of kilometres to which a single litre of petrol contributes – a.k.a. the mileage – drops.

The effect of an operating AC on the mileage also varies by the driving conditions. For example, driving within a city forces the engine to stop and start multiple times during a trip whereas on a highway the engine operates more continuously. In this scenario an AC's effect on the engine, and the

mileage, will be more pronounced in the former and less so in the latter. Drivers can also reduce the load on the engine by parking cars in shaded spots and pre-cooling the passenger area through other means before turning the AC on. -The Hindu S&T Desk

Selection and election

The Election Commission needs a selection panel free of executive bias

he quick, if not hasty, filling up of two vacancies in the Election Commission of India (ECI) has attracted justified criticism. The multi-member body got two new members within days of the resignation of Arun Goel, an Election Commissioner (EC) whose appointment itself came in the midst of a Constitution Bench hearing for a truly independent process of selecting members of the panel that conducts and supervises India's elections. Critics are not wrong when they point out that the Act setting out the process of selecting the Chief Election Commissioner and other ECs appeared to fall short of the sort of independence the Constitution Bench verdict of March 2023 envisaged. The selection took place at a time when a petition challenging the validity of the Act was about to be taken up for hearing. To add to the unfortunate set of circumstances, Mr. Goel's resignation for "personal reasons" has gone unexplained. It is a matter of grave concern that an EC whose term was set to go on for a few more years should choose to resign just days before the Commission finalised the Lok Sabha election schedule. It goes without saying that the discussion on the process selecting the ECs has no bearing on the competence or suitability of Gyanesh Kumar and Sukhbir Singh Sandhu, the two new ECs.

The real problem may lie with the law that Parliament chose to enact last year in response to the Supreme Court of India questioning the absence of any legislation since the inception of the Constitution, as required under Article 324, laying down an appointment process for the ECs. The Court's emphasis was on the ECI's independence from the executive so that the elections the panel conducts are truly free and fair. Towards that end, it sought to fill the vacuum by an interim arrangement under which the Prime Minister, the Leader of the Opposition and the Chief Justice of India (CJI) formed the selection committee to choose the CEC and ECs. However, it was meant to be in place only until Parliament enacted a law. In response, the government enacted a law that constituted a panel comprising the Prime Minister and any Union Minister, besides the Leader of the Opposition, or the leader of the largest single party in the Opposition. The question now before the Court is whether a committee in which the executive has a two-one majority can be a truly independent authority. The argument that Prime Ministers have always been selecting the CEC and ECs seems attractive, but, ultimately, an executive-driven process has to yield to one more rooted in the constitutional principle of having an independent body to hold free and fair elections, even if the CJI, as an institutional head, might not be the person most suited to be a part of the selection process.

Length and breadth

The curious case of Sosamma Iype and the Vechur cow

his is the unusual story of a quiet, unassuming woman who won the Padma Shri in 2022 for one of the more remarkable reasons imaginable: she saved and resurrected a breed of indigenous cattle, the Vechur cow. Dr. Sosamma Iype's story is located at the heart of India's tussle to industrialise rapidly while seeking to preserve its sublime biodiversity, at a time when the former was fashionable and the latter was not.

Agrarian transformations, erasure of breeds

Steeped in abject poverty and food scarcity at the time of Independence, India had to lay the foundations of a vigorous industry, which would catapult us into the future, and simultaneously ensure that the most basic necessities of our citizens were met. Exacerbating our woes was the fact that the major bulk of our populace subsisted solely on agriculture and animal husbandry, thus making their modernisation vital. Establishing a host of agricultural universities soon after Independence, we embarked on the quest to modernise our farming and livestock rearing practices, hoping to retrieve them from the depths of antiquity. And though our agricultural output soared with the advent of the Green Revolution and dairy production spiked with the onset of the White Revolution, these miraculous transformations also came at a pernicious cost. They reduced indigenous breeds such as the Vechur cow to the brink of extinction.

Acknowledged as one of the world's smallest cattle breeds, the Vechur cow had little value in the India of the White Revolution. In its pursuit to boost milk production through the crossbreeding of indigenous cattle with high-yielding foreign breeds, the White Revolution's corollary was the erasure of smaller breeds such as the Vechur cow. Cross-breeding served to dilute the genetic purity of native breeds and diminish their population, and the Vechur cow, prized for its adaptability to local environmental conditions, found itself imperilled in the face of a sweeping shift towards larger, more commercially viable cattle. As the White Revolution gained momentum, traditional farming practices that relied on smaller-sized cattle breeds fell into disfavour. The Vechur cow, with its unique characteristics, became a casualty of changing agricultural dynamics and dwindling demand. Indeed, it would have disappeared

altogether, had it not been for the selfless efforts of one unassuming Indian: Professor Sosamma Iype.

"I don't remember drinking my mother's milk," writes Prof. Iype, "but I remember clearly the taste of the Vechur milk that my mother gave us to drink." Having grown up in an idyllic era when Vechur cows abounded, with a mother and calf in the compound of her own ancestral home in rural Kerala, it must have been disheartening for Prof. Iype to realise, while teaching at a veterinary college in 1989, that the Vechur breed had all but disappeared. Neither in animal husbandry reports nor in official surveys could this cow be traced, leading many a Keralite environmentalist, including Prof. Iype, to conclude dejectedly that it had become extinct. Conveying as much to her students, she resigned herself to the loss of an animal she deeply loved.

A student's search

But that is where the story takes a turn. Reluctant to accept the depressing reality of the Vechur's loss, Anil Zachariah - one of Prof. Iype's students who is today a renowned veterinarian - set out in search of an animal that, to him, had assumed mythical proportions. After much wandering and asking, he stumbled upon a Vechur cow in Vaikom, Kerala. Exhilarated beyond measure, and unable to keep the news from his mentor, he scaled the wall of Prof. Iype's house at midnight and leapt into her compound, thrilled to be breaking the marvellous news.

No sooner was that first Vechur cow discovered than Prof. Iype poured herself wholeheartedly into a mission to resurrect and nurture not only the Vechur but several of Kerala's other endangered indigenous breeds, such as the Kasargod, Vilwadri and Cheruvally cattle and the Attappady goat. Her Vechur Conservation Unit, founded at the Kerala Agricultural University with only eight cows, rose from strength to strength, boasting of more than 24 cows at the end of the first year itself – a tremendous testament to Prof. lype's ardour. Yet, the road ahead was ridden with landmines. As with all idealists in India, she and her team had to contend with various obstacles, even as they blazed a trail. Simultaneously contending with government officials averse to her outlook; envious colleagues who sought to foil her efforts,

going so far as to cast bizarre aspersions on her; well-known environmentalists falsely claiming she had facilitated the "patenting" of an Indian animal abroad; and a brutish media accusing her of treachery and "gene theft," Prof. Iype negotiated a perilous terrain. But not once did she flounder or cower. She persevered, she soldiered: a gentle colossus, Kerala's "Vechur Amma".

The project that became a template

The allure of this pioneering movement was destined to transcend the bounds of Kerala; and it soon gained widespread traction, finding partners in national governmental institutions. Visiting the veterinary college and seeing the glory of the Vechur Conservation Project, R.M. Acharya, of the Indian Council of Agricultural Research (ICAR), incredulously asked Prof. Iype how she had conceived of such a project - and led it to fruition – when even the ICAR had not contemplated it. In the event, the ICAR adopted the Vechur Conservation Project, using it as a template for the whole of India.

For Prof. Iype, it has never simply been about performing a scientific miracle and making history with the astounding success of her mission. Instead, she believes firmly in giving back to society, especially to the destitute farmers and cattle rearers in whose homes the Vechur once occupied pride of place. It was in this spirit that, in 1998, she established the Vechur Conservation Trust, whose purpose was to evolve a culture of community participation and enable innumerable impoverished farmers to rear the Vechur by providing them its germ-plasm. This has empowered them and their families to attain a greater degree of self-reliance.

Prof. Iype does not project herself as a messiah. But she is one – a visionary for whom translating an ideal into reality was always more important than any exercise in self-aggrandisement. Not only has she saved the Vechur cow, but she has also left an indelible impression upon our cultural and agricultural landscape, for which we shall forever remain indebted to her. No one will make a movie about her, but she is an authentic Indian heroine.

Rahul Gandhi's yatras have energised the Congress, but unsettled some allies

he second edition of Congress leader Rahul Gandhi's Bharat Jodo Yatra, the Bharat Jodo Nyay Yatra, concluded in Mumbai on March 17 with a rally that also saw the participation of some of the party's allies. Through the two editions of this yatra, Mr. Gandhi traversed a distance over 10,000 kilometres across the length and breadth of the country, meeting multitudes of people from across society. In the process he has also travelled some distance in his own evolution as a leader, to emerge as the most strident face of anti-Bharatiya Janata Party (BIP) politics in India. If there was novelty and euphoria around the first edition, that was from Kanniyakumari to Srinagar, the second one, from Manipur to Mumbai, was more clinical and functional. With Mr. Gandhi tramping through the picturesque countryside, the first yatra delivered a nebulous message of love and harmony framed around the slogan, Nafrat Ke Bazaar Mein Mohabbat Ki Dukaan (outlet of love in a market of hate). To insulate Mr. Gandhi from expectations of immediate politics, the Congress insisted that the yatra was not an electoral exercise, but an ideological campaign. The yatra gained the Congress some electoral advantage in Karnataka and Telangana which it went on to win in the Assembly elections that followed, but the party lost in the elections in Chhattisgarh, Madhya Pradesh and Rajasthan.

In the second edition, the yatra's theme was built around social justice, a euphemism for a wider representation of caste groups in power. Both the yatras have achieved the goal of energising the party cadres, who found themselves suitably employed and connected to the party leadership in the run-up to the general election. The paradox for the Congress leaders is that the more success they meet, the stronger will be the pushback from their own allies. A wobbly, weak and flexible Congress at the centre of the anti-BJP alliance is a stronger glue to keep the alliance together. In States where the Congress is subservient to the regional forces, from Tamil Nadu to Bihar, the alliance is in better shape. But in West Bengal, where the State party chief, Adhir Ranjan Chowdhury, refused to bow down to the Trinamool Congress, the alliance fell through. The planning and management of the two editions of the Bharat Jodo Yatra also turned out to be a notable renewal of the party's organisational capacity. But, equally, the 2024 general election will put to the test Mr. Gandhi's brand of politics centred around left-leaning welfarism and inchoate secularism.

Guaranteed MSP is an ethical imperative

s the general elections draw closer, agrarian concerns have once again taken centre stage. Farmers from the heartland of the Green Revolution have travelled to the border of the capital to not only voice their distress, but also to shape the electoral discourse. The ruling dispensation, sensing adverse electoral implications, attempted to reach out to the farmers. It said it was ready to procure pulses, maize, and cotton at MSP, but this was contingent upon farmers guaranteeing crop diversification. However, these efforts were rejected as the core issues were not addressed, say farm leaders.

The perennial issue of fair pricing of farm produce reigns supreme, now coupled with calls for legal assurances of Minimum Support Price (MSP). However, beyond mere legal mandates lies the pressing concern of maintaining self-sufficiency in food production and addressing the ongoing challenge of distribution. This underscores the ethical imperative of anchoring a legal guarantee for MSP.

The MSP regime was a vital instrument for ensuring food security in India. Given the unique nature of agriculture, farmers lack the ability to exert significant influence, let alone determine the price of their produce. This constitutes a 'market failure.' Thus, MSP ensures that agricultural commodity prices remain above a predetermined benchmark to facilitate remunerative price discovery.

Produce and perish trap The MSP is announced annually for 23 crops covering both the kharif and rabi seasons, well in advance of sowing, with 21 of them being food crops. However, despite the announcements, the implementation of MSP remains poor. Only 6% of farmers, primarily those cultivating paddy and wheat in States such as Punjab, benefit from MSP. Most transactions involving these

As a result, farmers are trapped in a dangerous cycle of produce and perish, leading to crippling debt and deaths by suicide. All these emphasise the pressing need to ensure MSP, including the one recommended by the eminent agricultural scientist M.S. Swaminathan (with a 50% profit margin).

Several articles under the Constitution, as well as the United Nations Declaration on the Rights of Peasants, support the legal recourse to guaranteeing MSP. According to a recent opinion survey by an English TV channel, 83% of landowners and 77% of farm labourers expressed solidarity with the agitating farmers. Notably, 64% of the public also endorsed the farmers' demand for a legal right to MSP.

Sugarcane growers already benefit from a 'statutory' MSP, which sugar factories strictly adhere to when purchasing cane from farmers. A few years ago, Maharashtra attempted to amend its Agricultural Produce Market Committee (APMC) Act to prevent the purchase of agricultural produce below MSP, but the effort failed due to a lack of political will and a comprehensive strategy. The Karnataka Agricultural Price Commission has laid out a clear roadmap, including potential financial commitments, to ensure a legally binding MSP for crops cultivated in the State. A private member bill on The Farmers' Right to Guaranteed Remunerative MSP for Agricultural Commodities was tabled in Parliament in 2018. The Andhra Pradesh government unveiled a draft bill last year aimed at guaranteeing MSP for crops grown in the State. These efforts show that the objective of establishing a legal recourse to MSP has not emerged suddenly, nor is it impossible to attain.

The solutionA minor amendment to respective

State APMC Acts or the Centre's Essential Commodities Act would suffice to introduce a law ensuring that no transactions of farmers' produce occur at prices below the MSP. The budget outlay will not be as large as projected if legal recourse to MSP is accompanied by essential backward and forward linkages. Crop planning, market intelligence (including price forecasts), and other pre-sowing measures, along with the establishment of post-harvest infrastructure for efficient storage, transportation, and processing of farm commodities, greatly assist in managing the post-harvest glut in the market. Therefore, a legal route to MSP, complemented by the development of such linkages, would provide protection against "market failures" in addressing the surplus, rather than leading to "market distortion," as claimed by some mainstream economists.

Even enhancing MSP to provide a 50% profit margin over total cost is not challenging, considering that current margins already stand at around 22%. Finally, effective procurement and distribution, as envisaged under the National Food Security Act, 2013, is the most appropriate means to not only ensure MSP but also address hunger and malnutrition.

The PM-AASHA comprises schemes for price support and price deficiency payment, along with incentives to private traders to ensure MSP. While it possessed all the necessary elements as precursors to guarantee the MSP, its side-lining in policy circles highlights how political expediency rules the roost.

At present, farmers hardly get 30% of the price paid by the consumers; this will increase if MSP is guaranteed. Establishing a legally binding MSP will anger intermediaries as their share will get reduced. Often, government intervention, and particularly a legally binding MSP, is deemed a problem. It is this adherence to free market dogma that is preventing a just solution to the ongoing crisis in farmer incomes.

he Communist Party of India (Marxist) and the Congress are fighting for Christian and Muslim votes in Kerala. The two communities, which constitute 26.56% and 18.38% of Kerala's electorate, respectively, could play a critical role in determining the outcome of the Lok Sabha elections in the State.

Christians and Muslims have rarely behaved as a homogenous voting bloc in Kerala. However, the concerns of the leaders of these communities about the continuing dominance of the Bharatiya Janata Party (BJP) in the country may galvanise these groups to vote in a more focused and uniform pattern compared to the Lok Sabha polls of 2019.

The Samastha Kerala Jemiyyathul Ulama, an influential Sunni organisation, and the Latin Catholic Church have expressed their worry about the divisive politics playing out in the country.

Taking a potshot at the Congress, the Samastha published an editorial in Suprabhaatham, the organisation's mouthpiece, expressing "deep fear" at the "overnight" shift of those who had earlier endorsed the secular and democratic legacy of Jawaharlal Nehru, to the Sangh Parivar. The defections of Anil K. Antony, son of former Congress Chief Minister A.K. Antony, and Padmaja Ky. Venugopal, daughter of former Congress Chief Minister K. Karunakaran, to the BJP triggered the opinion piece. The editorial particularly expressed anguish at the fact that they had chosen the BJP over secular parties including the CPI(M).

of the International Seaport at Vizhinjam in 2022. The cases were sore points between the LDF government and the minority communities.

The Congress is yet to announce a counter to the CPI (M)'s minority outreach. Nevertheless, it remains confident that its closest coalition ally, the Indian Union Muslim League, will attract Muslim votes for the United Democratic Front (UDF). Moreover, the Congress believes that Latin Catholics, who constitute 13% of Christians in Kerala, will continue to support it, despite the CPI(M)'s and BJP's repeated efforts to reach out to the community.

Simultaneously, the Congress has attempted to dent the CPI(M)'s staunch anti-BJP image by alleging that both the parties are in cahoots in Kerala. The Leader of the Opposition, V.D. Satheesan, accused a top Left Democratic Front (LDF) leader, E.P. Jayarajan, and Union Minister Rajeev Chandrasekhar, of being stakeholders in an Ayurveda resort in Kannur. Mr. Satheesan alleged that the Enforcement Directorate and the Income Tax Department had dropped their investigations into the supposedly dubious sources of funding for the Ayurveda resort after Mr. Chandrasekhar acquired stakes in the institution. In return, the State government too dropped important cases against BJP leaders, he claimed.

In Kerala, given the social, educational, regional, political and economic differences among them, minorities have never voted in a homogeneous manner. However, the BJP's reported ascendancy in the State might alter this voting behaviour. Whether the Congress or the CPI(M) will benefit more from this remains to be seen.

Wilson Govt. wins crucial vote

London, March 19: A dazzling parliamentary performance by the Employment Secretary, Mr. Michael Foot, and a climb down by the Tory leaders over the challenge to the Wilson Government on pay policy enabled the Labour Party to win a crucial vote in the House of Commons last night. The Tory leaders decided not to press their critical amendment to the Queen's speech only two hours before the crucial vote was due to take place.

Mr. Foot a brilliant parliamentarian and a captivating orator came out with what amounted to a guarantee that stautory control of pay would be retained for the time being. The Tory MPs were awed by Mr. Foot's devastating speech which, as one observer put it, was like "a gorgeous though perilous firework display." Both Tory and Liberal leaders came out of it badly bruised and there was no denying that many Tories felt the entire episode was badly handled by Mr. Edward Heath.

Though cold political logic prompted Labour leaders to delight at the spectacle of Tory ranks being in disarray and Liberals thoroughly confused in terms of hard economic reality the Wilson Government is still walking on a tight political rope. Mr. Foot may be a gifted man but it does not mean that he will be able to contain the challenge from the trade unions. It remains to be seen for how long Britain can remain quiet, devoid of industrial strife.

Labour's confidence to survive and perhaps govern has been boosted a little and hence Mr. Wilson will mark his own time to call a general election for a respectable majority.

The SBI has submitted the data on purchases and encashments of electoral bonds. The details disclosed so far includes the date and amount of each transaction alongside the names of each purchaser and encasher. However, in the absence of the unique alphanumeric numbers, it is impossible to establish who has paid whom and when

he first tranche of data on electoral bonds disclosed by the Election Commission of India on March 14, 2024, under the directions of the Supreme Court, provides an incomplete picture of the transactions that have taken place between various companies and individuals on the one hand and registered political parties on the other, between April 12, 2019 and January 24, 2024. The apex court has now directed the State Bank of India (SBI) to ensure "complete disclosure of all details in its possession" by March 21, 2024 including "the alphanumeric number and serial number of the Electoral Bonds which were purchased and redeemed".

Unique alphanumeric numbers

The SBI has recorded every detail of 18,871 purchases and 20,421 encashments of electoral bonds between April 2019 and January 2024. However, in the absence of the unique alphanumeric numbers, only the total amount of electoral bonds purchased by each company or individual can be estimated as also the total amount of electoral bonds each political party has encashed: but it is impossible to establish

who has paid whom and when.

The disclosure of the unique alphanumeric numbers becomes imperative because the apex court has struck down the entire electoral bond scheme as unconstitutional. It is only natural that the very large sum of ₹12,155.1 crore worth of electoral bonds, purchased by corporate groups, companies and individuals between April 2019 and January 2024 are matched accurately with ₹12,769.08 crore total worth of electoral bonds encashed by political parties during the same period. In other words, the people need to know which political party got how much from whom, and on which date(s). No further inquiry or investigation can be conducted into these "unconstitutional" transactions, without linking the purchasers of the electoral bonds with the encashers.

Information asymmetry

The Union Home Minister has countered the embarrassment caused to the government by the disclosure of the BJP accounting for ₹6,060 crore, that is over 47% of the total amount of electoral bonds encashed, by pointing at the amounts encashed by other Opposition parties (Table 1).

The problem is that the total amounts encashed in electoral bonds by the various parties neither reveal much, nor can they be cited as actionable evidence of corruption and malfeasance. It is only through an analysis of the granular details of the electoral bonds, like their amounts, dates of purchase and encashment and the linked identities of the purchaser and encasher of each bond that possibilities of quid pro quo can be hypothesised, investigated and legally established as evidence. This explains the reluctance of the SBI to reveal the unique identification numbers of the electoral bonds. The political strategy of the ruling party appears to be simple: stall any investigation or legal proceeding against any transaction till the end of the election campaign.

The Union Government, as the owner of the SBI, is already in possession of the entire electoral bond database, which implies that BJP – as the ruling party – has access to complete information in this regard. Both the Opposition parties and the electorate, however, do not. Each

political party other than the ruling party, knows about its own transactions only. The voters have no information beyond what has been disclosed by the Election Commission of India. This information asymmetry provides the BJP with an undeserved advantage by virtue of its being the ruling incumbent.

This is similar to the non-disclosure of the politically sensitive data on the caste census, which was collected during Census 2011 but has not been released till date. The BJP has utilised the caste census data to its electoral advantage in every election held since May 2014, while the Opposition and citizens have been denied access.

Such abuse of power, through suppression of information and data that are public goods, should be prevented.

Preliminary analysis

The data disclosed so far provides ample grounds for suspecting malfeasance. Table 2 provides a list of companies and corporate groups who have purchased electoral bonds worth over ₹100 crore in total between April 2019 and January 2024, along with a list of individual purchasers of the bonds totalling above ${\bf \bar{x}5}$ crore. What stands out from the list are the following:

(a) Some of the largest purchasers of electoral bonds are under investigation by central agencies such as the Enforcement Directorate (ED), Central Bureau of Investigation (CBI) and/or the Income Tax (IT) Department. Table 3 provides a list of 19 such companies which have together purchased ₹4,787.3 crore in bonds; over 39% percent of the total amount.

(b) The names common in Tables 2 and 3 are Future Gaming, Megha Engineering, M K Jalan group, Vedanta Group, Haldia Energy Limited (Sanjiv Goenka Group) etc. If the bulk of the electoral bonds purchased by these companies, which are under investigation by central agencies like ED, CBI or IT department, are found to have been redeemed by the party in power, that is, the BJP, it would imply serious conflict of interest issues and probable quid pro quo.

(c) The largest individual purchasers of

electoral bonds are either heads of corporate groups and companies or their employees. It is clear that corporate houses and companies have tried to conceal their identities by deploying individual frontmen or making large donations in multiple small tranches. This generates suspicion of large scale bribery, money laundering and other forms of quid pro quo, like award of lucrative project contracts and policy changes in

exchange for party donations.

As the party in power at the Centre and the largest redeemer of electoral bonds, the BJP has much to answer for. The Modi government has tried to evade such accountability during the Lok Sabha election campaign, first by delaying the disclosure of data and then by withholding the unique alphanumeric numbers of the electoral bonds. ill December 15, 2019, even old residents of Delhi did not have much of an idea about Shaheen Bagh. Many had never heard of it; others just about knew its location. It all changed one cold December evening as news came of alleged police atrocities on Jamia Millia Islamia students protesting against the Citizenship Amendment Act (CAA) in the vicinity. The women of Shaheen Bagh, living around a kilometre from Jamia, were galvanised into action. The CAA had to be opposed, peacefully, persistently. But here they were, holding the Constitution of India in one hand, and copies of the Quran in the other to assert their status as equal citizens of the land.

After these two books on Shaheen Bagh in the summer of 2020, came three others, between 2021 and 2022. There was a visual chronicle in the form of Aasif Mujtaba and Mohammed Meharban's Hum Dekhenge, Protest and Pogrom: A Photo Document. The book, which had a foreword by noted legal eagle Prashant Bhushan, came with limited but engaging text, and photographs which documented the movement with many heroes as well as some intrepid victims. It had a photograph of some 40,000 women celebrating Republic Day with not an inch of space left at Shaheen Bagh. It also had the picture of the nephew of Mudasir Khan crying before the body of his uncle who succumbed to injuries he suffered during the 2020 riots in north east Delhi. Then came Nehal Ahmed's Nothing Will be Forgotten: From Jamia to Shaheen Bagh (LeftWord Books) which was an account of the police action at Jamia Millia Islamia University. Ahmed, a PhD scholar at Jamia, was present on campus when a completely peaceful protest site soon started resembling a war zone. His was a moving account of students shattered by violence on their campus, yet finding creative ways of resistance against the discriminatory law which made religion

the benchmark of providing or denying citizenship to those coming from Afghanistan, Pakistan and Bangladesh; all but Muslims were welcome under the new law. Ahmed managed to come up with a snapshot of a moment in history.

Props of a protest

A book written in Hindi, Shaheen Bagh: Loktantra ki Nayee Karvat, by Bhasha Singh garnered attention for its immaculate detailing and persuasive research. Bhasha's book, published by Rajkamal Prakashan, brought to the reader the rich Urdu vocabulary and poetry used by protesters of Shaheen Bagh, their abiding pride in the national flag, their ability to educate the masses about the pitfalls of CAA-NPR-NRC with the use of a mock detention centre, and a library on the pavement at the protest site.

Women at the centre

The Shaheen Bagh protest soon became a movement which not only spread across the country but also got international attention. The Dadis (grandmothers) of Shaheen Bagh even made it to Time magazine. Reams began to be written on the determined struggle of the Shaheen Bagh women against the CAA, which allows religious minorities of Pakistan, Afghanistan and Bangladesh to get citizenship in India. Among the first books was Shaheen Bagh and the Idea of India, edited by veteran journalist Seema Mustafa, and published by Speaking

Hassan and Nandita Haksar. Each essay opened a little window to the world of Shaheen Bagh protesters, showing the mettle of the women, untrained to lead a protest against a new law, yet able to provide leadership at a critical juncture. Theirs was probably the first movement led by Muslim women since Independence. They had not come out on the streets to protest against the Shah Bano case or the Babri Masjid demolition. They had kept their counsel even on the instant triple talaq case. However, here they were, fighting for Article 14 of the Constitution, sitting under the open sky in the chill of Delhi's winters. Every day began with a rendition of 'Sare Jahan Se Achcha'. Every midnight arrived with the national anthem, 'Jana Gana Mana'. Mustafa's book was a richly elevating experience, one that quietly exposed the double standards of larger society and

It recounted too how the women gave space to freedom fighters of all hues on their stage yet managed to keep politicians and clerics at bay.

These books prove that the Shaheen Bagh women may have been forced to retreat to their homes due to the pandemic but they managed to force the government not to issue a notification for the new law for four years – the new Rules for the Citizenship Amendment Act, passed by Parliament in December 2019, were issued on March 11, 2024.

The books are a fine example of literature with social responsibility, when writers stepped out of their little cocoons and into the heat of the battle.

he United Nations said on Tuesday that Israel's severe restrictions on aid into war-ravaged Gaza coupled with its military offensive could amount to using starvation as a "weapon of war", which would be a "war crime".

United Nations human rights chief Volker Turk denounced the rampant hunger and looming famine in Gaza.

In a statement slammed by Israel, Mr. Turk said that "the situation of hunger, starvation and famine is a result of Israel's extensive restrictions on the entry and distribution of humanitarian aid and commercial goods". It was also linked to the "displacement of most of the population, as well as the destruction of crucial civilian infrastructure", he said.



Hong Kong passes new national security law

Hong Kong lawmakers unanimously approved a new national security law on Tuesday that grants the government more power to quash dissent, widely seen as the latest step in a sweeping political crackdown that was triggered by pro-democracy protests in 2019.

The legislature passed the Safeguarding National Security Bill during a special session that lasted on Tuesday. It comes on top of a similar law imposed by Beijing four years ago, which has already largely silenced opposition voices in the financial hub. Hong Kong's Legislative

Council, which is packed with Beijing loyalists following an electoral overhaul, rushed the law through to approval. After the vote, Hong Kong leader John Lee said that the law would take effect on Saturday.

The new law threatens

stringent penalties for a wide range of actions authorities call threats to national security, with the most severe - including treason and insurrection punishable by life imprisonment. Lesser offences, including the possession of seditious publications, could also lead to several years in jail. Some provisions allow criminal prosecutions for acts committed anywhere in the world.

A city that could bridge Turkiye and Armenia's division

"Look at this stone bridge," said writer Vedat Akcayoz pointing to the crumbling stumps of a 10thcentury span over the Arpacay River that marks the closed border between Turkiye and Armenia.

"The fish under the bridge, are they Turkish or Armenian?'

The spectacular ruined city of Ani stands on one of the world's most sensitive borders, dividing two countries daggers drawn over their painful past. Deserted now amid snow-capped peaks, Ani was once the capital of a mediaeval Armenian kingdom before it fell to the Seljuks in 1064, the first city the Turks took as they swept into Anatolia. Their sultan Alparslan converted its cathedral into his "conquest mosque". But its sack by the Mongols and an earthquake sent Ani into terminal decline.

"This is the land conquered by our ancestors," said Ziya Polat, governor of the nearby Turkish city of Kars. "Sultan Alparslan's first Friday prayer, the first Turkish bazaar are all here," he added.

With such symbolic importance to both sides, historians and officials hope restoring the UNES-CO World Heritage site might ease relations poisoned by the mass killing of Armenians in the Ottoman Empire during World War I, which Turkiye refuses to recognise as genocide.

Mr. Akcayoz, who wrote a book on the ruins, said Ani is "humanity's common heritage". "Ani was Zoroastrian, Ani was Christian, Ani was Muslim, Ani was yours, Ani was ours," he said.

For years Ani was off-limits for tourists. But authorities are now keen to promote its haunting beauty.

epublican Donald Trump has launched his general election campaign not merely rewriting the history of the January 6, 2021, Capitol attack, but positioning the violent siege and its failed attempt to overturn the 2020 election as a cornerstone of his bid to return to the White House. At a weekend rally in

Ohio, his first as the presumed Republican Party presidential nominee, Mr. Trump stood onstage, his hand raised in salute to the brim of his red MAGA hat, as a recorded chorus of prisoners in jail for their roles in the January 6 attack sang the national anthem.

An announcer asked the crowd to please rise "for the horribly and unfairly treated January 6th hostages." And people did, and sang along.

"They were unbelievable patriots," Mr. Trump said as the recording ended. Having previously vowed to pardon the rioters, he promised to help them "the first day we get into office."

Jason Stanley, a philosophy professor at Yale, said in history the question comes up over and over again: How could people not have taken an authoritarian leader at his word about what was going to happen? "Listen to Trump," he said.

"When a coup against the democratic regime happens and it's not punished, that is a very strong indicator of the end of the rule of law and the victory of that authoritarian movement," he said.

"Americans have a hard time understanding that what happens in most of the world can happen here, too."

Mr. Trump is facing a four-count federal indictment over January 6 charges he conspired to defraud Americans over his 2020 election defeat and obstructed the official proceeding in Congress to certify the vote for Joe Biden. As the Supreme Court considers Mr. Trump's claim that he should be immune from prosecution, it's unclear when the case will go to trial, raising the possibility it might not be resolved until after the election.

From conflicts in Ukraine and the Middle East to salt mining in Brazil - courts in the Netherlands have become Ground Zero in a global legal battlefield with far-reaching implications.

A strong legal tradition, home to many multinationals and international organisations, and global ease of reach: the country has several trump cards making it the preferred legal arbiter of choice.

Three months into 2024, the city of The Hague's two most influential international courts have already cast headlinegrabbing rulings on Russia's invasion of Ukraine and the spiralling conflict in Israel and the Gaza Strip.

In early March, the International Criminal Court issued arrest warrants for two high-ranking Russian

Incoming Palestinian PM lays out plans for reform but faces obstacles

The incoming Palestinian Prime Minister said on Tuesday that he will appoint a technocratic government and establish an independent trust fund to oversee Gaza's reconstruction.

In a mission statement acquired by The Associated Press, Mohammad Mustafa laid out wide-ranging plans for the kind of revitalised Palestinian Authority called for by the U.S. as part of its postwar vision for resolving the conflict.

But the Palestinian Authority has no power in Gaza, from which Hamas

drove its forces in 2007, and only limited authority in parts of the Israeli-occupied West Bank.

Israeli Prime Minister Benjamin Netanyahu has ruled out any return of the Palestinian Authority to Gaza and his government is staunchly opposed to Palestinian statehood.

Palestinian President Mahmoud Abbas designated Mustafa as Prime Minister last week. The U.S.-educated economist and longtime adviser to Abbas

is an independent with no political base. In the mission statement, Mr. Mustafa said he

would appoint a "non-partisan, technocratic government that can gain both the trust of our people and the support of the international community."

'Zero tolerance' policy He promised wide-ranging reforms of Palestinian Authority institutions and a "zero tolerance" policy toward corruption.

He said he would seek to reunify the territories and create an "independent, competent and transparent agency for Gaza's recovery and reconstruction and an internationally managed trust fund to raise, manage and disburse the required funds."

The vision statement

made no mention of Hamas, which won a landslide victory the last time Palestinians held national elections, in 2006, and which polls indicate still has significant support.

The 88-year-old Abbas, who is in overall control of the Palestinian Authority, has remained in power since his own mandate expired in 2009 and has refused to hold elections, cit-

ing Israeli restrictions. Elections consistently find that a large majority of Palestinians want Mr. Abbas to resign.

estinian Authority aims to hold presidential and parliamentary elections, but he did not give a timetable and said it would depend "realities on the on ground" in Gaza, the West Bank and east Jerusalem, territories Israel captured in the 1967 Mideast war that the Palestinians want for their future state.

In 2021, Mr. Abbas blamed Israeli restrictions in annexed east Jerusalem for his decision to indefinitely delay elections in which his secular Fatah party was expected to suffer major losses.

North Korean leader Kim Jong Un supervised a livefire drill of nuclear-capable "super-large" multiple rocket launchers designed to target South Korea's capital as he vowed to boost his war deterrent in the face of deepening confrontations with rivals, state media said on Tuesday.

The report came a day after South Korea and Japan said they detected North Korea firing multiple short-range ballistic missiles toward waters off its eastern coast, adding to a streak of weapons displays that have raised regional tensions.

Experts say North Korea's large-sized artillery rockets blur the boundaries between artillery systems and ballistic missiles because they can create their thrust and are guided during delivery. The North has described some of these systems, including the 600mm multiple rocket launchers that were tested on Monday, as capable of delivering tactical nuclear warheads.

Photos published by the Korean Central News Agency showed at least six rockets being fired simultaneously from launch vehicles and flames and smoke blanketing what appeared to be a small island target.

South Korea's Joint Chiefs of Staff said later on Tuesday that it assessed North Korea conducted more launches than what was shown in the photos. Lt. Col. Lee Chang-hyun, a deputy JCS spokesperson, said that South Korea categorises the North Korean weapons system tested on Monday as a ballistic missile given its characteristics and capacities.

Bank of Japan raises interest rate, first time in 17 years

Japan's central bank raised its benchmark interest rate Tuesday for the first time in 17 years, ending a policy of negative rates meant to boost the economy.

The Bank of Japan's lending rate for overnight borrowing by banks was raised to 0-0.1% from minus 0.1% at a meeting, confirming a shift away from ultra-lax monetary policy. It was the first rate hike since February 2007. Policy measures "have fulfilled their roles," Bank of Japan Governor Kazuo Ueda said.

India to join U.S.-led carbon market project

India has decided to join at least one of the four cooperative work programmes unveiled last week under the 'clean energy pillar' of the U.S.-led Indo Pacific Economic Framework (IPEF) - the one on facilitating and promoting carbon-market activities.

Officials said New Delhi is also considering two of the other co-operative work-programme initiatives, one on clean electricity and the other on the use of sustainable aviation fuel but will take a call on whether to join or not after thorough analysis.

"India will join the cooperative working group on carbon markets through the Ministry of Power and the Bureau of Energy Efficiency will be the nodal body," an official tracking the matter said.

The IPEF, an initiative led by U.S. President Joe Biden, was unveiled in May 2022, bringing together 14 regional partners – Australia, Brunei, Fiji, India, Indonesia, Japan, the Republic of Korea, Malaysia, New Zealand, the Philippines, Singapore, Thailand, the U.S. and Vietnam.

Four pillars

Seen by many analysts as an attempt by the U.S. to counter China's growing influence in the region, the IPEF aims at having a common set of rules and standards around four pillars viz. connectivity and digital trade; resilient supply chains; clean energy; and corruption-free fair trade.

Others are focused on finding new areas that will benefit from AI, said Rene Reyna, head of thematic ETF strategy at Invesco and manager of the Invesco AI and Next Gen Software ETF.

'Changing landscape'

"The conversations we have with investors don't focus on finding the next Nvidia, but more on recognising that these technologies are changing the landscape and finding ways to get exposure to some of this growth," he said.

Analysts at Morgan Stanley last week published a list of 480 individual stocks that may benefit from AI.

Less obvious beneficiaries included Walmart and Caterpillar. The bank also recommended exploring "less crowded sub-themes" like the integration of AI and smartphones.

ETFs are also scrambling to provide offerings for every taste.

Robo Global Robotics & Automation ETF supplements its Nvidia exposure with holdings in stocks some expect to benefit from AI technology, like Intuitive Surgical.

The Roundhill Generative AI & Technology ETF is focusing on companies it expects to be beneficiaries of generative AI, including Salesforce.com and Marvell Technology.

Sees outflows

Still, at least one flavour of AI-themed ETF has failed to win fans. The Wisdom-Tree US AI Enhanced Value ETF, which uses AI to select its portfolio, has seen outflows of \$48.26 million in the last 12 months and lags the S&P 500.

One possible reason the fund and others in its category have underperformed: many of them lack a position in Nvidia and other AI-related stocks.

Clamour for collateral clouds China firm Vanke's credit pursuit

A rare Beijing directive to help Vanke beat a liquidity crisis has left lenders scrabbling for the assets that the State-backed developer has proposed for collateral, as parties pull out all the stops to arrest deterioration in the property sector.

China Vanke is gasping for funding after sales in both January and February fell below the monthly break-even point of 20 billion yuan (\$2.8 billion), meaning cash flowed out of the business, an internal memo showed.

China's property sector has been in the throes of a

crisis since mid-2021. Local policymakers' stimulus and easing measures have struggled to boost sales or increase liquidity, while many property developers have defaulted on debt obligations.

Rare intervention

Reflecting the deepening crisis, regulators asked financial firms and creditors to step up financing support for Vanke - China's second-biggest property developer by sales – in a rare intervention by central government, Reuters reported last week.

With plunging sales as well as bond prices clouding Vanke's outlook, the developer has shared a list of mainly commercial pro-

jects such as shopping malls and their revenue

According to the latest edition of the India Sports Sponsorship Report' published by GroupM ESP, the industry has swelled 6.5 times since the IPL boom in 2008. Its revenue from sponsorship, endorsement and advertising spending has grown from ₹2.423 crore in 2008 to a whopping ₹15,766 crore in 2023.

The bulk of the heavy lifting has been done by cricket, which contributed an astounding 87% of the total industry spends in sports in India.

This massive upsurge in the commercialisation of the most popular sport in India was largely driven by the IPL, whose brand value has ballooned by 433% since its inception in 2008. The media rights sale

for different platforms resulted in a per-match valuation of ₹118.5 crore for the IPL, second only to the

National Football League. The growth in sports spending in India was spurred by sponsorship and endorsement, which grew by 24 % each.

Cricket enjoyed the lion's share in sports sponsorship spending, contributing 79% to the total reby 25%.

The only category of sports spending that witnessed a de-growth in 2023 was advertising on sportsrelated content.

Even here, cricket held its own with a share of 94% in 2023.

Despite a fall of ₹59 crore in spending in 2023, media spends still accounts for the largest share (over 47%) in sports commercialisation in India.

While TV advertising still comprises more than 50% of the total media spending, it fell by 16% in 2023, even as the share of digital swelled by 40%.

This shift was visible during IPL 2023 too, where TV ads spending declined but digital spending grew

Air of anticipation as Pant prepares to take guard again



There are so many things Rishabh Pant knows he has to be thankful for. Sixteen months ago, the fact that his career might be over seemed a minor issue at the time. He had survived a ghastly car accident, and as he said later, he thought his "time in this world was over."

He didn't have a fracture, but he had torn all the ligaments in his knee which finished at a right angle to his hip while he landed face down. Each one had to be replaced. what-might-have-The beens are too frightening to speculate about. His re-

covery was steady (and must have been painful too), and he kept everybody's spirits up as he learnt to walk again, sending out social media messages of hope and cheer.

"I didn't think I would ever enjoy brushing my teeth," he said in an interview.

Yet the idea that he would be playing serious cricket in less than 15 would months have sounded bizarre then. Which is why despite the presence of some new stars and plenty of old ones, the IPL for many around the world will be about one man – Rishabh Pant. He will lead Delhi Capitals and keep wickets beside playing what Rohit Sharma has called 'Rishball' cricket.

Teammates and opponents as well as spectators has said that if he keeps

would be happy to give him time to ease into the many roles.

Sunil Gavaskar has said the injured knee means Pant may not hit the ground running (so to speak), sensibly advising impatient fans that the player will need time and

we ought to grant him that. Watching any player return from injury sustained in a match is both heartening and fraught. Watching a favourite return after what happened will be life-affirming.

Age factor

His greatest advantage, besides his courage and determination, is his age. He is only 26 after all those centuries and sixes and catching and chatter from behind the stumps. The cricket board secretary

Special player

time: free and fearless. It didn't matter if he were in the nineties; caution was an insult to his batsmanship, landmarks were meant to be incidental, not the focus. It meant he had more 90s than 100s in Test

cricket. Watching the new breed of young Indian batters from Yashasvi Jaiswal to Dhruv Jurel, it is not difficult to trace the line that began with Pant who started his Test career by hitting the second ball he faced for a six. This, in Nottingham on the 2018 tour.

Pant quickly built a reputation for banter from behind the stumps, often having his target join in the laughter too. When Tim Paine, his counterpart in Australia, asked him to babysit his children, Pant responded by having himself photographed carrying the kids (at a reception). Paine's wife called him "the best babysitter".

My favourite Pant quip came at an end-of-the match interview when Harsha Bhogle joked that Pant's 'commentary' from behind the stumps might soon leave the professional commentator out of a job. Without missing a beat, Pant responded, "Then you must improve." Bhogle probably laughed the loudest.

The return of Rishabh Raiendra Pant to his natural habitat is being awaited with all the keenness and anticipation the sight of him emerging from the pavilion evokes. That he has already come this far is a tribute to his spirit. The IPL has not been about one individual or one comeback. But this year it is, as Pant takes fresh guard.

After leading the after wicket-takers' chart for much of the tournament, she finished fourth in the list with 17 scalps in six matches; she also contributed 167 runs in six innings. number again in the reverse fixture with another peach of a delivery that appeared to turn well past leg-stump but straightened. She finished her maiden

season in the Women's Premier League with 12 wickets in 10 matches with best figures of three for 20 and economy rate of 7.31

Challengers Bangalore did just that.

After a disappointing first rodeo in the Women's Premier League, the RCB management sat captain Smriti Mandhana down and said, "This is your team, build it the way you want." That conversation also involved asking Smriti if she had any recommendations for RCB's next coach. The first name that came to her mind was Luke Williams, the assistant coach at Southern Brave in The Hundred, which she had been part of.

"During The Hundred is where Luke and I started jotting down a few names and tracking a few players. Sophie Molineux was one of them," Smriti told *The Hindu* after RCB's maiden WPL title triumph. "She was injured so we had to track her. Luke kept close tabs on the Australian system and we went through with her."

Ever the fighter

If you're an Indian women's cricket fan, you might remember Molineux copping a bouncing ball to the face during the third ODI against India at Mackay in 2021. She cut her lip but came back with her mouth taped to bowl the death overs, making the visitors work for their two-wicket win in the final over. That victory halted Australia's world record 26-match unbeaten streak but Molineux's resilience became the talking point of the day.

Her tryst with injuries continued as she sustained a stress fracture to her right foot at the end of the same year. That was curtains for her participation in the Women's National Cricket League (Australia's domestic 50-over tournament) and the Ashes.

She also missed the 2022 Women's World Cup in New Zealand, which Australia won for the seventh time, and the Commonwealth Games where Australia defeated India.

The eight-month-long lay-off eventually cost her the Australian national contract. The southpaw returned to cricket in The Hundred, where she took five wickets and scored 65 runs in five games.

During the Women's Big Bash League that year, Molineux – leading Melbourne Renegades – ruptured her anterior cruciate ligament which needed mandatory surgery and ruled her out of competitive cricket for 12 months. Consequently, she missed Australia's

The Bairnsdale-born all-rounder then made it to the Governor General's XI which beat South Africa ahead of the multi-format series Down Under. She was named Player-of-the-Match for her 41-ball 59 and one wicket. Molineux featured in the one-off Test against South Africa where she went wicketless but was economical. She has now taken Jess Jonassen's place in Australia's squad for the tour of Bangladesh ahead of the Women's T20 World Cup to be held in the Asian country later this year.

"I've always loved the game. I used to play three games a weekend back home and just loved it. When you get caught up in doing it day-in-day-out as a job, you don't stop and then you probably don't take it for granted when it's not there," she had said when she made her comeback in Australian colours.

"We've been following her for a very long time. I remember her bowling against us in the one-day series, which we nearly won, when we went to Australia. She was the difference between the Australian team and the Indian squad, and the way she bowled in the last four-five overs and it always stuck with me somehow – her performance," Smriti said after the WPL triumph.

"The last two years, with a few injuries, have been really tough on her. She went through ACL and I can feel that pain (having gone through it myself)... so really happy for her," she added.

WPL run

Coming into WPL Season 2, RCB had to deal with the loss of England captain Heather Knight who chose to prioritise national duty for the tour of New Zealand in the run-up to the World Cup. That opened the door for Molineux to repay the faith Smriti and Williams had shown in her.

In the first game, she left UP Warriorz skipper Alyssa Healy flummoxed with a ripper that straightened instead of spinning in. RCB won that game by two runs.

Facing Gujarat Giants next, Molineux claimed three scalps – Veda Krishnamurthy, Kathryn Bryce and Sneh Rana – in RCB's eight-wicket win. She went wicketless in RCB's 25-run loss to Delhi Capitals and seven-wicket loss to Mumbai Indians. Molineux had Healy's saw the Bengaluru outfit open the batting with the all-left combo of Molineux and Smriti. It was a call that left many puzzled as it exposed the Indian to her off-spin weakness early on. Though Smriti fell early, Molineux managed a 30-ball 33 in a chase that RCB agonisingly fell short by a solitary run. That loss put its playoff chances in danger. Molineux was expensive, going for more than 11 runs an over in that game, with questions emerging about her spot in the line-up.

However, Ellyse Perry helped RCB seal its place in the Eliminator with an all-round show against Mumbai Indians. Molineux retained her place in the knockout fixture against the same opponent, giving away just 16 runs in her four overs and taking a wicket.

It was in the final that Molineux truly came into her own. Taking on a dominant Delhi Capitals, RCB's spin trio of Shreyanka Patil, Molineux and Asha Sobhana proved to be a formidable spin web that pulled Meg Lanning & Co. into its trap. It was a spell-binding over by Molineux that turned the game on its head.

DC was 64/0 at the end of the seventh over. Molineux, who had conceded 10 runs in her first over in the PowerPlay, rocked Capitals with three strikes in a single over, removing Shafali Verma with a tossed up delivery which the opener struck straight to midwicket.

She then took out Jemimah Rodrigues and Alice Capsey off consecutive deliveries, both heading in between the middle- and off-stump. She went on to concede just 20 runs in the game and also pulled off a remarkable run out to send Arundhati Reddy back to the hut. Her performance powered RCB to its maiden title and she deservingly won the Player-of-the-final honour.

"To be picked by RCB after not playing cricket for a while... it is an incredible competition and it is only going to go from strength to strength. Proud to be a part of it and this one (the POTM award) is special," Molineux said. She had repaid the faith when it mattered the most.

Soph, the leader

During India's multi-format series against Australia late last year, Perry had walked up to her RCB teammate Shreyanka Patil with a message about her prospective When asked how she guides the spin groups in the teams she plays for, there was almost a hint of embarrassment.

"We made a conscious decision as a group that communication was going to be the key in this tournament, particularly for the spin group as we were playing on different pitches each night," she told *The Hindu*.

Smriti's smile – one akin to that of a gambler's when their punt pays off – was understandable.

"She is brilliant. She is one of the smartest bowlers I've seen in a while. She has a good yorker. She has a slower one that turns and one that goes into the wicket. That's great news for a captain.

"Sometimes, she would ask if a player would play a certain delivery or respond to it with a certain shot. That's it. She would do the rest. She leads (Melbourne) Renegades, so obviously... (she's tactically sound)," Smriti said.

She was, however, quick to add that not too many insights were passed on as the pair will be on opposite ends in the World Cup.

With her incredible displays at the age-group level, Molineux was always regarded as the next big thing growing up in a country that is used to ruling the world in the sport. It comes as no surprise that she leads the Victoria side which also has the likes of Lanning and Perry.

Molineux attributed a big part of RCB's change of fortunes to belief. It is incredible how that single factor has guided her comeback to the game.

The emphatic performances thereafter have boosted her chances of returning to the XI for Australia's World Cup title defence in September.
