With 47 votes, Champai wins floor test

Twenty-five MLAs of the BJP, the AJSU, and the NCP voted against the trust vote motion

he new Champai Soren government won the trust vote on the floor of the Iharkhand Assembly on Monday after 47 Jharkhand Mukti Morcha (JMM)-led alliance legislators voted for the motion and 29 against it. Mr. Champai Soren moved the motion on which a debate was held.

During the debate, former Chief Minister Hemant Soren, arrested by the Enforcement Directorate (ED) in the alleged land scam case, accused the Raj Bhavan of being part of his arrest. He said that he would quit politics and leave Jharkhand if anyone proved he forged land documents.

During the voting, 27 MLAs of the JMM, 17 of the Congress and one each of the Rashtriya Janata Dal and the Communist Party of India (Marxist-Leninist)

Liberation voted for the motion. The only nominated MLA, Glen Joseph Galstaun, who represents the Anglo-Indian community, also voted in favour of the motion, taking the total to

Twenty-five MLAs of the BJP, three of the All Jharkhand Students' Union (AJ-SU) and one of the Ajit Pawar faction of the Nationalist Congress Party (NCP) voted against the

Independent MLA Saryu Roy did not vote. Another Independent MLA Amit Yadav, Indrajit Mahto of the BJP and Ram Das Soren of the JMM were not present in the House.

Speaker Rabindra Nath Mahto made the formal announcement of the Champai Soren government winning the trust vote.

Before leaving the Assembly premises, Mr. Champai Soren said the Cabinet expansion would take place soon.

Ex-CM Hemant Soren says he will quit politics if anyone proves he forged land documents

As soon as Mr. Hemant Soren entered the Assembly, the JMM and Congress legislators shouted slogans in his support. They shouted slogans such as Jail Ka Tala Tutega Hemant Soren

Chutega (The jail lock will

be broken and Hemant Soren will be released).

"It is probably for the first time a serving Chief Minister or former Chief Minister was arrested at the Raj Bhavan. I feel somewhere even the Raj Bhavan is involved in my arrest," said Mr. Hemant Soren.

He alleged that the BJP treated tribal people as untouchables and the party wanted them to stay in the jungles only.

"If the BJP thinks that they can suppress my voice by sending me to jail, it's not going to happen. ED, CBI and IT cannot touch those BJP leaders who have gulped crores of money," Mr. Hemant Soren

said. He said the BJP did not want a tribal leader to complete five years of his term.

"The history of Jharkhand will never forgive the BJP. Bring a single document which can prove that I have forged 8.5 acres of land. If you can bring it, then I will leave Jharkhand forever. When ED did not get anything from me, they are now checking the bank accounts of my wife. I fear that the way Bandhu Turkey lost his membership of the Assembly, I may face the same fate," Mr. Hemant Soren said.



PM slams Congress, says NDA will return to power with 400 seats

Exuding confidence that his government will return to power in the next Lok Sabha election, Prime Minister Narendra Modi on Monday said that he could "gauge the mood of the nation" and that the BJP alone would get at least 370 seats and the NDA would cross the 400-seat mark in the Lok Sabha.

In a speech that went on for more than an hour and a half, on the Motion of Thanks to the President for her address to both Houses of Parliament, Mr. Modi mounted a spirited attack on the Opposition stating that he was convinced that they (Opposition parties) have "lost the courage to

contest elections and have resolved to stay on the Opposition benches for a long

He said the Congress is destined to sit in the Opposition for several more years, and that the third term of the government was not too far. "At the most 100-125 days are remaining," he said, referring to the upcoming Lok Sabha elections.

The Lok Sabha adopted the Motion of Thanks on the President's address via a voice vote, following Mr. Modi's speech.

He said that the Congress had for the last 10 years lost the opportunity to play the role of a constructive Opposition and blamed it solely for the "present condition" of the entire Opposition. "The Congress had a good opportunity to play a good Opposition but failed in that role.," Mr. Modi said.

Dynastic politics

Speaking on dynastic politics, Mr. Modi said that he termed parties dynastic where a particular family takes all the decisions, captures the leadership, and the party serves that family, not families where more than one person is in politics, but as part of a party structure. "Rajnath Singh has no political party of his own," he said. Mr. Singh's son Pankaj Singh is an MLA in Uttar Pradesh.

White Paper on economy to be tabled this session

Chandigarh election incident a mockery of democracy, says SC

The Supreme Court gave the BJP victory at the Chandigarh mayoral elections a jolt, threatening to order fresh elections after a video played in the open courtroom on Monday showed the Returning Officer "obviously defacing" ballot papers, while taking stealthy glances at the camera overhead like

"fugitive" "What is he doing? It is obvious that he has defaced the ballot. This man has to be prosecuted... Why is he looking at the camera like a fugitive and then quietly defacing the ballot? This is a mockery of democracy... He is murdering democracy. Is this the way to conduct an election?" Chief Justice of India D.Y. Chandrachud, heading a three-judge Bench, addressed Solicitor-General Tushar Mehta, appearing for the Union Territory of Chandigarh, and senior advocate Maninder Singh, for the winning candidates.

The Supreme Court directed the sequestration of the entire records of the mayoral election under the custody of the Registrar-General of the Punjab and Haryana High Court forthwith by 5 p.m.

'SC is watching'

These records include the ballot papers and the whole video shot of the electoral process.

The court also stopped the new dispensation of the Chandigarh Municipal Corporation from holding a Budget meeting on Fe-

bruary 7.

"Please tell your Returning Officer that the Supreme Court is watching over him. We will not allow democracy to be murdered like this. The great stabilising force in the country is the purity of the election process... What is happening here?" Chief Chandrachud Justice asked.

Senior advocate A.M. Singhvi, appearing for Aam Aadmi Party (AAP) councillor Kuldeep Kumar, said the election process was videographed on the orders of the High Court.

He said there were 20 AAP councillors and 16 BJP ones. The Returning Officer was supposed to sign on each ballot paper after the

'Active member of BJP'

"He makes squiggles on eight ballot papers and uses his own squiggles to disqualify the votes. Our votes are reduced to 12 and BJP wins the polls with a margin of four votes. After the voting, he picks up the whole lot of ballot papers and rushes out... This is a complete negation of democracy," Mr. Singhvi submitted.

He said the Returning Officer is "admittedly an active member of the BJP".

Punjab Advocate-General Gurminder Singh said "the man [Returning Officer] has to be prosecuted".

Mr. Singh began in defence to refer to certain regulations on the conduct of elections while Mr. Mehta said they would be able to "satisfy" the court. He said the Bench should not form an opinion without viewing the entire video.

"We are here to satisfy our judicial conscience. If we are not satisfied, we will direct the conduct of fresh elections and appoint the Returning Officer... Mr. Solicitor, this is a mockery of democracy... a mockery! The man defaces the ballot and looks at the camera to see who is looking at him..." the Chief Justice Chandrachud retorted, listing the case on February

The BJP had swept the Chandigarh mayoral elections, retaining all three posts, in a setback to the Congress-AAP alliance that alleged tampering with ballot papers by the Presiding Officer.

The Punjab and Haryana High Court had earlier refused to grant the AAP any interim relief. The AAP has sought

fresh election under the supervision of a retired judge.



M.P. CM meets Modi ahead of his February 11 visit to State

Madhya Pradesh Chief Minister Mohan Yadav on Monday met Prime Minister Narendra Modi days before the latter's scheduled visit to the State to kick-start the BJP's Lok Sabha election campaign. Mr. Yadav called on Mr. Modi at the Parliament House amid the ongoing Budget Session. "Today, I paid a courtesy visit to the respected Prime Minister Shri Narendra Modi at the Parliament House," he said in a post on X. Apart from Mr. Modi, Mr. Yadav also held talks with Union Home Minister Amit Shah and BJP national president J.P. Nadda.

Rajasthan to promote stone sector through easy approval

The Bharatiya Janata Party government in Rajasthan is set to promote the stone sector through a single window clearance system following the approval of business proposals worth ₹2,981 crore at the 12th edition of 'India Stonemart-2024', which ended here on Sunday. Rahul links privatisation to exploitation of tribals, promises caste census

In Ranchi for his ongoing Bharat Jodo Nyay Yatra, Congress leader slams the Modi govt, for 'strangulating' public sector units and the 'injustice' to HEC employees, promises to stand by them

n Ranchi on the fourth day of the Jharkhand leg of his ongoing Bharat Jodo Nyay Yatra, Congress leader Rahul Gandhi exulted over the Champai Soren government in Jharkhand winning the trust vote on Monday. Alleging that the BJP could not accept the fact that a tribal was the Chief Minister, he promised a nationwide caste census and removal of the 50% cap on reservation if the INDIA bloc formed the government at the Centre after the Lok Sabha polls.

Telangana caste survey On a day Telangana Chief Minister A. Revanth Reddy also met him in the Jharkhand capital, Mr. Gandhi said that a caste survey would be carried out in Telangana in accordance with the promise made during the Assembly election in that State.

Addressing a public

meeting at Ranchi's Shaheed ground on Monday, the Congress leader drew a link between the Telangana survey and the fate of employees of the Heavy Engineering Corporation (HEC) Limited in Ranchi, who have not received their salaries for 25 months.

"Soon, we will come to know the exact numbers of (Other Backward

Classes), Dalits and tribals in Telangana. I am saying it because the HEC people who are being harassed are OBC, Dalits and tribals, and all attempts are being to privatise HEC. Privatisation means making OBC, Dalit, tribals and poor people unemployed," Mr. Gandhi said.

He slammed Prime Minister Narendra Modi's government and held him responsible for the injustice to the HEC's employees.

Hundreds of HEC employees gathered at the ground, holding posters and banners against the Central government.

"Slowly and gradually, Prime Minister Narendra Modi and his government are strangulating public sector units. I give my assurance. When we form the government, we will give you all possible support," Mr. Gandhi said.

Meets Hemant's wife

Before addressing the public meeting, Mr. Gandhi also met Kalpana Soren, wife of former Chief Minister Hemant Soren, at her residence in Ranchi.

Senior Congress leader and former MP Subodh Kant Sahay, Congress communications chief Jairam Ramesh, the party's Jharkhand in-charge Ghulam Ahmad Mir, and State Congress chief Rajesh Thakur also shared the stage, along with Congress MLAs.

SC notice to Centre over job quota in Haryana

The Supreme Court on Monday sought a response from the Centre on a plea filed by the Haryana government against the Punjab and Haryana High Court order declaring as "unconstitutional" its law providing 75% reservation in private sector jobs to the residents of the State.

A Bench of Justices P.S. Narasimha and Aravind Kumar issued notice to the Union of India and the Faridabad Industries Association on the appeal filed by the Haryana government.

Solicitor General Tushar Mehta, appearing for the Haryana government, submitted that the High Court verdict was devoid of reasoning.

The High Court had also held the Harvana State Employment of Local Candidates Act, 2020 as "ultra vires".

Marriage dissolution does not efface status of child's parents: HC

Dissolution of a marriage does not efface the parental status of the mother and father of a child, the Delhi High Court has observed while allowing a man's plea to have his name reflected in the school records of his minor

The High Court said when the man was alive, there was no justification for his ex-wife to remove the father's name from the school admission form of their son and replace it with the name of her second husband.

'Can't refuse right'

It said while the woman has every right to have her name reflected in the school records as the mother of the minor, that cannot authorise her to refuse the man's right to have his name also entered in

the documents as the child's father.

"The dissolution of a marriage does not efface the parental status of the mother and father of the child borne out of the said marriage," Justice C. Hari Shankar said.

The court said the prayer of the man to have his name reflected in the school record as the father of the child cannot be refused.

Assam proposes jail term, hefty fine for cheating in job tests

The Assam government has proposed up to 10 years in jail and a fine of up to ₹10 crore to stop cheating in public examinations for recruitment and the leak of question papers for

The Assam Public Examination Bill (Measures for Prevention of Unfair Means in Recruitment), 2024, prescribing the stern measures, was tabled on the first day of the Budget session of the State As-

sembly on Monday. The Bill is expected to prevent the repeat of a cash-for-job scam that came to light in 2016, leading to the arrest of more than 120 people, including civil and police service offi-

According to provisions in the Bill, if any examinee indulges in unfair means, he or she shall be liable to Stern steps follow a cash-for-job scam in which more than 120 people were arrested

be punished with imprisonment for a term that may extend to three years and shall also be liable to a fine not less than ₹1 lakh.

The Bill says if any person, including the examinee, whether or not entrusted or authorised with the conduct of public examinations, indulges or attempts to indulge in unfair means and contravenes or abets to contravene any of the provisions of the Act, he or she shall be punished with imprisonment for a term which shall not be less than five years and may extend to ten years.

The person shall also be liable to a fine which shall not be less than ₹10 lakh and may extend to ₹10 crore.

Father by his side, Nakul Nath announces he is Congress LS candidate from Chhindwara

Congress Lok Sabha MP and son of former Madhya Pradesh chief minister Kamal Nath, Nakul Nath said on Monday that he would again contest the forthcoming parliamentary poll from Chhindwara. a seat which the senior Nath won in 2019.

Addressing a public meeting in Parasia area of Chhindwara, where his father was also present, Mr. Nakul said, "For the Lok Sabha (elections) I will be your candidate. These rumours that are going on whether or not Kamal Nath ji will contest the polls, I want to make it clear that Kamal Nathji will not contest, I will. Mr. Nakul is currently the only Congress Lok Sabha MP from the State. He

Lord Ram was at the centre of Uttar Pradesh's ₹7.36lakh-crore Budget presentation on Monday. Finance Minister Suresh Khanna started his Budget speech with a verse of the epic Ramcharitmanas and invoked Lord Ram several times during his 70-minute-long speech. Chief Minister Yogi Adityanath said the Budget has been dedicated to Lord Ram and is meant for 'Lok Mangal' (public welfare).

which The Budget, comes a fortnight after the consecration ceremony at Ayodhya and roughly three months before the Lok Sabha election, focuses on infrastructure, women, education, and developing cultural/religious centres.

The announcements made by Mr. Khanna on Monday included ₹27.086 crore to boost the State's health infrastructure. ₹2,475 crore for scholarships for students from the backward classes, ₹400 crore for handloom weavers with an aim to generate 40,000 iobs in the handloom and textile sectors, and an increase in the monthly pension for destitute women from ₹500 to ₹1,000.

Mr. Khanna also announced schemes for employment generation, infrastructure development, women empowerment, and the promotion of research and innovation in emerging technologies like

Samajwadi Party chief Akhilesh Yadav said it had nothing for "90%" of the State population. "Whether the Budget is of ₹7 lakh crore or ₹8 lakh crore is not important. The bigger

question is, what does it have for the backward classes, Scheduled Castes, and minorities? The Budget hasn't addressed the problems faced by the youth, farmers, women and every other section of society. It has failed to provide any road map for U.P.," said Mr. Yadav.

Kerala Budget focuses on private investment

he State Budget for the 2024-25 fiscal presented by Finance Minister K.N. Balagopal on Monday sought to mop up additional resources and draw private investment in key sectors, even as it proposed Chinese-model special development zones (SDZ) for tapping the potential of the Vizhinjam seaport project and a new 'assured' pension system government employees.

While focussing on judicious public spending, Mr. Balagopal has sought to attract private investment to the tune of ₹3 lakh crore within the next three years in sectors such as infrastructure and tourism to enliven the economy.

Mr. Balagopal, who later described the Budget as a "platform for a forward leap for Kerala", has sought to raise ₹1,067 crore in additional resources through a slew of rate revisions, including that of electricity duty, judicial court fees and other levies.

The Finance Minister started off his two-and-ahalf-hour speech in the Assembly saying that Kerala "is on the cusp of becoming a sunrise economy."

But he also mentioned a 'Plan B' to keep the State economy and development programmes afloat if the Union government's "neglect towards Kerala"

persisted. The Budget left the present ₹1,600 monthly social security pensions untouched.

In a bid to "revitalise" the construction sector, the government will undertake works to the tune of ₹1,000 crore, according to the Budget.

The government has also decided to raise the support price of rubber by ₹10 to ₹180. As part of raising additional resources, the government has decided to permit sand extraction from selected rivers, which is expected to bring in ₹200 crore.

In a bid to boost higher education, the government will explore opportunities for establishing campuses of foreign universities and private universities in Kerala, the Budget said.

In line with the govern-

ment's policy of promoting private industrial parks, 25 new parks will be cleared in 2024-25.

The government expects the growth trend in tax revenues to continue in 2024-25. Kerala's own tax revenue is projected to grow by ₹7,845.21 crore and non-tax revenue, by ₹1,503.41 crore over the 2023-24 revised estimates.

Congress slams Budget Leader of Opposition V.D. Satheesan slammed Mr. Balagopal for making "unrealistic announcements" and using the Budget to make political statements against the Opposition.

Abhishek's absence at Trinamool protest sparks speculation

The absence of Trinamool Congress general secretary and Diamond Harbour MP Abhishek Banerjee at the party's ongoing dharna in Kolkata's Red Road has sparked speculation among certain sections of the party.

The *dharna* began on Friday last week with Chief Minister Mamata Banerjee sitting at the protest site for two days before asking party's women, youth and other wings to take over. The protest was organised by the Trinamool Congress to highlight the Union government's delay in paying wages to the MGNREGS beneficiaries. The Centre has stopped funds to West Bengal under MGNREGS under Section 27 of Act reportedly on account of corruption in the implementation of the scheme.

The high point of the protest came on Saturday when Ms. Banerjee announced that her government would pay the pending wages to about 21 lakh MGNREGS workers on February 21. The protest would continue till February 13 and the Diamond Harbour MP was conspicuous by his absence.

In October 2023, Mr. Banerjee – who was also the Trinamool Congress's general secretary - held protests in Delhi and outside Raj Bhavan in Kolkata on the same issue. He had been time and again emphasising that if people of the State supported him,

he would get the State's dues from the Centre.

Amid discontentment against him for being promoted in the party, Sayani Ghosh - the head of Trinamool's youth wing - downplayed rumours of a rift and said Mr. Banerjee was in Delhi and that his absence was not a big issue. However, a cousin of Mr. Baneriee posted on Monday on social media that the "deserving are not getting opportunities, while those with no abilities are being promoted".

Differences surface

Meanwhile, as political activities gathered pace ahead of Lok Sabha polls, Mr. Banerjee has largely confined himself to his constituency.

There has been talk of differences between him and Ms. Banerjee on the retirement age in politics. While Mr. Banerjee was in favour of young faces, his aunt and party chairperson seemed to be in favour of seniors. The differences could likely play a role during selection of candidates for the upcoming Lok Sabha polls.

Karnataka got more funds under NDA than UPA, claims BJP

The BJP has countered the Congress government's allegations that the BJP government at the Centre has been displaying step-motherly attitude towards Karnataka by maintaining that the total Central allocation to the State has actually increased by three folds during the BJP regime compared with the UPA.

Leader of the Opposition R. Ashok took to social media to accuse the Chief Minister of resorting to lies. "A lie will not become a truth just because you repeat it 100 times. You too know that the actual truth is that the central allocation has increased by more than threefold during the BJP regime compared with the UPA regime," he said.

He urged the Chief Minister to come out with a White Paper on the Central allocation for Karnataka in the last 20 years so that the truth would be known. Former Chief Minister Basavaraj Bommai described the proposed protest in Delhi by the Congress as a "political stunt" to cover up its own mistakes.

Karnataka Cong. to protest in Delhi over devolution of taxes by Centre

Ministers and legislators of the ruling Congress in Karnataka have decided to stage a protest at Jantar Mantar in New Delhi on Wednesday under the leadership of Chief Minister Siddaramaiah against the alleged "stepmotherly treatment" by the BJP government at the Centre in devolution of taxes, nonrelease of drought relief, and denial of clearances for irrigation projects in the State.

Announcing this at a press conference on Mon-

day, the Chief Minister said that Karnataka had incurred a loss of ₹1.87 lakh crore during the 15th Finance Commission period owing to reduction in devolution of taxes, special grants, and non-distribution of funds collected by the Centre under cess on petrol and diesel, and surcharges.

"A huge injustice was meted out to Karnataka in the 15th Finance Commission (2020-21 to 2025-26) period compared to the 14th Commission (2014-15 to 2019-20). Our protest is not against the BJP, and it is not political. Our protest is to draw the attention of the Centre and the country," said Mr. Siddaramaiah, who also holds the finance portfolio.

For the first time, the Congress government in Karnataka will stage a protest in Delhi against the Narendra Modi-led government at the Centre.

The amount allotted to Karnataka from the total collection of taxes, including grants, reduced from 4.71% to 3.64% from the 14th Finance Commission to the 15th Finance Commission. As a result, the State lost ₹73,593 crore, he said.

Karnataka ranks second in collection of taxes ranking next to Maharashtra. The State contributes ₹4.3 lakh crore per year from all types of taxes, but, in turn, the State has been receiving only 12% to 13% of its share from the Centre, Mr. Siddaramaiah said

Will repeal **Land Titling** Act if TDP comes back to power: Naidu

Continuing his high-intensity pre-poll campaign "Raa Kadali Raa", Telugu Desam Party (TDP) president N. Chandrababu Naidu on Monday promised that he would repeal the Land Titling Act brought by the YSR Congress Party (YSRCP) government if his party was voted to power.

Addressing a huge gathering in Anakapalli district, the former Chief Minister said that the Land Titling Act was draconian in nature. "This Act has been framed to enable the land grabbers of the YSRCP to take over your (voters) land by changing the details of the documents online in connivance with the officials. I will not let that happen," he said.

Claiming that the YSRCP had failed the farmers miserably, Mr. Naidu said if elected to power, he would focus on the Sujala Sravanthi project to help farmers irrigate over 8 lakh acres of land in the Uttarandhra region. He also promised to finish the Polavaram project and bring the Godavari water to Raiwada reservoir so that the drinking water issues of the Uttarandhra and Visakhapatnam were sorted out permanently.

In a direct attack on Mr. Jagan, Mr. Naidu referred to the YSRCP's slogan 'Sidham' (ready) and asked the people if they were "ready to throw the ruling party out of power". "Mr. Jagan is not a mentally stable man. He may attack you, himself or even me, so before he can cause further damage, are you 'sidham' to remove him?" he asked.

SC dismisses petition on Sabarimala registration

Viswanathan asked the petitioner, K.K. Ramesh, to approach the Kerala High Court. The petition said the registration should be like that done in the Amar-

nath Shrine Board. The petitioner said a master plan should be framed to regulate the crowd visiting the temple.

CMRL pay-off case: SFIO begins probe, inspects Aluva office

A team of officials from the Serious Fraud Investigation Office (SIFO) under the Ministry of Corporate Affairs carried out an inspection at the corporate office of the Cochin Minerals and Rutiles Ltd (CMRL) at Aluva in Kerala on Monday as part of its probe into the alleged illegal payments made by the company to T. Veena, daughter of Chief Minister Pinarayi Vijayan, and her firm Exalog-

ic Solutions Pvt. Ltd. It is learnt that the officials checked the documents related to the alleged pay-offs made by the company to Ms. Veena and her firm. Sasidharan Kartha, managing director of the company, was present

at the office at the time of the inspection. The inspection team was reportedly led by M. Arun Prasad, deputy director of SFIO.

The SFIO had set up a six-member team after the Union government ordered an investigation under Section 212 (1) (a) & (c) of the Companies Act into the affairs of Exalogic Solutions Pvt Ltd, the CMRL and the Kerala State Industrial Development Corpo-

ration (KSIDC) Ltd, a State government entity that has a 13.4% stake in the CMRL.

The controversy had erupted after the Income Tax Interim Settlement Board released a report in August 2023 stating that Ms. Veena and her company had received ₹1.72 crore over the last three years as monthly payments from the CMRL despite there being no evidence of any services given in return.

The documents seized by the Income Tax department had allegedly included details of payments made to politicians, temples, government servants and media houses.

The Opposition parties had demanded that Mr. Vijayan should resign following the SFIO investigation ordered by the Centre.

Quad summit more likely after U.S. polls in November: envoy

U.S. Ambassador Eric Garcetti says the Quad agenda will be more productive by 2024-end; at a discussion on the grouping's new version, former officials clarify it was the U.S. and Australia, and not India, that pulled out of the Ouad in 2007

eaders of the Quad nations may not be able to meet for a summit in India before the U.S. elections, U.S. Ambassador Eric Garcetti said, stressing that the Quad agenda would be "more productive" by 2024-end. Australia, India, Japan, and the U.S. form the Quad.

Mr. Garcetti, who was speaking at a discussion with envoys from Australia and Japan and former officials at the Jaipur Literature Festival over the weekend, indicated that the election schedules and campaign requirements would make it difficult for U.S. President Joseph Biden to travel to Delhi. Mr. Biden had earlier declined an invitation to attend the Republic Day parade followed by the Quad summit, with the dates proposed by New Delhi for January 26-27.

"Absolutely. It will take place right after the elections," Mr. Garcetti said in

response to a question from The Hindu, clarifying that he meant the U.S. elections, to be held on November 5, 2024.

"As exciting as 2023 was for bilateral relations, with PM Modi's state visit, President Biden's visit to India for the G-20 summit, India being the number one destination for U.S. Cabinet members, and Treasury Secretary Yellen visiting the country four times, we need time to put the agenda back together... This will make the end of the year have more productive outcomes," the U.S. envoy

Mr. Garcetti said there would be some Quadrilateral discussions on technology later this month on the sidelines of the Initiative on Critical and Emerging Technologies (iCET)

U.S. National Security Adviser Jake Sullivan is expected to lead a delegation to Delhi for talks with his Indian counterpart, Aiit Doval, for the iCET intersessional meetings, and to address the annual Raisina Conference organised by the External Affairs Ministry and the Observer Research Foundation on February 21-23.

Mr. Garcetti, however, rejected the idea that the election schedule, or the possibility of Republican frontrunner and former President Donald Trump defeating Mr. Biden in the elections, would affect the India-U.S. bilateral or Quadrilateral relationship.

How it ended

The panel, which included former Australian Prime Minister Malcolm Turnbull and former Indian Foreign Secretary Shyam Saran, also shed light on how the first round of Quad engagement from 2005 to 2007 had come to an end, until it was revived in 2017 by the four countries involved.

According to Mr. Turnbull, it was Australia that publicly announced its decision to pull out of the Quad first in 2008, although Mr. Saran added that behind the scenes, it was the then-Bush administration that had directly asked India "not to push [the Quad] forward".

The accounts are at some variance with the belief that it was India, not the U.S. and Australia, that ended the Quad's earlier version.

During a speech in February 2023, External Affairs Minister Jaishankar had said that "in 2007, one country put pressure, you can guess which one and we backed down," he said referring to pressure from China, and comparing the responses in 2007 against 2017.

Mr. Saran, however, described a phone call from a senior U.S. official just before the then Prime Minister Manmohan Singh's visit to Tokyo in 2006.

"Please tell your PM not to encourage Abe [the then Japanese PM] on the Quad. This is not the time we should push this forward," he said. Mr. Saran added the official cited the Iran nuclear deal and North Korea six-party talks as reasons for the U.S.'s desire to not annoy Beijing in 2006.

Centre moves Bill for OBC quota in J&K local bodies

The Union government on Monday introduced a Bill in the Lok Sabha to provide reservation to Other Backward Classes (OBCs) in panchayats and municipal bodies in Jammu and Kashmir.

Union Minister of State for Home Nityanand Rai introduced the Bill on Monday. The number of seats reserved for OBCs will be decided by a commission that will be formed after the legislation is passed by Parliament.

Currently, there is no reservation for OBCs in panchayats and municipalities in the Union Territory.

The Statement of Objects and Reasons of The Jammu and Kashmir Local Bodies Laws (Amendment) Bill, 2024 said the Bill aims to provide reservation to OBCs in the local bodies and bring consistency in the laws with the provisions of the Constitution. "With this, justice will be ensured to the citizens of Other Backward Classes of Jammu and Kashmir for the first time after 75 years of Independence," it said.

7-judge Bench to hear pleas on SC, ST subgroups

A seven-judge Constitution Bench headed by Chief Justice of India D.Y. Chandrachud is scheduled to hear from February 6 a series of petitions regarding the validity of sub-classification among reserved categories. Lawyers representing several reserved communities across the country are appearing in the case

The sub-classification case dates back to 2020 when a five-judge Bench led by Justice Arun Mishra (retd) held that States could sub-classify Scheduled Castes and Scheduled Tribes in the Central List to provide preferential treatment to the "weakest

out of the weak". The questions referred to the seven-judge Bench for an authoritative decision include whether subclassification could be permitted for the SC and ST categories as the same was permitted for the Socially and Economically Backward Classes category.

HC CJ can take a call in case against T.N. Minister, says SC

The Supreme Court on Monday left it to the discretion of the Chief Justice of the Madras High Court as master of roster to allocate an appropriate Bench to hear a suo motu revision proceedings against Tamil Nadu Revenue Minister K.K.S.S.R. Ramachandran in a corruption case.

An apex court F

headed by Justice Hrishikesh Roy, however, orally expressed reservations about Justice Anand Venkatesh, acting as a Single Judge Bench of the Madras High Court, taking suo motu cognisance to revive the case. Justice Roy said the judge ought to have ideally placed the matter before the Chief Justice of the Madras High Court for passing an order numbering the suo motu case and assigning it to a Bench. "We deem it appropriate to say that the suo motu matter should be considered by the Chief Justice. He may

either proceed to take up

the matter himself or may assign it to a judge of the High Court, as he may consider appropriate," the apex court recorded in its

The Bench noted that all proceedings should emanate from the office of the Chief Justice in his administrative capacity of the master of the roster of the particular High Court. "The learned judge could have ideally directed the Registry to obtain orders of the Chief Justice of the High Court to allot suo motu revision number. Instead, a direction was issued to the Registry to allot suo motu revision number for the case being handled by the Judge," the apex court not-

In November last year, the lawyers of Tamil Nadu **Higher Education Minister** K. Ponmudy and his wife were in for a surprise when Chief Justice of India D.Y. Chandrachud praised the initiative taken by Justice Venkatesh to initiate suo motu proceedings against their clients.

Last edition of Rozgar Mela before polls on February 12

Prime Minister Narendra Modi will address the last edition of the Rozgar Mela before the Lok Sabha election on February 12. The recruitment drive aims to fill vacancies in Central government offices. Over 1 lakh appointment letters are expected to be distributed during the event.

The cumulative appointments with the help the expedited recruitment drive are expected to hover around eight lakh, a shortfall of two lakh appointments against the target of 10 lakh jobs as announced by the Prime Minister in 2022.

On June 14, 2022, Mr. Modi announced that 10 lakh existing Central government vacancies will be filled by December 2023 on a "mission mode."

In July 2022, the Department of Personnel and Training (DoPT) constituted a task force comprising officials from five Ministries, including Defence, Home, and Railways, asking all government depart-

ments to state the vacant 13, 2023 (70,000 letters) positions and steps taken to fill those posts.

"So far 11 editions of Rozgar Mela have been held. The last and the 12th edition will be one of the biggest recruitment drive as over 1 lakh vacancies will be filled in one go," said a senior government

The previous editions of the Mela were held on October 22, 2022 (75,000 appointment letters distributed); November 22, 2022 (71,000 letters); January 20, 2023 (71,000 letters); April 13, 2023 (71,000 letters); May 16, 2023 (71,000 letters); June July 22, 2023 (70,000 letters); August 28, 2023 (51,000 letters); September 26, 2023 (51,000 letters); October 28, 2023 (51,000 letters); and November 30, 2023 (51,000

letters). On July 27, 2022. the DoPT informed the Lok Sabha that over 7.22 lakh people got permanent Central government jobs between 2014-15 and 2021-22. The government received over 22 crore applications, the reply said.

The Railway Ministry informed the Lok Sabha in August 2023 that there were over 2.6 lakh vacancies in various divisions.

'Shared interest between India, U.S. to figure out civil nuclear cooperation'

Terming the India-U.S. nuclear cooperation envisaged under the nuclear deal two decades ago as "an important piece of unfinished business", U.S. Assistant Secretary of State for Energy Resources Geoffrey R. Pyatt said on Monday there is a "shared interest" to figure out how the two countries can move forward, both on the large traditional reactors which were foreseen as part of the nuclear deal but also importantly the "fantastic new opportunities" that are emerging around Small and Modular Reactor (SMR) technology.

Elaborating on the civil nuclear cooperation, Mr. Pyatt referred to the con-

versations he had in India, especially at the India-U.S. Forum and said he found strong interest from Indian companies, including Adani, Tata, Reliance, Birla, all of whom have expressed interest in using SMRs as part of their larger decarbonisation strategy. "Now to move forward

figure out how to scale these SMR concepts to take the designs that have been developed and get them to the stage of regulatory approval and industrial deployment. lmost no country seems to adhere to fixed fiscal goals any more, Finance Secretary T.V. Somanathan said, emphasising that the country's high growth trajectory should enable a gradual decline in its debt to Gross domestic product (GDP) ratio. He also noted that inflationary risks have not disappeared so the Central bank, which is reviewing the monetary policy this week, has to strike a delicate balance between growth and price rise concerns. Edited excerpts:

The [interim] Budget gives some broad directions on the government's focus areas for its next term. Can we expect more action points in the identified reform areas in the full Budget likely in July?

Definitely, you can expect more details. But it's too early to say what they will be, as things will evolve between now and then. It's a matter of timing between the new government taking charge and the presentation of the Budget.

The fiscal outlook is not

likely to change substantially, but the composition of programmes or scheme expenditures may change. But nothing can be ruled out. It is, after all, a vote on account and not a full Budget. So, who am I to preempt any decision that could very legitimately be taken? We have made fiscal projections with the infor-

mation, policies and data

available to us today.

The plan to lower borrowings and tackle the fiscal deficit has surprised many. Is there an underlying message to Mint Street?

Unlike monetary policy communication, where communication is itself a



part of the policy, our Budget is not intended as a message to anyone, whether it is bond markets, rating agencies or the Central bank. It is a communica-

tion of the substance of government's fiscal policy, and the direction it wants to take for our own longterm welfare and benefit. It may have implications or

inputs for others in their decision making. That is for them to take into account. There is no intention to use this to communicate anything - that is a burden this statement cannot bear – it can only bear the burden of being a truthful account of what we expect fiscally. That is

But would easing monetary policy help the broader aim to spur investments and jobs?

That is a matter for the Reserve Bank of India to decide because they also have to keep an eye on inflation. The balance between growth and inflation is a delicate one. It's not as if inflationary risks are totally absent. I don't want to be prescriptive on that.

The goal to take Central government debt to 40% of debt was set before the pandemic. How do we recalibrate the target?

Personally, I feel the legitimate aspiration would be to see a gradual decline in our debt to GDP ratio.

Beyond that, one should not be unrealistic. Internationally, the remedy of rigid, statutory fiscal targets is getting discredited. This is not unique to India. Almost no one any longer seems to adhere to a rigid, long term fiscal target neither the European Un-

ion nor many other countries. There are almost no exemplars for that model any more, and perhaps its continued relevance is questionable. A more nuanced and realistic approach to debt sustainability and fiscal responsibility is required. Actually, our debt levels are not very high by global standards if you look at other G-20 economies, and we have a very high nominal growth rate which is likely to be sustained for a long time.

Our growth-rate interest-rate differential is quite favourable compared to many economies. We have high growth, so sustainability is better. This fixation with a single number doesn't work any more.

Nirmala, Adhir spar in Lok Sabha over funds for Karnataka

The Lok Sabha on Monday witnessed a sharp exchange between Union Finance Minister Nirmala Sitharaman and Congress leader Adhir Ranjan Chowdhury after the latter alleged discrimination in devolution of funds to Congress-ruled Karnataka and other non-Bharatiya Janata Party-ruled States.

Replying to a supplementary question by Mr. Chowdhury during the Question Hour, on the Karnataka government's claim that the Centre was not releasing funds that are due to them, she said that devolution of funds was as per recommendations of

the Finance Commission. "This apprehension that some States are being discriminated against is a polwhich, I am sorry to say, vested interests are happy to go about saying," the Fi-

nance Minister said. "This is just not a possibility that any Finance Minister can intervene to say that 'I don't like this State, stop payment'..... It can't happen that way. The system is well placed...I have no right to change the rules as per my whims and fancies ... I have no role to play.," she said.

"That is what I have done in my term. All Finance Ministers do that. Implement the recommendations of the Finance Commission. It is done without fear or favour," Ms. Sitharaman added.

'Not getting its due'

Mr. Chowdhury said that there was a perception that non-BJP States were not getting their "legitimate

"Six months ago, the situation was not there and everything was hunky dory. After the installation of the new government, a non-BJP government has assumed office, trouble has started. What is the reason?" he asked.

Sitharaman said, "If the expenditure is going in areas which it cannot sustain by your Budget, I am not answerable. Which government was there till six months ago is not my role to talk about. If it was hunky dory then and now it is not, introspect, please."

Sukhendu Sekhar Ray, who started the debate, said the Centre was hounding Opposition leaders using the Central agencies. Attacking the concept of "one nation, one election," he said the BIP's aim was to destroy federalism.

Ayodhya event and PM CPI(M) MP John Brittas said none of the speeches by the BJP members were completed without Ayodhya and without mentioning Prime Minister. "The

primary responsibility of the Prime Minister is to give 'pran' [life] to citizens, not the Gods. He should obviously stick to his duties... he should go to Manipur and conduct a `Pran That should be done first," he said.

Shiv Sena (UBT) MP Arvind Ganpat Sawant said his party was happy about the Ram temple construction. "We should also remember those who sacrificed their lives for the Ram temple. The temple construction has been made possible today not because son," he said.

YSRCP leader Vijai Sai Reddy said the Congress's existence would be in doubt after the 2029 election as the party's electoral performance had been consistently poor in the past 10 years.

BJP MP Sudhanshu Trivedi and senior leader Sushil Modi led the counter-attacks of the Treasury benches. Mr. Trivedi said the demand for a caste census from the Congress was a proof of the lack of concern the party had for the welfare of people from backward classes. "You are only indulging in castebased politics," he said.

Mr. Trivedi said former Nehru, Indira Gandhi and Rajiv Gandhi did not believe in caste politics, but the present leadership of the Congress was banking on caste census.

Mr. Sushil said economic and social indicators of the country had improved in the last 10 years.

Despite court orders, AAP leader not called for taking oath in RS

Despite directions from a Delĥi court, Aam Aadmi Party leader Sanjay Singh, who was recently elected to the Rajya Sabha for a second term, could not take oath on Monday in the absence of summons from the House Secretariat. Mr. Singh was not called

for the ceremony as four cases of breach of privilege are pending against him before the Privileges Committee of the Upper House, said sources in the office of Chairman Jagdeep Dhankhar. The cases pertain to Mr. Singh's previous tenure. He was suspended on July 24, 2023. On August 11, the House passed a motion continuing his suspension till the committee submitted its findings.

Mr. Singh, who is in judquor policy case, did not come to Parliament on Monday. Special Judge M.K. Nagpal had on Saturday directed the Jail Superintendent to ensure that Mr. Singh was taken to Parliament on Monday to be sworn-in, under the condition that he would not ad-

dress the press.

Mr. Dhankhar's office said, "Summons were not issued to Mr. Sanjay Singh as he suffered the directives of the House passed on August 11, 2023, disentitling him from participating in the proceedings of the House till the House takes decision on the report of the committee of privileges as and when presented to it. The fact that this matter pertains to his previous term has no im-

Reacting to the incident, Rashtriya Janata Dal MP Manoj K. Iha said in a X post, "Our friend Mr. Sanjay was deprived of taking oath today after being elected as MP... This is the new parliamentary paradigm of the so-called Amrit Kaal."

Time to end all signs of slavery: U.P. BJP MP bats for renaming India as 'Bharat'

BJP leader from Uttar Pradesh Satya Pal Singh said in the Lok Sabha on Monday that the name of the country should be changed from India to Bharat as it was time to end all signs of "slavery". He made the statement while participating in the debate on the Motion of Thanks to President's Address.

"One sign of slavery is there in the Constitution. Article that says India that is Bharat. This India should end as the country's name is Bharat," said Mr. Singh.

Hailing the construction of Ram Mandir at Ayodhya, Mr. Singh called it the symbol of faith of millions of people.

Responding to his statement, several Opposition leaders questioned the dominance of religion in affairs of the state. Congress MP from Kerala, Benny Behanan, said the Narendra Modi government was leading the country to-

wards a "Hindu Rashtra".

"I am afraid our country is heading towards a theocracy by interlinking state and religion. Our Prime Minister, who is a state representative, was recently a part of the pran prathistha [consecration ceremony] of the Ram Mandir at Ayodhya, clearly violating the idea of maintaining principled distance between the state and religion as mandated by secularism," Mr. Behanan said.

'Niti and Rajniti'

Shiv Sena (UBT) MP Arvind Sawant said Lord Ram was a matter of *niti* (policy) for his party but for others, it was rajniti (politics).

Trinamool Congress member Shatabdi Roy also took a swipe at the BJP over its claim that only the Narendra Modi government could build the Ram Temple at Ayodhya.

"He [Mr. Modi] is a very powerful person. He can bring god [back to Ayodhya]. He has so much power that he can bring back god but he cannot bring back mere mortals such as Nirav Modi, Mehul Choksi or Vijay Mallya. Can he not bring back black money? These are the questions facing the country," said Ms. Roy, who represents Birbhum in the Lok Sabha.

Seeking to poke holes in the government's claims of pulling out 25 crore people from multi-dimensional poverty, Ms. Roy argued that the data pertained to COVID-19 pandemic years when surveys were not conducted.

She said issues such as unemployment, high inflation, safety and security of girl child, MSP for farmers, violence in Manipur, and the reality of the suffering of train passengers were missing from the President's address.

Bill to check cheating in govt. recruitment exams introduced

The Union government introduced a Bill in the Lok Sabha on Monday to check malpractices and organised cheating in government recruitment exams, proposing a minimum of three years' imprisonment and a fine of up to ₹1 crore for persons and organisations indulging in such illegal practices.

The Public Examinations Bill was moved by Union Minister Jitendra Singh in the Lok Sabha on Monday.

The Statement of Objects and Reasons of the Bill said that malpractices in public examinations lead to delays and cancellation of examinations adversely impacting the prospects of millions of youth.

"Therefore, it is imperative that elements that exploit vulnerabilities of examination system are identified and effectively dealt with by a comprehensive Central legislation," the statement said.

The **Bill proposes a** minimum of three years' imprisonment and a fine of up to ₹1 crore for persons indulging in cheating

The Public Examinations (Prevention of Unfair Means) Bill, 2024 mentions "leakage of question paper or answer key", "directly or indirectly assisting the candidate in any manner unauthorisedly in the public examination", and "tampering with the computer network or a computer resource or a computer system" as offences done by a person, group of persons or institutions.

"Any person or persons resorting to unfair means and offences under this Act shall be punished with imprisonment for a term not less than three years but which may extend to five years and with fine up to ₹10 lakh," said the Bill.

The Bill shall serve as a model draft for States to adopt at their discretion.

India can give befitting reply if attacked by any external forces, Rajnath tells Adhir

Plea for ASI survey of

Days after a district court allowed *puja* inside one of the cellars of the Gyanvapi mosque in Varanasi, a Hindu plaintiff on Monday moved a fresh application before the court, seeking that directions be given to the Archaeological Survey of India (ASI) to conduct a thorough survey of the remaining cellars inside the disputed structure.

The petitioners, Rakhi Singh, who is plaintiff no. 1 in the pending Shringar Gauri worshipping suit of 2022 at a Varanasi court, maintained that the survey of the remaining cellars was necessary to ascertain the religious character of the property in question.

In her application filed under Section 75(e) and Order 26 Rule 10A r/w Section 151 of the Code of Civil Procedure, Ms. Singh claimed that that within the Gyanvapi premises, cellar numbers N1 to N5 (in the north) and S1 to S3 (in the south) exist, and cellar numbers N1 and S1 are completely not accessed because their entrances are blocked.

"She hence demands that the survey of the unaccessed area of the mosque be done by removing the blocked entrance and debris through a safe metho-

dology," advocate Saurabh Tiwary, Ms. Singh's counsel, said.

The court will hear the matter on Tuesday.

Shree Jagannatha, Lord of The Universe is a compilation of short articles encompassing various aspects of rich traditions including the Rath Yatra of Lord Jagannath. Experts on Jagannath culture, journalists, and former bureaucrats have contributed to the book through their authoritative writings.

"This picture-rich coffee-table book attempts to tell the story of Shree Jagannatha worship, the temple, and its traditions. It can by no means claim to be a comprehensive account. It is but a humble effort to explain to people the uniqueness of Shree Jagannatha, literally the Lord of the Universe," said Mr. Srinivasan.

The sibling deities are known as living divine beings. The book's Editor's Note points out, "Like humans, the idols undergo a process of biological change and are replaced by a new set of idols periodically. Again, in a departure from tradition, the moola vioraha, or the main deity, emerges out of the temple twice a year to give darshan to devotees.'

Photographs have vividly captured events around the Shree Jagannath Temple, which was built in the 12th Century CE.

CBSE urges schools to prepare for National Credit Framework roll-out

The Central Board of Secondary Education (CBSE) has urged principals of schools affiliated to the board to start contemplating the pattern for allocating credits to students for niects in line with the National Credit Framework (NCrF).

The CBSE has proposed draft guidelines open for feedback from its affiliated schools, The Hindu has

Sample framework

The board is set to notify a new set of credit framework for schools next year from Classes 9 to 12, and in anticipation of the notification, has asked its schools to start implementing a sample credit framework at least for Classes 9 and 11.

As per the existing regu-

lations, a student has to clear five subjects (two languages and three main subjects - maths, science and social science) to pass the class. "Nearly 1,050 hours are allotted to five compulsory subjects. In order to aid teachers to implement the credit framework, we have allotted an additional 150 hours for internal assessment of subjects like Physical Education and Health, Art Education, a skill-related subject, and a third language," a senior CBSE official said.

Currently, a Class 9 student passing with five compulsory subjects and completing internal assessment of remaining

mentioned subjects will earn at least 40 credits. "In case the student opts for a sixth or seventh subject, and passes the five compulsory subjects, extra credits totalling up to 54 can be earned," the official

Ten subjects

The CBSE proposal says while this is applicable for the current academic session, when the new curriculum according to the Na-Framework kicks in for 2024-2025, students in Classes 9 and 10 will have to study 10 subjects compulsorily.

Additional subjects include a compulsory third language, one subject in inter-disciplinary area, physical education and health, art education, and a skillrelated subject.

Of the three languages, two will have to be native to India.

"Under new NCF, importance is given to Physical Education and Art Education. Every child will learn three languages," the ___ official said.

Academic locker All credits collected by stu-

dents will be stored in their academic bank of credit in the students' DigiLockers. The Ministry of Education is also working on systems to reconcile credits in case the student goes abroad. The idea of introducing credits right from schoollevel is to also reconcile it with higher education systems (consisting of undergraduation, post-graduation, and diplomas) for assessment and equivalence

"We are urging schools to internally start implementing the credit system according to the guidelines we are issuing so that they are better prepared to implement it officially after it is notified next year," the official further said.





The unusual cabbage mutation that could boost crop yield

Forty-four years ago, people found a plant that couldn't make pollen. All the seeds from these plants were the result of their eggs being fertilised by pollen from plants of other strains; none came from the same strain. The former seeds germinated to produce more robust plants

he males of plants as diverse as cabbage, cauliflower, broccoli, tomato, and rice can be made sterile by deleting a very small part of their genome's DNA. This is the take-home message of a paper published in the journal Nature Communications in October by researchers at the State Key Laboratory of Vegetable Biobreeding of the Chinese Academy of Agricultural Sciences, Beijing.

The simple deletion resulting in such a drastic outcome brings to mind the story of a kingdom that was lost for want of a horseshoe nail. But here, instead of loss, the researchers assure us of a gain: that the deletion could lead to an abundant harvest of these plants, thanks to a process called heterosis.

Genes and promoters

The DNA molecule consists of two long strands. Each strand is composed of four compounds called nucleotide bases. They are designated A, C, G, and T for simplicity (for adenine, cytosine, guanine, and thymine respectively). An A on one strand makes chemical bonds, called hydrogen bonds, with a T on the other and a C on one strand makes hydrogen bonds with a G on the other.

The bonds between As and Ts and the bonds between Gs and Cs hold the two DNA strands together. A base-pair, or bp for short, is a single A-T or G-C pair between the two strands, with the dash denoting the bond.

The genome of the cabbage plant (Brassica oleracea) consists of around 1.06 billion base-pairs organised in 18 chromosomes, which every cell holds in nine pairs of two each. In each pair of two chromosomes, one chromosome comes from the pollen and the other comes from the egg. The DNA (which is all the base-pairs together) in every chromosome pair share a mostly identical sequence of

base-pairs. A *gene* is a well-defined sequence of typically a few thousand base-pairs, or a few kilo base-pairs (kbp), in the DNA molecule. When a gene is expressed, it means a segment of the base sequence on one of its strands is copied into the sequence of bases in a related molecule,

DNA and RNA are the master and working copies of a gene. The RNA is loaded into a cellular machinery called the ribosome. The ribosome uses the base sequence of RNA to specify the sequence in which amino acids are linked together to create the protein encoded by the gene.

In short, a gene's DNA sequence defines the amino acid sequence of its encoded protein and the protein's structure. The cell uses the RNA and the ribosome to manufacture this entity.

Pollen loss promotes heterosis

Around 44 years ago, people found a cabbage plant that contained a natural mutation. As a result of this mutation,

they found that the plant had lost the ability to make pollen.

At first, scientists didn't know which particular gene in the plant had been mutated. They only named the altered gene, whichever it was, Ms-cd1.

The mutation's effect was to make the plant male-sterile, but they had no other defects. In fact, the eggs of the mutant plant could be fertilised by pollen from a normal plant, and the fertilised eggs would go on to make normal seeds.

In other words, all the seeds from the mutant plants were the result of the plants' eggs being fertilised by pollen from plants of other strains - a process called out-crossing. None of their seeds came from self-crossing. (In a self-cross, an egg is fertilised by pollen of the same strain.)

Out-cross seeds - which are also called hybrid seeds - germinate to produce more robust plants than self-cross seeds. This is because of a phenomenon called hybrid vigour or, in technical terms, heterosis.

The missing base-pair

The researchers who conducted the new study showed that seeds from the male-sterile plant consistently made bigger cabbages.

Specifically, they found that the Ms-cd1 mutation was dominant - meaning that if the mutant gene was present in only one of the chromosomes of the pair, the plant wouldn't be able to make pollen. It didn't matter if the other chromosome had a non-mutated gene.

Dominant mutations are relatively rare. Mutations are commonly recessive, meaning the same gene has to be mutated

in both chromosomes for its effects to be expressed. Fortunately for us, it is easier to scale up the production of hybrid seeds using dominant male-sterile mutations. One part of this process has to do with fine-tuning protein levels when making

As it happens, it's not necessary that all of a gene's DNA sequence is copied into RNA. Some sequences aren't copied, and one of them is the *promoter*. This sequence binds to regulatory proteins that determine when and in which cells a DNA sequence is copied to RNA.

The Ms-cd1 gene of cabbage is about 6 kbp long. Its promoter binds to a regulatory protein called ERF. This binding keeps the *Ms-cd1* gene from being expressed.

Using an approach called genetic mapping, the researchers found that the only difference between a mutated Ms-cd1 gene and a non-mutated Ms-cd1 gene was that the promoter in the former was missing one DNA base-pair. This minuscule absence destroyed its ability to bind to ERF. As a result, the Ms-cd1 protein continued to be expressed when in fact it should have been repressed.

The eventual outcome: the plant couldn't produce pollen and became male-sterile.

and the recessive mutations derailed pollen development in different ways which was an indication that the plant makes pollen properly only if it can make the Ms-cd1 protein in copious amounts at some stages, while in other stages its levels are repressed by ERF binding to the gene's promoter.

The researchers also introduced the (dominant) mutant gene into other plant species, such as rice, tomato, and arabidopsis (Arabidopsis thaliana, a favourite of plant biologists for research). In every case the recipient plants failed to make pollen. This showed that the pollen development pathway, along with the ways in which a plant can fine-tune it,

So deleting the base-pair offers us a new tool to produce hybrid seeds in these and other crops.

China has taken the open source route to evade

China bets on open-source chips to evade sanctions

When a Beijing-based military institute in September published a patent for a new high-performance chip, it offered a glimpse of China's bid to remake the half-trillion dollar global chip market and withstand U.S. sanctions.

The People's Liberation Army's (PLA) Academy of Military Sciences had used an open-source standard known as RISC-V to reduce malfunctions in chips for cloud computing and smart cars, the patent filing shows.

RISC-V is an instruction set architecture, a computer language used to design anything from smartphone chips to advanced processors for artificial

The most common standards are controlled by Western companies: x86. dominated by U.S. firms Intel and Advanced Micro Devices, and Arm, developed by Britain's Arm Holdings, owned by SoftBank Group.

Beijing and dozens of Chinese state entities and research institutes, many sanctioned by Washington, invested at least \$50 million in projects involving RISC-V between 2018 and 2023

U.S. and UK export controls prevent the sale of only the most advanced x86 and Arm designs - which produce the highest-performance chips - to clients in China.

But as the U.S. widens restrictions on China's access to advanced semiconductors and chip-making equipment, the open-source nature of RISC-V has made it part of Beijing's plan to curb its dependence on Western technology, although the emerging architecture accounts for a fraction of the chip market.

"The biggest advantage of the RISC-V architecture is that it is geopolitically neutral," the Shanghai government's Science and Technology Commission said in a report published in April.

Beijing and dozens of Chinese state entities and research institutes, many sanctioned by Washington, invested at least \$50 million in projects involving RISC-V between 2018 and 2023, according to a Reuters review of over 100 Chinese-language academic articles, patents, government documents and tenders, as well as statements from research groups and companies.

While the figure is modest, recent RISC-V breakthroughs and applications in China, many with government funding, have raised Beijing's hopes that the open-source standard could one day threaten the x86-Arm duopoly, according to state media. Intel and AMD did not respond to questions about the matter, while Arm declined to comment.

RISC-V chips made by Chinese firms and research institutes can now power self-driving cars, artificial-intelligence models and data-storage centres, according to two industry figures and the previously unreported documents.

The military science academy did not respond to a request for comment sent via China's State Council.

Arm and x86 are closed architectures, meaning they are proprietary and charge users a license fee. Their outlines are thousands of pages long, with complex instructions and numerous incompatible versions that can only be modified by their developers.

RISC-V is free to use and has a simpler outline, often leading to more energy-efficient chips, and users can build atop the framework to suit their needs.

Half of the more than 10 billion RISC-V chips shipped globally by 2022 were made in China, the state-run China Daily reported in August.

Honour and exception

Choice of past leaders for Bharat Ratnas is in tune with politics of the present

he Bharat Ratna, the highest civilian honour of the country, has been conferred on 50 people since 1954. Bharatiya Janata Party (BJP) leader L.K. Advani and the late socialist leader, Karpoori Thakur, are the newest recipients. The making of national heroes is equally about the recipients as it is about its function as a stimulant of a collective consciousness. It is often the collective that needs heroes to hold itself together. By placing leaders on a higher pedestal, the group seeks to reinforce ideals represented by them. Mr. Advani has been a defining figure of modern Indian history. As he reminisced, he joined the Rashtriya Swayamsevak Sangh at the age of 14. His role in the advancement of the Hindutva ideology has been the biggest by any single leader before Prime Minister Narendra Modi. He has been a mentor to Mr. Modi, with his campaign for a temple in Ayodhya definitively changing the course of Indian politics. The campaign pushed the limits of constitutional order, based on the claim that matters of faith cannot be subject to litigation. As it happens with an extraordinary assertion of popular sovereignty, the Ram Janmabhoomi movement changed the country at several levels; the Supreme Court of India, by 2019, unanimously ruled in favour of the temple that was inaugurated by Mr. Modi on January 22.

Thakur was a central figure in the social justice politics – a euphemism for the demand for better representation of intermediate castes - of Bihar and the larger Hindi belt, who challenged the Congress's hegemony. He served two terms as the Chief Minister of Bihar in the 1970s. Social justice politics went through phases of self discovery, and scattered into numerous parties over the years. One strand is closely aligned with the BJP. There are social justice groups that are still opposed to it, but the BJP owes its current strength considerably to intermediate castes. That ongoing process is being reinforced by honouring Thakur. In 2015, A.B. Vajpayee, the first Prime Minister from the BJP, and Madan Mohan Malaviya, the founder of the Banaras Hindu University, were conferred the Bharat Ratna. In 2019, Pranab Mukherjee, Bhupendra Kumar Hazarika, and Nanaji Deshmukh were recipients. All these selections are in tune with the politics of the present – and how the history of the Bharat Ratna has always been. All India Anna Dravida Munnetra Kazhagam founder M.G. Ramachandran and B.R. Ambedkar were also conferred the award in the hope that their followers would, in turn, back the party or alliance ruling at the Centre. Mr. Advani and Thakur represent the two legs of BJP politics, namely Hindu consolidation and higher representation for intermediate castes in all fields.

First among firsts

The growth of Sinn Fein in Northern Ireland is significant in itself

he rise of the Sinn Fein's Michelle O'Neill, as the first nationalist First Minister of Northern Ireland, is an indication of how the region's political landscape is changing. If the Sinn Fein, which began as the political arm of the Irish Republican Army (IRA), was on the fringes for decades, it is now a powerful political force in Northern Ireland (part of the U.K.) and the Republic of Ireland (an independent country and European Union member). In the 2020 elections, the Sinn Fein won the largest share of votes. And in 2022, it emerged as the largest party, with 29% of the vote share, in elections in Northern Ireland, while the pro-U.K. Democratic Unionist Party (DUP) finished second with a 21.3% vote share. According to the 1998 Good Friday agreement. which ended three decades of sectarian violence known as the Troubles, Northern Ireland's government should include representatives of the largest and second largest political blocs (unionists, who are largely Protestants, as well as republican nationalists, who are mostly Catholics). After the 2022 vote, Northern Ireland saw chaos with the DUP refusing to join hands with the Sinn Fein to form the government, citing its opposition to the Northern Ireland Protocol, which London had agreed on with Brussels to manage post-Brexit trade between the U.K. and the EU. The DUP alleged that the Protocol, which introduced checks on goods being transferred from Britain to the island of Ireland, weakened the union.

In a realistic assessment of the situation, the DUP decided to return to the power-sharing agreement after London agreed to reduce customs checks on the Irish border and spend some £3 billion in Northern Ireland to steady the region's finances. The Sinn Fein, which campaigned on bread and butter issues and promised to address immediate administrative challenges, is now formidable, and delaying the power-sharing agreement will not weaken the nationalists. For the Sinn Fein, which is still committed to the unification of the two Irelands, taking over the office of the First Minister is historic. Party leader Mary Lou McDonald has said that unification is now "within touching distance". It need not be so, as a majority of Northern Ireland's voters still prefer being a part of the U.K. Also, the posts of First Minister and Deputy First Minister (to be held by the DUP) are technically equal. However, the symbolic value of the Sinn Fein leading the government in Northern Ireland and being the largest bloc in the Republic of Ireland amid rising economic and political discontents in the island, especially after Brexit, cannot be understated. After decades of the Troubles followed by political reconciliation, the nationalists are on the ascendant, while the unionists are on the back foot.

A critical view of the 'sanitation miracle' in rural India

n the past decade, improving sanitation coverage has been one of the key public policy miracles in India. Access to water and sanitation is Goal 6 in the 17 Sustainable Development Goals envisaged by the United Nations. Public sanitation programmes have a long history in the country, beginning with the launch of the highly subsidised Central Rural Sanitation Programme (CRSP) in 1986. The Total Sanitation Campaign in 1999 marked a shift from a high subsidy regime to a low subsidy one and a demand-driven approach. The public sanitation programme evolved as a mission in 2014 under the Swachh Bharat Mission-Grameen (SBM-G) to make India Open Defecation Free (ODF) by October 2019.

Data and behavioural patterns

According to information by the Government of India, sanitation coverage in the country improved from 39% in 2014 to 100% in 2019. Encouraged by the achievements under the SBM, the government launched Phase II of the SBM-G. The focus here was on the sustainability of initial achievements by promoting solid and liquid waste management and covering those households left out earlier. The government aims to transform India from ODF to ODF Plus by 2024-25. Around 85% of villages in India have become ODF Plus, according to government data. Nevertheless, this impressive performance also needs to be viewed from the perspective of behavioural change, which will usher in sustainability in a true sense.


The construction of toilets does not automatically lead to their use. A National Sample Survey Office (NSSO) survey (69th round), showed that in 2012, when 59% of rural households had no access to a toilet, 4% of individuals who had access reported not using the facility. The primary reasons for not using one were: not having any superstructure (21%); the facility malfunctioning (22%); the facility being unhygienic/unclean (20%), and personal reasons (23%).

A survey conducted by us in 2018, covering the best and worst covered districts and blocks of three States, showed that 59% of households in Bihar, 66% in Gujarat and 76% in Telangana had toilet access. Among those having access, 38% of households in Bihar, 50% in Gujarat and 14% in Telangana had at least one member who did not use it. A higher non-use of toilets in Gujarat was due to a lack of access to water in Dahod district, one of the two districts selected from the State.

In another study by us in 2020, we observed that 27% of households in survey villages in Gujarat and 61% in West Bengal did not have their own toilets. Moreover, around 3% of households did not use their own toilets in either State.

washing clothes. The variations across surveys of the percentage of households having access to toilets and their use are due to the selection of different districts. The more comprehensive National Annual Rural Sanitation Survey (NARSS)- Round-3 (2019-20), conducted by the Ministry, shows that 95% of the rural population had toilet access in India. Access to owned, shared, and public toilets was available to 79%, 14% and 1% of households, respectively. It was also reported that 96% of toilets were functional, and almost all had access to water. However, the same report suggests that only 85% of the rural population used safe, functional, and hygienic toilets. Assuming that the same percentage of people have toilet access as the households, the gap rises to 10% between access to toilets and their use.

These surveys throw up two major issues – the left-out households and toilets unused for defecation. The left-out households appear substantial and need to be covered in Phase II. On the other hand, the government should identify the shortcomings of the previous phase and cover the gaps in the present phase.

Household size, social norms

Our econometric models show that along with economic conditions and education, toilet use depends on household size. The higher the household size, the greater the chances of not using the toilet. Overcrowding and social norms prevent all household members from using the same toilet. Our survey of 2020 shows that only 3%-4% of households have more than one toilet. Further, the chances of using a toilet are reduced if access to water is difficult. Toilet use is found to be very high in remote and backward villages if households have doorstep access to water. The chances of toilet use are also reduced if a household has a detached bathroom.

Phase II of the programme does not have any criteria mandating multiple toilets for households larger than a certain size. Neither does it have any provision for building an attached bathroom. The Jal Jeevan Mission (JJM) programme was launched to provide tap water to each household by 2024.

Nevertheless, no relation has been observed between per capita central expenses made on the JJM and the percentage of villages declared ODF Plus across States. Neither is there any relation between the percentage of ODF Plus villages in a State and households having tap connections.

Social norms that act through social networks play a significant role in toilet construction and use. Examining the networks through which others influence people for their sanitation behaviour, we observed that the size and characteristics of these networks can be different in various parts of the country. In one of the upper caste-dominated villages, lower castes were found to have high brokerage (ability to connect others) to make social norms acceptable and enforceable. Many networks pass through high brokerage nodes, making associated individuals highly connected. Hence, sanitation decisions are less likely to be taken independently. On the contrary, sanitation networks in upper caste villages are more cohesive, smaller and diverse.

Sanitation behaviour also varies across socio-economic classes. NARSS-3 finds that access to toilets was highest for upper castes (97%) and lowest for Scheduled Castes (95%). Our multi-State study finds that the percentage of non-users is higher among upper castes than backward castes. Hence, sanitation behavioural change campaigns should consider two steps: construction and use. Further, the variation in networks between villages should be considered in campaign design as in some villages. behavioural change of households can happen independently, and collectively in others. Phase II of the SBM-G does not seem to have given enough thought to social engineering through the social networks in a society haunted by regressive norms and caste hierarchy.

Lack of synergy

Around 10 crore toilets were constructed between 2014 and 2019 during the initial phase of the SBM-G. The spurt in coverage has also triggered awareness regarding safe sanitation practices. However, collective behavioural change in the nation has still to take place. Our studies suggest that behavioural change in sanitation cannot happen independently. It is contingent upon social networks and an overall improvement of living standards, including better housing and access to basic services. There are separate programmes for each of these basic needs, but they are not well coordinated. The lack of overall planning in India has led to a lack of synergy of programmes despite high levels of expenditure in fulfilling basic needs. Uncoordinated efforts would lead to an inefficient utilisation of precious public finances.

An Uttar Pradesh model to tackle malnutrition

ttar Pradesh is a remarkable example of the importance of women's empowerment in tackling malnutrition by community-based micro enterp led by self-help groups. These enterprises produce fortified and nutritious foods for pregnant/breastfeeding mothers and children, provided as take home ration through the Integrated Child Development Services (ICDS) programme.

In 2020, the Department of Women and Child Development and the Uttar Pradesh State Rural Livelihood Mission collaborated to set up a decentralised production of take home rations by women's enterprises. The model involves the production of different variants for ICDS beneficiaries. This is done by a 20-member women group that uses automated equipment with a capacity of five metric tonnes per day. Once the rations are delivered to Anganwadi centres by the women's groups, the women are reimbursed according to ICDS cost norms. The feasibility of this model was demonstrated by the United Nations World Food Programme (WFP) by using two pilot plants in Unnao and Fatehpur in

After positive feedback and commitment from the Government of Uttar Pradesh, this project expanded to 202 production units across 43 districts in just over two years. This has created livelihood opportunities for 4,080 women, reaching 12 million ICDS beneficiaries.

Women's empowerment for nutrition Engaging women from the community to run the take home ration production units is a game-changer. This unique gender-transformative approach provides livelihood opportunities to local women, empowering them economically. Over 4,000 women have organised themselves into 204 self-help group micro enterprises across 204 blocks in 43 districts. They have been provided with machinery and raw materials such as wheat at subsidised rates to produce and

distribute take home ration. This project presents an excellent opportunity for them to earn a livelihood and contribute to the local economy as

In the past, Uttar Pradesh followed a centralised model to produce and distribute take home rations, where private companies were awarded tenders. However, with the government shifting to a de-centralised model, women from self-help groups are responsible for preparing specific caloric values ration and its supply. The aim is to generate an additional income of ₹8,000 a month for each woman.

The Department of Women and Child Development has also used the opportunity to re-formulate the take home ration – it is nutritious with the inclusion of high-quality milk powder, oil, vitamins and minerals, which can help to support the health and well-being of children and prevent malnutrition. Different formulations were designed for different groups to address the monotony issue, and the packaging was reworked to reflect a sense of quality and create demand in the community. National Accreditation Board for Testing and Calibration Laboratories-accredited laboratories test the products before dispatch to Anganwadi centres to certify the requisite calorie and protein values and ensure food safety.

Strengthening demand

The WFP has collaborated with the Department of Women and Child Development to enhance the nutritional value and utilisation of supplementary nutrition provided through the ICDS scheme in the State. The focus has been on making the take home ration products more nutritious and diverse to increase consumption. This has been achieved through a validated process that improvises existing products and develops new products under ICDS norms and global guidelines.

To ensure good uptake of the variety of products developed, there was research which included production trials, shelf-life analysis, and an acceptability study. The products include sweet and savoury options, such as aata besan and energy-dense *halwa*. Ready-to-eat meals come in age-appropriate colour-coded packaging that includes helpful information on infant and young child feeding practices. The packaging label also lists the ingredients, nutritional information, cooking instructions, directions for storage, food safety and hygiene messages, manufacturing dates, and batch numbers. All these aspects have been included in alignment with the regulations set by the Food Safety and Standards Authority of India.

Fostering innovation and sustainability

An app-based solution is being developed to build the capacities of women to produce take home rations. To improve the viability of the production units, women will receive training to develop nutritious products for the local market. They will use the same units they use to produce take home rations, which will enhance their income, improve the revenue of the take home ration units, and ensure the availability of nutritious food in local markets.

A pilot project is being implemented to strengthen the supply chain and track home rations using QR codes during delivery. The WFP supports this project and will enable government officials to track the Take home ration production, delivery status, and value chain.

The State-wide expansion of micro-enterprises led by women who produce take home rations for supplementary nutrition confirms successful targeting and demonstrates how empowering women can bring about effective and sustainable processes that help improve long-term nutrition in a community. This also highlights the significance of a multi-stakeholder approach towards technically sound and comprehensive solutions that are scalable by leveraging the strengths of the community.

A protest and a predicament

While the LDF is set to stage a protest in Delhi, the UDF finds itself in a tight spot

n India, Centre-State relations have often been characterised by friction. Yet, it is not often that a State government decides to descend in full strength in New Delhi, alleging unfair treatment at the hands of the Union government.

The decision by Kerala's Pinarayi Vijayan-led Left Democratic Front (LDF) government to take its running battle against the "crippling" policies of the Bharatiya Janata Party (BJP)-led government at the Centre and its "neglect" towards the State all the way to Jantar Mantar, a place in New Delhi often used for protests, is significant on several levels. The protest is being held just a few months before the Lok Sabha elections. Mr. Vijayan has announced that he will be leading his Cabinet colleagues and elected representatives in the high-profile protest. To add more firepower, the Communist Party of India (Marxist)-led LDF has also invited Chief Ministers and senior leaders of non-BJP States to join the event.

While the impact of this strategy on the flagging INDIA alliance at the national level remains to be seen, the Congress-led Opposition in the State, the United Democratic Front (UDF), has refused to join the protest.

Financial relations between the BJP-led Union government and the CPI(M)-led LDF regime in Kerala have been far from friendly in recent years. Kerala has repeatedly accused the Centre of being motivated by political considerations in punching it where it hurts the most, namely, the the money



belt. It blames the Centre for cutting off crucial revenue inflow to a trickle, forcing the State to rely more and more on its own meagre resources.

The Kerala Finance Minister, K.N. Balagopal, a vocal critic of Union fiscal policies, alleges that Kerala was deprived of ₹57,400 crore in Central transfers and loan approvals just this year. The LDF government had moved the Supreme Court last December, charging the Centre with interfering in its finances and trimming its borrowing limit.

Politically, the CPI(M) hopes to cement its position as a prime mover in the anti-BJP alliance at the national level through the protest. On the fiscal front, the Left has singled out the BJP-led Union government as the source of Kerala's current worries. The LDF has built a narrative around the charge that the Centre has imposed a "financial embargo-like situation" on Kerala. While presenting the 2024-25 State Budget, Mr. Balagopal also mentioned a 'Plan B' to preserve the momentum of developmental programmes while "retaining the values of the Kerala Model of development," if the "neglect" persists.

But the UDF, while critical of New Delhi's policies, considers them to be only one part of the reason. It believes that Kerala's financial troubles primarily stem from mismanagement and wasteful spending by the LDF government. The Opposition steadfastly stuck to this stand when Mr. Vijayan held discussions with the Leader of the Opposition, V.D. Satheesan, and Deputy Opposition Leader P.K. Kunhalikutty in a bid to coax the Opposition to support his government's protest. Members of the UDF were also absent when the State Legislative Assembly passed a resolution against Union Government policies on February 2.

In reality, the Congress and the UDF were stuck between a rock and a hard place. Supporting the CPI(M), the Congress's chief adversary in Kerala, ahead of the general elections would have gifted the BJP a sharp election weapon. In trying to carve out a space in unfriendly Kerala, the BJP has for long argued that there is little difference between the LDF and UDF.

But in refusing to join the protest, the UDF has drawn flak from the LDF for disregarding the State's larger interests and scuttling the possibility of a united front against "stifling" Union government policies. The LDF has also been quick to use the fresh development as a stick with which to beat the Congress. It has portrayed the decision of the Congress government in Karnataka to stage a similar protest in New Delhi on February 7 as a vindication of its own anti-BJP stand. While Mr. Balagopal saw in Karnataka's decision "poetic justice," M.V. Govindan, the secretary of the CPI(M)'s Kerala unit, said that it should open the eyes of the Congress in Kerala.

The February 8 protest will be keenly watched for its implications for Kerala's standoff with the Centre. And, more importantly perhaps, for what it holds for the INDIA bloc in the run-up to the elections.

Higher autonomy of panchayats leads to better health outcomes

Panchayats which have a better say over power, people, and money also feature high on health, nutrition and sanitation scores

he Data Point published on Monday had highlighted how panchayats earn only 1% of their income through taxes, with the rest being sourced from Central and State grants. The Reserve Bank of India (RBI) study, based on which the report was written, had called for greater autonomy for panchayats and empowerment of local leaders. This Data Point aims to show that greater autonomy of panchayats results in better governance and leads to supposite autonome.

perior outcomes. Panchayats collaborate with health departments to maintain clinics and dispensaries in rural areas. By encouraging institutional deliveries and ensuring prenatal and postnatal check ups, they help reduce maternal and infant mortality rates (IMR). They also provide clean water and sanitation facilities. All these help improve health outcomes. The RBI study uses two datasets to show that panchayats which scored high on the health, nutrition, and sanitation parameters also had lower ru-

Chart 1 shows the State-wise average of panchayat-level health, nutrition, and sanitation scores calculated by the Ministry of Panchayati Raj (MoPR) on the vertical axis. The scores of all the panchayats in a State were averaged to present the State's overall score on these parameters. On the horizontal axis, the IMR of the State is presented. Both data were for 2018-19. In general, as shown by the trend line, the higher the score on health, nutrition, and sanitation parameters, the lower the IMR.

Major States including Kerala, Tamil Nadu, Himachal Pradesh, Punjab, Jammu and Kashmir (before it became a Union Territory), Karnataka, Maharashtra, and West Bengal all feature on the top left. That is, they have a high score and a low IMR. Madhya Pradesh, Uttar Pradesh, Assam, Rajasthan, Odisha, and Chhattisgarh can be seen on the bottom right – they have a low score and a high IMR.

Given that panchayats play a vital role in health management and as Chart 1 shows that some States outperform others, Chart 2 checks whether these better-performing States also have greater autonomy at the panchayat level. For this, the RBI study uses the devolution index prepared by MoPR using independent agencies. The devolution index rates a State based on three parameters.

First, the transfer of subjects, that is, how many functions including drinking water, rural housing, family welfare, and women and child development are under the control of panchayats. Second, transfer of functionaries, that is, how many positions were filled by panchayats on their own. Third, transfer of finances, that is, what share of funds are raised by panchayats on their own and what share can they spend based on their decisions. These three and some other categories are used to calculate the devolution index.

Chart 2 plots the States' devolution index on the horizontal axis. The States on the right – Kerala, Karnataka, Maharashtra, and Tamil Nadu – have higher devolution scores. The States on the left – Assam, Odisha, Chhattisgarh, Madhya Pradesh and Uttarakhand – have lower devolution scores. Chart 1 and 2 when read together shows that panchayat autonomy plays a vital role in better health outcomes in rural areas.

Map 3 which shows the percentage shortfall of primary health facilities in rural areas also concurs with this conclusion as States which perform better on the index have a surplus, with a few exceptions. Uttar Pradesh, Bihar, Jharkhand, Madhya Pradesh and West Bengal have very high levels of shortage. On the other hand, Kerala, Tamil Nadu, Karnataka and Himachal have none.






Chart 2: The chart shows the devolution index calculated by the Ministry of Panchayati Raj, across States

U.K. court says Ugandans have no right of entry

London, Feb 5: Three Appeal Court judges ruled yesterday that Britain is not bound under international law to receive "British protected" persons expelled from Uganda, reports DPA.

Lord Denning commented on the status of people from British Protectorates: "They were said to be British nationals, but they were not British subjects. They were not born here. They have never lived here. They live thousands of miles away in countries which had no connection with England except that they were once British Protectorates."

Posing the question whether by international law everyone has the right, if expelled, to come into these small islands, Lord Denning said: "Surely not. This country would not have room for them for they came, not in single file, but in battalions."

Lord Denning said that mass expulsions had never before come within the knowledge of international law. And he did not think there was any rule which affected the issue. The rules of international law, he said, only became part of English law in so far as these had been accepted and adopted by England.

The court dismissed an appeal by Mr.
Pravinlul Amanhi Thakrar against a decision of
Queen's Bench Divisional Court last October that
the Home Office had acted unfairly in banning
him from entry to the U.K. Mr. Thakrar, who was
born in Uganda of Indian parents, had been
expelled among thousands by "the sword of
General Amin." He had been detained since an
immigration officer at the Heathrow Airport
refused him admission.

Myanmar's civil war and India's interests

While security agencies will constantly evaluate the modalities of engaging with armed groups on India's borders, there is a need to scale up humanitarian and development assistance in coordination with a broader spectrum of ethnic organisations and local people to expedite Indian investments in the region

n February 2021, when the Myanmar military leaders ousted the elected government of Aung San Suu Kyi, they anticipated a resistance movement that would subside in a few months. Three years later, the opposition to military rule gains in strength. Ethnic Armed Organisations (EAOs) and the People's Defence Forces control many towns in different parts of the country. A few weeks ago, the Arakan Army captured Paletwa in the Chin State which lies on Myanmar's western borders with Bangladesh and India.

A conflict within a conflict

The fall of the town of Paletwa has altered the dynamic between the Chin and the Arakan ethnic groups. A majority of Paletwa's residents belong to the Chin ethnic community, and they see their town as an integral part of their homeland. On the other hand, some in the Rakhine State, previously known as Arakan, contend that the township was historically part of the Arakan Hill Tracts during colonial rule and should have been part of their province. There have been instances, prior to the coup, when Chin ethnic organisations expressed displeasure with the Arakan Army's operations in Paletwa.

In the recent past, ever since the Chin armed groups and the Arakan army have been fighting the Myanmar military, they have refrained from forcefully ascertaining their respective views of provincial borders. Nonetheless, to maintain peace and order, it is imperative that the Chin and Arakan groups agree on an inclusive framework for the governance of Paletwa and adjoining areas. For an effective fight against the military, the EAOs need to improve inter-ethnic solidarity by creatively accommodating each other's perspectives on ethnic boundaries. Finding an inter-ethnic compromise on settlements such as Paletwa can be particularly challenging. Paletwa's location on the western border makes it a good launchpad for the Arakan Army to conduct its operations against the military. Paletwa is a commercial town on the Kaladan River, and therefore, any armed group with a significant presence in the town would benefit from the economic activity in the region.

India's stake

The developments in Paletwa will also impact the Indian government's Kaladan Multimodal Transit Transport Project (KMTTP) in Myanmar, which has already faced significant delays. The Kaladan project was aimed at addressing the geo-economic and geo-political challenges of northeast India. The partition of the subcontinent and the subsequent hardening of borders converted northeast India into a landlocked region. Transporting goods to and from northeast India via the narrow Siliguri corridor is an expensive affair, and in a worst-case scenario with China, there is a possibility of movement along the corridor being adversely affected. Therefore, the Kaladan project was conceptualised as an alternative route that gives northeast India access to the sea.

India and Myanmar signed the framework agreement on the Kaladan project in 2008. The operationalisation of the project was delayed because of rugged terrain, inadequate inter-departmental coordination, political instability and security challenges in

Myanmar. While the Sittwe port and inland water terminal at Paletwa have been completed in the past few years, road construction is facing challenges due to the prevailing security situation in Myanmar. For expeditious implementation, the attitudes of the local ethnic organisations towards the Kaladan project should be factored in. The people of Mizoram and their co-ethnics across the border in Chin State are interested in the expedited completion of the Kaladan project, as it will spur economic activity

in the region. However, there is a perception in India that the Arakan Army is not favourably disposed to the Kaladan project. Prior to the coup, numerous reports indicated that India and Myanmar have launched coordinated operations against Arakan Army units that were operating close to India's borders near Mizoram and threatening the Kaladan project. In 2019, five Indian workers working on the project were kidnapped, reportedly by the Arakan Army. While all the workers were released, one Indian national died in the custody of kidnappers due to a cardiac arrest.

China's investments in the region


The Arakan Army, along with the Myanmar National Democratic Alliance Army and the Ta'ang National Liberation Army, is part of the Three Brotherhood alliance, which some claim has China's support. The alliance has pledged to protect Chinese investments in Myanmar. There are reports which suggest that the Arakan Army receives considerable funding and military equipment from China. If such reports are true, there will be concerns in Delhi that Beijing is using armed groups to slow down India's connectivity projects in Myanmar.

Meanwhile, the Chinese economic presence along Myanmar's Bay of Bengal coast has substantially increased. Beijing has operationalised oil and natural gas pipelines from the Shwe gas fields near Kyaukpyu in the Rakhine State to Yunan province in China. Two months ago, China signed supplementary agreements with the Myanmar military to operationalise the deep sea port and a special economic zone near Kyaukpyu. Reportedly, there were renewed efforts to construct a railway line from China's Yunnan to Kyaukpyu via Mandalay as part of the China-Myanmar Economic Corridor

Unlike India, China is a permanent member of the United Nations Security Council, which prompts many state and non-state actors in need of international support to be relatively more

accommodating of China's concerns. Consequently, China is in a position to extend political and military support to various ethnic armed groups as well as to the Myanmar military to protect its economic interests.

There are important takeaways from the progress of the Kaladan project. Since India is a liberal democracy, its external engagement will be closely monitored for its impact on sectarian/identity-based violence in its neighbourhood. While security agencies will constantly evaluate the modalities of engaging with armed groups on India's borders, there is a need to scale up humanitarian and development assistance in coordination with a broader spectrum of ethnic organisations and local people to expedite projects such as Kaladan.

The successful completion of the Kaladan not only requires competent technical personnel but also experts who can diligently monitor the fluid Chin-Arakan ethnic relations, the changing contours of military-EAO contestation, sectarian violence in the Rakhine state, and the growing Chinese footprint in Myanmar, specifically in the Rakhine state. The Kaladan experience suggests that perhaps it is time to bring such experts under one roof to expedite the implementation of various other connectivity and development assistance projects in India's immediate neighbourhood.

Do exams throttle India's education system?

One big function of exams is to create an illusion of equal opportunity in an otherwise highly unequal society. It is in the exam that all children – no matter what their background is – face the same test of three hours

As exam season approaches, this interview by G. Ananthakrishnan, with Krishna Kumar and Rohit Dhankar, from June 14, 2019, talks about India's education system and how exams are not a benchmark of a student's potential. Edited excerpts:

he importance accorded to school-leaving examinations in India puts enormous pressure on students to score the highest possible marks. But how scientific is the examination system at determining the progress of students? In a conversation moderated by G. Ananthakrishnan, Krishna Kumar, former director, National Council of Educational Research and Training and Rohit Dhankar , Professor of Philosophy of Education at Azim Premji University, Bengaluru, talk about the education system.

The school-leaving exam is a defining one in the life of a student. What outcomes do these exams actually achieve?

Krishna Kumar: This examination system is something that reminds us of the beginnings of the modern education system in India. The school-leaving examination was designed in the latter half of the 19th century as a way to determine who can be selected for further education, which was very scarce at that time, and also for lower-level jobs in offices. It was basically a means of elimination. And it has remained that all the way up to now. The Grade 10 exam, for instance, fails a large number of children and stops them from going any further. This is a kind of structural arrangement in a system in which secondary education is not very widespread and higher secondary education is even less so. Opportunities for further education at the undergraduate level or various kinds of technical education are also relatively

So, the exam system acts as a custodian which doesn't permit a vast number of children to go forward. It has acquired its legitimacy over the century, and therefore it is not questioned, but it has very little scientific basis, and it is not a system of any kind of valid assessment of the potential of a young person. Rather, it is a means of keeping out [children]. In what manner can you be stopped from going further? Grade 10 is the most draconian barrier, Grade 12 also fails a large number

That is one function of the examination system. The other big function is to create an illusion of equal opportunity in an otherwise highly unequal society. It is in the exam that all children - no matter what their background is, or whether they study in a posh school or a poor school – face the same test of three hours. Their names are turned into roll numbers. The identity of paper-setters and evaluators is not revealed. Thus, confidentiality enhances the legitimacy of a situation where children from contrasting circumstances are given an equal-looking opportunity.

Rohit Dhankar: I agree. The problem is well-known for quite some time. The first mention of the educational system being throttled by exams was in 1904 in

the Indian Educational Policy, at the time formulated by the Governor General in Council. After that this was mentioned in every commission and report. They always try to say exams should be reformed and something should be done about it. As far as reliability of children's understanding, acquiring knowledge and wavs of formulating knowledge are concerned, I don't think the examination system leaves much scope. Children do acquire snippets of information, but whether they construct that into knowledge remains seriously doubtful. I feel that this is also an outcome of intense competition in society. As long as the school structure and the structure of the curriculum remain as it is today, where every child has to finish certain kinds of learning in a given time, and at the same time the possibility of children exploring on their own is limited, it seems that the exam system cannot be changed.

If one changes these two things – the structure of the school and the curriculum - and somehow an alternative way is found which ameliorates the high competition in the parents' mind, there is a possibility of reforming the system in such a manner that it is more insightful

and less stressful.

How does India's exam system compare with the systems of other countries?

KK: Our system compares very poorly with the evaluation and assessment systems which are in place in other societies, including European and North American societies as well as China. These societies have reformed their evaluation systems from within by improving teachers' understanding of what they are looking for in a child right from the start. In our case, we don't equip our teachers with a deep understanding of how children learn and how to assess a child's growth. Our system right from the beginning becomes intensely competitive and stressful and starts promoting cramming as a way to move forward with high marks.

A recent attempt made in the Right to Education (RTE) Act to introduce Continuous and Comprehensive Evaluation (CCE) was an important step but this was not welcomed by a large number of schools and State authorities. And the idea that the RTE introduced that we will not have a Board examination

up to Grade 8 - has now been amended by Parliament. States are now once again free to introduce a Board exam. Some have already moved towards that by reintroducing at Grade 5 and Grade 8 levels an exam that can classify children into pass and fail categories. This was the old system. This reversal of a progressive step that the RTE had taken also shows how accustomed our system is to this old and rigid practice of examining children one against the other.

In comparison, European systems, including the British system on which we were modelled originally, have moved on to far more holistic and humanistic ways of assessing each child's own growth trajectory right from the beginning. Even where there are public exams, they are taken with much greater care for objectivity and justice for every child.

In the draft National Education Policy 2019, there is an idea that we can shift to modular exams rather than one single exam. Is this actual reform?

KK: This idea has been given many times earlier. And the National Institute of Open Schooling does provide the facility for taking one subject at a time, when completing your examination process over three-four years if necessary. I don't think this idea is going to make any impact on this very highly competitive system.

In fact, the draft policy has ignored a number of very good reforms within the various Boards that have been recommended over the last 20-25 years. Many of the Boards don't have adequate staff, enough academic faculty to monitor their own procedures. Many of the State Boards are actually in very poor shape as far as their academic infrastructure is concerned. Even the CBSE and ICSE operate as bureaucratic, mechanical set-ups. Unfortunately, the policy draft doesn't even look at this phenomenon of improving the institutional functioning of the Boards.

RD: Exam reform doesn't come alone in the draft education policy; it comes along with the changes recommended in structure, curriculum, choice of subjects. A lot is written about curriculum reform. At this moment, in the first reading, it was somewhat confused, and talks of too many things simultaneously and repetitively. For example, if we give more flexibility to children at the secondary level [it proposes to do away with secondary-senior secondary distinction] with eight semesters and around 40 courses, for 24 courses students should take Board exams. With how much understanding I don't know, but they also say the exam will shift from testing rote memory to basic concepts and their relevance to life, situations and problem-solving. If the bulk of the recommendations are implemented, then there seems to be a possibility that we will get a kinder and better assessment system.

But I must point out that on the curricular reforms to the subjects, for example, there are 14 or 15 different kinds of courses and subjects for 6th to 8th standard students, but there doesn't seem to be that much room in the time table. So, at this moment it seems the situation is not very clear. However, as far as examinations are concerned, if the policy understands what they are writing, the emphasis is more on the fundamental concepts in subjects and more on understanding. Through a modular kind of Board exam, it might help. But then this comes along with a whole bunch of recommendations, and piecemeal implementation is not going to help.



Myanmar forces flee into Bangladesh after clashes

early a hundred members of Myanmar's Border Guard Police have fled their posts and taken shelter in Bangladesh during fighting between Myanmar security forces and an ethnic minority army, an official of Bangladesh's border agency said Monday.

Shariful Islam, spokesperson for Border Guard Bangladesh, said by phone that the Myanmar forces entered Bangladesh over last two days to escape fighting with the Arakan Army in Myanmar's Rakbordering state Bangladesh.

They entered Bangladesh through the Tombru border in Bandarban dis-

trict, the spokesperson said.

"In total 95, Myanmar troops are there now," he said. "They have been disarmed and taken to safe places.'

Since Saturday, gunshots could be heard coming from the Myanmar side of the border.

The Arakan Army is the well-trained military wing of the Rakhine ethnic minority seeking autonomy from the central government and has been attacking Army outposts in the mid-November.

It is part of an alliance of ethnic minority Armies that launched an offensive in late October, gaining strategic territory in the country's northeast bordering China.

Its success was widely seen as a major defeat for the military government, which seized power in February 2021 from the elected government of Aung San Suu Kyi and is now embroiled in a wide-ranging civil war.

The alliance, called the Three Brotherhood Alliance, said in a statement on Monday that the Arakan Army had attacked two border outposts in Maungdaw township in Rakhine state and captured one of them on Sunday.

Maldives President Muizzu vows to boost defences after telling Indian troops to leave

The small but strategically placed Maldives will strengthen its military to defend its vast maritime territory, the new President vowed on Monday after ordering Indian troops to withdraw from the archipelago.

Mohamed Muizzu said in his first address to Parliament he would turn the modest Maldivian National Defence Force (MNDF) into a modern military capable of patrolling its seas, which straddle key global shipping lanes.

The leader reiterated that India will begin withdrawing its troops operating three maritime reconnaissance aircraft from March 10 and complete the within process two months.

New Delhi considers the Indian Ocean archipelago to be within its sphere of influence.

However, the Maldives has shifted into the orbit of China – its largest external creditor - with September's election of Mr. Muizzu, who demanded the Indian troops leave.

"I believe that the modern military capability to defend the country by road, sea and air should be strengthened in the Mal-

dives," Mr. Muizzu said. "We have started to do that now."

He said the MNDF will soon be able to conduct surveillance of the country's 9,00,000 square-km Exclusive Economic Zone (EEZ) around the clock.

Charges against India

The Maldives accused India's coastguard last week of entering the north of its EEZ and intimidating three Maldivian fishing vessels.

Mr. Muizzu said he had told India he would not extend a 2019 agreement to jointly carry out hydrographic surveying of the nation's 1,192 coral islands.

He did not identify India specifically but said he did not want to give "a foreign nation the power to measure and map the Maldivian oceans coastlines".

Australian gets suspended death penalty in China

"The Australian Government is appalled," Australian Foreign Minister Penny Wong said.

Mr. Yang, a former Chinese diplomat who became a political commentator and writer of spy novels in Australia, was detained in 2019, when he arrived in Guangzhou from New York.

King Charles receiving treatment for cancer in U.K.

King Charles III has been diagnosed with a form of cancer and has begun treatment, Buckingham Palace said on Monday.



Cascading light and 'wobbling' orbs at Tokyo art museum

It's immersive, interactive and, of course, Instagrammable – and now the digital art of Japanese collective teamLab, a major tourist draw, has a new home in the country's tallest skyscraper.

A shifting vortex of spotlights and a mirror room filled with ethereal "wobbling" orbs are among the brand-new artworks at the "teamLab Borderless" permanent exhibition, which opens on Friday. They join dozens of other mesmerising displays, from waterfalls of light to birds leaving colourful trails as they dart by, in a labyrinthine display at the 330-metre Azabudai Hills building in central Tokyo.

"Our goal is to touch people, and to prompt them to reflect on life and the world in a more positive way," Toshiyuki Inoko, director of the internationally renowned teamLab collective, said. "Our work is the continuation of our past endeavours, but offers a whole new experience at the

Visitors to the attraction at Azabudai Hills, which has towered over central Tokyo since its completion last year, are free to wander through the complex of artworks. Some displays move from room to room, and others react to visitors' movements, with petals scattering as they approach and fluid lights rippling at their feet. The exhibition has more than 50 artworks featuring a mix of natural and otherworldly motifs, from slow-blooming flowers to a vast room of cables through which digital light appears to rain down.

n the summer of 2020, Gerard Magliocca, like many during the coronavirus pandemic, found himself stuck inside with time on his hands.

A law professor at Indiana University, Magliocca figured he would research the history of two long-neglected sentences in the Constitution's 14th Amendment. Dating to the period just after the Civil War, they prohibit those who "engaged in insurrection or rebellion" from holding

On January 6, 2021, after then-President Donald Trump's supporters stormed the U.S. Capitol to try to block certification of his loss to Joe Biden, Mr. Magliocca watched as Republicans such as Sens. Mitch McConnell and Mitt Romney described the attack as an "insurrection."

That night, Mr. Magliocca composed a quick post on a legal blog: "Section Three of the Fourteenth Amendment," he wrote, "might apply to President Trump."

Just over four years later, the U.S. Supreme Court will have to determine whether it does. On Thursday, the nation's highest court is scheduled to hear arguments over whether Mr. Trump can remain on

the ballot in Colorado, where the state's Supreme Court ruled that he violated Section 3. It's the first time the Su-

preme Court has heard a case on Section 3, which was used to keep former Confederates from holding government offices after the amendment's 1868 adoption. It fell into disuse after Congress granted an amnesty to most ex-rebels in 1872. Before the attack on the Capitol, even many constitutional lawyers rarely thought about Section 3. It hadn't been used in court for more than 100 years. Its revival is due to an unlikely combination of Democrats and Republicans, liberals and conservatives, all rediscovering 111 words in the nation's foundational legal document that have now become a threat to the former president's attempt to return to office.

In the days after January 6, Section 3 started its slow emergence from obscurity.

Free Speech For People, a Massachusetts-based liberal nonprofit, sent letters to top election officials in all 50 states in June 2021, warning them not to place Mr. Trump on the ballot should he run again in

In January 2022, Free Speech For People filed a complaint in North Carolina to disqualify Republican Rep. Madison Cawthorn under Section 3. That same month, the group Citizens for Responsibility and Ethics, also known as CREW, decided to test Section 3 in court. "It wasn't just Trump we were focused on," chief counsel Donald Sherman said.

On September 6, 2022, a New Mexico judge ordered Couy Griffin, a rural New Mexico county commissioner convicted of illegally entering the Capitol on January 6, removed from his position after CREW filed against him. It was the first time in more than 100 years an official had been removed under Section 3.

Mr. Trump announced his campaign for president two months later.

Both Free Speech For People and CREW began scouring state ballot laws. looking for places that allowed the rapid contesting of a candidacy. CREW settled on Colorado.

Mr. Sherman and another CREW attorney, Nikhel Sus, contacted Martha Tierney, a veteran election lawyer who also served as general counsel of the state Democratic Party.

Ms. Tierney wasn't acting as the Democratic Party's lawyer, but CREW wanted to balance its team. Mr. Sherman contacted Mario Nicolais, a former Republican election lawyer who had left the party over Trump. Mr. Nicolais' first interaction with Sherman was a direct message about the case on X. Mr. Nicolais thought it could be from a crank.

On September 6, 2023 one year from the disqualification of Griffin – their 105-page complaint was filed in district court in Denver.

Mr. Trump hired former Colorado Secretary of State Scott Gessler to represent him. The Denver judge who got CREW's complaint, Sarah Block Wallace, said she was obligated to hold a hearing under state election law.

During the five-day hearing, two officers who defended the Capitol testified, along with a University of California professor who was an expert in rightwing extremism, two Trump aides and several other witnesses. One was Mr. Magliocca.

Mr. Trump's attorneys were pessimistic, expecting Wallace, who had a history of donating to Democrats, to rule against them. Trump spokesman Jason Miller addressed presspersons outside court, complaining that the plaintiffs had intentionally filed in a liberal jurisdiction in a blue state.

Ms. Wallace issued her decision on November 17. She found that Mr. Trump had "engaged in insurrection" but ruled that it wasn't certain that the authors of the 14th Amendment meant it to apply to the President. Section 3 refers to "elector of President and Vice President,"

but not the office itself. CREW was just a legal sliver away from victory. It just needed the Colorado Supreme Court to uphold all of Wallace's ruling besides the technicality of whether the president was covered.

Security forces used tear gas to disperse an Opposition rally outside Senegal's Parliament on Monday, shortly before the start of a contentious debate on postponing this month's presidential election.

Several dozen protesters could be heard chanting "Macky Sall dictator" referring to the incumbent President after being scattered by security forces.

Senegal has been grappling with a political crisis since President Macky Sall on Saturday announced a delay to the February 25 presidential poll, just hours before campaigning was set to officially begin.

Opposition leaders have denounced the move as a "constitutional coup", saying it is an assault on democracy.

It is the first time since independence that a presidential vote has been postponed in Senegal

Access to mobile internet was cut in several districts of the capital Dakar on Monday. The government also suspended mobile data last June amid high tensions in the country. The measure has become a common response to curb mobilisation and communication via social

Swaths of the U.S. state of California were flooded on Monday and hundreds of thousands of people were without power after a dangerous storm brought heavy rains and prompted a state of emergency.

"This is a serious storm with dangerous and potentially life-threatening impacts," said Governor Gavin Newsom as he declared the state of emergency for eight counties in Southern California.

Affected areas include Los Angeles, Orange, Riverside, San Bernardino, San Diego and Santa Barbara. Nearly 7,00,000 customers were without power early Monday morning, according to the electricity supply tracker PowerOutage.us. Dozens of flights in and out of Los Angeles airport were delayed or cancelled, according flightaware.com.

The National Weather Service (NWS) had earlier issued a warning that a "strong Pacific storm system would bring impactful and dangerous flooding rains, heavy snow, strong winds, and high surf to California". "Heavy rainfall will bring the threat for lifethreatening flash, urban, and river flooding."

The storm, packing gusts of 60 miles per hour or greater, is part of a "Pineapple Express", a weather phenomenon that grows in Hawaii from near where the tropical moisture is coming.

The NWS described it as "the largest storm of the season".

While wet weather is not unusual during California's winters, scientists say human-caused climate change is altering the planet's weather patterns.

States welcome private investors, but resist disinvestment'

DIPAM Secretary says States have a lukewarm response to disinvestment of PSUs while welcoming private investments through large summits

ome State governments tend to have a "duality" in their approach towards the strategic disinvestment of public sector enterprises even as they go all out to attract private investors by holding large investment summits with offers of land parcels and myriad sops, a top Finance Ministry official flagged on Monday.

The comments assume significance, coming a month after the Centre was compelled to drop a plan to privatise the Salem Steel Plant, a unit of SAIL, due to lack of bidder interest in the absence of co-operation from the Tamil Nadu government, which didn't even enable potential bidders to enter the plant and assess its worth.

"State governments, in general, have a very lukewarm response to strategic disinvestment," Department of Investment and Public Asset Management (DIPAM) Secretary Tuhin Kanta Pandey told The Hindu. "I think we need to engage more proactively with them. In general, if we are really saying that we are encouraging private sector participation, I think to that extent, there is a little bit of duality in the process there," he added.

Pointing to the several investment summits held by State governments, Mr. Pandey said that a lot of MoUs (Memorandums of Understanding) are signed in those summits, primarily with the private sector.

Pushback

"But then when it comes to privatisation or strategic disinvestment (of public sector enterprises in these States), there is a pushback. So both these things don't gel," the Secretary emphasised. "To do such transactions, you need a lot of patience and perseverance, as well as co-operation from multiple stakeholders," he said.

While the Centre had incentivised State governments to undertake disinvestment of their public sector enterprises in the Union Budget of 2020-21, the nudge was discontinued in the next Budget as

the idea did not find many takers. In some States, the disinvestment of Central PSUs has got delayed due to delays in notifying changes to the Indian Stamp Act that were cleared by the Centre to facilitate demerger of assets.

This proved to be a "bottleneck" in the case of Shipping Corporation of India, where land assets are being hived off into a separate entity, and the Air India Building in Mumbai, which was demerged before the airline's sale to the Tata group.

"We have sorted out this issue recently with Maharashtra... The States have to take cognizance of the Stamp Act changes and notify it for their collectors to follow. So this, we have to pursue with different State governments, be it West Bengal or Tamil Nadu, wherever the assets are," Mr. Pandey said.

FM seeks ₹78,673 cr. added funds for FY24

Other spending include ₹9,162 crore for defence.

Hyundai said to mull \$3 billion India IPO

South Korea's Hyundai Motor is exploring an initial public offering (IPO) for its Indian unit to raise at least \$3 billion, two sources familiar with the matter said.

Hyundai Motor India Limited (HMIL) is in early stage talks for an IPO later this year that could value it at \$25 billion-\$30 billion, the sources said.

While Hyundai's plan for an IPO later this year is not finalised, it could potentially be the country's biggest stock market offering, the sources said.

The company is exploring "value unlocking for its



India business" through the IPO, the sources said. A spokesperson at Hy-

undai's India unit declined to comment. Hyundai, India's second-largest carmaker by sales, has said it plans to invest \$2.45 billion in the country for its electrification push with plans to introduce new EVs, charging stations and a battery pack assembly unit.

Rival Reliance Jio's market share was at 39.49% as of November 30 and Bharti had a 32.91% share, while Vodafone Idea trailed with 19.44%, according to the Telecom Regulatory Authority of India (TRAI).

Bharti said its 4G/5G



subscriber base rose to 244.9 million users, an increase of 13% from a year earlier and 3.1% in the preceding quarter.

Average revenue per user (ARPU), a key financial metric where Bharti leads its rivals by a wide margin, rose to ₹208, from ₹193 a year earlier and ₹203 in the last quarter. ARPU was in the range of analysts' estimates of ₹205 to ₹208.

Track, trace system roll out for drug exports delayed

The Directorate General of Foreign Trade (DGFT) has agreed to yet another plea from drugmakers for more time to implement the Track and Trace system for export drug formulations.

"The date for implementation of the Track and Trace system for export of drug formulations with respect to maintaining the parent-child relationship in packaging levels and its uploading on Central portal has been extended up to February 1, 2025 for both SSI and non-SSI manufactured drugs," the DGFT said in a notification recently extending the deadline by one more year.

Conceived as a mechanism to rein in the counterfeit menace and address the challenges associated with product recall, the system has been in the offing for at least nine years with DGFT in August, in the previous extension notification, setting a February 1, 2024 deadline.

The latest extension comes on the heels of a representation from the

Pharmaceuticals Export Promotion Council of India to the Commerce Department on the difficulties expressed by its member exporters with regard to implementation of track and trace and requested for extension of timelines. Pharmexcil Director General Ravi Uday Bhaskar told The Hindu that the request for more time was made in the light of issues with the software during a pilot project for uploading secondary and tertiary packing data. The glitches have also been taken to the notice of C-DAC, the software developer, he said.

Lagging behind

Towards facilitating the roll out, the government has a scheme under which it provides ₹25 lakh grant, for the barcode machinery, to SSI units.

About 2.15 lakh cases pending before DRTs, says Minister Karad

About 2.15 lakh cases are pending before Debt Recovery Tribunals (DRTs) as on January 24, Parliament was informed on Monday.

Out of 2,15,431 cases, the Original Applications (OAs) filed under Section 19 of the Recovery of Debts and Bankruptcy Act (RDB Act), 1993, is 1,62,317 and Securitization Applications (SAs) filed under Section 17 of Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act (SAR-FAESI Act), 2002, is 53,114, Minister of State for Finance Bhagwat K. Karad said in a written reply to


Lok Sabha. As per the Recovery of Debts and Bankruptcy (RDB) Act, cases should be dealt expeditiously and every possible effort should be made to complete the proceedings in two hearings and to dispose of the application finally within 180 days from the date of receipt of the application.

As on January 24, 2024, he said, the total number of cases which are pending for more than 180 days before the DRTs is 1,85,076.

Out of these pending cases, 1,42,187 cases are OAs and 42,889 cases are SAs, he added.

Non-compliance

Pendency of cases is analysed from time to time, he said, adding pendency of cases has been mainly on account of the strategy of litigants in the form of non compliance with the summons issued by the DRTs, seeking intervention of the High Courts in DRT proceedings, choosing not to

appear before the Tribunal and then challenging the ex-parte orders passed against them etc. Pendency is also caused sometimes by the absence of lawyers either of one side or both sides or requesting adjournments, he said.

To reduce pendency, the government has taken a number of steps, he said.

Vacancies filled up

All vacancies of Presiding Officers (POs) except one are filled up and steps are underway to fill the said vacancy and other anticipated vacancies occurring up to September 30, 2024.

All possible steps for facilitating easy access to DRTs for litigants and advocates are also being taken such as providing video conferencing facilities for case hearings.

Replying to another question, he said ₹36.26 crore loss was recorded in the first half of 2023-24 due to financial frauds.

To help customers recover loss on account of fraudulent transactions, the Minister said the Reserve Bank of India has issued instructions on limiting the liability of customers in cases of unauthorised electronic banking transactions.

Vanguard cuts Ola's valuation '74%' to \$1.8 bn

U.S.-based asset management company (AMC) Vanguard has marked down the value of ANI Technologies, the parent company of ride-hailing platform Ola, to \$1.88 billion which is 74% lower from its peak valuation of \$7.3 billion, as per regulatory filings with the U.S. Securities and Exchange Commission (SEC).

Vanguard has slashed Ola's valuation for the third time in a row. In May last year, Vanguard said the company was valued at \$4.8 billion and then, again lowered Ola's valuation in August to \$3.5 billion in August 2023. The AMC lowered Ola's valuation in 2020 and 2021 too.

The Bhavish Aggarwal-led company had last raised \$139 million in December 2021 in a funding round led by Edelweiss PE that valued Ola at \$7.3 billion. In addition, several Indian consumer Internet companies have seen valuations being revised by U.S. investors in recent weeks. Funds managed by financial services giant Fidelity reduced the valuation of Meesho and Pine Labs last month.

Loss narrows

Recently, ANI Technologies narrowed its standalone loss by 65% to ₹1,082 crore in fiscal 2023. The ride-hailing platform's sales jumped 63% to ₹1,987 crore from ₹1,220 crore.

Meanwhile, Ola Electric has filed a draft red herring prospectus (DRHP) to raise up to ₹5,500 crore through a fresh issue, apart from an offer-for-sale of 95.2 million shares.

Trump adds to Nippon-U.S. Steel deal woes in major blow for Japan Inc.

Trump's pledge to block Nippon Steel's planned purchase of U.S. Steel if he retakes the White House compounds political troubles for the \$15 billion deal whose failure could reverberate across Japan Inc.

For Japan, the biggest foreign investor in the U.S., a collapse of the deal could give companies pause about acquisitions in other strategic sectors and force them to be more risk averse when sizing up deals, say former officials, lawyers, analysts and executives.

The planned purchase by the world's fourth-largest steelmaker of the storied American firm underlines the limits of "friendshoring", a term coined by U.S. officials to describe deeper economic cooperation between allies, an effort partly aimed at de-risking supply chains from rival power China.

Nippon Steel's acquisition already faces high hurdles, drawing criticism from Democratic and Republican lawmakers and the powerful United Steelworkers union.

Failure could be "a warning sign to some segments of Japanese inves-



tors", said Kenichiro Sasae, who was Japan's ambassador to the U.S. at the start of Trump's 2017-2021 term as president.

While the fallout might be limited to specific sensitive industries, it would show that even with more focus on economic cooperation between allies, countries will always decide based on their own core interests, said Mr. Sasae, president of the Japan Institute of International Affairs think tank.

Opposition to the deal appears at odds with U.S. efforts in recent years to encourage Japanese companies to boost their presence there. It is reminiscent of the 1980s, when Japanese acquisitions of trophy assets like Rockefeller Center ignited sharp

criticism from the American public.

Higher costs

In 2015, U.S. regulators, citing competition concerns, scuttled a merger between Japan's Tokyo Electron and U.S.-based Applied Materials, two of the world's largest manufacturers of semiconductor-making machinery.

Mr. Trump, whose protectionist "America First"

policies were a hallmark of his tenure, said on Wednesday he would "instantaneously" block the deal if he wins the Nov. 5 vote. The Republican is set for a likely rematch with President Joe Biden, Democrat.

Nippon Steel responded that the purchase would provide great benefit to U.S. Steel, the U.S. steel industry, its customers, employees, local communities and the U.S. more broadly.

"Failure to strike a deal has the potential to damage investment ties and set back friendshoring initiatives," said Stefan Angrick, senior economist at Moody's Analytics in Tokyo.

"The long-term consequences would be higher costs for businesses and consumers," said Mr. Angrick, who expects the deal to pass eventually.

Japan's direct investment in the U.S. hit 27 trillion yen (\$180 billion) in 2022, according to the latest finance ministry data, compared with just 1.4 trillion yen (\$10 billion) in Japan's other top trading partner, China.

Hard to approve

Concerns over Nippon Steel's attempt to buy a company that helped build the Empire State Building and arm allied forces in World War Two have arisen since its December announcement.

Mr. Biden's White House says the deal deserves "serious scrutiny" given its potential impact on national security and supply chain reliability. It said it supported a review of the transaction by the Committee on Foreign Investment in the U.S., a process that could take months.

Japan's industry minister declined to comment on Trump's remark about the deal on Friday but said the U.S.-Japan alliance was stronger than ever.

Chuck Rocha, a Democratic strategist and former political director for the steelworkers' union, said it would be hard for the Biden administration to approve the deal.

"I think there's certain core industries that you just don't outsource," said

Mr. Rocha. "It's not called ABC Steel. It ain't called Your Mama's Steel. It's called U.S. Steel."

The steelworkers, criticising both companies for not consulting with them on the acquisition, have urged regulators to scrutinise whether the deal benefits workers.

Mr. Biden and Mr. Trump have been competing to win the support of unions, which could prove crucial in the battleground states expected to decide the election.

Nick Wall, a Tokyobased partner at law firm Allen & Overv who advises on M&A deals, said the blowback from the Nippon-U.S. Steel deal shows Japanese firms will have to be more thorough when examining transactions, especially in unionised industries.

"You'd spend a lot more time thinking through othstakeholders-how they're going to respond, what engagement you should have with them before you announce the deal, bringing along PR experts to help you refine and polish the message," he said.

A former senior Japanese government official who now works for a Japanese conglomerate said the deal was a stark reminder that firms must be more mindful about studying the political implications of deals in the United States.

As China's central bank unleashes liquidity into the financial system to spur growth, banks are chasing factories with cheap loan offers. But squeezed out by bigger rivals, smaller firms are unwilling to take on loans to finance new business, in what economists see as a broken link in China's increasingly inefficient monetary policy.

Investment by private companies, which according to State officials provide 80% of urban jobs, slid 0.4% last year, while state investment rose 6.4%.

"Many bank managers call me and they sound very anxious when they can't lend money," said Miao Yujie, an e-commerce clothing exporter. Even after halving his workforce to about 20 people last year, he cannot turn a profit as bigger firms elbow him out of the market. "But you only need to borrow when you want to expand," said Mr. Miao, adding he mulls

o history was rewritten. No new height was scaled by Bazball. No stopping India wrapping up the second Test on the fourth day, grounding the high-flying England.

India won by 106 runs on Monday to square the five-match series 1-1. Chasing 399, England was bowled out for 292.

India's winning moment came in the first over after the second session was extended at the Y.S. Rajasekhara Reddy Stadium, with the host needing just one wicket.

That wicket was fittingly taken by Jasprit Bumrah. His sensational spell of reverse swing – six for 45 – on the second day had turned the match decisively in India's favour. He added three second-innings wickets to his tally. R. Ashwin, the other senior bowler in the Indian attack, also took three.

One more would have taken the champion off-spinner to that rare milestone of 500 Test wickets. But he won't be minding that, having helped India score what must be a very satisfying victory, after having to play without the injured duo of K.L. Rahul and Ravindra Jadeja, not to mention Virat Kohli, who had pulled out of the first two Tests because of personal reasons.

Earlier, England resumed at 67 for one and Rehan Ahmed, the night-

watchman, made the visitors' intention clear, hitting Axar Patel for successive boundaries. The left-arm spinner, however, had the last laugh, trapping Rehan lbw, as the batter was beaten while trying to flick.

The other overnight batter Zak Crawley (73, 132b, 8x4, 1x6) was always going to be a worry for India and the tall opener was stroking handsomely. Ollie Pope, whose 196 helped England win the first Test at Hyderabad, was another man India would not have wanted to see too much of.

Pope had hit five fours during his brief stay when he was snapped up superbly by Rohit Sharma at slip off Ashwin. It was an excellent reflex catch the Indian captain took towards his left with both hands.

Joe Root, who had damaged his finger while fielding on the previous day, had seemed a man in a hurry. He started by reverse-sweeping Ashwin for a couple of fours and also stepped out to hit Axar over long-off for a six.

Root didn't last long, though. He came down the

track against Ashwin, only to give a top-edge to backward-point.

Crawley was now joined by Jonny Bairstow and it was a partnership England needed to click. The stand was worth 40 when India's review against Crawley yielded success. The DRS found him lbw to Kuldeep Yadav, and the Indian fielders erupted in joy: they knew how important that

wicket was.

Then Bumrah brought one in sharply to beat the defensive bat of Bairstow, who was adjudged lbw; the DRS didn't help.

It's Sahaja's Day as she knocks out top seed

Wild card entrant Sahaja Yamalapalli competed brilliantly against the top seed Kayla Day of USA to keep the sparse crowd thoroughly entertained and pulled off a 6-4, 1-6, 6-4 victory in the first round of the L&T Mumbai Open WTA tennis tournament at the Cricket Club of India (CCI) on Monday.

'Son' rises for South Korea with hopes of ending 64-year-old drought in AFC Asian Cup

Son Heung Min, the talisman who had left Qatar as a boy in 2011, is proving to be the country's main man in 2024, steering it to the semifinals

outh Korea has drawn 2-2 with Japan in the AFC Asian Cup semifinal. An air of tense trepidation surrounds Qatar as both sides take spot-kicks. Japan scores thrice in its four attempts while Korea fails to convert a single opportunity.

In a few moments, the game is done and dusted. The Taeguk Warriors sink to the ground, with an 18-year-old weeping profusely at the Thani bin Jassim Stadium. His and the country's continental dreams are shattered. Korea is out.

Thirteen years later, on a cold Friday gight in the same country, that youngster now a Premier League star with the captain's armband on him, stood with the score 1-1 in a quarterfinal. Korea - playing 30 kilometres off that field where Japan knocked it out - had got a free-kick against Australia just outside the penalty box.

He placed the ball, looked up and then lashed in a right-footed curler which rattled the net after a touch off Mathew Rvan. Australia one. South Korea two.

When the full-time whistle blew, he dropped to the ground again - his eyes, full of tears. But this time, he stood on the other side of the cruel game, known otherwise as football.

Son Heung Min, the talisman who left Qatar as a boy in 2011, proved to be the man in 2024, to rescue his side and steer it to the semifinals.

He earned a penalty, three minutes into

the second half injury time, which was converted by Hwang Hee-Chan and then netted the winner.

"He was having difficulty in keeping his opponent's movements in check initially (in the tournament). Perhaps due to the pressure on him, he has not been able to leave a solid impact like Tottenham matches," Do-Yong Kim, a Korean journalist from Doha, told Sportstar.

"But tonight, he proved to be an ace by playing a decisive role in the match. Now I can see why he is attracting a lot of fans' attention at this tournament."

The goal was iconic in a number of ways. In the 2015 Asian Cup final, Son forced the match into extra-time with a stoppage-time equaliser and his team went on to lose the match 1-2 in extra-time. The opponent - Australia. Its coach? Ange Postecoglou, his current club manager.

Like Father like Son

Son's winner in the last moment brought flashes of a rather low-profile game played 40 years ago between Myongji University and Sangmu FC (now known as Gimcheon Sangmu FC) at the President's Cup National Football Tournament.

Trailing 0-2 at one point, Myongji made a comeback, winning the match 3-2. The scorer of the winning goal - Son Woong-Jung, the father of the current Tottenham and Korean skipper.

Though Woong-Jung could play only till the second team of South Korea, it was under his tutelage that Son grew up to

arguably become the best player in Asia.

"When I was 10 or 12, he came in to coach my school team and we were training, 15 or 20 players. The programme was for us all to keep the balls up for 40 minutes," Son told The Guardian.

"When someone dropped the ball, my father would not say anything. But as soon as I dropped it, he made us all start over from the beginning. The players understood, because I was his son and, yeah, it was tough. But when you think about it now, this was the right way."

Son went on to shine at the 2009 FIFA U-17 World Cup, scoring three goals and taking his side to the quarterfinals. Eventually, Europe came calling

The forward moved to Hamburg, honing his attacking skills with Dutch great

Ruud Van Nistelrooy. But it was at Tottenham Hotspur that he became a star - a figure beyond the stature of Cha Bum-kun and Park Ji-Sung, both

being legends in their own right. In over eight years, he has become the highest Asian goalscorer in the Premier League and the Champions League, has won the Premier League Golden Boot as the only Asian footballer and has more assists than any Tottenham player in the

"He is like David Beckham. Men and women of all ages like him," Do-Yong said, "Thanks to Son, Tottenham has become a popular club in Korea. Expectations are

Despite individual accolades, Son's quest for success with the national team remains a fly in the ointment. His three World Cup appearances yielded only a single Round-of-16 berth in 2022.

The Asian Cup hasn't been much kinder, with the closest achievement being a runners-up finish in 2015 when the Socceroos sealed the title.

But at 31, with the next Asian Cup potentially marking his twilight, this edition carries immense weight.

It's the perfect opportunity for the gifted forward to clinch the title which has eluded his country for over six decades.

Inspired by Lionel Messi's World Cup triumph in Qatar, Son, with three goals scored, two penalties earned and eight chances created, looks to try his luck on the same promised land to get his hands on the AFC Asian Cup.

And he, like Messi, has the whole team fired up with the same agenda.

"Everyone in the locker room and people back home are waiting for us to win this tournament. We have not won it for the last 64 years," Lee Kang-In said.

"We are hungry and motivated for the tournament. All of us, the coach, the players and the entire staff."

"I was delighted that I could win an Asian Games medal for the country after 13 years. This will inspire other wrestlers to work hard and bring laurels. I will also try to win more medals for the country in upcoming major

Nurturing a winner's attitude has also boosted Sunil. "Before a bout, I tell myself that when the bout ends my hand should go up. The scores can be up and down during a fight, but I focus on winning the bout. I begin slowly and don't get aggressive from the very start. My stamina is my strength."

Sharing his success mantra which has enabled him to be consistent, Sunil said, "An athlete has to set his own targets and do a lot of sacrifices and work with dedication in order to achieve something significant. India narrowly missed out on a podium finish in the previous season, finishing fourth behind the Netherlands, Great Britain, and Belgium.

"We have just come back from a successful tour in South Africa where we played against France, South Africa, and the Netherlands to begin the Pro League in the best shape possible," Harmanpreet said in a Hockey

"A few young players have been included in the squad this time and this will be a great opportunity for them to familiarise themselves with the play style of some of the best teams in the world." Five national teams -- Ireland, the Netherlands, India, Spain and Australia -- will participate in the India leg of

the Pro League, facing each other

once in Bhubaneswar and once in

Rourkela. "We are taking the Pro League very seriously as winning it would not only mean direct qualification for the FIH Hockey World Cup 2026 but these games will also be crucial in the build-up to the Paris 2024 Olympics," Harmanpreet said.

India will take on Spain in their first match of the season on February 10, followed by a clash with the bestranked team in the world, the Netherlands, on February 11.

After a brief break, the hosts will take on Australia on February 15, before they face Ireland in the last match of the Bhubaneswar leg on February 16.
